#### A. Humanitarian Context Analysis

Briefly describe (in no more than 300 words) the current humanitarian situation in the specific locations where CHF funded activities will be implemented. Provide evidence of needs by referencing assessments and key data, including the number and category of the affected population<sup>1</sup>

South Sudan continues to experience multiple internal and external problems resulting internal displacements causing multiple child protection risks such as separation from families, child abduction, recruitment, psychosocial distress and other violence continues. On the 15 December 2013, fighting broke out within the SPLA and according to the humanitarian matrix report of UNOCHA (2 January 2014), the fighting has already resulted into the displacements of 135,368 persons with the highest number reported in four locations: Awerial: 75,975 (56%), UNMISS Tonping: 17,464 (13%), UNMISS Juba 3: 12,000 (9%), UNMISS Bor: 9,000 (7%), Katigir & Wondurub in Juba: 8,700 (6%), Werkok in Bor: 6,000 (4%) and the remaining 6,229 (5%) are from different locations in the country. Though the conflict started in Juba, it quickly spread to other States and fighting continues mainly in Jonglei and Unity State where rival groups are fighting over key towns including Bor. Awerial County in Lakes State currently host the highest displaced population mainly from Bor in Jonglei State. Prior to the recent conflict which started in Juba in December 2013, fighting in Jonglei State already displaced over 100,000 people in mainly Pibor County and aid agencies were working to respond to this population. Amongst this population, Child protection agencies identified and registered over 1,000 separated and unaccompanied children.

UNICEF working in collaboration with other protection actors have started providing interventions in the two camps in Juba (UNMISS Tonping and UNMISS Juba 3) in order to address the situation of unaccompanied children and those separated from their families and those reported as missing, protection monitoring, prevention of violence including recruitment and use as soldiers, youth mobilization in armed violence, provision of Psychosocial Support services and mainstreaming child protection into other humanitarian sectors. In Awerial County where the highest displaced population is reported to be seeking refuge, the Government, has delivered medical assistance to the displaced in Awerial While ICRC and MSF have set up a clinic to provide urgent medical care. An Inter-agency needs assessment carried out in Awerial County on 31 December 2013 confirmed family separation, physical insecurity due to the tribal nature of the conflict and children recruitment as key child protection concerns. Aid agencies including UNICEF are currently working with partners to start delivering Protection assistance including identification, documentation and Family tracing services, Psychosocial Support care services, individual case management and prevention from recruitment and use in the conflict or mobilised for armed violence

#### **B. Grant Request Justification**

UNICEF is the co-chair of the Child Protection Sub-Cluster and hence is responsible for coordinating protection services for affected children through the provision of FTR services, provision of psychosocial support services, monitoring and reporting on grave child rights violations, prepositioning of child protection emergency supplies and building the capacity of child protection workers from governments, civil society and CBOs to deliver quality child protection in emergency services. Given the scale and urgency of this emergency, UNICEF is seeking this funding support in order to support frontline local CBOs and NGOs to provide needed Child Protection services in Unity, Lakes and Central Equatoria States. UNICEF will ensure that appropriate technical support and quality assurance needed to provide CP services are provided through capacity training and coordination of CP interventions. UNICEF, being the co-lead for the child protection sub-cluster and traditionally responsible for the provision of standard Child Protection in Emergencies (CPiE) supplies used for both community based and Centre based Psychosocial Support will procured and ensure that these supplies are available to CP partners responding to emergencies. UNICEF is considered as the agency of last resort for Child protection interventions and UNICEF will continue to play this role through funding from other donors to complement the support of the CHF funding to CP partners, including the provision of small grants to small CBOs.

UNICEF has not secured funding from other sources for the 2014 CAP, but efforts are currently ongoing to secure funding from ECHO and the Swiss Development Cooperation to complement the CHF funding been requested.

UNICEF's child protection in emergencies response strategy and proposed activities will contribute to the realization of the Protection Cluster priorities for 2014. UNICEF project will target children and youth affected by emergencies through displacement through CPiE Supplies support to CP partners, coaching/mentoring and on the job capacity building, coordination, quality assurance and provision of small grants.

UNICEF is the co-lead of the Child Protection Sub-Cluster and hence is responsible for coordinating and ensuring protection services for children affected by conflict and emergencies such as procurement and prepositioning of child protection emergency supplies; to deliver quality child protection services in particular provision of community based psychosocial support and supporting the coordination of work with Separated and Unaccompanied Children. Being the co-lead for the child protection sub-cluster, UNICEF is considered as the agency of last resort for Child protection interventions, and is therefore, responsible for making sure

that there are no gaps in child protection response during emergencies and in situations of armed conflict.

, 25,000 Individuals (including 12,000 boys, 3000 women, 2000 men and 8,000 girls) have been provided child protection services in three emergency affected States (Central Equatoria, Lakes and Unity States ) in South Sudan.

#### Strategy

UNICEF will procure and preposition the child protection in emergency supplies in the states of focus. CP Sub-cluster members and organizations responding to on-going emergencies will have access to the protection supplies which were procured through UNICEF and will use the kits to provide community based psychosocial support to boys, girls and community members affected by emergencies. UNICEF will also deploy Child protection staffs to ensure continuous coaching and mentoring of Child Protection agencies' staffs and ensure day to day coordination of the response. In addition to the capacity building and coordination, UNICEF will support national NGOs and CBOs, including religious institutions to provide, Family Training & Reunification and provide both centre and community based Psychosocial Support to displaced children and their families.

#### Activities

- Deployment of Child Protection staffs in the emergency locations for continuous coaching mentoring and coordination of child protection response;
- 2. Procurement of Child Protection in Emergency (CPiE) Supplies;
- Transport and pre-positioning of CPiE supplies;
- 4. Delivery of supplies to Child Protection agencies implementing Psycho social programme;
- Monitor the implementation of the Child protection in Emergencies programme to assess the use of supplies and ensure timely replenishment;
- 6. Coordination and Information management of CPiE;
- 7. Provide community based psycho-social support services to children Boys and girls affected by violence and emergencies;
- 8. Carry out Child protection monitoring and awareness raising on Child Protection issues amongst the displaced. Ensure that appropriate referral pathways are identified and share with the population;
- 9. Conduct prevention of family separation awareness campaigns at food distribution and other areas of huge population;
- Identify, register separated and unaccompanied children and ensure that families are traced & children reunified or place in temporary care.
- 11. Prevention of violence against children including, prevention of recruitment and use of children as soldiers in the conflict and prevention of children being mobilized and used in armed violence
- 12. Individual case management and referrals.
- 13. Mainstreaming child protection in other humanitarian sectors

The project will not address environmental issues directly, however, special efforts will be made to procure environmental friendly supplies and beneficiaries will be given information on proper disposal, to enhance environmental protection

#### vii) Implementation Mechanism

Describe planned mechanisms for implementation of the project. Explain if it is implemented through implementing partners such as NGOs, government actors, or other outside contractors.

Purchase of recreational Kits, child friendly space kits, hygiene kits for the girls and ground floor mats for child friendly space centers will be done by UNICEF within its well-developed procurement and logistics framework. Supplies will be procured and pre-positioned in the emergency locations (Bor, Bentiu and Juba depending on security situation in each location) and made available to partners carrying out Psychosocial support and community based Child Protection activities. The provision of supplies will be through a phase manner, i.e., UNICEF will ensure that CPiE supplies are replenished; partners provide report on the use of supplies previously provided.

The delivery of CPiE supplies to end users locations remains a challenge for many agencies. UNICEF manages the pipelines for Education, Nutrition and WASH which require huge and functioning logistical system, UNICEF Child Protection will use this facility to deliver and preposition CPiE supplies in State capitals. When a member of CP Sub cluster or CPWG makes a request for CPiE Supplies, these are deliver to the partner from the proposition supplies and in situation where the partner demonstrate its inability to deliver the supplies to the project areas, UNICEF will organize and deliver the supplies using the same systems mentioned earlier or the common humanitarian logistic where possible.

UNICEF will ensure that Child Protection staffs are deployed in the emergency locations to provide on-the-spot coaching mentoring and coordination of CP interventions in order to ensure that the CP services are of acceptable quality. In addition to the on-the-spot support, UNICEF will provide small grants to small CBOs in order to carry out FTR activities, Community and centre based Psychosocial activities and conduct case management and referrals, child protection main streaming to prevent risks that can harm children and prevention of violence against children including from recruitment and use as soldiers, strengthening community based networks to identify, mitigate/respond to child protection risks and protection awareness.

UNICEF Child Protection Staffs, the Child Protection Sub Cluster coordinator and the UNICEF's CP staffs in the field will be monitoring the implementation of the project through field visits and monitoring meetings. UNICEF has a robust procurement system which monitors supplies from the supplier to the field level. Additionally, UNICEF has "end user Monitoring tool" through which CP

Sub Cluster members' feedback to UNICEF on the supplies received and the number of children who have benefited from the supplies.

Throughout the project lifespan, written reports, number of boys and girls, men and women who have benefited directly or indirectly will be recorded and reported periodically to UNICEF and likewise to the CHF. The three indicators that have been developed will be monitored to achieve the expected project results. Various monitoring tools such as weekly updates, situational reports, monthly progress reports and field monitoring visits will be used in the monitoring of this project. Reports will be analyzed based on the set indicators and results in which data will be disaggregated by gender.

As this is an emergency and the situation remains fluid, daily briefing and activity updates will be collated and appropriate actions taken to address issues airing in the implementation of the protection including the changing realities.
