EXECUTIVE SUMMARY

In the second year of the joint program implementation, progress was made against the overall objective of the action and relevant results have been achieved. Participating Agencies (PUNOs) worked very closely together and in collaboration with national partners to address the most pressing needs of the target population and contribute to increasing the resilience of the most vulnerable groups in the country.

The Resident Coordinator Office provided strategic guidance and facilitated PUNOs discussions also to address some implementation challenges emerged from the pandemic and linked to the transition of the national government.

Many activities are still ongoing and have been postponed to Y3 of the joint program but, several results have been achieved in the period February 2021 to February 2022. The most relevant results are highlighted as follows:

<u>Under output 1</u>, together with national counterparts (Ministry of Health, Treatment and Medical Education (MOHME), and Ministry of Education (MOE), Drug Control Headquarters (DCHQ), and the International Red Crescent Society (IRCS), UN Iran:

- trained 150 technical staff and health practitioners on drug prevention and quality of care;
- delivered capacity building sessions on drug use prevention services to 1,288 adolescents, youth, and family members;
- developed several raising awareness materials and drug prevention programs at the time of COVID-19 (e.g manuals, videos educational short films) for DCHQ and MOE with a focus on adolescent boys and girls. These products helped increase the understanding of practitioners as well as families of the importance of drug prevention and quality assistance, especially in juvenile correction centers.
- Several preliminary activities were undertaken for the development of the baseline survey on substance abuse among children and adolescents (e.g the monitoring and evaluation framework for drug prevention and treatment; the methodology and assessment tools; initial arrangements with local stakeholders and the participating implementing agencies). High-risk factors for substance use in children and adolescents will be covered in the baseline survey. In addition, in line with the development of the National Strategy Plan (NSP), an operational plan for MOHME/Health Deputy was drafted after carrying out a situation analysis using the NSP rapid review tool. Through these activities, relevant information will be made available and help the identification and development of future programming especially to address drug-related issues in the country.

<u>Under output 2,</u> UN Iran helped increase access to pediatric cancer medicines for children with hematologic tumors. A total of 11,900 vials of Vinorelbine were procured and delivered to health centers; 41,000 vials of Vincristine Sulfate were purchased and will be handed over to hospitals in the country in May 2022. Cancer medicines have limited availability in Iran due to the US sanctions. The procurement of such medications significantly contributes to effectively treating patients with acute leukemia who are not responsive to conventional chemotherapy or other cancer medications.

<u>Under output 3</u>, to strengthen the socio-economic resilience of women, youth, and the most vulnerable, UN Iran worked closely with the government on developing policies that promote economic empowerment and disaster preparedness skills. A number of activities were identified in order to exchange knowledge on South-South and Technical Cooperation in the framework of the Technical Assistance Package (TAP). The resilience

of youth and women, including female-headed households (FHH), and girls was strengthened through several activities such as

- o a baseline analysis of vulnerable groups;
- the identification of vocational, entrepreneurship, and life skills training to help youth better access the job market;
- the development of social protection models targeting Female heading households (FHHs) in low-income households; the implementation of these models will be undertaken in 3 selected provinces later in 2022.

It is expected that at the end of the joint program, the resilience level of vulnerable groups, including women and youth will enhance as a result of UN Iran's joint and timely interventions.

During the reporting period, the Communication Task Force continued to provide timely guidance on the EU's requirements for visibility and communication and promoted joint communication and visibility efforts. Due to the pandemic, several visibility activities have been postponed to Y3.

As of the end of March 2022, out of the overall fund EU budget approved for this joint program, approximately USD 1,800,957 (the final amount will need to be defined by the EU as per Article 3 of the General Conditions) still needs to be collected by Participating UN Agencies (PUNOs) PUNO; unfortunately, due to many implementation challenges and delays, the 2nd funding tranche requested in 2021 has not been fully spent to date. As per the EU's rules and regulations, at this stage, PUNOs cannot request additional funding.

A work plan for the 3rd year of the implementation of the joint program is submitted along with the Annual report; it provides detailed information on planned activities and the related estimated budget for the period February 2022 to February 2023. In light of the delays in the implementation and the need for postponing several activities to Y3 and beyond (more detailed information in the *Indicator Based Performance Assessment matrix*), the Convening Agent and PUNOs would like to discuss with the EU a request for a 2 years' extension of the duration of the joint program (end date of the joint program will be February 2025). The Convening agent is ready to work closely with the MPTFO to prepare all the necessary documents for the EU's consideration and approval.

I. Results

AT OUTCOME LEVEL:

Specific objective- To respond to emerging needs and enhance the resilience of the most vulnerable communities, especially children, youth, and women.

In the second year of the program implementation, Participating Agencies (PUNOs) worked very closely together to address the most pressing needs of the target population and contribute to increasing the resilience of the most vulnerable groups in the country.

The Resident Coordinator Office provided strategic guidance and facilitated PUNOs discussions also to address some implementation challenges that emerged from the pandemic. As of the end of February 2022, many activities are still ongoing, and the overall impact of the program at the outcome level cannot be determined at this stage². Nevertheless, in the reporting period, some relevant results have been achieved; they contribute to meeting the specific objective of the JP:

- Together with national counterparts (Ministry of Health, Treatment and Medical Education (MOHME), and Ministry of Education (MOE), Drug Control Headquarters (DCHQ), and the International Red Crescent Society (IRCS), UN Iran:
 - trained 150 technical staff and health practitioners on drug prevention and quality of care;
 - delivered capacity building sessions on drug use prevention services to 1,288 adolescents, youth, and family members.
 - o developed raise awareness materials and drug prevention programs during the challenging times of COVID-19 (e.g manuals, videos educational short films) for DCHQ and MOE with a focus on adolescent boys and girls. These products helped increase the understanding of practitioners as well as families of the importance of drug prevention and quality assistance, especially in juvenile correction centers.
- Several preliminary activities were undertaken for the development of the baseline survey on substance abuse among children and adolescents (the monitoring and evaluation framework for drug prevention and treatment; the methodology and assessment tools; the initial arrangements with local stakeholders and the participating implementing agencies). High-risk factors for substance use in children and adolescents will be covered in the baseline survey. The resilience of youth and women, including female-headed households (FHH), and girls was strengthened through several activities such as
 - o a baseline analysis of vulnerable groups;
 - the identification of vocational, entrepreneurship, and life skills training to help youth better access the job market;
 - the development of social protection models targeting Female heading households (FHHs) in low-income households; the implementation of these models will be undertaken later in 2022 in 3 selected provinces.

It is expected that at the end of the joint program, the resilience level of vulnerable groups, including women and youth will enhance as a result of UN Iran's joint and timely interventions.

AT OUTPUTS level

1. Protection children and youth from the harm of drugs

<u>Output 1:</u> Evidence-based and tailor-made drug use prevention, treatment, rehabilitation and social reintegration programs, tools, and guidelines for children and adolescents are adapted, improved, and piloted

In the reporting period, several activities were undertaken to prevent families, children and adolescents' drug use and abuse, especially during the COVID-19 pandemic:

- Overall 110 mental health experts from Iranian Red Crescent Society (IRCS), Ministry of Health, Treatment and Medical Education (MOHME), and Ministry of Education (MOE) attended a total of 12 hours training of trainers workshops in the framework of the program "*Tele-counseling: Remote Stepped Psychosocial Care & Support (ReSPCT)*" and enhanced their skills to prevent drug use and abuse among adolescents, youth and families. In addition, 9-hours online booster/online individual sessions were provided to counselors and social workers in 31 provinces. A total of 1,288 adolescents, youth, and family members received mental health and psychological support services across 31 provinces by trained ReSPCT telephone counselors.
- 4 agreements were drafted between UN Iran and the Ministry of Education (MOE) and the Drug Control Headquarters (DCHQ) for 1) developing program manuals and service packages; 2) organizing 10 series of training workshops for drug use prevention practitioners from 31 provinces; 3) conducting 4 pilot studies; and for the implementation of 4 schools and family-based drug use prevention projects for children, adolescents, and families in 31 provinces (e.g "Families and Schools Together (FAST)" program, Teachers-led Drug Education and Life Skills Training (Unplugged), Life Skills Training for at-risk school students (TAHAMTAN), and Selective Drug Use Prevention program (Payame-Man) programs). The plan for the implementation of the mentioned projects in 31 provinces has been finalized.
- With the support of health professionals from the Ministry of Health, Treatment and Medical Education office, and Adolescent Wellbeing Clubs, the online version of *TAHAMTAN* (a Life Skills Training and Social Participation Service Package for at-risk Adolescents during COVID-19 Pandemic) was developed. In addition, 4 short educational videos for the prevention of drug use among young people during the COVID-19 pandemic were completed. UN Iran worked closely with DCHQ and the Ministry of Education (MOE) in developing and conducting a pilot study on a school-based drug use prevention package (*On My Own Feet*): 40 teachers and school principals in 2 schools of Tehran (one for boys and one for girls) received 5-day training on this program. It is foreseen that "*On My Own Feet Program*" will be implemented in about 100 schools in 31 provinces later in 2022. In addition, an Adolescent Wellbeing Center for reducing drug use and risky behaviors among adolescent girls in Khorasan-Razavi province (Mashhad) was established; 10 selected technical staff from the Adolescents Center and Anti-narcotic Council benefitted from a 12-weeks training and supervision sessions during 3 months on drug use prevention among vulnerable adolescent girls in Mashhad.
- On 11 October 2021, the "Strong Families" online expert meeting took place; focal points and experts from the State Welfare Organization, Ministry of Health, Ministry of Education, Drug Control Headquarters, and several NGOs met to discuss and review the training materials and the implementation modality of the Strong Families program across the country. All the facilitators who implemented the program back in 2019 were also present in this meeting and shared their experience and provided feedback regarding the training materials. In addition, from 6 to 16 December 2021, 66 participants (57 Women and 9 Men) representing 9 schools and nominated by MOE, and 4 NGOs nominated by DCHQ, partook in the training of trainers of the Strong Families Programme in Tehran.
- Several training programs and manuals were translated into Farsi and adapted to the context of Iran:
 - "Family United program", a family skills program that addresses the essential core needs of parenting skills (https://www.unodc.org/res/listen-first/parenting-under-covid-19-html/Family-UNited-leaflet-20200218.pdf).

• "Line Up Live Up" program that aims to address risk factors associated with crime, violence, and substance use, such as poor behavioral control through sport-based life skills.

- "ILO SOLVE" training manual for the prevention of drug use in workplaces in combination with the strong Families prevention program.
- The online "Strong Families" training platform was built in late 2021 to respond to all community/school-based prevention programs going on hiatus for several months during the COVID-19 pandemic last year and to overcome the challenges of piloting prevention programs worldwide, including in Iran. The online training platform contains over 50 short videos and animations helping the program facilitators get familiar with the program. Since November 2021 when the platform was adapted and translated into Farsi, facilitators from LNGOs have been utilizing the website to get prepared and trained for a new round of implementation in 2022.
- The "Strong Families" program was carried out in 3 Centers in Tehran and Karaj by 2 Local NGOs; 51 Iranian and Afghan families participated in this activity. The main caregivers who attended all three sessions of the program were mothers; also, 11 boys and 42 girls (ages between 8 and 15) benefitted from the activities. It is expected that more centers will implement this program in 2022.

Capacity building activities for relevant organisations on drug use prevention and treatment

In collaboration with the Drug Control Headquarters (DCHQ), UN Iran carried out several activities for enhancing the skills of national partners in drug use prevention and treatment:

- Overall, 120 counselors, psychologists, social workers, medical practitioners, and psychiatrists nominated by MOHME and Universities of Medical Sciences from 31 provinces, attended 8 rounds of 5 day-training workshops on the topic of drug treatment for children and adolescents. The Guidelines for treatment of substance use disorders in children and adolescents (6 packages/ manuals) were translated into Farsi and 6 treatment manuals were finalized for the usage of MOHME's General Practitioners and drug counselors.
- In the framework of the *Training on Family*-based treatment for young people with drug use disorders, a 6-day training course was organized remotely for counselors, psychologists nominated from the State Welfare Organization of Tehran, Sistan Baluchestan and Mazandaran provinces, and Medical Science Universities of Isfahan, Tehran, Kerman, Shahid Beheshti. Also, representatives from the Ministry of Health and Drug Control Headquarters and 14 participants (7 women,7 men) partook in the online training.
- DCHQ and the Prison Organization received technical support to run programs for children and adolescents in juvenile correction and after-care centers; specifically:
 - drug prevention programs were developed and will be implemented by the NGO Society for Prisoners Support in the next months;
 - 4 series of training workshops have been developed for 120 social workers from the Prison Organization social from 31 provinces on "Parenting for vulnerable adolescents", "Life Skills Training and Coaching for adolescent inmates", "Counseling and psychosocial support for young people in juvenile correction and aftercare centers", and on "Producing the media products and educational films for family members of inmates".
 - A report on the needs of young inmates was drafted to increase inmates' protection, psychosocial support, and implement quality drug prevention interventions for children in juvenile correction and aftercare centers across the country.

The UN in collaboration with the Ministry of Health and Medical Education (MOHME) developed the following activities:

- The baseline survey and NSP developed tools were revised based on newly received feedback from national counterparts through DCHQ. UN Iran is in close contact with national counterparts for their clearance and implementation of the NSP. In line with NSP development activity, an operational plan for MOHME/Health Deputy was drafted after carrying out a situation analysis by using the developed NSP rapid review tool. The analysis conducted in 3 provinces-from the provincial and the district level up to the service points- aims at strengthening the provided substance use prevention services for children and adolescents in the health sector.
- The scale-up plan of the piloted Strengthening Families Program (SFP) was developed after the positive evaluation of the first phase of the program.
- The preparatory phase for developing a drug treatment guide for children and youth was completed; in coordination with MOHME, a concept note was finalized and the implementation of the foreseen activities will start soon.

In line with post-intervention surveys, evaluation of planned interventions will be conducted including FAST, Unplugged, etc. and the provided mental health services to children and adolescents. In addition, an evaluation of the existing psychological interventions will be conducted including Brief Interventions (BI) and Cognitive Behavioral Interventions (CBI) for addressing substance use among adolescents, and child patients, and their family members; and on the service package for empowering spouses of substance users).

• The concept notes for the implementation of the following services were drafted in the reporting period: Evaluation of the integrated services for the management of substance use in Primary Health Care (PHC); and for designing and piloting the implementation of a surveillance system on drug-related emergencies.

2. Procurement of cancer medicines for children.

Output 2: Access for child cancer patients to life-saving pharmaceutical products is obtained

UN Iran worked in close collaboration with Iran Food and Drug Administer (IFDA), International Relation Department (IRD), and Non-Communicable Disease Department (NCDD) in MOHME, to purchase and deliver 2 anti-cancer medicines for children, Vincristine Sulfate and Vinorelbine. Vinorelbine vials were procured, handed over to MOHME, and distributed to 32 centers in the reporting period. Vincristine Sulfate medicine has not been yet delivered to Iran due to some availability issues in Iran, in the past years. The purchase order for Vincristine Sulfate has been issued in January 2022 and the vials will be distributed to health centers in May 2022. The target pediatric cancer centers benefitting from the procurement will be identified after the delivery of Vincristine to Iran.

3. Mainstreaming of women empowerment and the most vulnerable in disaster preparedness and response.

<u>Output 3:</u> Supportive local and national level environments for the most vulnerable communities are strengthened, targeting women and girls in disaster-prone areas.

UN Technical Assistance Package (TAP) and South-South and Triangular cooperation

In the framework of the "Support youth innovation and entrepreneurship (Youth Co:Lab) initiative implemented by Novin Tarh Pars institute, 84 hours online training courses, team building sessions, life skills courses, and mentorship sessions were organized to enhance the entrepreneurial skills of youths in Pole-Dokhtar county in Lorestan Province Through the "Youth Programme" platform (www.Youthprogramme.ir), an average of 50 young people (including women and girls) participated in online training courses on topics such as business, jobs and entrepreneurial skills, project management, content creation, and digital literacy, brand creation, marketing, and digital marketing, crisis management and business resilience, administrative affairs, accounting principles, and financial analysis. In order to monitor the knowledge improvement and build the capacity of users in the project, pre-test and post-test methods were used for 14 training courses titles. The results showed that the participants" knowledge of entrepreneurial topics increased as a result of the project activities.

Another South-South webinar on exchanging best practices from select countries in the region on the COVID-19 socio-economic impact on women and girls with a focus on FHHs was initially scheduled for 2021; due to the pandemic, it was postponed to 2022. UN Iran has been in consultation with stakeholders on how to promote the economic empowerment of women, and in particular, of female-headed households (FHH). The completion of the FHH monitoring mechanism, regular policy dialogues, the implementation of the social protection model at provincial levels, as well as the South-South exchange and identification of priority areas for the most vulnerable women and FHH, will further enhance the quality of consultations and exchanges with concerned local stakeholders.

Due to the COVID-19 restriction, the presidential elections, and changes in the UN Iran's governmental counterparts, the implementation of the other planned webinars had to be postponed to later in 2022. Negotiations with the new government are underway and the approval on new future workshops will very much depend on the new administration's confirmation.

<u>Youth skills, Entrepreneurship Framework and advisory services platform to facilitate youth-driven solutions (Youth Co-Lab)</u>

UN worked closely with national partners and organized several capacity building sessions for youth:

• In the framework of the "Support youth innovation and entrepreneurship (Youth Co:Lab) initiative" implemented by Novin Tarh Pars institute, 84 hours online training courses, team building sessions, life skills courses, and mentorship sessions were organized to enhance the entrepreneurial skills of youths in Pol-e-Dokhtar county in Lorestan Province. Through the "Youth Programme" platform (www.Youthprogramme.ir), an average of 50 young people (including women and girls) participated

in online training courses on topics such as business, jobs and entrepreneurial skills, project management, content creation, and digital literacy, brand creation, marketing, and digital marketing, crisis management and business resilience, administrative affairs, accounting principles, and financial analysis. In order to monitor the knowledge improvement and build the capacity of users in the project, pre-test and post-test methods were used for 14 training courses titles. The results showed that the participants' knowledge of entrepreneurial topics increased as a result of the project activities.

- Through 3 Online and face-to-face group mentorship sessions, 36 young people received tailored coaching on team building and on developing a business plan.
- 2 Innovation Challenges (1 online and 1 face-to-face) were launched to boost brainstorming, generate innovative ideas for entrepreneurship, and form teams. An average of 45 applicants participated in these challenges organized in 4 thematic areas such as agriculture and livestock, energy, and environment, tourism and handicrafts, and information technology. 14 innovative ideas and teams were finalized after the second innovation challenge that was held on 4 December 2021. The final "ideation event" was held on 8 February 2022, and 12 innovative ideas were awarded and supported in the last stage of the project.
- Life Skills of the youth target group were also strengthened through life skills training material developed by the Ministry of Cooperatives, Labor and Social Welfare; these materials include 11 topics related to skills such as self-awareness, decision-making, problem-solving, effective communication, creative thinking, interpersonal relations and sympathy, critical thinking, stress coping and emotion management. Electronic copies of the life skills materials were used in a joint program for the provision of life and vocational skills within UNDP's Youth Programme platform. Life skills material is in Farsi. The summary report in English is available for distribution.

Initiatives on Women economic empowerment and resilience

The monitoring mechanism/dashboard developed in the first year of implementation of the joint program for assessing the socio-economic status of FHHs proved to be an effective platform for policy dialogue with the Ministry of Cooperative, Labor and Social Welfare and for encouraging systemic changes for enhancing the FHH's resilience. To date, the dashboard data was used to 1) develop policy briefs on the socio-economic impacts of COVID-19 on the most vulnerable female-heads of households (FHH); 2) develop social support/protection plans/models targeting FHHs in low-income deciles and women in low-income households taking into account the socio-economic impact of COVID-19. In addition, 2 new indicators were added to the dashboard based on household income and expenditure survey in order to identify the most vulnerable FHHs and better respond to their needs through the provision of social support services and social protection. Data at the sub-provincial level will be used to implement social protection women empowerment models in 3 provinces in 2022, as a pilot demonstration.

During the reporting period, 883 beneficiaries (705 Females, 178 Males) acquired life skills on employability and economic participation as part of the Demographic Dividend (DD) program. This was also in synergy with the DG ECHO-funded action in 2020 when out of the 705 women in the target group, 321 female heads of households trained on life skills, were employed in various production units in many provinces.

Due to the COVID-19 restrictions in the past 2 years and specifically in the Pole Dokhtar area, and the need for physical presence in the county for baseline analysis and needs assessment of vulnerable target groups, the implementation of the mentioned planned activities was delayed. The recruitment of an Implementing partner for carrying out the planned activities is in progress.

Under the "Support to the design of temporary shelter standards and disaster preparedness and response capacity-building for women and vulnerable groups" initiative, the following actions were carried out by the International Institute of Earthquake Engineering and Seismology (IIEES):

- A set of recommendations and contents related to improving women and vulnerable groups' preparedness for natural disasters was provided based on successful national and foreign experiences in providing the available guidelines and standards. To increase preparedness and capacity-building for women and vulnerable groups, 2 workshops were organized in various cities of the Lorestan province during the period November- December 2021. The following participants benefitted from training carried out by UN Iran:
 - o 65 girls and women (including students, their parents, and schoolteachers);
 - 9 people with Hearing Impairment (HI) and people with Autism Spectrum Disorder (ASD).
 - A total of 188 representatives of NGOs active in the field of women and vulnerable groups, relief organizations (such as the Red Crescent Society and the Fire Department), government bodies, and disaster management organizations of county governorates, and municipalities from Poledokhtar, Azna, and Khorammabad counties.
- Standards for post-disaster temporary shelters were developed based on indigenous knowledge and international best practices; family and women's consideration and specific needs were taken into account. This initiative is also in line with the goal of a resilience workstream in the UN Technical Assistance Package (TAP), namely to promote resilience to economic and disaster-related shocks.

A consultant was hired to develop standards for conditional cash transfers (CCT) to withstand disaster and/or epidemics-related shocks based on traditional knowledge and international best practices. The consultant has reviewed global best practices in CCT and will soon organize a consultation with stakeholders in Iran to develop standards operating procedure documents (SOP) tailored to CCT programs in response to shocks in the context of Iran.

"Mainstreaming, Acceleration and Policy Support" (MAPS)

As reported in the Consolidated Annual report of the first year of the implementation of this joint program, the MAPS activity is no longer taking place and after several discussions with the national counterparts and other UN agencies, it was agreed that the related budget (USD 9000) be allocated to the following activities of the joint program:

- Activity 3.1: South-South and Triangular Cooperation (SSTC) Framework(transferred budget: 2000\$)
- Activity 3.2: Resilience workstream in the UN Technical Assistance Package (TAP) developed in cooperation with the government (transferred budget: 7000\$).

DELAYS IN IMPLEMENTATION, CHALLENGES AND LESSONS LEARNED Challenges and delays in the implementation:

1. The change in Government as a result of the Presidential Elections of June 2021 led to new government counterparts for UN Iran and delayed the approval of several activities planned for 2021. Specifically, newly appointed General Directors put in place new approval procedures,, new coordination systems, and security checks, especially for all school-based and community-based activities that led to significant delays in the implementation. Several briefing and follow-up meetings with respective ministries and as government implementing partners are now required to discuss the details of the programs and methodology for the implementation. In addition, the new government counterparts have requested to review and re-discuss some activities and work plan previously approved.

- 2. COVID-19 pandemic significantly affected the project implementation, especially with regards to school-based activities, capacity building actions (e.g webinars, training), and needs assessments run by consultants.
- 3. The baseline survey and rapid review of the institutional capacity for the development of a National Strategy Plan are being implemented for the first-time in Iran; therefore, discussions with the national counterparts are complex, sensitive, and time-consuming.
- 4. The limited production capacity of the supplier of cancer medicines delayed the procurement and delivery to national counterparts.
- 5. Several suppliers were not willing to directly deliver some of the cancer medicines to Iran because of the US sanctions. WHO Iran logistics team eventually managed to arrange a shipment through their Dubai Hub, which despite prolonged arrival time and extra shipment costs, arrived in the country.

Lessons Learnt and best practices:

- 1. The collaboration with influential people in the youth entrepreneurship project helped UN Iran attract and engage youth in successful capacity-building activities.
- 2. In the framework of the *Strong Families program*, instructors were connected to the in-person training hall via Vienna and London. The modality allowed the instructors to train remotely while the participants had the opportunity to practice training skills in groups.
- 3. The involvement of all stakeholders from the very beginning of the project design is highly relevant to help the implementation and sustainability of the action.

FUND OPERATIONAL PERFORMANCE

Under the Joint Program, as in the first year of implementation, the Office of the Resident Coordinator in Iran has played the role of Convening Agency: the RCO continued to provide support and coordinated all programmatic activities implemented by the participating agencies. Two consultants (coordination and communication consultants) supported the RCO to:

- Coordinate and chair Joint Coordination Unit (JCU) meetings: in the reporting period, four virtual
 meetings with PUNOs program officers and communication focal points were organized to assess the
 implementation status, discuss bottlenecks, and identify possible mitigation measures to address
 challenges;
- Provide technical support and capacity building on DEVCO/INTPA's rules and regulations to PUNOs, especially on visibility and financial management;
- Monitor commitments and expenditures through an online tracking tool;
- Ensure official communication with the MPTFO colleagues and DEVCO/INTPA officials.
- Consolidate the Annual narrative report and deliver on any additional reporting requirements as per DG INTPA's request;
- through the Communication Task Force and in collaboration with UNIC, promote and facilitate visibility products and activities.

RCO is ready to coordinate the organization of the Steering Committee of this joint program once DG INTPA's delegation is in Iran.

Payment mechanism for RCO consultancy

In line with the activities laid out in the ProDoc for the Joint Program a coordination consultant was recruited by RCO under this Joint Program, as a Junior Partnerships officer, to support the Convening agency role and responsibility.

As part of the UN development system reforms, the recruitment and management of consultancies for RCO will no longer be done by UNDP. In the period 2021-2022, this role of UNDP was gradually transitioned to the UN Secretariat.

After consultation with HQ colleagues managing the MPTF, it was agreed that UNODC will support RCO with the consultant recruitment. UNODC is both a member of EU-UN Joint Programme and a UN Secretariat entity and was therefore selected as the most appropriate entity to receive the funds for the recruitment. For this reason, funds to cover the payment for the consultancy (USD 6050) were transferred to UNODC by the MPTF. The funding that was intended for this purpose that was earlier transferred to UNDP will be soon returned by UNDP to the MPTF. This process was considered a one-off transfer and system to address the situation created by the transition of the management of consultancy services away from UNDP.

Review of joint program indicators

After two years of implementation and working during difficult times (COVID-19 pandemic, change in government), the participating agencies have revised the indicators of the log frame of the Prodoc and identified SMART and more effective indicators to be used in the next implementation years. The new set does not significantly deviate from the indicators listed in the logframe, nor impact the implementation of the activities listed in the Prodoc. The revised indicators will rather contribute to more effective monitoring and appraisal of the results, and the overall impact of the joint program. The new set of indicators is shared as Annex 2 for the EU's consideration, comments and approval.

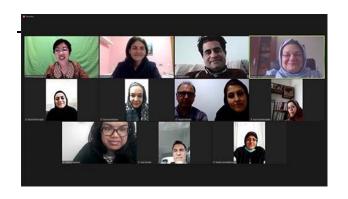

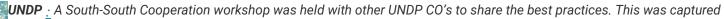
