advocacy actions engaging Mayors, Municipal Councils, Community Action Boards, and at the departmental level with governorates and departmental secretariats. 60% of considered their demands are being heard.
The project engaged the integral system. Truth commission: Advocacy on the final report of the Commission (CEV) and its legacy, with recommendations on the central chapter of the commission's report; the rural sector; the technical gender group of the commission and offered suggestions on the final content of the gender volume. The team participated in CSO roundtables, with meetings and dialogues with commissioners and the president of the CEV. JEP: Advocacy meetings were conducted with the JEP. Engagement with the office of Judge Belkis Izquierdo on macrocase No. 2 stands out, the project engaged on strategies for improvement of investigation methodologies for violence based on gender, for discoveries of truth for accredited victims. As part of the Cinco Claves alliance, the project used a range of advocacy strategies in support of Macro-case 11 with the JEP. UBPD: engagement on the prioritization of the National Search Plan, emphasizing discrimination in disappearances. The LGBT Expert group has supported leadership actions of 3 lesbian women and a trans woman in 4 regions of the country: Amazonia, Eastern Plains, Caribbean Coast and Valle del Cauca and Cauca. Colombia Diversa's 'High Gender Instance', reviewing implementation of the gender provisions of the FPA was presented, compiling challenges in the functioning of the JEP, CEV and UBPD affecting LGBT women, with proposals to address them (shorturl.at/rstuF).





Project activities has successfully completed. Provisional analysis shows the project exceeded support to survivors through strategic litigation activities before JEP, including through macro-cases, by 142%; public activities promoting a culture of non-repetition reached 127% of targets and engaged 206% of the targeted women in the territories; psychosocial support for women and LGBT people reached 203% of targeted survivors enhancing impact. Project closure is underway, including closing events, data collection and analysis of impact, and final report preparations. The announcement of the opening of macro-case 11 in Auto SRVR 103 of 2022 indicates the success of advocacy actions by the Cinco Claves Alliance, with partners the National Network of Women and Colombia Diversa. This is specifically cited in the rationale of the JEP to open a macro case investigating macro-criminality of gender-based violence in the armed conflict.

The devaluation of the Colombian peso between July and August, resulted in exchange rate gains during the final months of implementation. Based on analysis, these funds were invested to bolster project activities without altering the budget in dollars. This facilitated additional training of 25 diploma students from the 4 departments, held in Bogotá, additional publications, printed materials and events for the dissemination of reports. A greater allocation of funds has been executed with a gender focus than forecast, as a result of financial commitments made to enhance the effective participation of women in the Diploma. Financial closure with partner organizations has begun and the financial audit has been initiated

The Project contributed to institutional and community recognition of the existence and experience of LGBT people during the conflict especially in indigenous communities, with enhanced local and national feminist and human rights activism to support non-repetition. "We have failed to target the LGBT population. Therefore, we want to invite the LGBT population of the department so that we can improve... We hope to nurture them jointly to have this inclusion approach, not only in the identification of people but truly in participation, in the formulation of policies... and in projects', Arnold Yesis Paz, delegate from the Secretary of Agriculture and Rural Development in Cauca.

At the institutional level, civil society strengthening and engagement with the JEP, UBPD and CEV leveraged the institutions as pioneers (national and international) in taking an LGBT approach. The Truth Commission is the first in the world to commission a study with specialized recognition of the differential violence experienced by LGBT people during armed conflict; LGBT search experts in alliance with Colombia Diversa and the UBPD are offering the first specialized parameters for searching for LGBT people; and the JEP is the first to include the study and sanction of violence motivated by discrimination or prejudice against LGBT people as punishable violence in transitional justice process, through the grouping and concentration stage of macro-case 11.

The project strengthened the relationship between LGBT and feminist organizations in targeted departments, enhancing the documentation of gender-based violence and driving local advocacy for women and LGBT people. At the national level, this partnership advocated with the JEP to open macro-case 11 and develop a chapter on gender in the Final Report of the Truth Commission, specifically addressing the experience of women and LGBT people during the conflict. Recognition of violence due to prejudice against indigenous LGBT people, led to advocacy with local government, supporting indigenous LGBT to incorporate LGBT public policy in the department and engaged the Departmental Assembly of Cauca in a political control table on LGBT issues, in which 8 secretaries of the local government participated, along with deputies and organizations of women and LGBT people. 'These spaces are important because they allow us to make visible the advances made by the Departmental government or in the articulation with the community, but they also generate agreements and much more expeditious strategies can be built in the territory and will give us better results". Jorge Octavio Guzmán, Education Secretariat in Cauca.

At the community level, the project supported the reconstruction of social fabric in regions impacted by long-term impacts of conflict and violence. Through the project it was possible to develop a change in the way in which memory is understood for the construction of a stable and lasting peace. 'It [memory festival] was something necessary that has been urgent for a long time for a diverse community that has long worked on recognition, on the generation of their own spaces and where they feel safe... to contribute to the construction of peace and justice in the context of the conflict", Memory festival participant in Buenaventura. This established an innovative path in targeted territories, using the catalytic potential of arts in the construction of memory, exclusively from a gender perspective.

Significant progress was made with women and LGBT people leading initiatives to promote a culture of peace and non-repetition. The micro-fund had greater scope than anticipated empowering 21 organizations (90% women-led) to engage more than 2,100 people, through community-based initiatives (art, music, sports, theatre, research). Each project generated a product, disseminated in public-community spheres and traveling exhibitions outside their communities. "The project allowed us to support the development of collective awareness based on reflective dialogues regarding peacebuilding with women and youth, and the territory was impacted with communication products that expressed messages that encourage resilience, equity and respect. for diversity", woman from North Cauca. All 21 organizations noted the micro-fund contributed to their sustainability through training on fund management, visibility as organizations in the territories, and the provision of capital.

Memory festivals were led by women and LGBT people from the 4 departments. 97% of participants strongly recommend replicating this in other municipalities and 88% voiced support for the efforts of women and LGBT people after the memory festivals. It catalyzed inter-generational, inter-ethnic ties, to create memory construction spaces. "[Festivals reflect] historical memory that the elderly has, to strengthen the new generations with knowledge that shields and protects the territory and the community of [the past]", gay male participant in Chocó memory laboratory.

Political and social practices in each territory were leveraged to narrate and claim memory (pilgrimage in Popayán, a balsada in Buenaventura, play in Quibdó). Through the visibility of sensitive issues as violence against women and the LGBT population, through forms of cultural expression, peace is built, minds are changed' participant, memory festival in Chocó.

Collecting and systematizing on-line memory repositories linked to the process of emotional recovery allowed the victims to heal collectively, be empowered as political agents engaging communities and institutions, to reconstruct the notion of non-discrimination as a desirable social value in the Colombian transition. This also constructed a depository reflecting the experiences and resistance of survivors, that exists beyond the life cycle of the project to reinforce acknowledgement of gender-based violence.

This outcome was exclusively focused on GEWE, and integrated specific supports and accompaniments to foster women and LGBT people's active and meaningful participation. The project prioritized access to resources and capacity strengthening for women-led organizations, making visible the challenges and needs of women's and LGBT people's organizations, providing space to engage with the wider community and municipal policy makers highlighting, their survival through memory festival and travelling exhibitions. 90% microgrants recipients were women-led (16 CBOs) or LGBT-led (3 CBOs), with 66% citing medium – high levels of empowerment as a result of organisational strengthening supports and investment through the micro-grant to promote memory, reconciliation and non-repetition, and all recognizing the funds contribution to their sustainability. For example, fund management capabilities were enhanced, in accordance with international standards, through the process of accompaniment and accountability for the micro-donations, supporting not only the action but the strengthening of CBOs beyond the lifecycle of the project. Care networks were also strengthened through self-managed groups, within the framework of the project, women were encouraged to express and access their support needs, building stronger and more supportive networks together.

Virtual depositories such as Celeste worked to capture and promote the experience of LGBT people and women through the conflict, to humanize victims and draw commonalities with the wider citizenship to support non-repetition of violence and drive gender equality. This creates a long-term record of memory and truth for women and LGBT people to influence discussions, providing dignity and voice to survivors beyond the transitional justice process within society. The process of collecting stories for the web platform "A Journey of Peace" through artistic methodologies, gave strength to the activism of women survivors of violence. The documentation of their experience and stories resistance had further empowered them to work for gender equity and the guarantee of their rights.

In the reporting period, the majority of diploma students are already leading peace initiatives in their neighborhoods, communities, educational institutions and greater involvement of young people has been achieved in monitoring the gender proposals of the PDETs. It also responded to addressing the lack of training to support leadership for community leaders.

Capacity strengthening workshops, empowered participants with awareness of the institutional architecture created for the Peace Agreement, addressing gaps in knowledge - a key barrier to women and LGBT people's meaningful participation. Training was scaled-up through advocacy plans that identified strategic pathways to engage policy makers and support full implementation of the gender provisions of the Peace Agreement at the territorial level (PDETs and PATRs). Empirically, this included interviews and petitions with 9 peace entities, including: The National Protection Unit; Reintegration and Normalization Agency; Territorial Renewal Agency; the Ombudsman; the JEP; the Victims Unit; the Unit of Land Restitution; the Search Unit for Missing Persons, and the Department of Social Prosperity. Political transitions in the post-election period resulted in numerous unfavorable responses, highlighting implementation obstacles at the local level, compounded by a reduction in civic space observed since the 2018 elections. However, political training, empowered the participants to lead actions within their municipalities, evidencing women, youth and LGBT leadership and positive outcomes. "We realized that there was no sexual diversity table in the municipality, so we began to insist on the Mayor's Office to open it, until we managed to do so." Peasant lesbian woman, participant in capacity building workshops in Cauca. "The [diploma] gave us a push to feel more confident in our leadership, so much so that we managed to convene and sit down to talk with the municipal administration, which does not pay attention to anyone. We got them to sit down and listen to our requests and proposals. A formal request was made to advance public policy for women in the municipality and it was accepted. Now we have to follow up on that commitment, but we have already taken the first step." Peasant woman, participant in the workshops in Cauca.

In each of the 4 territories, forums were held with local authorities and women's organizations, making known the 5 priority axes for women in public policy. More than 80 people attended these, engaging key actors: Deputies, councilors, Ombudsman, Police, Secretary for Women, local Mayors, and Personerías. Similarly, the 8 Plans for prevention, protection, and non-repetition of attacks against women leaders and human rights defenders continue to be implemented, creating an enabling environment for women and LGBT leadership. Although the perception of security has not changed, leaders have highlighted that protection plans and tools make them less vulnerable. In addition, the very construction of the plans implied new knowledge for the participating women to bolster their advocacy with local actors related to the field of protection: "This process allowed us to have more tools compared to the update with the territorial CERREM (Committee for the Evaluation of Risk and Recommendation of Measures)", Cisgender woman leader, Putumayo.

Political advocacy at the national and international level was focused mostly on the national government, including space created by elections for Congress and the presidency. This empowered women and LGBT people to position their demands and visions of peace before the new national government, for the first time in a joint process between government. "One of the main achievements to highlight in the connection was active participation during this process. As a Caucana leader, engaging with various organizational processes in the territory, it is very important to be able to reach spaces like this, which had been unimagined for us", Woman leader in Cauca, participant in capacity building workshops and national advocacy.

Given the long-term commitment that the diploma, a series of internal discussions were held within the implementing consortium on how to address domestic / care responsibilities of women participating, without generating harm or reinforcing stigma of women's leadership. While very few people expressed the needed this support, an important campaign was carried out to destigmatize the visibility of care work.

The opening of macro-case 11 represents the only opportunity for victims of GBV and violence due to prejudice in the framework of the Colombian armed conflict to access the transitional justice system. Before 2023 there will be three crucial decisions for the victims represented before the JEP linked to the project: protection measures for victims from Tumaque with a focus on self-protection and risk prevention; the Order of Determination of Facts and Conduct of the macro-case 02 in which violence due to prejudice and persecution against LGBT people on the Pacific coast is recognized; and the opening of macro-case 11 with a specific investigation subline on LGBT victims of the armed conflict. The final report of the Truth Commission also includes a chapter in which the facts against women and LGBT people are specifically studied and made visible, aligned with the reports developed and disseminated under the project. Under the UBPD, cases of LGBT people considered missing who are being sought have increased. At the end of 2019, there was only one case searching for an LGBT person, by September 2022 there are 60 cases. Under the project there has been an increase in accredited cases (117% of target), with all litigated processes in macro case 01 and 07 progressing through the procedural phase of the JEP.

Demands for implementation of the gender provisions of the FPA were made visible through 4 communication campaigns, including the participation of Gustavo Petro in the "Feminist Debate" that reached more than a million people through national and international media, analyzing presidential candidates' commitments to women's rights. The "Gossiping about politics and gender" campaign reached 17,559 social media accounts and countered more than 50% of the hate messages identified from 140 local and national media sources. "Paddling Together for Peace" reached 130,000 accounts, profiling 12 peace stories and highlighted territorial advocacy of women's organizations in support of the FPA. The "Other Futures Are Possible" campaign linked with Memory festivals to make other forms of memory visible, reaching more than 25,000 accounts.

The "Paddling Together for Peace" campaign, particularly profiled the work of small organizations of black and indigenous women. In the execution of the project, it became evident that those who receive more violence and suffer more violence due to political participation are black and indigenous women, and to respond to this situation, their work in the communication campaign was prioritized. The communications work of Colombia Diversa on what happened to LGBT people in the armed conflict has been relevant to position the issue of equality for LGBT communities and the violations of their rights, as a collective responsibility of Colombian society linked to nonrepetition. Visual pieces and reels were published through networks specifically targeted urban youth, who were often unaware of the existence of LGBT people in rural areas or of the differential impact they suffered. This has aimed to expand the social and institutional appropriation of historical memory with a gender perspective, supporting implementation of the provisions that the FPA. Strategic litigation has placed a strong lens on harmful gender-motivated practices towards women and LGBT people, empowering victims to access justice. Similarly, advocacy work and reports presented to the SIVJRNR highlighted gender-based violence and violence due to prejudice as essential concepts to understand the dynamics of the conflict, stimulating an intersectional institutional response to understand the diversity and complexity of women's experiences, including those of LGBT women, in all dimensions of justice, reparation and memory building, and reflected in macro-case 11 and the final report of the truth commission.

Participation in activities offered through the project is a challenge due to the care work commitments. Mental health problems associated with confinement, were identified in the 4 venues of the course.

Another important challenge is the precarious conditions in which many participants live. In the case of Chocó, many women stated that attending project activities allowed them to access quality food at least once a week.

The diploma provided full scholarships to all participants, addressing barriers. Positive impact was identified was in terms of mental health. Meeting other people in territories with the same experiences and aspirations has been key, and because the project provided them with the basic conditions to actively participate this had a positive impact fostering meaningful participation.

A few months ago I was diagnosed with depression, coming to the diploma every Saturday has meant a respite from that sadness I feel. The challenge is always the financial sustainability of the actions, since the advocacy never ends. By not feeling alone, by working together on their risks, the impact on the perception of vulnerability has changed to the extent that they have obtained tools that allow them to identify the risks that they can mitigate and those that cannot.

Non-heteronormative and non- cisgender individuals experienced high levels of structural and direct violence throughout the conflict, and the post-conflict period. Violence and discrimination has been more concentrated for Indigenous and Afro-Colombian LGBT people as the intersectionality of identities compounds vulnerability, and make the prosecution of crimes against specific groups difficult to attribute. Patterns of exclusion and discrimination remain a prevalent barrier to LGBT people's participation.

The project has supported and enhanced the engagement of LGBT people at the micro, meso and macro level in Colombia. Supporting psycho-social support and creating safe spaces to capture memory and stories of resistance and survival. Through capacity strengthening the project facilitated LGBT leadership and engagement with policy makers through dialogue and community arts and engagement methodologies the project has bolstered the capacity of LGBT people to safely and constructively engage power-holders, while providing an enabling environment with power holders. At the national level strategic litigation and advocacy has directly address the justice-gap evidenced for LGBT people through the institutions of the transitional justice process.

The community arts methodologies included in two large activities, micro-donations and memory festivals, has had an impact at the community level. In general, cultural activities for leisure purposes can hardly be found in these territories, much less for the purpose of building memory and rebuilding the social fabric. The component has drawn attention of young people to lead creative community initiatives in support of peace and non-repetition of violence. We have received requests for support from different groups of young people to lead community initiatives based on art. As a strategy to provide voice, remember and share women and LGBT people's experiences of violence has had great impact at a personal and community level.

At the community level, cultural activities represent contextually innovative activities that mobilised diverse groups, especially young people, with art viewed an effective tool for memory that does not revictimize, but looks towards the construction of the shared future, supporting the transition from victim to political actor. This had supported survivors and target groups to address the process of pain and healing in alternative, structured and safe ways. The diminishing presence of artistic and cultural practices, due to the conflict, the use of art and community-based activities represented an act of recognition and recovery, providing voice to the knowledge that was being lost in new generations and to support the reconstruction of social fabric. "...participation in peace must leave the conventional spaces of the participation of the dialogue tables and has to go out into the streets" Participant of Memory Festival, Putumayo. In community terms, art made the participants reflect on what the community should do to ensure non-repetition of violence: "These scenarios of being able to listen to life stories make one recognize oneself within the framework of those violence that are not made so widely visible and that can generate thinking about mechanisms of non-repetition", participants of the Memory Festival, Cauca.

The social cohesion dividends were evidenced, bringing together entire communities through innovative methodologies (urban interventions, plays, murals), engaging people of all ages, creating constructive spaces to reflect together on the future they want. "It meant very significant and great progress and evolution, because there are entire families watching the event and the only thing that is breathing is freedom, the peace of social inclusion and that a future with reconciliation is possible", participant of Memory Festival, Chocó. "This shows a contribution from the cultural commitment to forms of violence in which vulnerable populations identify with feminist movements. As members of the LGBT+ population, I frequently find spaces where women are seeking recognition and visibility and in that search, we find ourselves benefited", Participant of Memory Festival, Putumayo. In individual terms, art contributed to the healing process of people, women who, used singing, dance, painting, and acquired communication skills that they had never practiced before such as public speaking and singing in front of an audience, gradually lost their fear and realized that they are capable of giving their opinion and telling their story. "Art is healing, it is history, it is our life, from art we can remove everything that hurts us in the soul and externalize it in a healthier way in which over time it ends up eliminating body and heart pain." participant of microgrant project, Valle del Cauca. "it was possible to empower oneself and recognize new talents, as a way of being able to make known everything that we often want to express, say but fear does not allow us to give. We know our stories, but it was through art, leadership, cameras, scripts, the creation of scenarios that reflected places in the region that it was possible to make known culture, history, colour, the LGBT+ population will continue to contribute to business growth, that after a great struggle comes a great reward." participant of microgrant project, Putumayo.

CD's work generating reports and producing information on access to justice for LGBT people, investigation of violence due to prejudice, has led them to be part of the gender and diversity commission of the truth commission and has a knock-on effect in the litigation of cases and the transitional justice process. Representation of cases before the JEP and the work carried out with the UBPD and the CEV have supported rights of LGBT people in the transitional system. Catalytic impact is evidenced through this, as LGBT people were not originally contemplated within case 007, however litigation and accompaniment of CD within the framework of this project has resulted in key outcomes. Important judicial decisions have been made through calls by the JEP for a trans woman to participate, highlighting the integration of LGBT people. CD was consulted by CEV staff on how to make gender recommendations with an intersectional perspective and strategies that would allow progress in destructing heteronormativity and cis normativity in Colombian society. This demonstrates direct catalytic impact shaping the approach of national institutional to the representation of LGBT communities and their rights to justice through the transitional justice process. At the beginning of transitional justice proceedings (December 2019), only Colombia Diversa and two other feminist organizations asked questions about gender roles and behaviors that would challenge acts motivated by discrimination by armed actors. This dynamic has changed significantly, and public officials continue this line of questioning. It is established within macro-case 02 that the FARC-EP stereotyped and pursued harmful gender-motivated practices towards women and LGBT people both within armed structures and in civil society. It has also been accepted that the sexual and reproductive life of guerrilla women was heavily policed by combatants, including practices such as forced sterilization, forced abortion, and the approval of their sexual partners. Finally, it has been possible to demonstrate that there was a strongly homophobic and transphobic prejudice that explain acts of violence that Colombia Diversa. This was crucial to shape the understanding of conflict-related sexual violence and to inform the institutional responses.
