Government agencies have played a significant role in supporting the implementing partners and CBOs. At the national and county levels, the project has had interactions at the highest level of those agencies that work on land and conflict issues; the Liberia Land Authority (LLA) and the Alternative Dispute Resolution unit at the Ministry of Justice.

The LLA is an autonomous agency of the government with operational independence, which has subsumed land functions that were performed by several agencies of the government, including the key land administration agencies.

The Ministry of Justice has developed the Alternative Dispute Resolution Unit as a pilot conflict resolution programme to address and settle a range of appropriate disputes and complaints that have to do with land ownership and inheritance. This has freed up scarce resources in the judicial system and reduced overcrowded court dockets.

The LLA and MoJ have supported through training for CBOs and Networks on land-related policies. They have also supported in developing the baseline tools and formed a part of the baseline team in 4 project counties.

The project has also had engagements with the Ministry of Internal Affairs (Superintendents Office). The County Superintendent launched the project at the county level.

Firstly, the project has made young people aware of land issues and to be on the lookout for any suspicion of a possible land conflict.

Communities, families and individuals are sensitized on land-related issues so as to avoid land conflicts. Simplified land policies have been explained and interpreted plainly in the local dialect. This has ensured every bit of the policies and processes involved in land sales, purchases, and ownership is well explained. Individuals have started taking action on solving cases locally using the Alternative Dispute Resolution mechanism and techniques.

Young women now have the confidence to discuss land ownership at town squares and are involved with mitigation initiatives. Communities now have confidence in the ADR process as it is faster and keeps the community at peace.

In areas where there were conflicts on concessions, communities now have a voice and are getting a fair share of benefits from the land.

Since inception, the 8 CBOs and 4 networks have been trained in Participatory Vulnerability Analysis, REFLECT Action and other participatory methodologies. These methodologies have helped build communities' awareness of existing land legislation and the tenure system, with an emphasis on women's rights to land, e.g. through inheritance, marriage, transfer, demarcation, and the process of distribution. 48 persons were trained (36 women and 12 men aged 16-35) from 8 CBOs and 4 women networks.

ToT was also delivered on women's rights, and the Human Rights Based Approach (HRBA), in order to encourage local women to take actions that guarantee equality. 48 young women were trained; 12 persons per county; comprised of 6 CBO members, 2 women's network members, 1 member of the National Rural Women Structure, 1 woman town chief, 1 traditional woman leader and 1 person from the Liberia National Police Women and Children Protection Division.

Four leadership and advocacy trainings were conducted with the 8 CBOs and 4 Networks to increase knowledge and skills in engaging community members on land governance and mitigating conflict. A total of 25 females between the ages 16-35 were trained per county.

6 CBOs received small grants of 1,333 USD, amounting to Eight Thousand United States Dollars (\$8,000.00USD). These small grants were to:

a) Support awareness raising and informal meetings on land rights and governance amongst women and young people

b) Conduct media engagements and awareness programmes on local radio stations and social media.

Town hall meetings with community leaders and local stakeholders on the alternative dispute resolution processes and the Liberia land rights laws were conducted; one per project county. These were attended by local Liberia Land Authority officials and representatives from the Alternative Dispute Resolution Unit from the Ministry of Justice. During these meetings, cases were documented for further investigation by the CBOs and local government. 75% of attendees were young women between 18-35.

Security Risk Management Training was conducted with 80 women from the CSOs and Networks to support them to identify and assess threats and mitigate against them.

During the period of community engagement and conflict mitigation, community meeting times and locations were made flexible for women. In these communities, women are the ones doing most of the farm work and taking on home responsibilities. Meetings were scheduled at convenient times for them to ensure their full attendance and participation.

In some instances, young people were given the responsibility for chairing meetings, taking meeting notes, and filling out ADR case tracking forms. In this way, young people are a part of the activities at every level.

The project ensures an equal number of women are represented on every committee and that they take on leadership roles.

Over the reporting period the 2018 Land Rights Act has been reproduced and distributed to the CBOs and networks by the implementing partners to enhance the knowledge of women on their rights to land ownership. The final approved and validated training manual was provided to the four implementing partners as a tool for training on land conflict issues at the community level. The national ADR policy was also reproduced and distributed to CBOs and networks as a guiding tool to mitigating cases in their communities.

The revised land rights law has been a major instrument through which young people are getting to understand the issues of customary land and key questions related to customary land rights. There are ongoing dialogue sessions with local community leaders and stakeholders on land tenure and ownership, economic and climate justice for young people. There have been 4 dialogue sessions held in 4 counties and the local leaders and stakeholders have committed to peaceful dialogue around land conflict in their communities.

Eight youth-led CBOs have utilised informal spaces such as town halls and motorbike parking lots in the market squares, as a way of disseminating messages on peaceful land conflict mitigation processes. Previously, young women did not gather in these informal spaces during evening hours, but the capacity building activities have given them confidence to engage their male peers in discussing these issues. Sessions have been conducted during evening gatherings in local tea shops, video clubs, and during Village Savings and Loans Association (VSLA) sessions and saving club meetings.

IEC materials (billboards, banners, stickers and flyers with peaceful land conflict resolution messages) have been developed and distributed across the 4 counties. These materials were developed from issues arising from activities and engagements in the communities as a means of showcasing project visibility in a wat that appeals to the audience that leaves a lasting impact.

The process of empowering women to take leadership roles in their communities has been intentional in the communities where the project is being implemented. A higher percentage of young women are seen engaging communities in informal spaces and an emphasis is being placed on women's groups and collectives. With the leadership and advocacy skills young women are acquiring, they can now engage with local leaders on issues that affect their wellbeing, and they feel compelled to voice their concerns in meetings and on local radio programmes.

Communities have also been encouraged to ensure that women lead on the publication and distribution of materials as a means of fanning the flames of women's empowerment in the project counties.

The project has engaged the Federation of Liberian Youth and the Liberia National Student Union in four counties and provided cash support to further enhance their advocacy campaigns at the national and county levels. These groups have developed jingles and conducted awareness sessions on land governance in communities and on radio programmes. These supports have widened their coverage and enhanced government efforts in mitigating land cases around ownership. This support was provided by the project implementing partners in the 4 counties.

The CBOs and Networks have been linked to the Alternative Dispute Resolution Unit at the government Ministry of Justice to mentor and provide technical support on mitigating land cases at the community level without reaching court. This has been a major initiative that is complimenting government's efforts in trying to mitigate numerous cases. The collaboration among the project implementing partners and stakeholders from local levels, and the increase in capacity and resources, has facilitated women's involvement in these issues.

Young people have been involved with dispute resolution of land cases at community levels, paving the way for increased participation of young women in conflict resolution through the Alternative Dispute Resolution process rather than the customary law.

The National Civil Society Organization and the National Rural Women Structures in the counties have been benefitting from mentorship and training on the ADR processes with support from the ADR unit.

It is important that gender equality and the empowerment of women remains the objective of the programs we work around at Action Aid. It is also the reason that gender equality is on the public policy agenda of almost every AA country of the world today. Therefore, the focus on gender equality in young women empowerment is important. First, female youth's empowerment is essential in the fight against poverty. This is not only because of the direct and interrelated contribution that empowerment makes to household welfare, but also because of the personal power it provides the female youth in shaping and making decisions and in redirecting decision making on essential needs, especially in favour of the female that own land. From a rights-based perspective, gender equality in young women empowerment is enhanced simply from the standpoint that, as recognized internationally, everyone deserves the same opportunities. Indeed, gender equality in youth empowerment is about economic empowerment and equity.

With careful considerations of power relations and dynamics, the project has ensured inclusion of young women at all levels and has provided appropriate trainings/capacity building. In this regard the project is building a strong, intergenerational network of women leaders, supporting and galvanizing women's individual and collective power to champion social change and safeguard their human rights.

What were the challenges/problem they faced prior to the project implementation?

Administratively, there has been insufficient implementation of regulations by land sector institutions. Regulations which are meant to monitor and regulate the actions of land users are left idle. Users, therefore, take advantage of this and transact deals according to their own whims and caprices which sometimes trample upon the interests of other users, causing land conflicts.

The lack of communication, cooperation and coordination among land sector institutions is yet another challenge the communities had before the project. These institutions are supposed to work hand in hand for the common good. However, other institutions work without the knowledge of colleague institutions which results in technical errors. These errors tend to render transactions inaccurate and misleading, which causes land disputes. On a legal basis, we can talk of legislative loopholes and the legal pluralisms regulating land markets. There is a myriad of laws in place to control land transactions, but these are, however, sometimes contradictory. Due to this, different judgements are passed depending on which law was used and how it is understood by the interpreter. In addition to the above, the poor or disadvantaged in society usually have limited or no access to law enforcement. On the other hand, some of these formal laws are not disseminated appropriately to reach all groups of people. What has been the impact of the project on their lives

Firstly, the project has made young people or individuals aware of land issues and to be on the lookout for any suspicion of a possible land conflict.

Communities, families, and individuals are sensitized on land-related issues to avoid land conflicts. Simplified land policies have been explained and interpreted plainly in the local dialect. This has ensured every bit of the policies and processes involved in land sales, purchases, and ownership is well explained. Individuals have started taking action on solving cases locally using the Alternative Dispute Resolution mechanism and techniques.

Young women now have the confidence to discuss land ownership at town squares and are involved with mitigation initiatives. Communities now have confidence in the ADR process as it is faster and keeps the community at peace. In areas where there were conflicts on concessions, communities now have a voice and are getting a fair share of benefits from the land.

Oree Bah is a commissioner in a district where there has been series of land conflicts before the start of the project. He has said that "before the start of this project we had difficult time explaining the land right laws to our people who came to get a redress to their land issues. But thankfully this project came, and now young people are interpreting the laws in the local language in communities and creating a platform for people to have their land issues settled. Even the young children have gotten involved with dispute resolution that takes a burden from local leaders now that the youths are taking the lead."

What were the challenges/problem they faced prior to the project implementation?

Young women are often not aware of their rights to land and property which prevents them from claiming ownership.

What has been the impact of the project on their lives

The project has had a significant impact on the lives of women who did not understand their rights on land ownership. In Gbarma, one of the project communities, the CBO Kukatornom intervened in a family land dispute with Monice Mendu Okai and her brothers. Over the years, Monica has been in conflict with her brothers over farmland owned by their late father, and she did not know that she had rights over the property as a woman. During an awareness activity in a community in Gbarpolu County, Monica realised that she has rights to land ownership and that there is an alternative means of resolving this dispute rather than going to court – since in fact she never had the money to do so. She engaged CBOs on the way forwards, and the CBOs called a dialogue with the parties (Monica, her brothers, the town chief, women leaders etc.) and representatives from the Liberia Land Authority, and they peacefully harmonised the conflict. The parties were satisfied with the negotiation and agreed for a survey to present to Monica her just portion of the land.

Monica said after the decision, "I am happy today that I got justice over this land business without my brothers having any grudge in mind for me, and I will encourage my friends who have this kind of land problem to speak with the Kukatornom group."
