

Significant portion of youth supported by the project recovered from previous emotional distress and developed new positive coping strategies at individual, family and community levels. Previously alienated youth experienced reconciliation with and reintegrated back into their families. The emotional recovery has also been evidenced by youth taking up voluntary roles in public good initiatives involving helping in shelter rehabilitation for the vulnerable community members, including neglected elderly persons and persons living with disability.

Empowered young women discovered their voices and spaces to influence decision making in the society against the backdrop of prevailing social norms where young women are socialized to be not participate in public matters. Empowered young women continued to deploy their sharpened leadership skills to assert themselves in advocacy for peacebuilding and gender equality. Further, close to four hundred (400) graduates of gender transformative approach deployed as youth influencers with their peers for a lasting positive impact in the community.

Graduates from vocational and entrepreneurial skills continued to steadily grow their small businesses including hair therapy and beautification, welding and metal fabrication, soap making, tailoring, handcraft, catering, and hospitality. The youth (report improved self-esteem, experiencing a sense of acceptance, and a new confidence to make significant contributions to their families, and community. In addition, the youth in socio-economic activities have become a positive motivation for other youth in the community and has thus contributed in demotivating youth from crime and delinquency.

Further, youth empowered by the project continued to demonstrate enhanced capabilities to meaningfully and effectively participate in decision-making processes at all levels of the society. In consultative forums with community leaders, the youth-both male and female- ably articulated their concerns, robustly engaged, challenged, and debated ideas with the other interlocutors to find mutually agreeable solutions. As a result, the local authorities have continued to embrace youth participation in decision making processes. The Ministry responsible for Peacebuilding constituted a Youth Peace Ambassadors Forum as a platform for the youth to engage stakeholders involved in peacebuilding arena. Further, the Ministry responsible for Youth Affairs initiated a Joint Working Group on Youth Empowerment as a platform to harness synergies and resources from stakeholders toward taking forward and replicating gains made under current PBF -supported project.

Project interventions also challenged prevailing prejudice and negative perceptions towards the youth entrapped in gang groups. Consequently, community leaders including Chiefs and Security focal points have since shown greater openness and willingness to engage youth through constructive problem-solving as opposed previous adversarial approaches used in the past. On their part, the youth have made strong pledge to abide by the rule of law and to address deviancy within their ranks. The testimonials from local authorities, including the police and Chiefs, indicate that Wau Town has experience significant reduction in criminal activity in last one year.

Significant portion of youth recovered from previous emotional distress and developed new positive coping strategies at individual, family and community levels. Youth developed capacities to express their perceptions and to handle conflict and their situations in a positive approach. Previously alienated youth experienced reconciliation with and reintegrated back into their families and are contributing in day to day tasks and chores. As an example, youth in Lokoloko area initiated a welfare targeting the most vulnerable members of their communities where youth offer their labour freely to rehabilitate houses and to gather shelter materials for the elderly and people with disabilities in the area.

Significant results were also registered through efforts on transforming negative gender norms and practices. Through Gender Transformative Approach involving capacity development on dialogues, communication, relationships, masculinity, and the use of violence, 380 (190 male, 190 female) youth at-risk were empowered as a core group of "youth influencers" to work with their peers towards a lasting positive impact. Participating youth affirmed that they have experienced attitudinal transformation from agents of violence to become agents of peace and non-violence at interpersonal and community levels. Consequent transformed attitude was evidenced by formation of "youth friendly group for development" in Wau which has united competing youth gang groups that used to be in conflict with each other, into one peace-oriented heterogeneous group and hence contributed to significant reduction of violence. Chief of Hai-Inkas remarked "there is a drastic fall in violence and crimes that were initially perpetrated by the youth. The youth now invite local authorities to peacefully discuss community related issues without resorting to violence."

Further, against the backdrop of social norms where young women are socialized to be shy and to not participate in public matters, the project empowered 40 young women who with leadership and confidence building skills and they are now able to articulate issues in public forums. Monica Anthony from Hai-Kosti states "I can now stand in front my community and speak about issues affecting young women in my community. I am now a leader."

The gender transformative dialogues incorporated the needs and experiences of young men and young women by including issues from a participatory action research with groups of young men and young women in the curriculum that was adapted for training and used in gender dialogues. As previously mentioned, the project trained 40 young women in leadership and confidence-building to enable them to effectively participate in peacebuilding and decision-making processes at the community level.

During the reporting period, two gender transformative trainings reached 30 young men and 30 young women, of which 32 (16 male and 16 female) Peer Facilitators were selected and facilitated sessions for 320 youth (160 male and160 female) in Wau. The sessions were facilitated in gender-separated groups (young men and young women) to ensure that the specific issues of young men and young women could be addressed in safe spaces. In other words, all activities took into consideration proportional numbers of young men and young women where applicable except for the young women's leadership trainings that were particularly designed to address the needs of young women, as informed by the participatory action research.

A significant proportion of the youth at-risk empowered with vocational and entrepreneurial skills have now become productive in positive socio-economic activities and small businesses and some secured employment opportunities in the relevant sectors in the local economy. The provision of start-up kits enabled the youth launch own small group businesses including hair therapy and beautification, welding and metal fabrication, soap making, tailoring, Information handcraft, catering, retail shops. At least 75% of the 413-youth empowered through vocational and entrepreneurial skills continue to sustain and steadily grow their small businesses in various parts of Wau town.

Twenty-five (25) female youth engaged in hair dressing and beauty therapy report a regular monthly income worth SSP 150,000 – 200,000. Youth operating retail tailoring and clothing shops report SSP 50,000 SSP per/month. Those producing and selling soap, shampoo and Vaseline report earning about SSP 40,000 per week. . Nearly all beneficiaries report stable, profitable and promising business growth in future.

Generally, the youth report improved self-esteem and experiencing a sense of acceptance, and confidence in their capabilities to make significant contributions to their families, and community. In addition, the integration of youth at-risk in socio-economic activities and small businesses has become a positive motivation for other youth in the community and increased the demand for skills training and development. Several relevant state ministries are proposing scaling up similar interventions targeting youth in other Counties and Payams outside Wau town. They believe TVET skills are essential and highly needed by young people especially young women for self-employment and increased employability prospect.

Furthermore, other component of the project such as the functional literacy skills combined with soft skills, career counselling and mentoring services provided to beneficiaries enhance interest as a means of orienting TVET learners on job search and preparedness. This has widened the scope for job search opportunity with increased efficiency and quality assurance in their job performance.

By and large, testimonials from security agencies indicate that the security situation and incidences of violence perpetrated by the youth in Wau has greatly reduced.

The focus of the project is exclusively on youth in all its activities. Project partners and stakeholders were briefed from the initial stage on the need to balance considerations for both young male and young female beneficiaries during the identification and selection processes. This consideration has been consistently observed and upheld throughout the project intervention; hence the project included a balanced number of young male and young females in all its activities. This split has been achieved by, among other things, including youth benefitting from TVET activities in the gender transformative sessions.

Empowered youth continued to demonstrate enhanced capabilities to meaningfully and effectively participate in decision-making processes at all levels of society. In consultative leadership forums and inter-generational platforms organized by the project, the majority of the participating youth-both male and female- ably articulated their concerns and robustly engaged, challenged, and debated ideas with the other interlocutors to find mutually agreeable solutions.

The above experience –of youth giving bold and articulate presentation- obligated local authorities to embrace youth participation in decision making processes at different spaces in the society. The Ministry of Peacebuilding proposed to constitute a Youth Peace Ambassadors Forum as an enduring engagement platform for the youth, the Ministry and other stakeholders involved in peacebuilding, social cohesion, and community security arena. Further, the Ministry of Youth Affairs initiated a process to form a Joint Working Group on Youth Empowerment as a platform to harness synergies and resources from various stakeholders geared toward taking forward and replicating gains made under current PBF –supported project.

Project interventions also challenged prevailing prejudice and negative perceptions towards the youth entrapped in gang groups. Combination of interventions involving inter-generational dialogues, peace promotion through sports and arts, and youth contribution in rehabilitation of community assets, including local feeder roads, playgrounds and other public facilities, contributed to improved community perceptions of and reduced stigmatization towards the youth. Consequently, community leaders including chiefs and security focal points have since shown greater openness, acceptance, and willingness to engage youth through constructive problem-solving as opposed previous adversarial approaches used in the past. On their part, the youth have made strong pledge and shown considerable level of commitment to abide by the rule of law and to address deviancy within their ranks. The youth commitment aligns with testimonials from local authorities, including the police and Chiefs, which indicate that Wau town has experienced significant reduction in criminal activity in the last year.

To promote and ensure gender equality and women's involvement, the project sensitized the youth to ensure balanced involvement of both boys and girls in all activities throughout the selection, preparation, and implementation phases. As a result, the youth selected different activities, including sports and cultural events, specifically focused on women and girls. For example, the project ensured that four girls-only football teams were formed to participate in the peace and social cohesion tournament. One of the traditional leaders in the Block (E) (Eastern Bank) after watching female playing football "like men" admitted that he never thought before that women can play football because he believed that it is only meant for boys not girls. However, after that moment, he urged his community members to allow their daughters to play football, arguing that this opportunity will reduce the likelihood that they are exploited by "irresponsible boys and men." In addition, the Director General of the Ministry of Culture, Youth and Sports, acknowledged the role of women in the promotion of peaceful coexistence, especially through sport and arts activities.

The sports activities also brought hundreds of young people and elders to interact together and talk about the peaceful coexistence and role of young people in the community. CEPO and IOM used the football tournament as an avenue to promote social cohesion. For example, the transformed gang youths shared their personal history of the journey of transformation, and how they were welcomed back home by their family members and community, no longer viewed criminal or a nuisance to the community. In fact, their life journey and history were appreciated by the community leaders who attended the football games and other youth groups.

The project identified and engaged 97 Juveniles in Reformatory Centre and 150 recently released delinquents at community level around Wau Municipality .About 840 Functional Literacy (FL) and Psychosocial Support (PSS) sessions were conducted targeting different youth in line with their established needs. Functional Literacy empowered targeted juveniles with basic numeracy, writing, and English language skills and also aimed encouraging behaviour and attitude transformation toward future educational pursuits. Additionally, the juveniles received emotional support and transformation through psychosocial support including basic counselling, psychological first aid, and referrals to specialized services where needed. The FL & PSS interventions complemented some vocational skills training already offered by the Reformatory Center. As a result of FL & PSS interventions, some released delinquents chose to re-join school and continue with their education while others have enrolled in vocational skills training. Further, significant number of juveniles previously disconnected from families have reconnected and reintegrated back into their homes.

All the above was achieved through close collaboration with State Prison Service, State Ministry of Education and Block (Sector) Leaders in Wau. The National Ministry of Education provided support for standards and design of the Curriculum developed for use in FL& PSS sessions. The Prison Service and Chiefs supported retracing of released juveniles in the community. Further, the Community -Based structure for monitoring FL/PSS activities at juvenile recreational centres was established and capacitated to support released juveniles, to reintegrate more effectively into the community and to ensure the continuity of the program by at end of the project as community resource persons.

Further, the project supported linkage of 150 released delinquents in socio-economic interventions including rehabilitation of community assets. The intervention helped improve community perceptions of the juveniles and strengthened their social cohesion bonds with families who now perceive the juveniles as productive members of the society.

The enrolment of juveniles and delinquents in detention centres was primarily geared toward those who were in juvenile detention centres and released delinquents who are were involved in risky activities. As part of the project, these juveniles were engaged and connected to their parents after being provided with adequate emotional and reformatory support. Gender inclusivity was strongly observed during the mobilization and registration processes. As part of FL, PSS and socio-economic interventions, gender consideration was carefully considered to enable both boys and girls gained access to FL, PSS, livelihood, and income-generating activities through this project.

What were the challenges/problem they faced prior to the project implementation? Young women and young boys were facing difficult challenges: unemployment; trauma of civil war; shattered dreams from lost schooling opportunities; broken families; lack of basic skills and support to engage in gainful economic enterprises; unending conflicts with guardians at home and security actors in the public space. In the above context, youth resorted to forming gang groupings as a way of seeking a sense of belonging; self-affirmation; and purpose. Youth gangs engaged in parties; rivalry with each other; and general criminality in the community

What has been the impact of the project on their lives

Youth recovered from emotional trauma and strengthened their emotional self-regulation skills. Other youth integrated in the local economy and others underwent a

gender transformation, which is challenging negative gender norms and re-socializing other youth on a gender approach. Further, youth developed capabilities to voice their issues and advocate for space in decision-making processes. The majority of youth also shunned criminality and as a result their relationship with local authorities and community drastically improved

Quote 1: Madelena Arkangelo, one of the female youth participants said: "I have seen some good changes in my life. I could not interact with people from different communities, now I have realized the importance of socializing with other people to promote peace in our community. In addition, I used to be afraid to speak in front of many people because I had low self-esteem and believed that decision-making, and leadership is a role for men and boys only. I don't believe that anymore because I have gained skills and confidence to participate in decision making processes and I know my rights, thanks to IOM."

The first visit with project implementing partners spot check and interactingwith TVET beneficiaries in Wau and understand how they were using their skills and witness how their business was faring. During this mission, project visited 15 female graduates and interviewed five trainees .The visit revealed that most of the TVET graduates have started group entrepreneurship but some need more training on entrepreneurship skills.
UNESCO Head of Office and Country Representative undertook the second monitoring mission and it enabled HoO to interact with the project stakeholders at the State level and beneficiaries. The HoO conducted e spot checks for some TVET groups and observe their activities.
Third visit involved PBF Country focal person who interacted with and visited project sites to asses progress and impact

A baseline survey was conducted at the start of the project. Under Outcome 1, the indicator uses the World Health Organization (WHO) well-being index to measures the percentage (%) improvement in well-being of people who participate in supportive activities and report on reduced emotional distress levels. The baseline stood at 64 per cent and the projects targets realize a 10 percentage point improvement by the end of the project. An additional indicator which sought to measure, the percentage of youth who believe that the use of violence is never justified to resolve conflict stood at 88 per cent at the baseline. The project seeks to realize positive attitudinal change at 10 per cent at the end of the project.
Under Outcome 2, the baseline established a 57 per cent rate of youth who report increased self-esteem and enhanced self-reliance outside of criminal activities. The project targets to realize a 20 per cent increase at the end of the project.
Under Outcome 3, the baseline established that 35 per cent of youth believe they have improved relationships and increased influence within their communities and the project aims at a 10% increase by end of the project. Further, the baseline found that a rate of 78 per cent of community members who believe that youth positively contribute to their communities and project targets to change this by a 10% point by end of the project.

The youth gangs targeted by the project are part of the actors perceived as instigators of violence and a threat to peace and harmony in their communities and to larger society. Testimonials from community leaders indicate a transformation of behaviour among the youth and a significant reduction in crime and enhanced social cohesion in all areas of Wau municipality have been observed. The larger pool of transformed youth continues to act as agents of change and motivators to youth still trapped in gangs and it is anticipated that more youth will be motivated to leave gang lifestyles by opting for positive coping mechanisms as a result of peer influence exerted by reformed youth.

Lessons learned and experience from this project are being used as a platform from which to engage armed actors more broadly, seeking to enhance the inclusion of marginalized groups such as youth. The experience has translated into project proposals that catalyse this experience into more marginalized areas, such as Greater Tonj, for peacebuilding and reconciliation

Project partner used the local ownership strategy and brought on-board six (6) government entities at State level to be part of project implementation, entities responsible for youth, peacebuilding, education, security, gender, and local governance, as a premise to ensure long sustainability. As a result, the Ministry responsible for Peacebuilding proposed to constitute a Youth Peace Ambassadors Forum as an enduring engagement platform for the youth and other stakeholders involved in peacebuilding, social cohesion, and community security arena. The Youth Peace Ambassadors will also act as mentors and positive influencers to their peers and this will ensure provide continuity and sustainability of the project gains. Further, the Ministry responsible for Youth Affairs initiated a process to form a Joint Working Group on Youth Empowerment as a platform to harness synergies and resources from various stakeholders geared toward taking forward and replicating gains made under current PBF -supported project. Additionally, youth empowered through vocational and entrepreneurial skills continue to sustain and steadily grow their small businesses and in their places of employment in relevant sectors in various parts of Wau town and elsewhere in the country. Also, youth have developed enhanced capabilities to meaningfully and effectively participate in decision-making processes at all levels of the society and the community leaders, including Chiefs and Security focal points ,have since shown greater openness, acceptance and willingness to engage youth through constructive problem-solving as opposed previous adversarial approaches used in the past. It is anticipated that this new approach of engagement will continue and that it will enable the stakeholders sustain gains made in respect to overall reduction of violence in Wau. Further, significant number of youth gangs have indicated willingness to transform themselves into Self-Help Groups (formal group registered by government) with altruistic objectives of doing communi
draining the pool of youth entrapped in gang violence in Wau.
