The project carried out three policy level dialogues with the Ministry of Justice and Constitutional Affairs that resulted in the Minister formally presenting the Constitution Making Process Bill, 2021 to the Transitional National Legislative Assembly (TNLA) on 11 April 2022. The TNLA debated and discussed the Bill and repassed it for the second time in October 2022 after it was recalled when the peace parties resolved the rift amongst them. The passing of the bill into law will enable the establishment of the Reconstituted National Constitution Review Commission (R-NCRC), the Constitutional Drafting Committee (CDC) and the National Constitutional Conference (NCC). The bill now is awaiting presidential assent.

#### Progress summary

In preparation for the debate in the TNLA, the project supported a consortium of 40 CSOs to present their views and recommendations for strengthening the Bill before it was tabled in the TNLA. Through the project, the UN reviewed the Bill from a gender perspective, including participation of 60 people (37 females and 23 males) representing 30 CSOs who validated the outcome which formed the basis for advocating for a gender responsive CMP law. The involvement of the CSOs in reviewing the CMP bill ensured a collective and coherent voice that influenced the debate so as to have the final content of the constitution that is rights based and gender responsive.

As part of the advocacy for speedy enactment of the Constitutional Making Process Bill, the project provided financial and technical support to the R-TGoNU through the Ministry of Peace Building to celebrate International Peace Day on 21 September 2022 under the theme "Ending Ethnic Discrimination: Building Peace in Diversity." The International Peace Day celebration provided a platform for the R-TGoNU to convey key messages on the need for political commitment to the constitution making process and call upon the TNLA to expeditiously enact the CMP Bill into law to enable commencement of the development of the permanent constitution.

A number of planned activities were constrained as they were predicated on the enactment of the constitution making process law and the reconstitution and establishment of the related mechanisms. The constrained activities include a) the training of members and staff of R-NCRC and NCC and other critical institutions involved in the CMP like the Gender Committee and the Women's Parliamentary Caucus on gender-responsive, rights based and conflict sensitive CMP; b) the deployment of Senior Gender Advisers to support the work of the constitution making institutions including the R-NCRC and National Constitutional Conference (NCC) and; c) the learning exchange opportunities for women leaders engaged in the CMP with countries that have recently undergone gender-sensitive CMP within the region.

In light of the recent bill's final reading , the project has finalized the call for proposal to provide a grant to local partners to implement the activity relating to the training of the Gender Committee and Women Parliamentary Caucus training of the TNLA.

The project contributed to ensuring that the participation of women is included in the Constitution Making Process Bill through the provision of affirmative action clauses calling for at least 35 per cent representation of women in the constitution making bodies. The inclusion of these clauses will serve as an essential vehicle to address substantive gender equality issues throughout the process and in the text.

The project conducted a two day workshop on the Constitution Making Process from a gender perspective for the Transitional National Legislative Assembly (TNLA) members. Sixty TNLA members (40F, 20M) attended and participated in the workshop. About 50% of the participants were young parliamentarians, aged 33 – 50. The preand post-workshop evaluation were conducted, which indicated that 80% of the participants were not well-versed with the gender perspectives of the Constitution Making Process before the training was conducted and at the end of the workshop, 70% of the female and 60% of male participants respectively indicated that they had gained knowledge of the Constitution Making Process from a gender perspective as a whole. The project continued to engage with the communities on the process of the Permanent Constitution Making for the people of South Sudan from an inclusive and gender perspective; to ensure they have a clear understanding of the process and advance a call to action with a clear indication of what is expected from them to participate meaningfully. The project provided grants to three media organizations and four CSOs that used tailored messages to sensitize the community through outreaches, community radios programmes and talk shows, meetings, and dialogues to prepare the community, and mainly the vulnerable groups in Central, Eastern and Western Equatoria States, Unity State, Northern and Western Barl El Ghazal, Warrap, Unity, Upper Nile, Jonglei and Lakes States as well as Greater Pibor, Abyei and Ruweng Administrative Areas, to engage in the process willingly and actively throughout all the stages of CMP. During the reporting period, across the country, the project reached out to over 1,238,550 (43 % F) people with messages to sensitize the citizens through radio and other outreach approaches on their role in determining their permanent constitution. Over 10 radio stations were used to convey the key messages. The project conducted 2 community engagements targeting 109 (86M/23F) stakeholders that included the youth, faith-based leaders, security officers, traditional leaders, government representatives and CSOs on equipping them with the skills on advocacy, promoting access to information and how to engage the media in the context of the CMP.

In strengthening the capacity of the media organizations in the CMP process, the project supported the training and mentorship of over 50 journalists (26 females and 24 males) from different media houses in Juba – Central Equatorial State and Aweil - Northern Bar-El-Ghazal State (NBS,) on conflict sensitive, gender reporting ethics, accurate reporting, safety and protection, and gender-sensitive reporting on the CMP. Furthermore, the project has finalized the call for proposal documents to provide grants and engage local partner(s) to support formation and strengthening CSOs women led coalitions and agency to advocate and lobby for women's participation with a collective voice; and develop and support specific civic education materials and awareness campaigns for women and on women's issues.

The project partnered with the Union of Journalists of South Sudan (UJOSS) to train 270 journalists (192 males and 78 females) from twenty-five media houses across the country. As a result of these engagements, the journalists have gone ahead to cover stories about the constitution making process at the media houses. Furthermore, a total of 137 (102F/35M) duty bearers, including youth, were reached, and trained on the role of the media in the constitution making process.

During the reporting period, across the country, the project reached out to over 1,238,550, of which w 532,576 were female and 495,420 were youth. They were reached with messages on their role in determining their permanent constitution. Particularly, women and youth wanted the permanent constitution to stipulate their participation in various governance and livelihood systems in the country. The training and mentorship of journalists across the Country on the CMP ensured gender equality and youth inclusion. For example, in Juba and Aweil, 50 journalists and editors (26 F, 24 M) participated. More than 70% of the participants were young journalists, aged 25 – 35 The pre and post workshop evaluations and disclosed that at the end of the workshop, over 80% of the participants gained knowledge of the Constitution Making Process and were empowered to deliver well-informed and gender-sensitive information on the CMP.

In addition, 6 Women listener clubs were targeted during the project through which 60% of the females were reached and equipped with relevant skills in leadership, presentation and using the radio to air their views and be heard. This was a significant step in increasing women's participation and engagement in and through the media. These groups have been provided tools to facilitate their work and engagement with the media in their respective locations.

The project developed tailored messages that resonated with women, youth and displaced populations through jingles, drama and, skits that there should be no barriers or reasons for them not to participate in the CMP. The tailored messages helped to make them aware of their civic responsibility to contribute the process making their voices heard and needs included in the permanent constitution.
