

The project was scheduled to end on 16th August 2022 but received a 6 months no-cost extension on 5th August 2022. The signed NCE alters all government-related activities towards civil society stakeholders as per the latest guidance on engaging with the Sudanese government. Upon receipt of this extension, sub-award agreements of local implementing partners in target states were extended to complete pending activities. Local partners' contracts initially expired on 10th April 2022 but were renewed on 10th August. During this gap, only Search activities were implemented.

Until the end of this reporting period, partner implementation of activities is on track and activities are expected to end by December 2022. The remaining two months of the extension are for close-out and the final evaluation.

Despite Sudan's fragile political context after the coup in October 2021, the project continued to empower an intergenerational and diverse group of women leaders from the peripheral, conflict-affected states of Sudan to meaningfully engage in peace, security, and advocacy at various levels: both as advocates for community concerns at the local level as well as candidates for prospective transitional bodies. While increasing established and emerging women leaders' capacity and confidence to engage, the project continued to engage young men to act as leaders and champions for women's inclusion and active participation in the complex political landscape. As the project enters its final implementation stage, it has retrospectively made significant and sustainable gains for women's improved political participation in Sudan through the induction of different beneficiaries into formalized decision making platforms and increased public participation. The widest reach is seen through the Women Leader Networks formed under the project whose members have independently conducted various cascade grassroot awareness-raising sessions in West and South Kordofan on topics related to women's rights, GBV and UNSCR 1325. At its final stage of implementation, women and youth engaged at the earlier stages of the project are beginning to manifest the result of different hard and soft interventions under the project. This is seen through the independent conduction of coffee ceremonies to raise awareness by members of the Women Leaders' Network, the inclusion of 5 members under a women's network into the Reconciliation Mechanism in South Kordofan and the participation of the West Kordofan Women's network in celebrating the International Women's Day by conducting technical training on farming and pest control. This is evidence that the women reached through the project are applying the skills they have gained, are willing to and capable of bringing these gains to others in their home communities. While the political climate in Sudan remains highly tense and fragile, the project has successfully empowered a pool of women and young leaders who continue to participate within their local communities through independent cascade awareness raising sessions. This continued activity demonstrates the leadership capacities of women and youth to participate in the civic space and has earned their recognition from local structures. Evidence of this is the inclusion of 3 members who participated in the Community Peace Forums that attended the state-wide dialogue in Kadugli. South Kordofan in March 2022.

Leadership capacities of women and youth have also been actively highlighted through Search's various ongoing multimedia campaigns which showcase their leadership in socio-political and economic affairs. Through a partnership with a local influencer, a comedic and informative social media video on Facebook debunked famous Sudanese gender-biased sayings. One post alone received 75,000 likes on Facebook, effectively utilizing online tools to start conversations which challenge negative community perceptions. This number is more than Search's Facebook followers proving the effectiveness of utilising social media to reach audiences outside of our immediate network. As the campaign continues, we anticipate associated posts to reach larger audiences and spark meaningful online conversations around women's socio-political participation in Sudan.

Feedback from monitoring visits has highlighted the need for concentrated efforts to engage male stakeholders to increase women's socio-political participation.

Activities conducted under this outcome yielded significant peacebuilding results contributing to the project's larger aim of increasing women's political participation as seen by the participation of beneficiaries in local peace structures and decision-making bodies. As a result of 3 Mentorship Reflection and Training for Established Women Leaders, 100 women leaders were equipped with the skills and knowledge to pass on their accumulated experience onto younger generations. A monitoring visit found that several beneficiaries of these trainings have independently conducted coffee ceremonies within their local communities to spread awareness of women's rights and other gender-related issues. This demonstrated the increased confidence and agency that young women have nurtured after these trainings.

Despite the context, young women were engaged on transitional justice issues through 1 Leadership and Conflict Transformation Training for Young Women was conducted for 30 resistance committee members to reach a consensus on transitional justice despite the different charters being proposed to protect the shared rights of women in transitional processes.

A total of 4 Community Peace Forums were conducted in South Kordofan reaching a total of 120 community members. The forums provided a platform for young women to lead discussions on grievances driving local conflicts. Moreover, the forums created a space for intergenerational dialogue with the community. Through one forum, a local chief (Omda) of Debebat Kinana tribe in South Kordofan vowed to induct a woman leader into his consultative council. Such steps are the beginning of women's improved representation in local community authorities which are historically male-dominated circles promising more gender-sensitive native court decrees.

A diverse selection of young university students were supported through 1 Young Women-led Community Initiative in West Kordofan. 30 young women were reached through this initiative to increase their awareness of human and women's rights. The young students voiced displeasure with pronounced gender biases of the student deanship limiting their participation in the student body. The initiative strategized on tools and techniques to remove these barriers. The young women will be supported by local partner to ensure they are able to effectively and confidently address any gender bias within the student body.

Interventions contributing to this outcome have ensured gender equality and youth inclusion through the purposeful selection and engagement of women of different ages. An overt positive bias was employed to ensure the majority of participants were women, and particularly young women under 35 years old, to bridge the knowledge and access gaps to training opportunities between the two genders and different generations in traditional patriarchal societies such as South Kordofan and West Kordofan. Beyond engagement, activities under this outcome like A1.2.3 were solely led by women to strengthen their capacity to lead discussions – both to the larger community and each other. These nuanced expressions of women empowerment ensure that gradually communities become more accepting of women leaders and that women themselves are encouraged and confident enough to lead communities.

Other interventions, particularly the youth initiative supporting female students to counter gender-biased university regulations under A1.2.3, ensures that negative social practices which limit women's public and political participation in social spheres are removed from academic environments. The gender biased nature of student representing committees within these universities is extremely troubling as it could mask unreported gender-based violence and discourage young women from pursuing their education. It is important to support female representation within student bodies and organising committees as female student percentages are significantly lower in periphery states where traditional norms are unsupportive of girls' education.

Though the political situation remains tense, the draft constitutional document proposed provided a start for public thought of a transitional period. Recognizing this great opportunity, the training on Transitional Justice for resistance committee members represented youth and gender-responsive programming as it addressed the knowledge gap that exists between older, established politicians making decisions and mobilised youth on the ground. Propositions related to transitional justice have led to extreme fragmentation among youth in different resistance committee alliances Charter for the Establishment of People's Power signatories versus Revolutionary Charter signatories); thus, young women were equipped with the necessary knowledge to play leading roles in resolving this new conflict dynamic contributing to the recognition of women's leadership role in unstable contexts.

During this reporting period, 2 Common Ground Approach (CGA) training for Women Political Leaders engaged a total of 53 females and 7 males. Another 2 CGA training for Women and Women Supporters were conducted reaching 43 females and 19 males. M&E data from A2.1.2 demonstrated an average 41% knowledge increase among participants of both sessions.

Trainees of these sessions include members of the 6 Women Leader's Networks A2.1.3 formed during this reporting timeframe - 2 in West Kordofan and 4 in Gadarif state. The formed networks represented disabled women, youth, students and workers. A monitoring visit found that network members have independently conducted coffee ceremonies to discuss UNSCR 1325, women's protection and gender-based violence. In West Kordofan, the women's networks attended the state's international women's day celebrations and delivered training afterwards. More so, 5 members from the West Kordofan women leaders' network are members in the male-dominated local reconciliation mechanism.

2 Peace Agreement Forums were conducted reaching 60 community members to raise awareness of the Juba Peace Agreement and its implications for women. According to M&E data, 90% of participants reported no prior knowledge of the agreement nor its special clauses. Additionally, 4 Reflection and Planning Sessions brought together network members and male champions to align priorities for women's participation.

Prior to the NCE request, 2 Advocacy visits were conducted by women's networks members. This activity was adjusted to Town Hall Meetings whereby 3 Townhall Meetings were successfully conducted in three states after strategizing in A 2.2.1 and A2.2.2. The meetings discussed the draft constitutional document engaging diverse women and community stakeholders to assess its gender sensitivity and gender-responsiveness. The meetings reached a total of 75 females and 26 males.

During this period, 4 Youth-led Initiatives were implemented. The latest initiative was conducted in Khartoum in collaboration with university debate clubs to organise a public debate. The session attracted 100 attendees across generations to discuss "National Reconciliation in Sudan". The gender-balanced debate was a wide platform for young women to voice their opinions on important issues such as transitional justice.

The interventions conducted under this outcome have prioritised the participation of young women and men to champion improving women's political participation. Particularly through the latest initiatives conducted under A2.2.3 where strategic partnerships were formed with two popular debate clubs - Nileen Debate Centre and University of Khartoum debate club - attracting a diverse range of youth represented in the different student bodies. All debaters were under 35 years old and more than 70% of the audience were youth.

The meetings conducted in A2.2.4 are notable examples of ensuring gender equality and inclusion amongst diverse women even in times of political uncertainty which are known to dismiss women's priorities and participation. Discussing the draft constitutional document for women's feedback ensures that any future democratic transition reflects the rights and demands of women in the periphery and centre unlike historic agreements which only serve the needs and demands of elite women in Khartoum. Out of a total 101 attendees of the meetings conducted, 75 were women - showcasing the purposeful positive bias to ensure women's empowerment.

In this reporting period, a combination of innovative offline and online interventions were conducted to increase recognition and acceptance of women's role and contribution to the socio-political sphere. At the local level, 6 Friends of Women Luncheons were implemented in West and South Kordofan reaching 140 male champions who support women's political participation.

Virtually, women leaders' contributions were showcased through 1 Virtual Discussion on YPS with champions from Sudan and South Sudan. A successful young woman leader from South Sudan shared the challenges she faced in claiming her space with peers in Sudan to learn from. The similar patriarchal contexts of the two countries enabled a rich exchange of lessons learnt. Additionally, an intergenerational array of women were connected through 1 Workshop on Young Women's Role in Peace Processes to learn from the experiences of politicians who contributed to the previous transitional period.

At a national level, Search concentrated efforts to reach wider audiences - specifically youth - through various media channels under the ongoing Multimedia Campaigns highlighting women's contributions to peace and security. A Peace Media Academy bootcamp for women was conducted under A3.1.2 engaging 12 mature and young women from networks created under A2.1.3 with an interest in media.

Additionally, a practical training was conducted for various canvas artists under A3.1.2 titled "Art for Peace" which trained 15 different canvas artists on gender concepts and supported their creation of art pieces to reflect gender equality. The works and artists of this training will be featured during the intensive campaign during the 16 days of activism.

After the NCE request, Search completed an assessment and procurement for Women's Livelihood to ensure diverse women reap the peace dividends associated with Sudan's transition. South Kordofan was selected as it is experiencing an influx of refugees exacerbated by continued increase in exiles from other localities. During this timeframe, a highly participatory selection process of beneficiaries was conducted. The livelihood interventions will improve social cohesion in the ethnically diverse communities as their management will be shared, led by elected women committees and utilise all profit for common good.

An overt positive gender bias was employed in activities under this outcome specifically in the Multimedia campaign which will only feature women champions to highlight their achievements and encourage younger peers to participate in socio-political affairs. Though this program recognizes the meaningful role of supportive male champions, it understands that the achievements of women do not receive equal coverage by media outlets nor are they as celebrated within communities; hence, the sole focus on women leaders throughout the campaign.

Additionally, youth-responsiveness was ensured under A3.1.2 recognizing the different forms of expression that are most popular with youth. Asides from concentrated social media campaigns, progress during this reporting period recognized youth's strong interest and participation in art after the December 2018 revolution. As such, it utilised canvas art as an entry point to discuss gender roles, concepts and women's empowerment with young artists who will act as agents of change to communicate positive messages on gender equality through different mediums.

Responding to the disproportionate impact of insecurity and displacement on women and youth, South Kordofan state was selected as the implementing site of the newly introduced A3.2.3. Only women and youth - prioritising young women - will be supported through these initiatives. The selected initiatives are more than income generating activities. They will act as additional platforms for grassroot women in fragile communities, who were not previously engaged by the project's trainings or mentorship, to play leading roles within their communities. More directly, the different livelihood interventions such as the proposed flour mill will help reduce the physical effort and GBV risk associated with crossing long distances for women - responding to their specific gender needs.

Particularly in male-dominated sectors such as political and civic engagement, women are rarely at the present in decision-making circles or present with meaningful participation. Their poor representation in decision-making circles in a compound result of social norms and subsequent lack of confidence and capacity to participate in different leadership roles. Women have limited access to capacity building, economic resources and platforms which contribute to political participation and civic engagement.
