<ul style="list-style-type: none"> • Key achievements in 2022 	<ul style="list-style-type: none"> • Green Recovery Modelling and Green Economy Progress (GEP) Measurement Framework (3rd edition, 2022): ILO contributed to produced 3rd edition of the GEP report by the UNEP in 2022 with active participation to meetings organized by the PAGE Secretariat, and provided technical inputs. • The ILO supported and contributed PAGE global cluster work “Supporting UN reforms – strengthening cooperation with UNDCO” (led by the UNITAR): At regional level, the PAGE has actively participated and contributed to two regional UNDCO’s retreats in 2022. Between 30th May and 3rd June 2022, PAGE and agency focal points were invited to the “Europe and Central Asia Regional Economists Network Annual Retreat”, which was aimed to enhance the understanding of the roles of the Economists within the RCOs and UNCTs and discuss challenges, capacity gaps, good practices and lessons learned. Event was organized in hybrid while PAGE agency focal points contributed on-line. PAGE shared how the Partnership is supporting partner countries in accelerating a fair and green economic transformation. - Under the PAGE and UNITAR lead-work, the ILO had delivered, and contributed in two days thematic training “Advancing a green and fair economic transformation in a crisis-driven World: The role of macro-economic modelling” conducted online on 13 and 14 December 2022, in Zoom (*in-kind contribution of the ILO*).

- **Stockholm+50: high-level in-person side event titled “Revisiting Economics & Finance to Accelerate Action for People & Planet” organized with support from the ITC-ILO and ILO:** ILO and the International Training Center (ITC) had supported the PAGE Secretariat in organized two high-level events at **Stockholm+50** on 2-3rd June 2022. On June 2nd, the PAGE facilitated a high-level panel in-person discussion focused on key actions and actors needed to revisit economics and finance to accelerate action for people and planet. From ILO-lead countries, the State Secretary of Climate Change, Sustainable Development and Innovation, Ministry of Environment and Sustainable Development in Argentina was invited and spoke at the high-level panel discussion highlighting the country experience with shared perspectives on circular economy. On 3rd June 2022, PAGE organized with ITC-ILO a Ministerial breakfast meeting to discuss and identify pathways to make our economies low carbon, circular, nature positive and pro-poor, and to discuss how PAGE can take forwards and help make the outcomes of Stockholm+50 a reality.

- UNIDO and ILO collaboration on study titled: “**Impact of COVID-19 on green enterprises: Policy guidance towards inclusive, resilient and sustainable recovery (Ghana, India and Uruguay)**” under the PAGE: The study is coordinated and managed by UNIDO in collaboration with the ILO, and aims to map the impact of COVID-19 on the green SMEs in selected PAGE countries; develop a set of policy measures that could be adopted by the government, enterprises, private sector, financial institutions, and the international community to bring the businesses back and thriving despite the crisis. The study aims to take stock of similar studies in order to find lessons and insight for PAGE countries. The study aims to analyze and investigate the following areas:

- Impact of COVID 19 on green enterprises: Identify the extent of the impact of COVID on green enterprises, how firms are being affected, its nature, scope, how many green firms ceased to exist, what the fundamental reasons are behind green SMEs facing such challenges. What are the factors that help them to survive? Examine to what extent it affects enterprises' implementation of the SDGs (Decrease of work in the area of SDG). The study will identify the impacts on creating entirely new green enterprises and also shed light on the impact of the COVID-19 crisis on women and youth-led businesses.
- Impact on Green Jobs: investigating the impacts of COVID on green employment (lay off, reduction in working hours, incomes, compensation).
- Measures in response to COVID 19 for SMEs: to what extent these measures help them to survive, grow, go green and implement SDG, climate/NDC targets. Impact of the measures on the efficient and sustainable use of resources, strengthening SMEs in providing green services, creation of green jobs, and availing green economic opportunities.

- Business opportunities emerging from COVID 19: many MSMEs manage to innovate at various levels, such as products, operations, services, processes, as well as business models, in facing the challenges of COVID. The pandemic is also forcing businesses to go online. Hence, this also acts as an opportunity for SMEs to grow and to become stronger. Therefore, the study will identify the opportunities that have stemmed from COVID 19, i.e., new business models that create job opportunities, e-commerce, entrepreneurship development and application of new technologies, and innovation to boost green entrepreneurship.
- Best practices in response to COVID-19: Identify best practice cases of SMEs from India, Ghana, and Uruguay in dealing with the economic impacts of COVID-19 and bringing the sector back better. The study will also examine case studies from other countries to draw lessons for the PAGE countries.
- Policy recommendations: The study will identify precise policy measures for the government, international community, financial institutions, and enterprises to boost green entrepreneurship. It will also develop a recovery toolkit for SMEs.

In November 2022, in addition to rounds of review based on drafted ToRs (in 2021), the ILO team (Green Jobs Programme and SME Unit) provided technical inputs to draft final report and toolkit. The work is conducted by Environmental Management Centre (EMC) Pvt. Ltd, who is engaged and contracted by UNIDO in conducting this study with pilot and research zoom in Ghana, India, and Uruguay. The work is planned to be finalized with publication of the report by UNIDO in Q1, 2023 (in-kind technical contribution of the ILO to this workstream).

- **PAGE and EfD collaboration on IGE in Africa: ILO’s joint session on sharing insights on policymaking in Africa:** The Environment for Development Initiative (EfD), a global environmental economics research network based in Sweden had invited PAGE (liaised with for Stockholm+50), to join the virtual high-level panel discussion as part of their IGE course session organized on 6 September 2022, titled “Implementing a Green Transformation in Africa”. Based on PAGE Secretariat’ invitation, the ILO had prepared presentation and contributed with intervention focusing on just transition, green jobs and policy making in Africa. About 25 senior civil servants involved in green reforms in Ethiopia, Kenya, Tanzania, Uganda and Rwanda are enrolled in this EfD course, and PAGE speakers (ILO-HQ, UNIDO-Morocco) shared and brought international and country perspectives from different African region. The feed-back and online survey results (in menti platform) was conducted from participated trainees with addressed inputs by the ILO .
- **Annual PAGE Management Board and Global Technical Team meeting hosted by the PAGE Secretariat and the ILO, November 2022, Geneva:** The PAGE Technical Team and Management Board met on 22 and 23 November to discuss and provide guidance for the future strategy and operational model of PAGE, considering the evolving global context with multiple crises and PAGE’s funding prospects. The ILO had organized this meeting at its premises in close collaboration with PAGE Secretariat. In addition, ILO contributed to organized dedicated session and online survey & live poll with agency focal points and National Coordinators to collect their views on opportunities and challenges vis-à-vis current multifaceted crisis on how best to deliver the PAGE country work on green, resilient and sustainable agenda (reports are available produced and disseminated by the PAGE Secretariat in Dec 2022).

- Preparatory work was initiated by the ILO for hosting the **5th edition of the Global Green Economy (GE) Academy with ITC-ILO** and agencies in October 2023 to mark 10th years of PAGE anniversary. The ILO had designed a concept nthat was updated and submitted to PAGE Global Technical Team on key objectives, suggested way forward and format of training. In November 2022, the **Academy Technical Committee (ACT)** was established within objective to work jointly on the theme, content, programme and foster PAGE- interagency collaboration. PAGE-ACT will organize monthly meetings as of January 2023.
- In 2022, the ILO organized and coordinated two high-level **closing ceremonies in Senegal** (organized 16-18 October 2022 met with funding partners and celebrated jointly [8 years of PAGE work with concluded key results and achievements](#)), **South Africa** (31th October 2022, [marked 7 years celebration on PAGE work on IGE](#)) ILO organized closing ceremonies in Dakar and Pretoria in collaboration with its Regional Offices and Directors, agency focal points, technical regional specialists, members of nationals teering committees (NSC) and PAGE inter-agency country teams. PAGE agencies were involved in organizational process as well in technical contribution in thematic sessions (see country progress annual reports for South Africa and Senegal). All media with communication work was delivered in collaboration and support from the PAGE Secretariat and its Communication team. The UNRCO country teams were involved and a invited to events accordingly. In addition, the ILO was part and contributed to different panel-discussions and thematic sessions of PAGE Transition (closing) ceremonies in 2022 For more details on key results to see country sections below.
- **ILO PAGE- Asia Regional collaboration and workshop as fostered peer-learning at regional level on PAGE work, 16-18 November 2022:** The Asia-Pacific Green Jobs Network face-to-face meeting is held first time in 2022 after two consecutive years of online monthly meetings organized by the ILO Asia-Pacific Regional Green Jobs team (based in Bangkok) to share knowledge and facilitate networking in advancing ILO’s agenda for greening the world and future of work, with the aim to:
 - discuss how the ILO is working for a Covid-19 recovery with green jobs,
 - exchange information about keeping climate change action commitments in place as part of the recovery measures for better jobs, and
 - contribute to global efforts against the Climate Change emergency by focusing on implementation of actions.

Furthermore, the network has also been expanded to include national constituents working on relevant issues in Asia-Pacific countries, thus developing into an important regional exchange and networking platform on green Jobs and Just Transition. The regional knowledge sharing workshop adopted a sectoral approach and shared best practices and experiences of **PAGE Asia**, ILO-SIDA Decent Work in Garment Supply Chains in Asia project, UN Issue -Based Coalition on Raising Ambition for Climate Action, and other relevant programmes, projects and initiatives from ROAP and ILO Country Offices in Asia and the Pacific region on Green Jobs and Just Transition. The event was coordinated and organized by UNITAR and PAGE Secretariat in close collaboration with UNIDO, UNDP, UNEO and the ILO. The ILO supported PAGE in facilitation of bringing speakers from UN Secretary General’s Youth Advisory Group on Climate Change (YOUNGO Green Jobs Working Group) and the International Organization of Employers (IOE), who were part of the panel discussion • PAGE Family Gatherings in 2022: ILO as lead agency in Argentina, South Africa, Peru and Senegal had joined and contributed to bimonthly meetings in 2022 as well shared inputs to thematic questions. Also, ILO was part and contributed with substantive inputs to monthly PAGE global technical team meetings organized by the PAGE Secretariat.

Support for Green Recovery)	<ul style="list-style-type: none"> • UNIDO and PAGE 2nd Summer School on Green Industry for Inclusive and Sustainable Industrial Development was organized by UNIDO on 26-29th July 2022 (Part 2: Advanced Instructor-led Online Course on Green Industry). Under the PAGE umbrella and funding, the UNIDO-led Summer School provided participants with an understanding of green industrial policy as a tool for accelerating a green economic transformation, together with an opportunity to learn and discuss how industries, and specifically SMEs, can overcome key challenges that prevent them from adopting green industry-related products and services. Key Achievements 2022 (Add. Support for Green Recovery)	<ul style="list-style-type: none"> • Global Recovery Observatory (GRO) update: Feb -Dec 2022 in 2022, the ILO involved and collaborated with Cambridge Econometrics (CE), a member of its network of the Green Jobs Assessment Institutions Network (GAIN¹) to produce a methodology for assessing potential job impacts of the COVID-19 related fiscal spending tracked by GRO. This methodology provides a first effort in an ongoing exercise to enable a more granular measurement of potential employment effects of individual fiscal policies. The objective of this global-level activity was to estimate job outcomes on a country/region basis for the policy archetypes included in the PAGE- GRO database. The GRO database collects global recovery, relief policies and classifies them into 40 archetypes and 158 sub-archetypes. The GRO database was continuously updated on a weekly basis in 2022. Currently the database includes the

policies' country, archetype, sub-archetype, total value, and binary indicators (0 or 1) on whether the policy can be considered (clean / dirty). The challenge at hand is modelling employment outcomes from the wide range of illustrative policies contained in the GRO database. These have widely different effects in different economic settings (i.e., different countries), thus reinforcing the need to use a consistent modelling framework.

Methodology: the ILO lead and technical contribution was to work technically with Cambridge Econometrics (CE)- the GAIN member² to use and employ the E3ME macro econometric model, with a certain set of selected archetypes/sub-archetypes and standardize the process to the extent possible so that job estimates can potentially be updated periodically in the future. The current project aimed to produce net employment results by region (and sector by region), yet possible extensions to disaggregate the job estimates by gender, age and occupation that can be added in the future.

The **main outcome** of this activity resulted in final report with key insights produced end of 2022 with notably a global methodology and standardized process that had assessed job impacts of alternative fiscal policies, as well as two country recovery assessment for Indonesia and Brazil. Key achievements in 2022	NA
Key Achievements 2022 (Add. Support for Green Recovery)	<p>In support of the “Ger and Nature scheme”, the ILO completed all green recovery funding activities in 2022. A Green Jobs opportunities assessment was conducted to identify opportunities for and barriers to the promotion of green jobs and decent work standards in the nature-based tourism sector. Study findings suggest growing international and domestic tourism demand for Ger and Nature tourism activities in which Mongolia’s herders, tour operators, and supporting actors could be involved in creating green jobs and decent work within the context of a just transition. However, the stakeholders’ understanding of ‘green jobs’ is often limited to environmental aspects while lacking decent work components. The study puts forward recommendations to enhance the opportunities and address the gaps through improved policy development and coordination and targeted capacity building. The capacity building workshop was jointly carried out with the National University of Mongolia, herding communities, tour operators, and other stakeholders involved in nomadic Ger and Nature tourism activities and the cashmere industry as a related sector in Mongolia. The draft research findings were shared and validated through tripartite consultation on 4 July 2022 in Ulaanbaatar. <p>Key achievements in 2022</p>	<p>The ILO developed a capacity building plan with programme and training materials and presentations for an on-site training of local herder communities and SMEs, which was held on 6-7 July 2022 in Hustai National Park and at Boutique Ger, Tuv province, Mongolia.</p> <p>This activity built on the findings of the ILO Green Jobs and Decent Work assessments which included knowledge on decent work agenda and guidance for herders on safety and health (OSH) among others. The activity engaged regional destinations and included knowledge related to cashmere combing, horse riding etc., which contribute to income generation opportunities for local communities/SMEs as well as preservation of traditional nomadic culture and lifestyles. The activity brought together local herder communities (19 herders/10 women) and SMEs (9 SMEs/3 women), which:</p> <ul style="list-style-type: none"> • enhanced their awareness and understanding of the environment and employment impacts from the development of nature-based tourism, • advised on local income generation and investment opportunities as well as skills needs for nature-based tourism development, and • enhanced their awareness and capacity to actively participate in Green Jobs and Just Transition promotion in nature-based tourism development through social dialogue.

AGENCY - PERU

<i>Outcome 1 - Countries have reinforced and integrated inclusive green economy (IGE) goals targets into SDG aligned national economic and development planning through multi-stakeholder collaboration.</i>	
Key achievements in 2022	<p>Under the PAGE Green TEAM workstream, the ILO –Lima supports the use of models for policymaking in close collaboration with UNRCO Economists for updating the Common Country Analysis. In 2021, the United Nations System in Peru developed the Common Country Analysis (UNCCA for its acronym in English) as a step prior of the new Framework of Cooperation for Sustainable Development 2022-2026 (UNFCSD). This document was signed end of 2021 with the Government of Peru and entered into force on January 1, 2022. In this CCA framework, the circular economy has been identified as one of the key “accelerators” in the country to advance with the national development priorities to achieve the 2030 Agenda and the SDGs.</p> <p>To generate this evidence, a "soft-link" will be developed between the set of models used in the decarbonization project (Quiroz et al., 2021) and the T21-Peru. It was also supported under the PAGE in 2019 (https://unfccc.int/sites/default/files/resource/PAGE%20presentation%20%20Ronald%20Gainza.pdf). The T21-Peru model has the capacity to generate additional social, economic and environmental indicators, for which reason it will be considered establish a soft link between the models in order to expand the set of indicators to introduce in Peru. This approach will make it possible to integrate the analysis of economic, environmental and of the eventual implementation of green policies in key sectors of the economy. Policies will come mostly from NDC instruments related to mitigation in the main GHG emitting sectors in Peru. The main partner has been identified (Pontificia Universidad Católica del Perú) and work at the UNCT coordination level is being carried out since 2022 with an outcome expected in 2023.</p>
Key Achievements 2022 (Add. Support for Green Recovery)	

<i>Outcome 2 - Countries are implementing evidence based sectoral and thematic reforms in line with national IGE priorities.</i>	
Key achievements in 2022	<p>Jointly with a regional ILO project promoting labor integration of migrants and refugees, PAGE supported the development of a study on “Opportunities to generate green jobs for refugees, migrants and nationals in Peru” (Oportunidades de generación de empleos verdes para personas refugiadas, migrantes y nacionales en el Perú) published in 2022. Publication referred to initiated PAGE work since 2014. It includes case studies for the sub-national departments of Piura, Lambayeque, La Libertad, Cusco and Lima. The study identified agriculture, solar energy, sustainable construction, and recycling as the economic sectors with the greatest potential to create green jobs and sustainable enterprises for Venezuelan refugees and migrants as well as for host populations in the framework of a just transition. The ILO-coordinated project "Promotion of the Labor integration of refugees and migrants under decent work conditions in Ecuador and Peru" took up the main recommendations of this study and is working to promote skills certification in the identified sub-sectors in the Piura region.</p>

Support for Green Recovery)	<p>Since March 2022, the ILO-Lima Office supported and organized number of PAGE inter-agency meetings that were aimed to discuss planning (ToRs) on green recovery activities and synergy of collaboration with key stakeholders (MINAM, MoL and MoE).</p> <p>Under the PAGE Peru Green Recovery project, -guidance materials were developed for green entrepreneurship in San Martin region, to promote eco- & bio-business: The work is being carried out in conjunction with the Regional Directorate of Development of the San Martin Region and the National University of San Martin’s BioInnova. Since November 2022, 25 professionals were trained as trainers, who afterwards will deliver training on enterprise and cooperative development to cooperatives and producer organizations in relevant green activities in the region. The new trainers will begin delivering the training planned early 2023, which aims to support and help small green businesses in the region to become more greener, innovative and competitive.</p> <p>With ILO-Lima support, it is planned to support work to develop a proposal to improve institutional framework to promote eco- and bio-businesses in the San Martin. The Regional Concerted Development Plan (Plan de Desarrollo Concertado) considers bio- and eco- businesses and financing options. The current PAGE support under the green recovery funding mechanism aims to improve the capacity for promoting bio- and eco- businesses. Furthermore, UNIDO will support the capacity of cooperatives and other associative enterprises in the bamboo value chain in 2023.</p>

Support for Green Recovery)	<p>As part of PAGE Peru Green Recovery project, ILO-Lima supportsthe development inclusive green entrepreneurship training programme (ToT) for the Regional Center for Entrepreneurship and Innovation of San Martin. In partnership with the Regional Center for Innovation and Entrepreneurship and the Regional Government of San Martín, PAGE leveraged two professional training of trainer (ToT) methodologies offered by the ILO to promote the development of green entrepreneurship in San Martín —the ‘My Green Business methodology’ and the ‘Think.Coop and Start.Coop methodology’. The training of trainers started and was organized by the ILO in November 2022 and the replication with certification is planned to start in March 2023. The PAGE supports activity to strengthen the capacity of public and private policy makers towards a transition to a green economy in San Martin. It is planned to be done via a Diploma on Just Transitions. The National University of San Martin’s Faculty of Ecology is currently developing the contents, in conjunction with ILO inputs as well as national frameworks to be completed in 2023.</p>

<p><i>Outcome 1- Countries have reinforced and integrated inclusive green economy (IGE) goals targets into SDG aligned national economic and development planning through multi-stakeholder collaboration.</i></p>	
<p>Key achievements in 2022</p>	<p>PAGE and the Government of Senegal, under the leadership and coordination of the Ministry of Environment, Sustainable Development and Ecological Transition (MEDDTE), met on October 13-14, 2022, to mark 8- years of partnership and action to build an inclusive green economy. This event was an opportunity to exchange perspectives, challenges and opportunities, in the run-up to COP 27. The two-day event included panels and thematic sessions, exhibitions and a Media Award Ceremony. The aim of the event was to capitalize on the achievements of the PAGE partnership and for the Government of Senegal to lay the foundations for their reinforcement, through a well-thought-out sustainability strategy. Support for Green Recovery)	<p>As part of green recovery funding, the ILO is providing technical assistance to the Government of Ghana through the Ministry of Employment and Labour Relations (MoLR) and coordinating activities to develop a Green Jobs Assessment model (GJAM) for Ghana in collaboration with Government and through synergies and integrated support with the ILO-Sida Partnership project.</p> <p>Since September 2022, the advanced ongoing work is being carried out by SINTEF³ (Contracted International Research Institution from ILO's Green Jobs Assessment Institutions Network (GAIN)) and national Expert, to develop the macro-economic model, to assess the green jobs potentials in various sectors of the Ghanaian economy, establish a baseline on green job and green enterprises (in case national data on enterprises by sector are available) in Ghana and generate a baseline on green jobs requirements for implementing the revised NDCs⁴. The ongoing work includes collecting relevant data from institutions, stakeholders in the NDC relevant sectors on labour, social, economic and environmental statistics, building scenarios out of these, policy analysis and developing a green jobs assessment model for Ghana. It will also generate a baseline on green jobs requirements for implementing the revised NDCs.</p> <p>The work being carried out will ensure employment and just transition policies are integrated in the national policy making process, notably climate and sustainable development policies including climate-related sector and implementation plans and strategies. It will also serve as a tool for monitoring. These 3 scenario parameters were taken from the National Energy Transition Framework (2022-2070) blueprint document, which was out-dooed by the President of Ghana and the Minister of Energy, at the just ended COP27 in Egypt. This framework, according to Ghana's president, has not only been crafted on the back of Ghana's updated GH-NDCs submitted to the UNFCCC in 2021, but it also encapsulates all sets of interventions intended to achieve complete decarbonization of the energy sector by 2070. It thus provides acceptable milestones, backed by executive authority, on how to reduce GHG emissions in the energy sector by the end of 2030, 2040, 2050, and 2070 (on page 9 of the Framework).</p>

Key achievements in 2022	<p>PAGE, led by ILO, with the University of Mauritius and in close collaboration with national stakeholders (Ministries of Finance, Labour, Education and Human Resources, Statistics, and trade unions), conducted a modelling exercise that identified skills needs for green jobs in emerging sectors entitled “Green jobs and employment impacts of a green and low carbon strategy in Mauritius” (2022) which highlighted the importance of enhancing the current institutional mechanisms and policy coherence on skills development for existing and future green jobs.</p> <p>Mauritius’ Climate Change Act entered into force in April 2021 and the National Determined Contributions (NDC) were submitted to the Climate Secretariat in October 2021, stepping up the island’s long-term commitment to sustainable development. Mauritius aims to reduce overall Greenhouse Gas (GHG) emissions by 40% in 2030 compared to the Business-as-Usual (BAU) scenario, levelling up existing green strategies and climate policies.</p> <p>At the same time, Mauritius aspires to further economic growth and job creation while addressing the increasing socio-economic expectations of a growing high-income country, as which Mauritius was identified in 2019. There is a strong commitment to develop both the economy and society whilst subduing the adverse impact on the living environment. Following consultations with and assistance from institutions at both national and international levels such as through the ILO and the PAGE, several policies and programmes have been implemented in Mauritius to help the island to make the transition to a greener economy and to promote green jobs. With the new and ambitious climate target and socio-economic expectations, the key question is which type of policies and strategies would maximize employment creation and economic growth while at the same time reaching the climate target. This research finds that economic sectors having a potential for green jobs directly offer opportunities to reduce GHG emissions. These initiatives helped in fostering economic growth, create income, reduce poverty and inequality, and strengthen the ecological foundations of the economy as well as enhance the capacity building of Mauritius towards its transition to an inclusive green economy at the macro-economic multi sectorial level. In January 2022, a total of 20 enterprises (including food processors, hotels and restaurants) registered to participate in Phase II - Resource Efficiency practices under the [Operation COSHARE programme](#). A training of trainers (14 trainers) was conducted by ILO for local trainers from NPCC for further dissemination of the programme to enterprises. A scoping exercise was also conducted to assess the commitment of participating enterprises for implementing the improvement projects.

On 21st October 2022, the National Productivity and Competitiveness Council (NPCC) and ILO formally ended the Operation COSHARE programme. High-level government officials were present from the Ministry of Industrial Development, SMEs and Cooperatives, and ILO Country Director for Madagascar, Comoros, Mauritius, and Seychelles was present in person and intervened during the event. The audience consisted of the Operation COSHARE beneficiaries, who shared their positive experiences and outcomes of the programme. Most enterprises were able to identify 'quick wins' during the programme, and this was very encouraging for them. The NPCC, local partner working with ILO on this project, provided some interesting insights and shared future opportunities to continue the work. End of November 2022, a dissemination workshop and award ceremony was successfully delivered on Phase II of the Operation COSHARE programme.

The ILO lead activity on skills had three components & deliverables;

- a) Skills for green jobs in Mauritius (a national study) produced by the ILO and national expert, designed and published in 2019 ([wcms_706879.pdf \(ilo.org\)](#))
- b) The Skills Roadmap was suspended in 2021 due to poor quality work of hired consultant. This mentorship consisted of two phases: a) Individual Initial assessment: at the beginning of the Mentoring and Coaching Programme, the appointed Business Development Service (BDS) provider has conducted individual capacity needs assessment immediately after winners and runner ups are announced in the Awards Ceremony; b) The BDS provider was engaged to ensure SMMEs participate in a baseline survey to gain fuller understanding of their needs, review and refine the SMEs business plans to confirm viability and discuss the utilization of the four - six months mentorship and coaching prize.
3. Engaging with winners and runners-up to determine current knowledge of business acumen; also, engagement was established with winners and runners-up to determine extent of business and objectives/achievements to date and targets and outputs planned;
4. Determined current status/quality and comprehensiveness of business plan (if available)
5. Identified GAPS where specific attention should be paid in order to advance knowledge base of winners and runners-up and drafted a plan of implementation on what key focus areas should be (in addition to general business acumen skills)
6. Support was provided to business development: after SMEs have been exposed to green business acumen training conducted by ITC-ILO, BDS provider will support the implementation of business plans and the achievement of established targets in terms of sustainable growth of enterprises and job creation. The individual capacity needs assessment conducted by the BDS provider will allow the identification of the required areas of expertise. The BDS provider undertook the following activities:
 - Maintain a direct communication line with the assigned enterprises through e-mail, Zoom, MS Teams, WhatsApp or phone (calls and/or SMS) to receive queries and confirm mentoring appointments;
 - Carry out individual mentoring sessions for a maximum of 16 hours / per company. Progress made by the respective SMME during the sessions will be a further determining factor regarding the frequency and number of sessions);
 - Organize online knowledge sharing sessions for the group of companies under their responsibility to stimulate peer learning and maximize the cost-effectiveness of tools and services provided (e.g., one introductory session for all to understand scope and objectives of the mentoring programme, one mid-way evaluation on results achieved, one technical session on a topic of common interest, etc.). Depending on the companies' profile and group dynamics, between 2 and 4 group sessions of 1.5 hour each can be organized throughout the mentorship period (via Zoom, WhatsApp, WebEx or any other online communication channel considered adequate to the scope).
 - Due to COVID-19 lockdown measures mentorship should be provided mainly online. Based on lockdown regulations, at least one face-to-face visit to the company is

The support to NSC the for the enhancement of the national statistical system included working sessions with an international expert on SEEA from Statistics Norway and one expert on national accounts from Statistics Estonia as well as the hiring and training of two local experts. Work on the data production has supported the development of the Green Jobs Assessment Model (GJAM) for the Kyrgyz Republic (see the following subsection).</p> <p>ILO and the NSC of the Kyrgyz Republic designed a questionnaire and workplan to carry out an establishment survey on green sector and jobs. The survey is taking a nation-wide sample of establishments, and it is currently being carried out by the NSC. Carrying out a survey of green and conventional jobs in the informal sector with information on SMEs and household environmental production can be a key component for the sustainability strategy. A key component of this has been the extensive technical assistance to the NSC in producing a national account matrix (NAM), which will be expanded with labour force and household budget data to provide a complete picture of the economy, the income distribution and job structure. A full social accounting matrix (SAM) was completed which is the basis for an extensive database for the GJAM. The analytical tool represents a complementary analytical tool for policy analysis focussing on the socio-economic dimension of conventional and green policies. For the GJAM project ILO has established since 2019 a collaboration with Statistic Canada (StatsCan) and coordinated with IMF-CARTAC. The use of this SUT will support the completion of the GJAM project with official data.</p> <p>The BoS has participated to the general introductory training on the GJAM in February 2019. In December 2019 a joint in-person hands-on training by ILO and StatCan supported advancing in the production of the 2015 SUT as a capacity building exercise for the benchmark 2019 SUT. Moreover, during the COVID-19 pandemic, the ILO, StatsCan worked virtually with the BoS to advance updating of the SUT. They focussed on building capacity on integrating environmental accounts into national accounts. StatCan provided a one-day workshop on the SEEA-EGSS. Currently, a tripartite workshop is under preparation to validate the study’s result which is expected to be finalized in the first half of 2023.</p> <p>PAGE, together with the ILO project “Decent Work in the Garment Supply Chain in Asia” funded by the Government of Sweden (Sida), supported a two-day workshop “Achieving a Just Transition through Stronger Collaboration in Indonesia: A Social Dialogue on Just Transition for the Energy and Textile & Garment Sector”, 24-25 October 2022 in Jakarta. The event aimed to facilitate social dialogue among stakeholders on Just Transition planning in the garment and textiles sector. Fifty representatives of relevant governmental departments including the Ministries of National Development Planning and of Manpower, employers’ organizations, and workers’ organizations actively participated in the workshop, sharing their knowledge and experiences.</p> <p>Aimed to facilitate a social dialogue process among relevant parties, the workshop discussed the just transition policies to support coal phase out in Southeast Asia, including Indonesia, and the overview of the global changes and trends on the sustainability practices in the garment and textile sector and implications for a just transition. Indonesia is known for its highest levels of coal consumption in Southeast Asia and one of the largest textile producers in the world. Key findings from the ILO Just Transition policy readiness assessment were presented and ways discussed to move forward with a Just Transition in the energy and textile sector.</p> <p>During the interactive and group discussions, the participants highlighted the importance of certification and reskilling to ensure workers from these sectors have better opportunities to gain new employment, the implementation of social dialogues at both enterprise and sectoral levels, the crucial development of labour market information and the identification of risks and opportunities for these two sectors. Representative from the government agreed that there should be a coordinating mechanism between relevant stakeholders and to make the just transition as part of the governmental programme with the possibility of the development of National Action Plan or other relevant measures. ILO Country Director for Indonesia emphasized the importance of social dialogue throughout policy making processes at all levels. A [training of trainers](#) (ToT) using the ILO’s Start and Improve Your Business Programme (GERME in French) took place in Rabat from 14 to 25 February and in Kenitra from 28 February to 11 March for 40 participants from the National Agency for the Promotion of Employment and Skills and the Regional Center for Young Agricultural and Agro-Food Entrepreneurs. Since then, the 35 newly trained SIYB trainers supported over 700 entrepreneurs and students in the Rabat-Sale-Kénitra region to develop their business idea, create a business plan, and start a business, as well as in improve their skills in marketing, accounting, inventory management, and human resources. Main beneficiaries of which were from the National Agency for the Promotion of Employment and Skills (ANAPEC) and the Regional Center for Young Agricultural and Food Entrepreneurs (CRJEA) of RSK.

In October 2022 was launched a large 12-month program on decarbonization of agriculture and agribusiness. This program is co-funded by PAGE, an ILO Proagro project (and the Morocco’s University Mohammed VI Polytechnic (UM6P). The program combines a series of interventions on sensitization (seminars, workshops, podcasts), entrepreneurship & innovation, skills development (executive training and MOOC) and support to enterprises (development of a digital too to assist enterprises in CO2 estimation and reduction). On 22 November 2022 the first event was organized called “Agri Carbon Day” in Rabat. In total, 12 experts and companies provided technical inputs and examples to over 150 people who attended the event (policymakers, companies, researchers, think tanks and international organizations). This event was the first one of its kind in Morocco, focusing the discussion on the challenges and opportunities of decarbonization for the agriculture and agribusiness sectors.

One of the lines of work is the PAGE Uruguay project was to strengthen the capacities of rural women entrepreneurs, which aimed to provide training on green jobs in the framework of decent work, including the identification and promotion of good practices in productive enterprises; the presentation of projects that include the green component and good practices to strengthen their development through seed capital.</p> <p>The activity included designing, together with rural women's organizations, the implementation of seed capital and capability in co-managing resources for the implementation of green projects, collaborating in the identification of synergies between green enterprises, promoting coordination, associativity and strengthening women's networking.
