- 1,5 mln ppl reached out as a result of public awareness raising campaign (12 videos 12 TV channels; 1,746,000 views in Instagram and 346 000 in Facebook)
- Policy recommendations development for establishing I4P both at central and local levels
- Conflict-sensitivity analysis conducted for implementing Kyrgyz Jarany in religious communities
- A Charter of Local Communities amended & adopted to enable LSGs to allocate resources from local budgets
- Public hearings resulted in drafting amendments to the Law on LSG to define sustainable role of LSGs in peacebuilding
- 995 U-Reporters engaged for data collection to inform decision-making of LSGs to address youth's needs
- 520 youth and 155 LSG reps trained on youth and child inclusive decision-making and 42 community solutions proposed on tolerance and diversity issues
- 106 teachers trained to promote peace, tolerance and diversity at Early Child Development centers
- 122 reps of Women Councils and 125 of youth activists trained in human rights, equality, diversity, tolerance and participation in decision making and facilitating internship

Key findings of Baseline Survey include:

- Low awareness of population about Kyrgyz Jarany Concept
- High proportion of population (77%) share the importance of forming a common civic identity and involvement of citizens in the governance process
- Baseline survey recorded quite high level of cooperation and interaction between different target groups within pilot communities (84,5%).
- At present, the target locations have already established and are using mechanisms of inclusive and accountable management, such as councils, commissions, working groups, committees, public monitoring groups, etc

Key structural, institutional level changes:

(i) The project analysed policy frameworks and institutional mechanisms for establishment of Infrastructures for Peace (I4P) at central and local levels. So, various policies and strategies analysed aimed at social cohesion. The analysis recommended to shift towards portfolio implementation of policies and multi-stakeholder coordination. Results were discussed within the Inter-Ministerial Coordination Mechanism (IMCM) on Civic Identity. As an early sign towards portfolio implementation, Cabinet of Ministers conducted a first-ever joint session of two IMCMs created for Civic Identity Concept and State Policy on Religious Affairs on March 31st, 2023. Further actions will be taken to further interconnect with Youth Development Concept, NAP 1325, PVE and CSOs to build I4P at the central level.

(ii) To strengthen policy frameworks and institutional mechanisms at the local level, the decentralization of peacebuilding was kicked off at the policy level through policy advocacy and national consultations with Members of Parliament. As a result, draft amendment to the Law on Local Self-Governance drafted and submitted for Government's consideration. The amendments will (i) engage local self-governance into peacebuilding as an important institutional system of governance (ii) create a solid foundation for building local level peace infrastructures.

The Charter of Local Communities, updated and adopted by integrating peacebuilding interventions, defined peacebuilding as an important domain of community level social contract.

(iii) Ministry of Education is in the final stage of testing the lessons on diversity, equality and civic identity as part of secondary school curriculum.

At the society level, the project implemented capacity building activities for trust among different groups:

– a training program on participatory local governance was jointly developed with the Ministry of Culture,
Information, Sports and Youth Policy (MoCISYP) to enhance the capacity of Local Self Government (LSG). Staff from
MoCISYP have been trained as Master Trainers who can roll out this training to other LSGs to promote youth
inclusion on local governance. The training, rolled out in 7 LSGs, resulted in a more inclusive, responsive approach to
governance, ensuring that youth voices are heard, and their perspectives are considered in policy development and
implementation. Capacity-building of youth, parents, and early childhood development workers resulted in
changing behaviour and local initiatives that foster social cohesion. These include starting up a school-based
journalist hub and sharing an NGO-run mental health training and delivering it to parents.

- LSGs in 7 project locations increased their capacity to ensure the right to participate in decision-making processes and hold dialogue with communities.

The project analysed national policies and strategies and IMCMs for establishing I4Ps at central and local levels. The analysis identified siloes in policy implementation, which the project will address by developing an integrated cohesive action plan.

To strengthen local peace infrastructures, a Charter of Local Communities amended & adopted, which defined peacebuilding as an integral domain of community level social contract. National consultations with the Members of Parliament led to the decision to amend the Law on LSGs to define a sustainable role of LSGs in peacebuilding, sustain peacebuilding action plans and budgeting.

As part of strengthening local peace infrastructures, 155 LSGs and 328 youth trained on development planning and youth engagement. 42 youth-designed peacebuilding solutions presented to LSGs, with 27 selected for implementation and co-financing by LSGs. Financial support for the remaining 15 solutions provided by LSGs and KOICA. U-Report polls on school bullying and digital skills engaged 4,050 youth. 294 parents gained skills in supporting adolescent mental health. 106 early childhood educators worked with 3,000 parents in identifying peace dividers and co-creating solutions.

To increase civic participation in decision-making, the project supported public hearings in drafting the law on youth, the law on the rights of persons with disabilities and the law on equality. Assistance is provided to the Institute of the Ombudsman to monitor access to justice for vulnerable groups and to the National Institute for Strategic Studies to monitor public access to decision-making processes. 176 local representatives capacitated on civic participation in decision-making, while 335 community members engaged to discuss conflict-related issues. A school curriculum on human rights, diversity and civic identity is piloted. 24 reps from the Ministry of Interior capacitated to develop training programs for police officers on conflict prevention and response in multi-ethnic communities.

Based on the analysis of national policies and strategies aimed at social cohesion, the project supports in developing cohesive action plan by synergizing action plans of Civic Identity, Religious Policy, Youth Development, NAP 1325, to break siloes, strengthening I4P and achieving a greater peace impact in long run.

Baseline survey evaluated the baseline situation in 7 target locations across relevant project indicators by disaggregating data by gender, youth, disabled and ethnic minorities.

The project conducted conflict analysis in religious sphere with gender and youth disaggregated data. A matrix of indicators to measure religious situation drafted, also by considering gender and youth dimensions. Youth and women inclusion were a key focus at the local level. Community dialogues on socially relevant topics engaged 335 participants, with 196 women. 122 women representatives of Women's Councils and 125 representatives of active youth trained on civic participation in decision-making. The project engaged youth in identifying peace dividers and co-creating solutions, giving them a platform to actively participate in decision-making. Efforts were made to address specific challenges faced by girls, promoting their active engagement. For example, the project focused on reducing girls' school dropouts – a significant barrier to their education and prospects – through targeted interventions such as mentorship programs, awareness campaigns, tailored support.

In Aidarken in Batken oblast, the targeted youth have established a Young Journalists' Cabinet in their school with the consent of the school administration. This cabinet's objective is to enhance media literacy and fact-checking skills among their peers. During the September 2022 cross-border conflict, local youth effectively countered online hate speech by identifying fabricated images and misinformation. The project participants emphasized the importance of understanding media manipulation, promoting friendship, and peace, exemplified by their use of hashtags such as #tajikpeoplelovekyrgyzpeople and #kyrgyzpeoplelovetajikpeople, and other positive media messages during the conflict.

The project's overall strategy is based on UNDP's Conceptual Framing of Social Cohesion, aimed at strengthening vertical Govt-Citizen relationships and trust and preventing vertical polarization. For this reason, the project pursues to establish Infrastructures for Peace both at central and local levels, so that national stakeholders are enabled to jointly formulate and address the complexity of vertical and horizontal dynamics of social cohesion. Also, the project promotes the decentralized peacebuilding, so that central level institutions and local self-governments are institutionally integrated each other in implementing peacebuilding agendas.

Youth engaged in the project reflected that their parents had little understanding of adolescent mental health. As a result, the project partnered with the Public Foundation "AIDS Foundation East-West in the Kyrgyz Republic" (AFEW) to deliver the non-medical component of the mhGAP (mental health Gap Action Plan) training, which focuses on mental, neurological, and substance use disorders, including suicide prevention. The training module is endorsed by the World Health Organization (WHO) and the Ministry of Health (MoH) of the Kyrgyz Republic. 294 parents received this training, which was delivered by Master Trainers of AFEW, equipping them with valuable knowledge and skills to support mental health and well-being in their children – project participants. Whilst UNICEF covered the cost of this training, the Mayor of Osh has committed 200,000 KGS to continue this training. This initiative contributes to raising awareness about mental health issues and promoting a more supportive and inclusive environment for adolescents and youth facing mental health challenges. This is aligned to the underlying premise of Kyrgyz Jarany – to ensure a society that is tolerant of and inclusive towards all citizens as part of building social cohesion.

Upon adoption of amendments to the Law on LSGs, the entire local self-governance system (there are 484 LSGs throughout the country, thus the whole country) will become institutionally responsible for peacebuilding within their own territories by peacebuilding action planning and resource allocation. On the other hand, the project's policy engagement led to the preliminary agreement to amend the Budget Code by introducing relevant sources of funding. These amendments will have a systemic country-wide change in long run allowing to allocate funds from local budgets of the entire local self-governance system.

The project successfully mobilized approximately \$25,000 in funding. Local self-government bodies in Suzak allocated 70,000 KGS, in Uzgen 100,000 KGS, and in Osh 200,000 KGS, equivalent to 4,300 USD. The Korean International Cooperation Agency contributed 20,000 USD towards implementing youth-led initiatives.

The project promotes improved policy frameworks and institutional mechanisms for strengthening I4P both at centra and local levels. With regards to local peace infrastructures, the project promotes the decentralized peacebuilding by defining sustainable role of LSGs. The project provided expert support to government partners in updating provisions of Kyrgyzstan's legislation, in particular the draft law on youth, the draft law on the rights of persons with disabilities and the draft law on equality, which are currently under consideration in the country's parliament.

The local youth and women led organisation "Youth of Osh" is the implementing partner. The project also collaborates with the Public Foundation "AIDS Foundation East-West in the Kyrgyz Republic" (AFEW) and the Korean International Cooperation Agency.

CSO "Eurasia Foundation for Central Asia" is implementing partner and works to improve the existing methodologies of monitoring of inter-ethnic tensions used by the Public Reception Centers on Interethnic Issues towards making it multi-dimensional to monitor the risks of social cohesion in pilot communities. The result will be explicated to other 23 existing Public Reception Centers.

The project's exit strategy planned to be ensured through improved policy frameworks, institutional mechanisms, strengthened capacities, increased knowledge of both civil society and institutions.

The civic participation of ethnic in decision-making processes is integrated into the law on youth, the law on the rights of persons with disabilities and the law on equality. Youth engagement in decision-making processes and peacebuilding actions are implemented as part of the national program on "Youth and Child Friendly Cities (YCFLG)", with the leadership role of the Ministry of Culture. The ECDs will be owned by the state-funded libraries with strengthened capacities to promote social cohesion among children and parents.

As per approved Project Document, the project aims to strengthen shared and inclusive civic identity through the promotion of a Peacebuilding Architecture that encompasses, governance and accountability, rule of law and human rights, age and gender equality. This aim was planned to be achieved, inter-alia, by clarifying and institutionalizing roles and responsibilities across sectors, strengthening partnership with civil society and community-based organizations, integrating peacebuilding into local level development programming and promoting whole-of-government coordination.

To achieve this goal, the project must address the non-existence of Peacebuilding Architecture, siloes at the central level, scattered and un-coordinated interventions of various national stakeholders. The absence of the role of local self-governance in peacebuilding processes is another challenge.

Secondly, the Output 2 of the project aims to establish a comprehensive early warning and early response system for risk-informed development and conflict prevention. The system cannot be created autonomously without conceptual embedding into broader governance frames – Peacebuilding Architecture, as well as without clear roles and coordination mechanisms between all stakeholders concerned at all levels of governance, including civil society. Nevertheless, the project has made a tremendous breakthrough in promoting a Peacebuilding Architecture through policy engagement and advocacy as described in the foregoing sections, which provide a solid foundation towards the goal. However, the project needs for Non-Cost Extension for an additional six months to ensure that the planned goal is achieved at the maximum possible extent to ensure transformative change in peacebuilding area.
