Amendment No. 2 to the Memorandum of Understanding (MOU) between Participating UN Organizations¹, and

United Nations Development Programme's (UNDP) Multi Partner Trust Fund (MPTF) Office regarding the Operational Aspects of a

Phase II GRZ-UN Joint Programme on Gender-Based Violence in Zambia

WHEREAS, the Participating United Nations Organizations signing this Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations") have developed a Phase II GRZ-UN Joint Programme on Gender-Based Violence in Zambia (hereinafter referred to as the "Programme") starting on 27 November 2019 and ending on 30 September 2023² (hereinafter "End Date"), as may be amended from time to time, as part of their respective development cooperation with the Government of Zambia (hereinafter referred to as the "Host Government"), as more fully described in the Joint Programme Document dated 2 November 2019, document no. 00123699 (hereinafter referred to as the "Joint Programme Document"), a copy of which is attached hereto as ANNEX A, and have agreed to establish a coordination mechanism (hereinafter referred to as the "Steering Committee")3 to facilitate the effective and efficient collaboration between the Participating UN Organizations and the Host Government for the implementation of the Programme;

WHEREAS, the Participating UN Organizations have agreed that they should adopt a coordinated approach to collaboration with donors who wish to support the implementation of the Programme and have developed a Joint Programme Document to use as the basis for mobilising resources for the Programme, and have further agreed that they should offer donors the opportunity to contribute to the Programme and receive reports on the Programme through a single channel;

WHEREAS, the Participating UN Organizations have further agreed to ask UNDP's MPTF Office (which is also a Participating UN Organization in connection with this Programme) 4 to serve as the administrative interface between the donors and the Participating UN Organizations and for these purposes MPTF Office has agreed to do so in accordance with this Memorandum of Understanding; and

WHEREAS, the Participating UN Organizations have further agreed to ask the United Nations Development Programme (UNDP) ⁵, which is also a Participating UN Organization in connection with this Programme, to coordinate the programmatic aspects among the Participating UN Organizations, and (UNDP) has agreed to do so in accordance with this Memorandum of Understanding;

WHEREAS the Steering Committee, on its meeting on 12 September 2023 has agreed to extend the duration of the programme until 31 March 2024.

Accordingly, the Memorandum of Understanding between the Participating UN Organizations and the United Nations Development Programme's Multi-Partner Trust Fund Office (acting as Administrative Agent) is therefore modified as follows:

WHEREAS, the Participating United Nations Organizations signing this Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations") have developed a Phase II GRZ-UN Joint Programme on Gender-Based Violence in Zambia (hereinafter referred to as the "Programme") starting on 26 November 2019 and ending on 31 March 2024⁶ (hereinafter "End Date"), as may be amended from time to time, as part of their respective development cooperation with the Government of Zambia (hereinafter referred to as the "Host Government"), as more fully described in the Joint Programme Document dated 26 November 2019, document no. 00123699 (hereinafter referred to as the "Joint Programme Document"), a copy of which is attached hereto as ANNEX A, and have agreed to establish a coordination mechanism (hereinafter referred to as the "Steering Committee") to facilitate the effective and efficient collaboration between the Participating UN Organizations and the Host Government for the implementation of the Programme;

All other terms and conditions of the Memorandum of Understanding remain unchanged.
