Due to the recent changes in the government, the project team has agreed to hold the first meeting of the steering committee after the establishment of the new government.

In May 2023, Interpeace with its implementing partner and Voz di Paz met with the Youth Institute to define a strategy for the engagement of youth at the regional level avoiding the duplication of efforts. A further meeting has been carried out in October 2023 to engage the new Youth Institute President nominated after the election in June 2023. In the meeting representatives from Interpeace and Voz di Paz introduced some components of the project to the Youth Institute President and set the basis for the collaboration on some key project activities as the evaluation of the National Youth Policy. A dedicated session with the president and the Technicians of the Youth Institute will be held in December 2023 to jointly define the calendar for the evaluation exercise.

From the beginning of the project, UNFPA and Interpeace held different technical meetings to revise and finalise the work plan that was presented in April 2023 to the President of the Youth Institute (IJ). In March 2023, under the framework of the visit of Interpeace Representative to the UN and Interpeace Programme Manager for Youth Peace and Security (YPS) to Guinea-Bissau, UNFPA and Interpeace teams met to discuss their respective approaches to YPS and set the basis for further collaboration on the topic.

The project was officially launched on the 12th of May 2023, in collaboration with the Ministry of Youth and Sports, through a workshop with participation of members of the key government, non-governmental institutions, including the youth networks and associations, academia and private sector. In August 2023, based on a joint reflection and taking in consideration the data collected with the baseline, the project team started a revision of the indicators at the output level which is still ongoing and will be submitted to the PBF Secretariat for approval.

Contracting of Partner: Interpeace and Voz di Paz, Interpeace national counterpart, whose relationship is regulated by a MoU, signed in April 2023 an agreement specific for this project to ensure its smooth implementation.

Staff Recruitment: Finally, while waiting for effective recruitment of a Project Manager and Program Assistant, UNFPA is in process to recruit a National Consultant to support the implementation and coordination of the project. The national consultant will assist in management, monitoring and reporting of project.

The implementing partner supported the Guinea Bissau Programme on how to better frame the work on the National Youth Policy foreseen in the project (output 2.1). Based on this reflection, Interpeace defined the scope of the work and some key points of the methodology for the participatory evaluation of the National Youth Policy. To ensure the continuative engagement of the Youth Institute in the development of the activities under outcome 2, in October 2023, Voz di Paz convened a meeting with Interpeace and the new President of the Youth Institute October 2023. The meeting allowed Interpeace and Voz di Paz to present the work foreseen for the participatory evaluation of the National Youth Policy to the new President and define the Institute's engagement.

As a starting point the project team organised an internal reflection on the Youth Platforms architecture created with PBF project No landa Djuntu between 2021 and 2022. Based on this reflection, between May and June 2023 the team organised 11 assessment meetings in the regions with youths from different organisations and institutions (A3.2.2). The Interpeace Representative to the UN and Interpeace Programme Manager for Youth Peace and Security visited Guinea-Bissau in March to strengthen Interpeace YPS work and support the Guinea Bissau Programme on how to better frame the work on the National Youth Policy foreseen in the project (output 2.1). Based on this reflection, Interpeace defined the scope of the work and some key points of the methodology for the participatory evaluation of the National Youth Policy. After that, Interpeace and Voz di Paz collaboratively developed a Term of Reference (ToR) for a consultant to accompany Interpeace and Voz di Paz in the definition of the methodology for the participatory evaluation of the National Youth Policy. Interpeace has made the ToR publicly available on its website to ensure transparency and attract suitable candidates. The selection of the candidates will be organised in November 2023 and the first workshop for the definition of the methodology is foreseen for January 2024. To ensure the continuative engagement of the Youth Institute in the development of the activities under outcome 2, in October 2023, Voz di Paz convened a meeting with Interpeace and the new President of the Youth Institute October 2023. The meeting allowed Interpeace and Voz di Paz to present the work foreseen for the participatory evaluation of the National Youth Policy to the new President and define the Institute engagement.

As a starting point the project team organised an internal reflection on the Youth Platforms architecture created with PBF project No landa Djuntu between 2021 and 2022. Based on this reflection, between May and June 2023 the team organised 11 assessment meetings in the regions with youths from different organisations and institutions (A3.2.2). Participants were identified using the members' lists of the Youth Platforms created in 2021 integrated by consulting the database of the Youth Associations Mapping carried out by the Youth Institute in 2022 so to include people with disabilities, young women and youth from rural and marginal areas. Along the assessment meetings, 260 people nationwide (of those 125 women and 104 are youth under 25) reflected on the role they could play in governance at the regional level, on the collaboration dynamics they want to create. Along with the assessments, they refine their terms of reference and internal regulations and develop an action plan, in the format of a "Regional Agenda" to identify their priority and the actions they want to carry out. On the 25th and 26th of July 2023, Interpeace and Voz di Paz organised a national gathering of the 205 members of the Youth Platforms (103 men and 102 women) to validate their ToR and finalise and present the different Regional Agendas which received a small fund to allow the implementation of key activities. The implementation of the Regional Agenda started in September 2023. To monitor the implementation and results of the Platforms' activities nationwide, Interpeace and Voz di Paz adapted the Integrated System for Plans and Projects (SIPP) (A3.2.1). In July 2023, 22 members from youth platforms were trained in the Voz di Paz office to collect data on the activities they would have been implementing and, in September 2023, 8 members of Voz di Paz team also were trained to support youth data collection

After a series of meetings (including a presentation of the Integrated System for Plans and Projects in Gabu), an MoU between Voz di Paz, Interpeace and the Project IandaGuiné!Djuntu was signed in May 2023. The MoU includes a financial contribution to this project which will allow the implementation of the action plans developed by the Regional Platforms. This MoU will also contribute to greater synergies between the UNFPA-Interpeace initiative and other initiatives which have been supporting CSOs participation in and monitor of decision making in Guinea-Bissau.

The project sustainability is organised across three main objectives: 1) contribute to the institutionalisation of processes and practices to increase inclusion and representativeness of youth organisations through the capacity building work foreseen under outcome 1, 2) provide solid and substantial policy tools under outcome 2 and 3) to catalyse the capacities and create the conditions for youth playing an active role at the local level. In this framework the project aims to work on reinforcing existing institutions, organisations, dynamics and tools. With a specific focus on the first three months of implementation, the project established its institutional relationship with the Youth Institute, that participated in the framework of the project development of the project and will be the main beneficiary of the work included under outcome 1 and a key stakeholder to ensure the ownership and legitimacy of the products under outcome 2. The project in collaboration with the landaGuiné!Djuntu project, funded by the EU, to build on the online monitoring tools they already created and on the results of the work on the YPS agenda carried out by Interpeace, Voz di Paz, the Youth Institute, the PBF Secretariat and the landaGuiné!Djuntu project. Finally, a first meeting was organised with the Youth Institute to identify possible synergies between the work the project aims to carry out at the regional level and the ongoing process of "Redefinition of the National Youth Council". Further meetings will be carried out with the National Council of Youth (CJNJ) and the National Network of Youth Association (RENA J) to ensure the work of the youth platforms feed the efforts to make the CNJ more capable to represent youth across the country. Based on these reflections, an exit strategy for the work developed under outcome 3 will be drafted ensuring greater sustainability of the action of youth at the regional level. The work to reinforce the capacity of young people (young men and women, including those with disabilities) and institutional stakeholders will contribute to creating an enabling environment for change and consequently ensure the implementation of future actions.

To better navigate the context and enable a peaceful environment for the implementation of the project, Interpeace and Voz di Paz launched a small data collection exercise nationwide to monitor conflict in the pre-electoral phase. The data collected gave the team the possibility to assess the context evolution along the electoral campaign which started in May 2023, allowing the implementation of the activity in a delicate situation. For this purpose, 54 data collectors were trained in Bissau on the 30th of March 2023. The data collected have been analysed and consolidated in a small report that has been shared with other CSOs in the framework of the monitoring of elections and with the National Electoral Commission.

The delivery rate of this project is quite low. This is due to the significant amount of time spent in the preparatory phase for the launch of the project. Furthermore, the slow process of recruiting a project manager and program assistant to accelerate the implementation contribute to the low delivery rate. It is expected that the recruitment of a project manager and a program assistant will help to increase the delivery in 2024.
