2. Reason revision is being requested:

IOM is seeking a revision to its project initially implemented in response to the earthquake in Khoy, based on recent developments and changing needs identified by the National Disaster Management Organization (NDMO). The NDMO has indicated that the requirement for power generators is no longer a priority. The project will therefore mostly concentrate its focus on the delivery of multi-purpose cash assistance in Khoy. Due to delays in the provision of multi-purpose cash assistance, the project will require a longer implementation timeframe to complete all planned activities. The NDMO remained committed to receiving technical assistance, particularly in the form of training focused on a broader range of disaster risk reduction and management topics. Hence, following the conduct of a capacity building initiative for the NDMO, the engagement of a consultant is required to work closely with the NDMO and monitor the application of the concepts covered in the training sessions and support preparedness work for future disaster situations.
