

Addendum 1
to the Memorandum of Understanding
between
Participating UN Organizations
and
the UNDP Multi Partner Trust Fund Office
regarding the Operational Aspects of the Joint Programme
Financing a Green, Inclusive and Sustainable Recovery

WHEREAS, the Participating United Nations Organizations signing this Memorandum of Understanding, the United Nations Development Programme (UNDP), United Nations Environment Programme (UNEP), United Nations Department of Economic and Social Affairs (UNDESA), and the Executive Office of the Secretary-General (EOSG) (hereinafter referred to collectively as the “Participating UN Organizations”) have developed the Joint Programme Financing a Green, Inclusive and Sustainable Recovery (hereinafter referred to as the “Programme”) starting on 01 January 2021 and ending on 31 December 2023¹ (hereinafter “End Date”), as may be amended from time to time, as part of their respective development cooperation, as more fully described in the Joint Programme Document dated December 7, 2020 (hereinafter referred to as the “Joint Programme Document”), a copy of which is attached hereto as ANNEX A, and have agreed to establish a coordination mechanism (hereinafter referred to as the “Steering Committee”)² to facilitate the effective and efficient collaboration between the Participating UN Organizations for the implementation of the Programme;

WHEREAS, the Participating UN Organizations have agreed that they should adopt a coordinated approach to collaboration with donors who wish to support the implementation of the Joint Programme and have developed a Joint Programme Document to use as the basis for mobilising resources for the Joint Programme, and have further agreed that they should offer donors the opportunity to contribute to the Joint Programme and receive reports on the Joint Programme through a single channel; and

WHEREAS, the Participating UN Organizations have further agreed to ask the UNDP Multi Partner Trust Fund (MPTF) Office (which is also a Participating UN Organization in connection with this Joint Programme) to serve as the administrative interface between the donors and the Participating UN Organizations and for these purposes the United Nations Development Programme has agreed to do so in accordance with this Memorandum of Understanding.





The Participating UN Organizations, the Convening Agent, and the Administrative Agent have now agreed to extend this Joint Programme until **31 August 2024**.

¹ This is the date that the Programme is expected to come to operational closure as stipulated in the Joint Programme Document and all programmatic activities are expected to be completed.

² The composition and role of the Steering Committee will be determined in line with the applicable UN rules and policies, and guidance for the Programme, namely the UNDG Guidance Note on Joint Programmes.




