## I. Background

The project was developed to improve capacities of the authorities in both jurisdictions to create more violence-resilient communities through series of closely coordinated activities such as joint trainings and sharing of experience and intelligence, joint analysis and developing problem and risk profiles, information sharing and joint actions in combating converted weapons trafficking. It also aimed at promoting an integrated institutional approach towards dealing with firearms-related threats. Project activities built upon and complemented the ongoing SALW control projects in Kosovo and North Macedonia to achieve synergies, develop best practices and allow for more coherent and result-oriented investigations.

The project intended to reduce and overcome the knowledge and skills gap on SALW detection and investigations, improve the quality of investigations and secure solid and reliable information flow and increase in the number of conviction court cases. It further aimed to examine complexities and inconsistencies in operational structures and working procedures between the two jurisdictions and bring them closer to best European practices in the field. Project results were geared towards directly enhancing the cross-border and inter-institutional collaboration between the two jurisdictions in the field of SALW from the early stage of investigations and improve the capacities of law-enforcement institutions to deal with trans-national arms trafficking threats.

The project rationale was developed and agreed on during number of meetings in Kosovo and North Macedonia with representatives from the interior ministries, police and other law-enforcement institutions. In light of the implementation of the [Roadmap for a sustainable solution to the illegal possession, misuse and trafficking of SALW/firearms and their ammunition in the Western Balkans by 2024](#), strengthening of capacities of law-enforcement institutions in the area of identification and combating SALW, advancing cross-border cooperation and endorsing integrated approach to safety and security issues had been the main topic of these discussions. The need to jointly address the illicit arms trafficking (IAT), which is closely linked with other types of organized crime such as drug trafficking, human trafficking and migrant smuggling had also been addressed.

Hence, the objective of the project was to strengthen cross-border integrated institutional approach in combatting illicit arms trafficking between Kosovo and North Macedonia through increased institutional capacities, improved and shared police practices and information and raising public awareness of the dangers of SALW misuse and trafficking. The project also integrated the role of the jurisdictions' Firearms Focal Points (FFP) in the operational structure of respective police forces in both jurisdictions.

The project was in line with the Roadmap and contributed to the implementation of the respective national action plans in both jurisdictions.

### III. Executive summary

The following represents an overview of the achieved results and implemented activities under this Project, for the period 01 April 2021 – 31 March 2023.

**Output 1:** Strengthened institutional capacities and police officers' knowledge and understanding of illegal possession, misuse and trafficking of SALW through specialized trainings and use of innovative IT tools:

- One **gap and needs analysis report** per jurisdiction was prepared.
- A series of **specialized training sessions** was delivered in line with the needs assessment, enabling **820 police officers** from both jurisdictions (743 men, 77 women) to enhance understanding and knowledge on illegal possession, misuse and trafficking of SALW. More specifically:
  - o 12 trainings on information gathering, information sharing, and information analysis were provided for 420 police officers in total from both jurisdiction, 220 from Kosovo and 200 from North Macedonia (384 men, 36 women);
  - o 11 trainings on weapons categorization and their essential parts, explosives and other handmade explosives, the possession and misuse of firearms and community policing/ILP were provided for 400 police officers in total from both jurisdictions, 200 each jurisdiction (359 men, 41 women).

**Output 2:** Strengthened institutional capacities and improved operational information sharing between North Macedonia and Kosovo law-enforcement institutions in combating trafficking of converted firearms.

- Four **comprehensive trainings on IAT of converted firearms** and a workshop on the topic were developed and delivered enabling **119 law enforcement officers** (75 men, 24 women) to jointly exchange and enhance knowledge and understanding on the subject matter.
- A **Joint Investigative Operation** between police of Kosovo and North Macedonia was prepared and successfully executed by the end of 2022, tackling a potential organized crime group dealing in illicit arms trafficking. This paved the way towards future joint operations and actions.
- Several **knowledge products** were developed and translated into local languages, in addition to the needs assessment and gap analysis for each jurisdiction, including:
  - o Practical Manual on the Investigation of Small Arms and Light Weapons (SALW) on the Internet.
  - o Manual on explosives, handmade explosives, and precursors.
  - o Manual on community policing and intelligence led policing.

**Output 3:** Improved capacities of Cyber Crime Units and Firearms Focal Point (FFP) in dealing with illicit firearms trafficking on the Internet and Darknet.

- A **training on dealing with illicit firearms trafficking on the Internet and Darknet** and a workshop / coordination meeting related to internet investigation procedures and the collection of information through OSINT (open-source intelligence), enabled 27 police officers (10 women and 17 men, 17 from Kosovo and 10 from North Macedonia) to enhance knowledge and skills on the matter.
- Several meetings were held between the focal points for cybercrime investigations in both jurisdictions. As a result of meetings, the hired experts in both jurisdictions prepared the manual on investigating IAT on the internet (Output 2), which was subsequently made available in local languages and disseminated to relevant units.

**Output 4:** Increased outreach and communication to citizens through mass-media and targeted awareness raising campaigns.

- Two **mass media campaigns** and four **targeted campaigns** on the dangers of misuse and trafficking of firearms were carried out.
- Numerous **articles** were published as part of the awareness campaign. Regarding the awareness raising campaign on preventing celebratory shootings, this entailed 104 articles in North Macedonia, and 23 articles in Kosovo.

- Four **border events** have been implemented to raise awareness on firearms misuse among the local populations, two on each side of the border.

*During the joint Project Board Meeting on 5 October 2022, when reflecting on the project achievements, the SALW commissions from both jurisdictions reaffirmed the added value brought by the projects:*

*The Head of the SALW Commission in Kosovo, Mr. Blerim Gashani, considered the joint project as one of the most successfully implemented projects. He praised the work stemming from the project, the good collaboration and the relevant capacity development of police officers in the field. Mr. Gashani emphasized the importance of initiating such a cross-border initiative, having Kosovo and North Macedonia jointly fulfilling the commitments for the implementation of the regional guide, the Regional SALW Control Roadmap. He considered that the successful implementation of this joint project paves the way for future similar cross-border activities.*

### 1. Description of the output

The focus of this output was placed on operations and investigation departments and public prosecutor's offices in Kosovo and North Macedonia and the assessment of their current knowledge on IAT, SALW control, possession and misuse and weapons categorization as well as information gathering and sharing.

### 2. Description of activities implemented

**Activity 1.1.1: Needs assessment and gap analysis in relation to IAT, SALW control, possession and misuse and weapons categorization.**

At the onset of the project, the project teams from both UNDP Country offices collaborated closely with the SALW Commissions in respective jurisdictions to assess institutional needs and identify gaps in human capacity development. To **gap and needs analysis were produced** as a result, one per jurisdiction. Subsequently, project management from both offices convened with the Heads and members of the SALW Commissions to harmonize priorities and determine areas lacking in both jurisdictions, requiring joint capacity building efforts. The identification and customization of training sessions on information gathering, sharing, and analysis, as well as sessions covering weapons categorization, explosives, handmade explosive devices, firearm possession and misuse, and community policing/ILP, proved highly beneficial and contributed effectively to achieving the desired outcomes.

**Activity 1.1.2: Institutional capacity development.**

In 2021, 60 police officers from each jurisdiction (120 in total, 11 women and 109 men) were trained in information gathering, information sharing, and information analysis. In addition, 30 police officers from each jurisdiction (60 in total, 9 women and 51 men) were trained in weapons categorization, explosives and other handmade explosive devices, the possession and misuse of firearms and community policing/intelligence-led policing.

In 2022, in agreement with the police counterparts, the project combined training sessions and one hundred and forty (140) police officers from each jurisdiction (280 in total - 25 women and 255 men) were trained during 7 combined trainings on information gathering, information sharing and information analysis (2-day training) and on weapons categorization, explosives and other handmade explosive devices, possession and misuse of firearms and community policing/ILP (3-day training).

Further to the completed series of training sessions, the project conducted an additional, 12th two-day training session on increasing knowledge on legal framework on SALW control, information gathering, analyzing and sharing for 20 Kosovo police officers (all men), in Pristina, in March 2023. The additional session came upon the request by the project beneficiary and was accommodated by the project team using the available funds within the project.

In these tailor-made training sessions, the community police officers, patrolling officers, border police officers and analysts from Kosovo and North Macedonia increased their abilities on better recognising and learning weapons categorization, legal instruments and framework towards Small Arms and Light Weapons (SALW) control, various types of explosives and handmade explosives and potential precursors and police officers' approach in line with community policing standards and contribution to intelligence-led policing.

### 3. Difficulties encountered, measures taken to overcome the problems, and changes introduced in implementation

Insufficient police personnel from both jurisdictions were available to attend the training due to their heavy workload and existing commitments within the police service. To address the challenge of limited police personnel availability from both jurisdictions, the project team collaborated closely with the beneficiaries to consolidate the training sessions. This approach aimed to minimize travel time, reduce costs, and enhance efficiency, thereby overcoming the constraints posed by the heavy workload and existing commitments within the police service.

Initially the trainings were planned to be held as two separate events (one 2-day and one 3-day training). However, in order to ensure time efficiency and cost effectiveness, it was decided to combine these into five-day trainings that included both topics.

#### **4. Achievements**

Two gap and needs analysis developed, one per jurisdiction, and a series of specialized training sessions delivered in line with the assessed needs. 820 police officers from both jurisdictions (743 men, 77 women) enhanced their knowledge and capacities on illegal possession, misuse and trafficking of SALW.

### 1. Description of the output

The output focused on enhancing operations and investigation departments offices in Kosovo and North Macedonia to improve joint capacities on information gathering, analysing and sharing in the field of SALW control and illicit arms trafficking.

### 2. Description of implemented activities

#### **Activity 1.2.1: Institutional capacity building on converted-firearms investigations**

A total of **3 trainings** were prepared and delivered in 2022 on establishing trafficking routes, integrated use of financial investigation during IAT cases and firearms-conversion methods. In addition, a table-top exercise were held in Kosovo. A total of 76 participants attended the trainings and exercises, 39 (32 men and 7 women) from North Macedonia and 37 (32 men and 5 women) from Kosovo.

A **separate workshop** on converted weapons was held in North Macedonia for 18 police officers (7 women, 11 men), 10 participants from North Macedonia (5 women and 5 men) and 8 participants from Kosovo (2 women and 6 men).

As a result of the successful trainings and positive feedback from the police forces in both jurisdictions, a **fourth training** on converted firearms was organized in Kosovo in Q1 2023, for 25 police officers (20 men and 5 women) from both North Macedonia (10, 9 men and 1 woman) and Kosovo (15, 11 men and 4 women).

#### **Activity 1.2.2: Formation of JIT for converted-firearms investigations**

Creating JITs as foreseen became very complex and impossible to implement due to different legal frameworks and changes and legal procedures required on establishing JITs in both jurisdictions. In order to establish JITs between Kosovo and North Macedonia, it is required to conduct legal framework analysis and legal amendments respectively harmonization in both jurisdictions to enable the formation of JITs. Therefore, instead of undergoing legal framework revision and potential amendments and approval by the governments in both jurisdictions and respective assemblies, in consultation with SEESAC's Chief Technical Advisor (CTA) and in close cooperation with beneficiaries in both jurisdictions, this activity was adjusted into a Joint Investigative Operation.

The **Joint Investigative Operation** between Kosovo Police and North Macedonian Police was conducted in November-December 2022, to tackle a potential organized crime group dealing with illicit arms trafficking.

#### **Activity 2.3: Development of knowledge products**

The following knowledge products were produced as cross-cutting results stemming from project activities:

- o Two Needs Assessments and Gap Analysis Reports in both jurisdictions;
- o One practical Manual on the investigation of small arms and light weapons (SALW) on the internet;
- o One Manual on explosives, handmade explosives, and precursors;
- o One community policing and intelligence led policing manual.

These will serve as a continuous resource to police officers.

### 3. Difficulties encountered, measures taken to overcome the problems, and changes introduced in implementation

The difficulty to organize a JIT as planned was overcome by adjusting the format into a Joint Investigative Operation. The Joint Investigative Operation enabled mutual learning of police from both jurisdictions. The more complex JIT will necessitate an adjustment in the legal and operational frameworks, and a more comprehensive preparation.

As a result of the successful organisation of the trainings, positive feedback from the police forces in both jurisdictions as well as the availability of funds, it was decided in close consultation with SALW Commissions from both jurisdictions to organise a fourth training on converted firearms, to take place in Kosovo in February-March 2023.

#### **4. Achievements**

Through a series of 4 trainings and a workshop on converted firearms, 119 police officers (95 men, 24 women) from both Kosovo and North Macedonia, representing border police, investigators, community policing and traffic police officers from the police authorities in both jurisdictions- 59 from North Macedonia (46 men, 13 women) and 60 from Kosovo (49 men, 11 women). The average satisfaction rate of received feedback was 96,86%.

## 1. Description of the output

This output contributed to enhancing capacities and resources of Cyber Crime Units and Firearms Focal Point (FFP) in dealing with illicit firearms trafficking on the Internet and Darknet. It supported the development of a guidance and measures, and enhancement of skills which should be taken by an investigator in online/darknet investigation, thus addressing a lack of Administrative Instruction which regulates the investigation process in Internet/Darknet.

## 2. Description of implemented activities

### **Activity 1.3.1: Development and harmonization of the operational procedures in Kosovo and North Macedonia**

The project developed a Guidance Manual on Investigation of Small Arms and Light Weapons on the Internet. A training on Investigation of Small Arms and Light Weapons on the Internet was held in Skopje, using the developed Guidance. It was attended by a total of 19 participants (representing cyber-crime units, FFPs and community policing and crime prevention officers), 7 women and 12 men.

Also, a training / coordination meeting related to internet investigation procedures and collection of information through OSINT was organized in Kosovo with 8 participants (3 women and 5 men) from Kosovo Police Investigation Department, ILECU.

## 3. Difficulties encountered, measures taken to overcome the problems, and changes introduced in implementation

Initially, the project document envisaged engagement of one local consultant. However, due to the specificities in both jurisdictions and Ministries of Interior, it was decided to contract two local consultants, one per jurisdiction. The consultants worked together on preparing the documents and materials as per ToR.

## 4. Achievements

Trained 19 police officers (7 women and 12 men), 10 from North Macedonia and 9 from Kosovo, on a novel topic, namely investigation of small arms and light weapons on the internet. The prepared Guidance Manual will serve as an important knowledge product for future use by the authorities in both jurisdictions. In addition, enhanced skills and understanding of 8 Kosovo Police staff related to internet investigation procedures and the collection of information through OSINT (open-source intelligence).

## 1. Description of the output

This output aimed to increase public awareness of the risks posed by SALW in Kosovo and North Macedonia with special emphasis on the communities along the border. To this end, mass media campaigns were carried out to provide a wide coverage and produce positive changes and/or prevent negative changes in firearms-related behaviours across the population in both jurisdictions. In coordination with other activities related to cross-border illicit trafficking of firearms, smaller targeted awareness-raising campaigns were conducted as well, for communities along the illicit firearms trafficking routes.

## 2. Description of implemented activities

### Activity 2.1.1: Improving public awareness through campaigns and visibility events

The project organized a targeted campaign per jurisdiction, focused on the dangers of celebratory shootings during weddings in the summer period. Leaflets and other promotional materials were distributed to citizens by police officers, in close cooperation with the Ministry of Interior.

The project contracted a marketing agency in 2022 to implement the public awareness campaign. The communication activities were planned and implemented in close consultation with beneficiaries of both jurisdictions. The campaign was launched in October 2022, and it targeted celebratory shootings related to New Year's Eve holidays.

The campaign activities included development of a communication strategy, opening events with travelling exhibitions, production of communication materials (video, radio, web banner, posters, flyers, TV, radio and web media buying etc.) and organisation of targeted border events in both jurisdictions.

Below is a brief outline of the events organised as part of the awareness raising campaign:

- 06 October 2022 – Opening event with travelling exhibition, simultaneously in Kosovo and North Macedonia;
- 28 October 2022 – Border Event in Slupchane, North Macedonia
- 15 November 2022 – Border Event in Tearce, North Macedonia
- 09 November 2022 – Border Event in Gjilan/Gnjilane Municipality, Village Zhegër/Zegra, Kosovo;
- 17 November 2022 – Border event in Hani i Elezit Municipality/Village Gorancë/Gorance, Kosovo;

In addition to the aforementioned efforts, a distinct online campaign focusing on raising awareness about the danger associated with fireworks and pyrotechnics was organized in December 2022 for both jurisdictions. This campaign aimed to educate the public about the potential risks and safety precautions associated with the use of fireworks, especially during festive seasons. Through various digital platforms and targeted messaging, the campaign sought to promote responsible behaviour and reduce the incidence of accidents and injuries related to fireworks usage. By engaging with communities online, the initiative aimed to foster a culture of safety and accountability, encouraging individuals to prioritize their well-being and that of others during celebratory events.



## 4. Achievements

Overall, the project successfully completed two mass media awareness raising campaigns (one in each jurisdiction) and four targeted campaigns (two in each jurisdiction) on the dangers of the misuse and trafficking of firearms with

more than 1.3 million registered social media views and more than 8 million social media impressions. The campaigns were highly praised by the project beneficiaries in both jurisdictions and received excellent visibility by the targeted audiences.

## V. Monitoring and Evaluation of activities

Numerous joint capacity development activities were organised for law enforcement from both jurisdictions within this project. The attendees submitted surveys and evaluations regarding their assessment of the trainings, which provided a very high level of average satisfaction of 93,73%. The project team took part and was actively engaged in the sessions and monitored directly the training and gathered relevant feedback.

The progress was monitored regularly and reported to the Trust Fund Secretariat on a quarterly basis and more comprehensively on an annual basis, including contextual analysis, challenges, risks and opportunities. The progress was also presented and discussed with the Steering Committee members after the project's end, at a Steering Committee review meeting that took place in December 2023. The SALW Commission Heads from both jurisdictions – Mr. Blerim Gashani and Mr. Arif Asani - also took part in the December review session of the Steering Committee and provided positive assessment of the results and cross-cutting benefits that the project has brought to the jurisdictions, including through setting a good practice of cross-border collaboration and peer exchanges through joint learning sessions, which jurisdictions plan to pursue further.

## VI. Coordination with relevant stakeholders - Partnerships

Through the organisation of trainings for police officers from both jurisdictions, the project further strengthened the good cooperation and collaboration between the Ministries of Interior of both jurisdictions and their agencies, as well as the UNDP teams from both Country Offices. This established cooperation presented a valuable asset for the implementation of further cross-border projects in the jurisdictions.

The joint project facilitated the establishment of a robust and enduring partnership with the Kosovo Academy for Public Safety. This collaboration has been instrumental in conducting numerous joint capacity development sessions aimed at enhancing skills and knowledge within the relevant sectors such as SALW control, ammunition, explosives, community policing, & ILP, weapons categorization, etc. Moving forward, we plan to leverage this partnership for similar future activities, ensuring the continued effectiveness and sustainability of our endeavours in advancing capacity building initiatives and promoting excellence in public safety practices.

## VII. Sustainability

Since the project was implemented jointly in both jurisdictions, a Joint Project Board meeting was held in Prevala, Prizren, Kosovo, that was attended by representatives of UNDP, the police authorities and representatives of the donors from both jurisdictions. The Presidents of both SALW Commissions expressed their satisfaction with the project results and declared their commitment to designing and implementing further cross-border initiatives in the field of combatting illicit arms trafficking with UNDP North Macedonia and Kosovo. During these meetings, it was acknowledged that the sustainability of the excellent results achieved through this project can be guaranteed through implementing a second phase of the project in cooperation with the police authorities of both jurisdictions.

The sustainability of the capacity development activities on SALW control, ammunition and explosives management, converted firearms handling, community policing, and ILP, implemented for law enforcement agencies in Kosovo and North Macedonia through the joint project, is multifaceted and integral to the long-term success of the initiative.

Firstly, the project prioritized the establishment of comprehensive training programs tailored to the specific needs and challenges faced by law enforcement personnel in both jurisdictions. These programs not only equipped officers with essential skills and knowledge but also fostered a culture of continuous learning and professional development within the agencies.

Secondly, the project emphasized the importance of institutional capacity building by working closely with relevant government bodies, such as the SALW Commissions, to strengthen regulatory frameworks, enhance coordination mechanisms, and promote sustainable practices in arms control and community policing efforts. Additionally, the project successfully bolstered local ownership and sustainability by engaging with community leaders, religious leaders, and other stakeholders to ensure the effective awareness raising implementation regarding SALW Control and prevention of firearms misuse and long-term impact of the capacity development activities.

By fostering collaboration, promoting institutional resilience, and empowering local stakeholders, the joint project managed to create significant advancements in SALW control, community safety, and law enforcement capabilities in Kosovo and North Macedonia.

## VII. Update on risks and mitigation measures

Some of the risks identified during the planning phase have materialised, such as the risk of delays as a result of ineffective coordination between institutions, organisations and authorities, the political instability in both jurisdictions and the unavailability of police officers due to overload of professional engagements. As a result of this, two no-cost extensions of the project were requested, whose approval enabled the full achievement of planned objectives.

A new risk was added in 2022, namely the lack of resources and institutional capacities for project implementation by project beneficiaries. The risk occurred during the project implementation, causing delays in the execution of plans. The project teams assessed the need for extended timeframes for effective project activity implementation.

Furthermore, the risk of sustainability of results was raised. Although the participants at capacity development activities have shown a high level of interest and engagement, there is a risk that such activities may not be continued by the respective Ministries following the end of the project, due to lack of finance and human resources.

The exchange of best practices and experiences between law enforcement agencies from both jurisdictions fostered mutual learning and strengthened relationships, creating a supportive environment for ongoing cooperation. This peer-networking not only facilitates knowledge sharing but also builds trust and camaraderie among officers, enhancing their motivation and commitment to implementing the acquired skills and strategies.

Moreover, the continuous engagement of project stakeholders, including UNDP Country Offices in Kosovo and North Macedonia, government agencies, and local partners, serves as a crucial mitigation measure against potential challenges or setbacks.

Thus, through this cross-border collaboration between Kosovo and North Macedonia, peer-networking, and ongoing engagement, the joint project managed to mitigate risks and ensure the enduring impact of its capacity development activities in advancing SALW control and community safety in both Kosovo and North Macedonia.

The project team is working with relevant stakeholders in both jurisdictions to ensure adequate continuation of capacity building activities in future.

## **VIII. Lessons learnt**

A key project success was the successful completion of a total of 11 trainings, 7 combined trainings on information-gathering and weapons categorisation, and 4 trainings on converted firearms. The close coordination by the project teams resulted in successful implementation of all project activities, as well as in extending the cooperation between the two UNDP offices, which can be further developed by cooperating on other joint projects in the future and replicated as a good practice in the region.

As a crucial recommendation to improve future programming, it is necessary to envisage a longer implementation period for projects which entail a large number of activities including numerous stakeholders from two countries. The experience shows that cross-border projects require a stronger coordination between the involved parties, in order to ensure timely and sustainable achievement of project results. However, the results that arise from cross-border projects are beneficial not only to the jurisdictions involved, who share their positive experiences and knowledge, but also serve as an excellent examples to other signatories of the Roadmap.

## **IX. Communication and visibility**

The joint cross-border project between Kosovo and North Macedonia demonstrated the strategic utilization of effective communication channels, through using UNDP's channels and particularly through leveraging of social media platforms owned by the project partners and beneficiaries. By tapping into the existing channels and multiplying messaging, the project teams ensured widespread dissemination of information regarding each activity undertaken as part of the initiative. Through regular updates and posts, the aims, objectives, and outcomes of each activity were articulated and elaborated upon, allowing for increased transparency and engagement with stakeholders, including local communities, governmental bodies, and donor organizations. This approach not only facilitated greater awareness and understanding of the project's progress and impact but also encouraged active participation and feedback from the target audience, thereby fostering a sense of ownership and accountability among all stakeholders involved.

Furthermore, the communication strategy strategically emphasized the role of donors in enabling the implementation of the project activities. By highlighting the support and contributions of donor organizations within the Western Balkans SALW Control Roadmap MPTF, the project team underscored the collaborative nature of the initiative and the collective effort required to address the complex challenges of SALW control, community policing, and capacity building in the region. This transparent acknowledgment of donor support not only enhanced the credibility and legitimacy of the project but also served to inspire confidence and trust among stakeholders in the project's objectives and outcomes.

Moreover, by effectively communicating the impact of donor funding on the ground, the project teams aimed to reinforce the importance of continued support and investment in similar cross-border initiatives aimed at promoting peace, security, and sustainable development in Kosovo, North Macedonia, and beyond.






