The Project Steering Committee (PSC) which provides strategic oversight of the project has met once, on 13 May 2024. This PSC is co-chaired by the UN RC and Ministry of Human Rights and Refugees of Bosnia and Herzegovina (BiH). The PSC includes representatives from relevant national level ministries (Ministry of Human Rights and refugees BiH, Ministry of Defence BiH, Ministry of Security BiH and Ministry of Civil Affairs BiH), entity-level ministries (Ministry of Family, Youth, and Sports of Republika Srpska (RS), Ministry of Health of the Federation of Bosnia and Herzegovina (FBiH) and Ministry of European Integration and International Cooperation of RS), civil society organization (CSO) representative (Foundation "Lara" Bijeljina representing women BiH wide CSO's peace network "Peace with Women's face") and UN Women, UNFPA and IOM representatives. Diverse expertise and perspectives of PSC members ensure comprehensive decision-making and effective implementation strategies. By including these representatives from various sectors, the project will benefit from a more holistic approach and foster collaboration and synergy among stakeholders.

Looking ahead, continued engagement and cooperation among members are vital for the project's success in achieving its objectives. The engagement of relevant parties from both entities and the state level ensures equal representation of political actors able to foster an atmosphere of cooperation and overcome potential political obstructions to the project activities and potential results due to the challenging topics that will emerge throughout the process.

Over the past six months, the project has initiated negotiations with the Ministry of Human Rights and Refugees of Bosnia and Herzegovina to establish a partnership aimed at supporting capacities, collaboration, and coherence in the national and local level implementation of the Women, Peace and Security Agenda. The Ministry of Human Rights and Refugees of Bosnia and Herzegovina has been chosen as a partner due to its extensive experience in implementing interventions related to the WPS Agenda in BiH, collaborating with international organizations, developing legislative and policy frameworks, and promoting women's leadership in peace and security initiatives. This partnership is crucial for the successful implementation of our project over the 36-month project and will be finalized in in the next quarter.

Based on the joint UN approach to partnership, implementing agencies have ensured the cooperation with the key governmental stakeholders through their participation in the Project Steering Committee which will provide strategic oversight of the project.

To strengthen the healthcare sector in its response to gender-based violence, a strategic partnership with the entity ministries of health was successfully negotiated. Both ministries of health in the Federation of Bosnia and Herzegovina and the Republika Srpska had extended their institutional support for the project, approved the action plan for project activities and nominated team members. Activities will advance health and psychosocial services for survivors, also including conflict-affected and marginalized women. This commitment of healthcare institutions is telling given that it was extended during the period of increased femicide and an unfavorable political environment for improving the framework for survivors of gender-based violence. It speaks of recognition of the project's timely area of intervention. Several activities were implemented in May with continuous institutional support.

Key updates include progress in selecting and initiating contracts with the Implementation Partner, the Ministry for Human Rights and Refugees of Bosnia and Herzegovina (through the Agency for Gender Equality of Bosnia and Herzegovina), with a focus on maximizing their credibility and legitimacy in supporting capacities, collaboration and coherence in national and local level implementation of the WPS agenda. The process is partially completed. This contract is crucial because through the continuous consultation and establishment of working and consultative mechanisms such as the Women, Peace and Security Steering Committee, we aim to overcome the challenge that arose from the withdrawal of the Republika Srpska representatives from the implementation of the previous Women, Peace and Security National Action Plan. Through this partnership and other project mechanisms, the goal is to involve representatives from Republika Srpska in the implementation process of the next National Action Plan and thus create preconditions for achieving better results in the domain of peacebuilding and social cohesion through country-wide coordinated efforts.

Staff recruitment has been mostly completed in all three agencies, with 13 out of 16 positions recruited. UNW has filled two positions: Project Assistant and Field Coordinator. Currently, the recruitment process is underway for two positions: Programme Coordinator and Outreach Coordinator. This process is expected to be completed in the next quarter. IOM is in the process of finalizing the recruitment process for the Project/Grants Assistant, and UNFPA has completed recruitment for all staff.

A selected company has conducted research for the baseline study and has submitted two draft reports by May of 2024. The baseline study focuses on comprehensively examining the implementation of the Women, Peace, and Security agenda in Bosnia and Herzegovina and mapping key human security concerns faced by women in local communities. The final version of the study will be completed in the next quarter. However, based on the preliminary findings and identified vulnerabilities of women and communities, the project team developed an approach to fieldwork, community mapping, and organizing networking events. This approach aims at identifying issues and partners, which will be applied in the next quarter through intense field and local community work. Designing such an approach was necessary due to heightened tensions surrounding the adoption of the Srebrenica Genocide Resolution and the upcoming local elections in October. These political challenges underscored the need for a systematic approach to intervention through which the project will ensure success and effectively target interventions in communities most in need.

Project Steering Committee established: One of the main outcomes was their determination for the Project to build upon previous successful results achieved through various initiatives, to avoid overlap and maximize available resources - human, material, and time. This demonstrates maturity and creates conditions for utilizing the momentum to address challenges within our society, with a focus on peacebuilding and overall human security.

Baseline Study on WPS Agenda Implementation in BiH: Preliminary results of the Baseline Study were presented at an event gathering representatives of women's and youth civil society organizations for feedback. This participatory verification demonstrated the usefulness of the research by showing how it will provide new data to enhance the success of future interventions. Study results indicate that people feel least safe in traffic, on streets, and public transportation. Forms of violence that are perceived to be most prevalent in communities are domestic violence, sexual harassment, and sexual violence in the online space. Regarding women participation in decision making process at the local level, many survey participants are unsure whether women participate in meetings and assemblies or serve as members of local councils.

Identification of Beneficiaries The of baseline study guided the selection of 13 regions and community assessment is conducted gradually starting from June 2024 until the end of the year, with engaging communities through community dialogues. Initial discussions with key stakeholders will be held in communities less likely to undergo political changes after the elections and those not directly affected by the UN resolution on Srebrenica Genocide Remembrance Day, yet facing challenges that classify them as vulnerable according to our criteria (such as compromised social cohesion and human security). With this strategy, we aim to facilitate the project implementation in communities most in need of interventions.

Creative Industries Mapping: two parallel processes commenced to map non-traditional WPS partners. Agencies identified IPs from the creative industries sphere, and initiated negotiations with Sarajevo Film Festival, Al Jazeera Balkans, Female Art Rising, Sarajevo Photography Fest, and Festival WARM1. Additionally, call for companies was open to map additional non-traditional actors in communities with the aim of connecting them with traditional and larger non-traditional actors.

Strengthening capacities of the healthcare sector to deliver increased and inclusive services for conflict-affected and marginalised women:

- a) Training for healthcare providers in the FBiH on clinical management of rape with 24 participants attending. Participants are better capacitated to provide survivors-centred services. Integrative knowledge framework included an array of key factors of clinical treatment and spans from introduction to human rights-oriented approach towards protection for survivors of GBV, procedures for medical examination of survivors, specialist medical examination procedure, survivor-centred approach towards taking medical history and providing assistance for further support.
- b) Training on provision of integrated response to gender-based violence for first points of contact in the system, i.e. nurses, psychologists, social workers. Participants are now better equipped with knowledge of referral mechanisms and services available for survivors that they are obliged to provide survivors with. There were 19 participants in attendance.
- c) ToT on referral mechanisms and service provision was organised in the Republika Srpska for health care and social welfare providers. The main objective was to ensure transfer of knowledge to first point of contact for survivors of gender-based violence. These individuals will in the following period take part in further educations in their communities with aim of achieving sustainability in standard of provided services. 19 participants took part in the training.

Amplifying voices of women in public space: Workshop held for representatives of media and students of journalism in the Republika Srpska in collaboration with the Radio Television of Republika Srpska and Uni of Banja Luka. Follow up session will be in September. Some of the stories had been produced and can be found here.

Building the capacity of CSOs to support the survivors of CRSV and marginalised women: Established cooperation with CSO "Snaga zene" whose work will commence in June. Activities aim to strengthen organisation capacities and sustainability to provide psychosocial support and services, and to support partnerships with non-traditional stakeholders to promote linkages with WPS agenda.

Partnerships with non-traditional stakeholders: To stimulate social awareness and bring attention to aspects of WPS agenda, partnership with cultural and academic institutions had been established and innovative. The objective of this partnership is to support the establishment of diverse platforms, utilize various tools, and engage different voices in promoting a culture of peace. This includes fostering non-discriminatory narratives, trust, and cross-community collaboration, and advocating for the advancement of the WPS agenda.

Weekly project team meetings involve joint planning, dialogue, and addressing challenges. The collaboration produced results at the project launch event in mid-May, gathering key stakeholders and fostering intersectoral dialogue on BiH 's WPS agenda and ways to enhance peace and human security through the project. The event received media coverage, and the interagency project team demonstrated how coordinated efforts can lead to successful events, with each agency contributing its part, achieving the common goal in solidarity.

As the project itself focuses on gender equality and women's empowerment, additional efforts have been made to ensure the identification and representation of the needs of young women, especially in terms of their representation within the communities and decision-making processes. By respecting project's goal of building social cohesion, the project team adopts a comprehensive collaborative approach throughout the preparatory processes. In this regard, close collaboration has been established with the United Nations regional initiative 'Youth 4 Inclusion, Equality & Trust'. In the initiation process of our project, further analysis was undertaken, incorporating findings from the regional research initiative titled Voices of Youth: Gender Equality and Social Cohesion in the Western Balkans. This collaborative endeavour provided valuable insights for enhancing the engagement of young women at the grassroots level. By utilizing the outcomes of the regional project, we have gained a deeper understanding of community dynamics, enabling us to tailor our activities more effectively. These findings were presented at an event alongside the presentation of preliminary baseline results, demonstrating our collaborative approach and facilitating the dissemination of collective insights to Civil Society Organizations and other stakeholders.

The change brought about by the capacity-building workshop for media representatives and students is evident in the participants' increased understanding of the role of media in shaping public discourse, particularly regarding women's representation in Bosnia and Herzegovina. By gaining practical skills in ethical reporting methods during the workshop, participants are now better equipped to address issues relevant to women in their society through media content. This newfound knowledge and skill set prompt participants to take action by producing more media content focused on localizing the Women, Peace, and Security agenda in Bosnia and Herzegovina. Thus, the applicable change is a shift towards more informed and responsible media coverage that contributes to greater awareness and understanding of women's issues within the context of peace and security efforts in the region.

Healthcare professionals, who are identified as the first point of contact in the healthcare system, have undergone training and are now better equipped to provide survivor-centered services as part of their response to gender-based violence. Despite the existence of ethical standards and referral mechanisms established by the Ministry of Health in both entities, the delivery of services has often been inaccessible and of varying quality due to various factors, including existing stereotypes, stigma, and a lack of knowledge and soft skills in treating survivors. Through stakeholder identification and collaboration, several areas of intervention have been identified as particularly crucial, including services for survivors of conflict-related sexual violence and war torture, support for children who witness gender-based violence, and the improved mainstreaming and integration of referral mechanisms.

Project Team Meetings and maintaining regular communication and feedback between all project partners
• Regular weekly updates on project activities implementation, which included planning the next steps, identifying possible delays and strategies on how to adequately prevent or address them, and monitoring the pre-identified risks, as well as new potential risks, and ensuring that proposed mitigation/treatment plans are still relevant. In total, 17 regular staff meetings were held in the period from February to June of 2024, attended by all the relevant staff from UNW, UNFPA, IOM and RCO.
• Additional planning and coordination sessions aimed at defining and finalizing community visit schedules aligned with other project activities and obligations – two meetings were held during May 2024 by the field project staff, and the first visits were scheduled in the week of 3rd to 7th of June.
Baseline Study Planning and Monitoring
• The Baseline study was conducted by the externally contracted service provider. The aim of the study was twofold: to assess the effectiveness of policies, strategies, and National Action Plans (NAPs) related to the Women, Peace and Security Agenda in Bosnia and Herzegovina, with a specific focus on identifying meaningful changes in policy development and implementation, and to map key human security concerns faced by women in local communities. 6 meetings were held in the period from February to April of 2024. In addition, one presentation on key findings was held on 30th of April.

Baseline data for outcome indicators are planned to be collected as part of the Evaluability Assessment. This assessment will be carried out by an externally engaged agency responsible for conducting the project's external evaluation. The key tasks of the external evaluators will include assessing the evaluability of projects' Theory of Change and indicators in place, assessing already available baseline data, and collecting missing data necessary to feed into the projects' Framework. In addition, the evaluators will assess relevance and appropriateness of existing M&E systems and tools that Agencies (UN Women, UNFPA and IOM) have in place. As part of the Baseline Study, an online survey and focus group discussions were conducted. The primary objective was to gather insights and identify trends that could inform future programming and research in the area of women, peace, and security within Bosnia and Herzegovina. The survey results indicate that despite the presence of improved legal frameworks, the participation of women in decision-making roles in Bosnia and Herzegovina remains low. This hinders the comprehensive integration of the Women, Peace, and Security (WOMEN, PEACE AND SECURITY) agenda. Furthermore, the implementation of the WOMEN, PEACE AND SECURITY agenda varies across different governance levels, impacting its overall effectiveness. The human security concept, included in the Action Plan 1325 of Bosnia and Herzegovina, is not fully developed, and there is a lack of data on women's human security challenges in Bosnia and Herzegovina. Civil Society Organizations (CSOs) are recognized as key stakeholders in supporting the implementation of the 1325 Action Plan. However, their role in monitoring and reporting remains unclear, implying that the existing expertise, resources, and networks of the CSOs are not being fully utilized. The identified issues will serve as the central focus of advocacy efforts and form the basis for all interventions planned throughout the project implementation. The collected data will be used to set baselines and targets for outcome-level indicators, especially for Outcome Indicator 1a (The extent to which women-led CSOs are actively participating in the structures and processes for the implementation and localization of the WOMEN, PEACE AND SECURITY agenda) and Outcome Indicator 1c (Addressed gaps identified during the implementation of the WOMEN, PEACE AND SECURITY Agenda in the country by the project).
