Justification: Please provide a detailed justification to support your project revision request.

The construction of the 200 –Bed female accommodation at Shai Hills suffered serious delays as a result of the poor bearing capacity of the soil at the site. A major variation on the project was ordered. The substructure had to be redesigned after construction started. This situation was further exacerbated by serious rains which slowed down work and made access to the site difficult. The contractor lost about 3 months as a result of these challenges experienced on site. These challenges were communicated in earlier reports.

Some additional works (additional washrooms, additional staircase), were also ordered on site which were not captured by the original project document but are essential for the functionality of the accommodation.

The Project is currently about 90 per cent complete. It is expected that the Accommodation Block will be completed by mid of September and handed over by the end of September.

The cost of the variations, additional works, delays and the fluctuations resulting from the general economic situation are projected to cause an increase in the project cost.

There will be the need to move funds in between the budget lines due to inflation and exchange rate fluctuations leading to an overspend in respect of the Shai Hills project. This will however not affect the overall project budget as the difference will be funded with savings from the other budget lines
