Part C) Justification

The BRIDGE Joint Programme is currently on track and is scheduled to complete implementation by the project closing in April 2023. However, there is still a final independent evaluation to be conducted. Therefore, the BRIDGE JP would like to request a revision in project duration to allow for quality final evaluation of the programme.

According to the evaluation TOR and proposals received, a minimum of 35 working days is necessary to accomplish the evaluation with the expected high quality and accuracy. The BRIDGE JP explored possible reduction of the timeline with the best candidate, however, the team received feedback that it is not possible to compromise the timeline for a quality evaluation. It is also necessary to take into consideration the likely delay due to the Holy Week (3-7 April), which is one of the most important holiday seasons in the Philippines as it would be challenging to engage with external partners, particularly the Government. As BRIDGE is still in the process of selection of the evaluator, a 2-month extension is requested to complete a robust evaluation.
