No change will be required in the Joint Project <u>budget by Outcome</u>, <u>Output and Activities</u>. The changes will occur in the Joint Project budget by <u>UNDG budget categories</u> due to re-allocations among UNDG categories for PUNO 2 (UNHCR) to align them as per new UNHCR's implementation modality (direct implementation and implementation through partnership agreements) as UNHCR accounting/budgeting system has changed and UNHCR accounting system now differs from the originally determined division in the UNDG categories when the project was developed and awarded (link between UNHCR internal budget/expense account and UNDG expense categories).

Therefore, discrepancies can be noted in the UNHCR financial reports among UNDG budget categories. With this request for the revision, JP would like to align UNHCR accounts with UNDG categories in the Joint Project document and budget and in the total JP budget division per categories. In particular, category 2. Supplies, Commodities, Materials will be decreased for 23% in comparison to original budget; category 4. Contractual services will be decreased for 12%; category 6. Transfers and Grants to Counterparts will be increased for 86%; and category 7. General Operating and other Direct Costs will be increased for 11% in comparison to the original budget. All other categories including the Sub-Total Project Costs, Indirect Support Costs and the Total budget will not be changed.
