#### **Part C) Justification**

Taking into consideration the complex context in which the project implementation was initiated (late project launch, increasing cases of COVID-19 and resulting mobility restrictions and planning many activities in short time and lengthy process of procurement procedures), the duration of the project was extended. The project "Empowerment of 'Families left behind' for improved Migration Outcomes in Khatlon" awaited for over seven months the green light from the Tajik government to initiative implementation. This was resolved with the issuance of a Note Verbale by the Ministry of Foreign Affairs on 14 June 2021, providing formal authorization to start implementation of the joint programme. The Steering Committee took note of the unfortunate delay but, in light of the positive development, it decided to allow for an immediate start of the joint programme and granted a 7 months no-cost extension. The start date of the programme remains unchanged because, in line with the Migration MPTF rules and procedures, it is determined by the date the funds were transferred by the UNDP MPTF Office to the participating UN organizations. In the case of the project, it is 28 October 2020. Accordingly, given that the joint programme was approved with a 24 months durations, it was originally scheduled to end at the end of October 2022. However, since the Steering Committee granted a seven month no cost extension, the end date is now pushed back to May 2023 (logically May 28, 2023).
