#### 3. Reason revision is being requested.

#### 3.1 Please indicate the reason for the revision.

The work plan of the Joint Program "Advancing the Creation of a Favourable Environment for the Recognition of Persons with Disabilities as Rights Holders and Active Members of Society" has been impacted due to the challenging social-political context that the country has faced since June 2022, which has affected at crucial moments, the receptiveness of the authorities, particularly of our most direct partner (SENADIS), to carry out the coordination and prioritization of the planned activities of the program. Social protests of June- July 2022 and the current nationwide crisis since October 2023 and the general context have hindered progress in the work with counterparts and impeded the development of activities with Organizations of Persons with Disabilities (OPD) due to mobility and travel restraints.

There is currently an atmosphere of instability, characterized by massive public protests of national character with escalating violence. According to OHCHR's monitoring, a mining contract was approved by law on October 20th, which allows for a Canadian company to continue operating a copper mine in Panama. 1159 protests and road closures have been registered, including 116 riots/violent confrontations (10% of the total events), with a balance of four persons dead, 57 civilians and 39 police officers injured.

For more than a month, street blockades have continued throughout the country and are having an impact on almost every aspect of people's lives, notably on food distribution, access to health centres; this situation has prevented the mobilization of the country's active forces, such as private sector organizations (e.g., local, service providers, among others) as they have been affected by the climate of instability. This has also implied a change of priorities and sense of urgency of the project's key government stakeholders, who are currently more focused on dealing with this crisis.

It is also important to mention that the project has confronted challenges due to the lack of available technical specialists (in some areas) at the national level, which has forced us to manage these processes externally (internationally), leading to delays and impacting many activities that are interconnected due to the nature of the program. An example is the second round of calls for consultancies related to Planning, Budgeting, and Accountability activities with a gender and inclusion approach, whose delayed selection has impacted the project's roadmap.

In addition to the above, the country's activities between November and December involve several days off for government institutions and the private sector, limiting the options for changing or adjusting dates of delayed activities since many people tend to take vacations during these months, further delaying the planned actions.

Additional risk: Presidential elections will be held in May 2024, which may distract public institutions and other counterparts and therefore not prioritize the project's activities.

Mitigation measures: There will be more time to prepare to implement the final activities. Now, the country is facing a climate of socio-political instability, amidst an electoral campaign process that is advancing; also, we have only a little less than a month of effective 2023 working days. In addition to the challenges commented on, the elections are planned for May 2024, but we have a good chance to reach our goals working from the beginning of the year through April 2024.
