Project progress summary

The progress made and the results achieved during the reporting period built upon the Capacity Assessment and Gap Identification conducted in October/November 2023 for all 23 Civil Society Organizations (CSOs), including umbrella CSOs. However, for strategic reasons and social inclusion purposes, The Gambia Federation for Disabled and the Network of Community Radios were also assessed and added to the list of the implementing organisations, bringing the total to 25 CSOs. This assessment laid the foundation for targeted interventions to address gaps in management, quality assurance, financial practices, and programmatic effectiveness. A Collaborative Training Approach was adopted, involving umbrella CSOs who jointly planned and shared training responsibilities. Each of the three umbrella organisations focused on specific areas, ensuring that planning, budgeting and support were aligned with the needs of the CSOs under their supervision. The GPI 2.0 Project Secretariat played a crucial role in supporting the umbrella organisations and their affiliated CSOs, providing guidance and assistance where gaps were identified in management, finance, or programme implementation.

Capacity building programmes

Gender Transformative Approach Training: The training benefitting 67 participants (women: 38, men: 29, PWD: 1) strengthened CSO members skills in gender-responsive programming for maximum impacts to targeted beneficiaries.

Human Rights Based Approach (HRBA) training: The training targeting members of 25 CSOs was designed to improve their knowledge in promoting the rights of excluded persons through participatory programme intervention and incorporates HRBA in every aspect of project design, implementation, monitoring and reporting.

Gender Mainstreaming and Budgeting Training: A total of 69 participants attended the training, comprising 37 women, 32 men, and 2 PWDs. The training enhanced the CSOs' proposal development capabilities, enabling them to integrate gender considerations effectively into their budgets and work plans. This alignment is crucial for achieving the recommendations of the TRRC in The Gambia.

Board Formation and Governance Training: The training developed essential skills in leadership, organisational management, resource mobilisation, and most especially governance and oversight functions for efficient and result-oriented performance of the organisation. As a result, the CSOs will have skilled, empowered and effective boards, better equipped to serve women and girls with quality and assurance, attract donor support, and progress in their implementation efforts to promote Gender Equality and Women Empowerment in The Gambia. The programme benefitted 49 participants (Women: 14; Men: 35).

Resource Mobilization and Strategic Development: The training focused on equipping participants with the necessary skills and knowledge to effectively raise and manage resources, and to develop strategic plans that align with their organisational missions and goals. The training was attended by 52 people (Women: 24; Men: 28; PWD: 2). As a result, CSOs will have enhanced strategies for resource mobilisation that will enable them to grow as a remarkable civic space in The Gambia and achieve their overall goals as women-led organisations.

Financial and Procurement Management System: The on-site training improved CSOs' organisational financial systems and procedure for efficient finance management to foster credibility and accountability and to avoid any fiduciary risks.

Project Management Training: The training enhanced the participants' skills in impactful project conceptualisation, design and implementation. It benefitted 54 people (Women: 30; Men: 24; PWD: 2).

Monitoring, Evaluation and Reporting Writing Training: The training benefitted 59 people (Women: 19; Men: 40; PWD: 2). The training focused on enhancing result-based management, quality assurance, accountability and evidence-based reporting.

These trained personnel will support the project's endeavour on establishing processes for programme coordination, monitoring, and financial management for improved programming of targeted CSOs and help them to meet the set criteria for next level of operations.

The GPI 2.0 CSO House initiative made a significant step forward. Many CSOs in The Gambia currently face challenges due to a lack of physical presence and proper facilities, which affects donor confidence. During this period, key partners, including the Ministry of Gender, Children, and Social Welfare, the Governor of the Lower River Region, and other stakeholders, conducted a site visit with contractors to select and allocate land for a CSO house. The purpose of a CSO house is to bring several CSOs together in one location to coordinate their efforts, share expertise, and enhance service delivery. This initiative aims to build donor trust and confidence, ensuring more

effective support for their important work as women-led and women-focused CSOs.

Notably, the three umbrella CSOs actively participated in a coalition addressing the critical national challenge of repealing the FGM Law and advancing women's rights. Their engagement extended to consultative meetings with National Assembly Members (NAMs), where they contributed knowledge and materials to advocate for women and girls' protection. Additionally, they participated in a joint study tour to Egypt to fully understand how other Muslim countries perceive FGM, which helped shift perspectives toward maintaining and strengthening the law rather than repealing it. As a result, FGM is now highly criminalised and punishable in The Gambia. This outcome highlights the coalition's impactful role within the civic space.

To ensure youth inclusion and responsiveness in gender equality and women empowerment, the project has enlisted eight youth groups (Sankiwa Integrated Young Association, Young Advocates for SSHSR Gambia, Youth Power Network International, Sandu Youth, Basse Got a Talent, Kombo Youth, Raise the young Foundation, National Youth Parliament) which collectively represent 34.8 % of the implementing CSOs. Currently, the capacity of these youth-focused CSOs is being built and they will be supported by the GPI Project technical team as well as through a Peer-Mentorship Approach in the next phase of the GPI project implementation. The technical support includes (but is not limited to) strengthening the operational and institutional capacity of these youth-led and women-led/women-focused CSOs/CBOs in addressing women's issues, thereby optimizing gender equality and women empowerment programming. The Project will achieve this by supporting the implementation of The Gambia National Action Plan for UNSCR 1325, as well as the Gender Equality and Women Empowerment (GEWE)-related elements of the TRRC White Paper recommendations.

In addition, the project will build their capacity in key areas, including the protection of the rights of women and girls in conflict situations and in peace support operations; the participation of women in conflict prevention and resolution, peace and security institutions and processes; and the prevention of violence against women and girls including sexual, gender-based and conflict-related violence. The project's strategies and initiatives were developed to support the implementation of The Gambian National Action Plan UNSCR 1325 and the TRRC White Paper GEWE Recommendations for the greater participation, protection, and representation of women, girls and youth in decision-making processes within governance institutions and within national, regional and community level conflict prevention, management, and resolution mechanisms.

The GPI 2.0 umbrella Civil Society Organizations (CSOs) and Community-Based Organizations (CBOs) have actively joined forces to address national-level human rights abuses, particularly those affecting women and girls. They have been engaged in high-level discussions regarding the repeal of the FGM Law and women's bill, as well as other deeply entrenched social norms that impact women's and girls' rights, leading to gender-based violence and child marriages. The CSOs and CBOs mobilise for peaceful demonstrations, sharing Information, Education, and Communication materials with a unified message at the National Assembly. This collaborative effort has empowered the civic space, giving them a respected voice and attention which eventually prevented the repeal of the FGM law in The Gambia.

A coalition of CSOs, led by Network against Gender Based Violence - NGBV, has emerged. These CSOs collaborated to create Information Education Communication (IEC)materials and establish regional partnerships. Their collective efforts focus on advocating for women's and girls' rights, leading to positive community impact and a strong stance against harmful practices. The organisation "Men 4 Equality" adopts a positive masculinity approach. By engaging men and boys in the national debate on harmful norms, they contribute to shifting societal attitudes and promoting gender equality and women empowerment. Social media influencers, radio presenters, and news editors received mindset transformation training on human rights issues. As a result, they actively combat Female Genital Mutilation (FGM) and amplify marginalized voices through their media work. Political leadership engagement has changed, previously most of them have been silent on FGM, political leaders can now discuss the issue in various forums. This

increased awareness and dialogue that contribute to addressing FGM more effectively. Additionally, individual anti-FGM campaigners like Fatou Baldeh, associated with a CSO in The Gambia, received the 2024 Women's Rights Award for her tireless efforts in advocating for women's rights and harmful practices.
