Outcome 1

From March 2022 to September 2024, The Carter Center made significant progress in coordinating among Sudanese youth-led organizations and effectively integrating youth perspectives into key political, peace, and public policy processes. This coordination has empowered young Sudanese, particularly women, to take leadership roles in monitoring, reporting, and advocacy. As a result, youth actors have contributed directly to the transitional political dialogue, ensuring that the voices and priorities of their communities are included.

Youth participation in national and international platforms has been a major success of the project. With Carter Center support, YCON's real-time reports on conflict and human rights violations have informed influential actors such as the

U.S. Special Envoy and international stakeholders, shaping peace negotiations. Additionally, YCON's presence in forums like United Nations Security Council briefings, with Carter Center support, solidified youth perspectives as critical components of Sudan's political future.

Quantitatively, the project saw a notable increase in the number of youth organizations engaged through YCON, from fewer than 50 at the project's start to over 150 by September 2024. These organizations collectively contributed to 125 public reports that provided vital information to national and international decision-makers.

Qualitatively, the project has been instrumental in empowering young women, who now make up 469e of the Lead Observers. The Carter Center provided leadership roles and capacity-building opportunities for young women, ensuring their voices were included in discussions about the conflict, with a focus on gender-specific issues. This empowerment has also challenged traditional gender roles, advancing the inclusion of women in peace and political processes.

The Carter Center's efforts with Sudanese youth have contributed directly to more inclusive peace processes. So even though Sudanese and international partners have fallen short of their desired transitional and peace-making objectives, the Center's work elevated youth voices and perspectives in peace and policy discussions. The network's achievements position it to continue advocating for youth-led solutions and sustaining its influence on peacebuilding beyond the project's formal conclusion.

Outcome 2

Over the course of the project, particularly since the outbreak of violence in April 2023, The Carter Center made substantial progress in expanding civic space for Sudanese youth, despite significant challenges. The Center's work with YCON promoted an inclusive environment where young Sudanese, particularly women, can express their concerns and take part in political processes, even in a context that limits physical gatherings.

The Carter Center responded to Sudan's conflict by organizing online meetings to launch YCON's interim executive branch and engage network member organizations. This resulted in the publication of the YCON's first statement and several reports that highlighted the youth's vision for peace. Social media has been instrumental in this process, with YCON using Facebook, Twitter, WhatsApp, LinkedIn, and its own website to disseminate reports and updates. Despite internet connectivity issues, over the past six months the network managed to conduct more than 24 online network- wide meetings and publish eight reports. These reports have significantly increased youth visibility and engagement, reaching over 52,000 people in the first week of Facebook activity alone. Reports shared through WhatsApp groups have further extended the network's reach, though exact metrics are difficult to trace.

The challenging security environment has delayed direct in-person training on advocacy and communications for partner organizations. However, The Carter Center plans to address this by holding a workshop for YCON leaders in Nairobi, where future training needs will be assessed, and further capacity-building programs will be launched. This approach will help ensure that the youth, especially young women, are equipped with the skills needed to engage effectively in advocacy and communication, despite the difficult circumstances.

Outcome 3

Significant strides have been made towards strengthening the capacities of the YCON and youth-led partner organisations to identify and mitigate conflict at a local and national level, notably through targeted training and the establishment of operational frameworks that emphasize youth engagement in peacebuilding processes. Throughout the project life The Carter Center successfully organized numerous training sessions, including Hostile Environment Awareness Training (HEAT) and specialized workshops in Nairobi and Kampala. These sessions equipped over 180 participants, including 36 lead observers, with essential skills in conflict observation, data

collection, and reporting. Notably, 36% of the lead observers are young women, reflecting an ongoing commitment

to gender parity within the organization.

With Carter Center support, YCON produced a total of 26 comprehensive reports, synthesizing data from local observations that inform both national dialogues and international discussions. These reports have been instrumental in providing reliable, on-the-ground insights into the ongoing conflict, contributing to a better understanding of the dynamics affecting Sudanese communities. Furthermore, the network has engaged in advocacy meetings, amplifying the voices of youth in political dialogues, which fosters a culture of inclusion and responsiveness to the needs of marginalized groups.

Gender equality and women's empowerment have been integral to The Carter Center's approach in this project. From the outset, emphasis was placed on selecting partners and Lead Observers who actively support women's participation. Civil society organizations led by women or with significant female involvement were prioritized during partner evaluation and selection. This focus extended to the selection of YCON's 36 Lead Observers, ensuring young women had leadership opportunities. By the project's completion, 46% of Lead Observers were women, demonstrating a strong commitment to gender inclusivity.

However, substantial structural barriers emerged, particularly in areas where conflict dynamics and cultural norms limit women's roles. These barriers included restrictions on mobility, societal expectations, and limited educational access for women in rural regions. In certain locations, the need for ethnic diversity occasionally took precedence over gender parity, adding complexity to gender equality efforts.

To address these challenges, the Center adjusted its strategies to empower women. For instance, instead of conducting door-to-door surveys, observers were trained to implement structured, remote interviews, making female observer participation more acceptable within these social contexts. After the outbreak of violence in April 2023, YCON's shift to online methodologies further improved female observer comfort and engagement, particularly in conflict-prone areas.

To sustain and enhance female participation, active women in the network are encouraged to apply for Lead Observer roles, and specialized training is being developed to address the unique challenges faced by women. This approach ensures that women's perspectives, especially from conflict zones, are integral to YCON's reporting and advocacy, thereby strengthening inclusive peacebuilding.

Young women's inclusion has been a priority throughout, inspired by the significant role they played in Sudan's revolution. Despite increasing restrictions on civic space, efforts have ensured female representation in YCON leadership and reporting. Observation methodologies have been tailored to address gender-specific challenges, ensuring women can participate safely in monitoring activities.

The project framework is deeply rooted in principles of gender equality and youth empowerment, with a focus on providing young women with equal leadership opportunities. Training methodologies for observers are gendersensitive, embedding women's empowerment into the project's core. Selection criteria, training materials, and community engagement strategies are designed to address the unique challenges young women face in conflict zones. By fostering safe spaces for women to share their experiences, YCON ensures that they contribute effectively to peacebuilding initiatives. Continuous monitoring of female participation will inform future strategies, keeping gender considerations central to all YCON activities.

The project's primary goal—empowering youth to play a central role in conflict observation and reporting—has been realized through the establishment of a sustainable, youth-led network. This network has granted young Sudanese unprecedented opportunities to engage in peacebuilding, amplifying their voices both locally and internationally.
On a structural level, The Carter Center's support has guided YCON's growth from an informal youth network into a formalized organization with strong reporting and management systems. YCON's progression toward legal registration as an international NGO in Uganda is crucial, as it enables continued independent operations. By supporting YCON's development of strategic planning and financial management skills, the project has cultivated a resilient, adaptable organization capable of responding to Sudan's complex political climate. The recent handover of key tasks, like organizing Lead Observer training, signifies a major step toward self-sufficiency and demonstrates YCON's readiness to operate autonomously.
Institutionally, The Carter Center has helped YCON build a robust framework for conflict reporting, strengthening youth capacity to engage in political processes and inform international decision-making. YCON's credible, timely reports have gained recognition among diplomatic circles and international stakeholders, contributing to discussions around ceasefires and peace agreements. The field-based observation model developed with The Carter Center has positioned Sudanese youth as indispensable informants on ground realities, directly influencing peacebuilding dialogues. YCON's credibility with the international community underscores the project's success in embedding youth-led conflict reporting within Sudan's institutional landscape.
At the societal level, the project has brought about meaningful change by amplifying youth voices in Sudan's political and social spheres, where they have historically been excluded. By equipping youth with conflict-reporting skills and platforms to share their insights, The Carter Center has empowered young Sudanese to shape narratives about Sudan's peace process. As the project nears its conclusion, YCON's engagement with key international stakeholders—including a briefing at the United Nations Security Council in October 2024 and potential partnerships with the UN Peacebuilding Fund (UNPBF), the US government, and other NGOs—underscores the growing recognition of Sudanese youth as vital actors in peace and security. These high-level engagements mark a significant societal shift, demonstrating that young people are not merely witnesses to conflict but active participants in shaping their nation's future through reporting and advocacy.

Civil Society Organizations (CSOs)

Challenges Faced Prior to Implementation: Many CSOs struggled with limited resources, capacity, and knowledge to engage effectively in conflict monitoring and advocacy. Their impact was often hindered by a lack of collaboration and support networks, leaving them isolated in their efforts to address community issues. Impact on Their Lives: The **Carter Center strengthened the** capacities of Sudanese CSOs by fostering significant collaboration and knowledgesharing. Through training and partnerships, these organizations have enhanced their ability to advocate for peace and engage with stakeholders. As a result, they are more effective in addressing the needs of their communities and influencing policy discussions.

From partner organization in Red Sea state: "The conflict in Kassala state erupted between the Beja and the Beni Amer tribes following provocative statements by the principal of the Beja tribe. The conflict somewhat subsided after the intervention of the Sudanese army and the following involvement of the YCON: "The city of Port Sudan and some localities witnessed bloody tribal conflicts, a breach of the social fabric, a rise in racism, and discrimination between the people of the local components. So that the formations of civil society are subject to classification on a tribal basis. We were able to bring together the two main components in the leaders of the Civil Monitoring and then engage with us in the formation of the public body and the melting of those strife in the midst of joint work" - 26 year old female lead observer from Port Sudan

Youth Observers

Challenges Faced Prior to Implementation: Before the YCON project, many young people in Sudan felt marginalized and lacked a platform to voice their concerns regarding the ongoing conflict. The absence of structured engagement opportunities limited their ability to participate in decision- making processes that directly impacted their lives. Moreover, youth ofien faced harassment and intimidation, which deterred them from advocating for their rights and the needs of their

communities.

Impact on Their Lives: The YCON project has empowered youth observers by providing them with training and resources to effectively monitor and report on local issues. This empowerment has fostered a sense of agency and responsibility among youth, enabling them to actively contribute to peacebuilding efforts. Observers have reported increased confidence in their abilities to engage in civic life and advocate for their communities, fostering a culture of leadership among young people.

Young Women

The Youth Citizen Observer Network (YCON) has had a profound human impact, particularly during a time of escalating conflict in Sudan. By empowering youth, especially women, and fostering a culture of civic engagement, the project has contributed to social cohesion, resilience, and the promotion of peacebuilding initiatives across the country.

Strengthening Community Resilience:

One of the most significant impacts of the YCON project is the strengthening of community resilience in the face of adversity. By training over 180 youth observers, including a substantial number of young women, the network has equipped local communities with the tools needed to monitor conflicts and respond to crises effectively. These trained observers have become vital links between their communities and the broader national dialogue, providing timely information and facilitating communication with decision-makers. For instance, local observers have reported on the humanitarian situation in various conflict-affected regions, helping to raise awareness about critical issues such as displacement, food insecurity, and access to healthcare. Their observations have been crucial in guiding local NGOs and international organizations in their response efforts, ensuring that aid reaches those most in need. Daily and Bi-monthly Reporting Mechanisms: YCON developed and maintained a consistent reporting structure, involving daily check-ins and bi-monthly reports from local observers across all 18 states in Sudan. This rigorous reporting schedule allowed for the continuous capture of real-time data on conflict dynamics, local incidents, and ceasefire violations, which was then relayed to YCON's central Secretariat for synthesis and broader distribution. Additionally, weekly coordinator reports and spot reports were generated to provide focused updates on specific events.

Regular Stakeholder Meetings and Community Feedback Mechanisms: Engagement with advisory bodies and community stakeholders formed an integral part of the monitoring strategy. In each state, advisory bodies were convened, comprising activists, local youth leaders, and members of civil society, to ensure field observations were validated and aligned with on-the-ground needs. Although formal in-person meetings were often disrupted by security concerns, informal consultations and feedback loops with these advisory members were maintained to gather insights and respond to emerging issues. Feedback from these bodies informed specialized reports.

Social Media and Public Platform Monitoring: YCON utilized platforms such as X (formerly Twitter) and Facebook to distribute reports, which reached over 52,000 people within their initial active period alone. Engagement data—including reach, shares, and interactions—provided insight into the public's response.

Perception Surveys and Outcome Assessments: Perception surveys established baseline data on youth engagement and attitudes toward conflict reporting. After the outbreak of violence, YCON quickly adapted, using online questionnaires to assess state-level needs and public sentiment. With 471 responses, this survey highlighted key security concerns and unmet basic needs, shaping the focus of subsequent YCON reports and serving as a reference for measuring outcome- level change over time.

Capacity Assessment and Partner Evaluations: A Technical and Operational Capacity Assessment (TOCA) was conducted to evaluate and improve YCON partners' capabilities in reporting, monitoring, and advocacy. This assessment, along with direct feedback from network members, was essential in identifying areas where partners required further support, enabling the project to tailor capacity-building interventions accordingly. This assessment occurred twice.

Third-Party Evaluations and Stakeholder Interviews: The final evaluation report was conducted by an independent firm, Consilient Limited, in September 2024. This evaluation included direct observations, stakeholder interviews, and trend analyses to comprehensively assess project impacts. Additionally, weekly program staff meetings facilitated internal reflections.

Community Feedback Mechanisms: Field observers engaged directly with local communities. This enabled the network to quickly adapt its focus areas in response to local needs and concerns.

The project's M&E is partly based on perception surveys and community-based data collection. Within days of the onset of violence, with the support of The Carter Center, the YCON began meeting daily despite communication interruptions. It then canvassed its partners and advisory bodies nationally through an online questionnaire to better understand citizens' needs and perceptions on the state level. The survey received 471 responses; respondents' main priority was ceasing fire, followed by access to food, medicine, and other necessities. The survey found that the main threat to security was not only due active fighting but also due to mounting insecurity and fear brought about by potential expansion of fighting into other formerly peaceful areas. This personal insecurity is connected to the overall dynamics of war, and not necessarily due to specific fighting incidents at given time or place. This survey helped serve as a baseline for future reporting. Thereafter, observers continued to report observation of cease-fires, humanitarian situations, and other aspects of the conflict relevant to the Sudanese population.

Due to the ongoing conflict and severe security constraints in Sudan, the Center was unable to implement comprehensive outcome-level data collection initiatives, such as perception surveys. The volatile situation posed significant risks to both data collectors and respondents, making it unsafe to conduct such activities. Instead, we have relied on other methods of feedback and assessment, including direct observations, stakeholder interviews, and the monitoring of key indicators to evaluate the project's impact. As opposed to the partner organizations and other internal pieces of the YCON architecture, advisory bodies are largely composed of activists, unregistered organizations, and unaffiliated civil society. This allows the YCON to share and validate field-based observations and findings with youth on the ground. Without the ability to freely meet throughout Sudan, advisory body meetings are not taking place as envisioned. Instead, YCON observers are communicating with advisory members frequently and informally. Formal advisory body meetings are expected to resume upon determination that the operating environment is conducive to civil society activity. The Field Observers are mostly chosen from the organizations and groups forming the advisory bodies in the states. The reports are shared with the advisory body when published and feedback on the reports is received through the Admin Body on the content of the reports. In addition, the suggestion on the topics to be addressed in the specialized reports is based on the information provided by the members of the advisory body. As an example, the report tackling the Humanitarian distribution was initiated due to the information received from the field on the misuse of the humanitarian aid and the fact that the aid was sold instead of being distributed to the rightful recipients.

The Carter Center has had a significant catalytic effect on peacebuilding in Sudan by creating conditions that promote long-term change and unblocking stalled processes. Through its focus on youth engagement, the project has fostered a new generation of active citizens who are equipped to influence political dialogue and institutional reform.

Empowering Youth Voices: The Carter Center empowered more than 180 youth observers, including a substantial number of young women, to take on leadership roles in their communities. By providing training in conflict monitoring, advocacy, and reporting, the project has not only built individual capacities but has also instilled a sense of agency among youth. These empowered individuals are now actively participating in local and national discussions about peace and governance, ensuring that youth perspectives are considered in decision-making processes.

Influencing Policy and Advocacy: The Carter Center promoted changes in policy frameworks by supporting the YCON in presenting actionable recommendations based on community observations. The network's reports have been utilized by various stakeholders, including the UN Peacebuilding Fund and U.S. agencies, to inform discussions on conflict resolution and humanitarian response. This influence has helped to shift narratives and priorities in peacebuilding efforts, highlighting the importance of youth engagement and gender-sensitive policies.

Building Collaborative Networks: The project has fostered collaboration among over 500 civil society organizations (CSOs) and youth-led groups, creating a united front for advocacy and peacebuilding. These coalitions have strengthened collective efforts to address shared challenges, enhancing the overall impact of peace initiatives in Sudan. By building networks that promote solidarity and resource sharing, YCON has laid the groundwork for sustained collaboration beyond the project's duration.

Establishing New Processes for Engagement: The Carter Center has initiated new processes for youth engagement in peacebuilding, including regional conferences and dialogues that bring together diverse stakeholders. These events have created opportunities for networking, knowledge exchange, and joint action, helping to establish a culture of collaboration and proactive engagement in peace efforts.

In conclusion, the YCON project has not only implemented direct changes through its activities but has also encouraged broader systemic shifts in peacebuilding processes. By empowering youth, bridging gaps, influencing policy, building collaborative networks, and establishing new engagement processes, YCON has created a sustainable framework for ongoing peacebuilding efforts in Sudan.

To ensure the sustainability of peacebuilding gains achieved through the programming, several strategic mechanisms have been put in place, with the goal of evolving YCON into a self-sufficient entity capable of influencing civic spaces in Sudan.

Organizational Development: The network's administrative and financial systems continue to grow to sustain independent operations. The YCON is in the process of finalizing its registration as an INGO in Kampala, Uganda. However, financial dependency on The Carter Center poses a challenge. Banking disruptions due to the conflict have impeded the ability of partner organizations to make salary payments, affecting observer retention. YCON is exploring alternative funding strategies to mitigate these risks and to take on the responsibility of network wide payments.

Capacity Building: The Carter Center continues to support network-wide training and mentorship. Capacity-building initiatives focus on governance, observation practices, and advocacy skills. However, YCON partners within Sudan face significant security risks, including intimidation, harassment, and detainment by warring factions, which have impacted their ability to operate safely. Enhancing training in security measures is critical for sustaining operational capacity.

Expanding Membership and Activities: YCON seeks to broaden its membership and activities. Inclusivity remains a priority, aiming to engage marginalized groups. However, security risks and observer retention challenges have made expansion difficult, particularly in conflict-affected areas.

Financial Sustainability: The YCON's General Secretariat, with Carter Center support, is exploring future potential partnerships with local and international donors and private sector entities to diversify its funding sources. However, disruptions in-country banking access have delayed salary payments and operational activities. To address this, YCON is considering alternative financial transfer mechanisms, such as fintech solutions and informal networks, to maintain financial flow in conflict zones.

Networking and Collaboration: The network has built strong connections with over 500 CSOs and international stakeholders, enhancing its ability to influence policy discussions and mobilize support. Maintaining and expanding these relationships is crucial as YCON moves toward independence.

Public Recognition and Advocacy: The program has gained visibility through reports and participation in national and international forums. However, this visibility has also increased the risks faced by observers. requiring careful management of their safety while continuing advocacy.

Socio-Economic Initiatives: The Network's future plans include support of initiatives addressing socio-economic factors driving conflict, including community development, youth economic empowerment, and civic awareness programs, contributing to a more resilient society.

While The Carter Center made significant progress in promoting youth engagement and peacebuilding in Sudan, several challenges and capacity needs remain that could impact the YCON project's overall effectiveness and sustainability.

Security Risks for Observers: The ongoing conflict in Sudan presents substantial security risks for YCON observers and partner organizations. Many youth who are involved in monitoring activities face harassment, intimidation, and violence, which could hinder their ability to carry out their work effectively. Addressing these security challenges is critical for maintaining the integrity and safety of the network. Enhanced security training, better communication protocols, and increased protective measures are necessary to ensure that observers can continue their work without undue risk.

Capacity Needs of Recipient Organizations: While YCON has successfully built capacities among youth observers, many of the local civil society organizations (CSOs) involved in the project still face significant capacity gaps. These organizations often struggle with limited resources, insufficient technical expertise, and a lack of experience in advocacy and monitoring. Providing ongoing training in areas such as data analysis, report writing, and strategic communication will be vital for empowering these organizations to contribute effectively to peacebuilding efforts. A tailored capacity-building program could significantly enhance their impact.

Financial Sustainability: The transition from UNPBF funding to CSO funding is a critical step for Carter Center support of YCON's sustainability. However, the reliance on external funding sources poses challenges in long-term financial planning. Developing a diversified funding strategy that includes partnerships with private sector entities, international donors, and local businesses will be essential to ensure continuous support for the network's activities.

Monitoring and Evaluation Framework: Strengthening the monitoring and evaluation (M&E) framework is vital for assessing the impact of YCON's initiatives. Developing more robust indicators and data collection methods will help track progress and inform future programming decisions. Enhancing the capacity of local organizations to conduct evaluations will promote accountability and transparency, ensuring that the network's activities are aligned with its goals and objectives.

Need for Comprehensive Communication Strategies: While the project has utilized social media and digital platforms, a more comprehensive communication strategy is needed to reach broader audiences, including policymakers, community leaders, and the general public. Targeted messaging and outreach campaigns will enhance YCON's influence in peacebuilding discussions.

By proactively tackling these challenges, YCON can maximize its impact and contribute to lasting peace and stability in Sudan.
