All Peacebuilding Fund projects have one overarching steering committee Co-Chaired by the Ministry of Peacebuilding and the UN Resident Coordinator and thus this project does not have a specifically dedicated steering committee to it. The project, however, has an active Technical Working Group (TWG), comprised of all the Implementing Agencies (UNDP UNESCO, and UNWOMEN) and PBF Secretariat at UN Resident Coordinators Office. TWG provides a platform for assessing progress of the project implementation and provides technical advice to mitigate and address challenges and bottlenecks that may slow down implementation.

Over the past 6 months, the PBF Steering Committee has met twice. However, the TWG met once on 06/03/2025 where it discussed each implementing Agency's progress and plans for the implementation of the project interventions from January - March 2025. This meeting resulted in a coordinated support to the National Constitutional Review Commission (NCRC) to launch the civic and public consultation manuals on 27th March 2025.

The project worked with the National Constitutional Review Commission (NCRC) to launch the civic and public consultations for the Constitution Making Process on March 27, 2025, in Juba. This launch marked the beginning of substantive work towards the machining of the Permanent Constitution. The NCRC's civic education will raise awareness on the constitution making process as well as collate public opinions and views to help draft the Permanent Constitution.

The project engaged the Ministry of Gender, Child and Social Welfare to plan for official and public submission of the South Sudan Women's Charter to the NCRC, in line with the requirement under section 12 (6) of the Constitution Making Process Act, 2022. This submission is to ensure that women's priorities are formally integrated into the drafting process of the Permanent Constitution, advancing gender inclusion in national policymaking.

The project engaged the Women Parliamentary Caucus (WPC) of the Transitional National Legislative Assembly to strengthen their understanding and role in the gender-responsive constitution-making process. This engagement equipped the WPC with crucial insights to effectively contribute as part of the Constituent Assembly in deliberating and adopting a gender-responsive permanent constitution for South Sudan. Additionally, the project rescheduled the benchmarking mission to Kenya and Uganda from November 2024 to June 2025, ensuring the WPC will gain valuable comparative experience to further support women's meaningful participation in the constitution-making process.

The project also engaged the University of Juba's law School to produce and finalize a position paper on constitution Making and elections. The position was validated in January 2025 and is being printed for dissemination to various stakeholders. The paper highlights the need for sequenced processes and the inter-connection between the constitution and other relevant governance processes including general elections.

The project has completed all preliminary activities including contracting partners and staff recruitment. During the time under review, the project has finalized the recruitment and deployment of the Senior Gender Advisor, a process that had started in October 2024 to support the work of the constitution making institutions including the NCRC which was pending the formation of the commission. The NCRC welcomes the deployment of the Senior Gender Advisor as fundamental to support the work of engendering the Permanent Constitution Making process. The project also onboarded additional implementing partner- Centre for Inclusive Governance, Peace and Justice (CIGPJ) in September 2024 that has strengthened capacities through trainings of the Constitution Making mechanisms, including the NCRC and Members of Parliament in November - December 2024 through training to perform their mandated roles regarding the Constitution Making; commissioned four (4) position papers providing comparative analysis on contentious constitutional issues from a gender perspective; and supported strengthening capacities of the women-led coalitions on the Constitution Making Process established in Yei, Wau, Juba, Yambio, Torit, and Bor to carryout awareness on the Constitution Making at the grassroot and lobby for women's participation in the CMP with collective voice. Other additional implementing partners included three CSOs that received Low Valuer Grants over 2024 to disseminate and provide civic education and awareness on the constitution-making process in the three regions of South Sudan, have been selected to be granted a cost-extension to continue on implementing the same activities throughout the second half of 2025, starting from June 1st making a total of 18 Civil Societies, academia and media organization as implementing partners for the whole duration of the project.

The project facilitated the NCRC to revise its internal rules and civic and public consultation manuals to implement inclusive public participation in the Constitution Making Process. The revision includes the development of a strategy that ensures women, youth, and persons with disabilities lead and participate fully in civic education, public consultations, and constitution drafting. This marks a significant step toward a people-driven, inclusive permanent constitution that tackles gender barriers and integrates gender equality and youth-centered principles. The development of the strategy was as a result of the November 2024 training of 217 (147 Female and 70 Male) key constitutional actors from the NCRC, Secretariat, and Transitional National Legislative Assembly (TNLA) by constitutional experts from South Africa and Kenya on gender-responsive public participation and constitutional gender mainstreaming. The NCRC also launched the national civic and public consultations for the constitution-making process on 27th March 2025 in Juba. Out of 201 (79 F and 122 M) participants, reflecting inclusive engagement. This launch initiated the core phase of public participation in the permanent constitution process, setting the stage for nationwide awareness campaigns and public input collection expected to commence from June to October 2025.

The project through Centre for Inclusive Governance Peace and Justice (CIGPJ) commissioned four position papers, offering comparative analyses on governance structures, women's affirmative action, enforcement of the bill of rights, and constitutional safeguards against gender-based and conflict-related sexual violence (CRSV). These papers, due to be submitted to the NCRC by June 2025, will directly support the implementation of section 12(6) of the Constitution Making Process Act, 2022. The papers will drive inclusive dialogue, facilitate mediated negotiations, and build broad consensus on critical issues shaping the permanent constitution. Additionally, two position papers produced by FIDA (CSO) and Human Rights Commission of South Sudan, and has been submitted to various stakeholders, including the NCRC. The two papers address fundamental issues on inclusiveness namely "Woman social economic rights and the constitution" and "Access to justice as a basic constitutional right". These position papers will inform, to extend possible, critical text of the permanent constitution when the drafting commences.

Through six (6) grassroots dialogues in Juba, Yei, Torit, Yambio and Wau, 180 people (135 F and 45 M) accessed information on key constitutional topics including the definition of a constitution, women's rights, inheritance, family law, marriageable age, property rights, affirmative action, and governance. They enhanced their understanding of constitutional rights and are expected to disseminate the acquired knowledge in their communities. The project used a visual and audio recording titled "Know Your Constitution Campaign" in Arabic at the dialogues.

The project in collaboration with the Female Journalists Network (FJN), in November 2024, trained and mentored 60 (41F, 19M) journalists on accurate and gender-sensitive reporting on the constitution making and 74 (48F, 26M) leaders on public speaking skills. As a result of the trainings, some of the Journalists have commenced writing gender-sensitive articles on the constitution making process and women leaders have gained confidence in articulating women's priorities in the constitution making process through radio talk shows, press release writing, and participation in constitutional consultative meetings .

As a result of the project's capacity strengthening, some journalists are writing gender sensitive articles on CMP and women are confidence in articulating women's priorities in the CMP. In partnership with the Union of Journalists of South Sudan, 25 (15M and 5F) journalists in Abeyei Administrative Area were trained and their skills strengthened ethical reporting, fact checking, gender responsive reporting, conflict sensitive reporting, safety and protection, media laws and reporting on the constitutional making process. As a result of these engagements, the journalists have gone ahead to discuss and cover stories about the constitution making process at their various media houses and the Union presence strengthened in the location. In addition, a journalists safety guide has been published to enable physical and digital safety of journalists as they carry out their work. As a result of the activity, UJOSS has gone ahead to strengthen its presence and network in Abyei Administrative Area. This has boosted media monitoring and continued advocacy for conducive environment and the safety of journalists during the constitution making process and implementation of the peace agreement across the country.

The project in partnership with Samaritan Media (CSO), conducted capacity building workshops for (8) Eight Community Radio stations and community groups across the country (The targeted stations reached include Amadi FM 93.0 in Mundri West Western Equatoria State Voice of Hone Marwi County Eastern Equatoria State Pihor FM

Greater Pibor Administrative Area, Iyete FM 87.8 Morobo County Central Equatoria State, Yirol FM, Yirol West County Lakes State, Jam Jang FM, Ruweng Administrative Area, Nile FM Malakal, Upper Nile State and Voice of Reconciliation Bor Jonglei State. The main goal for the capacity building was to promote community listenership and contribution to programs on Constitution Making Process. More importantly, participants were trained in the importance of listeners clubs and their roles and functions. Two listener's clubs were formed in Morobo and Pibor as a result of this capacity building intervention.

The project launched a series of constitutional dialogues on constitution making in the drafting process of documents. The dialogues started with a youth constitutional forum that took place on May 21st and 22nd, with participation of more than 90 youth, 40 of which are female youth. The forum served as a platform to discuss the CMP, and the civic education and public consultations campaign launched and led by the NCRC, and the latter attended the forum and delivered several presentations in that regard.

The NCRC is now developing a strategy that ensures women, youth, and persons with disabilities lead and participate fully in civic education, public consultations, and constitution drafting. This marks a significant step toward a people-driven, inclusive permanent constitution that tackles gender barriers and integrates gender equality and youth-centered principles following outcomes the November 2024 training of 67 NCRC members (41 men, 26 women) by constitutional experts from South Africa and Kenya on gender-responsive public participation.

As per the Partner report of March 2025 informal feedback showed that 92% of Female parliamentarians increased their knowledge of their role in promoting women's and youth participation, debating, and adopting a gender-sensitive permanent Constitution making process, protecting the rights of all. This followed the training of 150 (106F, 44M) TNLA members on gender mainstreaming in the Constitution-making process through implementing partner CIGPJ, with 71% of participants being female legislators from the Women Parliamentary Caucus and Young Parliamentarian Caucus.

One hundred eighty (180, (135F and 45M) Women and Youth coalition members are now empowered to lead grassroots awareness campaigns on the Constitution-making process across Yei, Torit, Bor, Wau, Yambio, and Juba. This empowerment comes from strengthening six women-led coalitions through targeted trainings and the distribution of Arabic-translated audio-visual civic education materials as part of the 'Know Your Constitution' campaign. These coalitions have raised awareness to 200 people (152F, 48M), on key issues such as women's inheritance rights, family law, marriageable age, property ownership, affirmative action, resource management, and governance at the subnational level. Consequently, they are fully prepared to articulate the priorities of women and youth during the public consultations with the NCRC scheduled for June 2025, ensuring their voices influence the Constitution-making process.

Twenty (20) (17 F and 3 Male) women-led coalitions members gained knowledge and skills to carry out civic education and promote public participation in the constitution-making process at the grassroots in Yei, Juba, Torit, Wau, and Yambio. As a result of the training, 20 representatives from women-led coalitions across Yei, Torit, Wau, Yambio, and Juba are now equipped to lead civic education efforts and foster inclusive public participation in the constitution-making process. They effectively articulated women's priorities during consultations with the National Constitutional Review Commission (NCRC) using the South Sudan Women's Charter, making the public debates more gender-responsive and inclusive. This strengthened their capacity to mainstream gender concerns and engage marginalized communities, ensuring a broader, more representative dialogue around the country's constitutional future.

A significant achievement in peacebuilding occurred on November 3, 2023, with the reconstitution and appointment of members to the National Constitutional Review Commission (NCRC), as mandated by the Constitution Making Process Act of 2022. The NCRC was reformed to include 57 members, along with one ex-officio member. Of the 57 members, 19 are female (including the Vice Chairperson), representing 33.5% of the total, while 38 are male (including the Chairperson), accounting for 66.5%. This reconstitution marks a meaningful institutional advancement in alignment with Outcome 1 of the project.

The reconstitution establishes a foundation for advancing the creation of a permanent constitution. This process includes conducting multi-phase civic education and public consultations on various constitutional issues and recruiting members for the Constitutional Drafting Committee (CDC), which will be responsible for drafting the constitutional text. As the primary body overseeing the constitution-making process, establishing the NCRC required broad support and consensus from key stakeholders. This reflects a collective commitment across political divides to collaborate in establishing a new constitution as the supreme governance framework for the country.

Through the project's technical advisory services, the NCRC in collaboration with the Ministry of cabinet Affairs, Ministry of Finance, and Ministry of Justice and Constitutional Affairs, organized an event under the theme "Together for a People-driven Constitution" on the 6 March 2025 that assessed the preparedness of the NCRC to deliver the Permanent Constitution and appealed for Government funding. The NCRC highlighted that its key challenges include lack of funding (US\$ 42.2M) from the Government and the composition of the NCRC with 9 appointed members yet-to-be sworn-in. The Government funding challenge erodes sense of ownership and stales the process especially the operationalization of the Constitution Drafting Committee and nationwide roll-out of the civic and public consultations phase of the Constitution Making process. To address the Government funding and the NCRC composition challenges the Minister of Cabinet Affairs and Minister of Finance committed to prioritize allocation of financial resources the NCRC amongst the electoral bodies in the 2024/2025 National Budget and seeking appointment with the presidency for the oath taking of the 9 remaining NCRC members. Notwithstanding the lack of government funding, significant substantive and procedural work on the Constitution making process, including the launch of the constitutional civic and public consultations has been achieved with resources from partners and the PBF investment supporting the constitution making process

Compared to 2023 at the project's baseline finding that showed only a fewer people got information about Constitution Making Process (CMP) because there were limited outreaches on the process, by May 2025, 7% of the targeted 5,010,000 people, including 3% females have benefited from awareness on constitution making process through participating in constitutional engagements during the development of Charter or constitutional dialogues carried out by women coalitions and CSOs inspired by the Women's Charter. This reflects a change in the societal structure by empowering women's participation in the CMP to achieve a gender-responsive Permanent Constitution that will support elections for a peaceful end of the South Sudan's Transitional period.

In 2024, South Sudan achieved a landmark milestone for gender equality and women's empowerment with the adoption of the South Sudan Women's Charter for constitution making. This historic document, developed through nationwide consultations and supported by the project, promotes women's meaningful participation in constitution-making, elections, political parties, and policy interventions, directly contributing to the Sustainable Development Goal 5, Target 5.5, by prioritizing women's leadership and representing a transformative step toward embedding gender equality in South Sudan's governance and legal frameworks, ensuring inclusive, transparent, and accountable systems that protect and empower women and marginalized groups.

Drawing from experiences of six countries—Ghana, Kenya, Nigeria, Zimbabwe, South Africa, and Libya—the Charter outlines women's twelve critical constitutional priorities, including decision-making participation, economic rights, education, health and reproductive rights, protection against GBV, protection of the elderly and persons with disabilities, marriage and family, access to justice, climate security, and public finance management reforms. As a result of Charter's demands and capacity-building efforts with key partners, including the National Constitutional Review Commission (NCRC), National Legislative Assembly (NLA), civil society, youth, persons with disabilities and media practitioners the NCRC has strengthened its civic and public consultation manuals by developing a specific strategy to ensure the leadership and

participation of women, youth, and persons with disabilities in civic education, public consultations, and constitution drafting. Beyond constitutional reform, the Charter is actively guiding the Ministry of Gender, Child, and Social Welfare (MGCSW) in drafting critical legislative measures, including the Anti-GBV Bill, Family Bill, and Gender Affirmative Bill as well as guided the Political Parties Council (PPC) to conduct gender assessment of thirteen (13) registered political parties in South Sudan to ensure gender equality within party structures, contribute to building a more inclusive and democratic political system in South Sudan. Six (6) women's coalitions with 30 women in the leadership of civic education at subnational levels in Yei, Juba, Wau, Yambio, Torit, and Bor inspired by the Charter, are now creating awareness and advocating for their constitutional priorities with collective voice.

Strengthened partnerships within UN Agencies: In training the NCRC on gender-responsive public participation in Constitution Making process - comparative experiences from Kenya and South Africa, UN Women worked and partnered with UNMISS and UNDP in the planning of the training and selection of the experts. This strengthened collaboration and partnership with these UN Agencies.

Partnered with local civil society organizations: UN women partnered with SSuDEMOP and CIGPJ in training of the women-led coalitions on the CMP in Juba, Yei, Torit, Yambio, Bor, and Wau. Moreover, UN Women partnered with the Female Journalists Network to train and mentor Journalists, women, and youth on gender-responsive reporting on CMP and public speaking skills to articulate constitutional issues confidently during public participation. UNESCO partnered, with institutions such as the Union of Journalists of South Suda, Catholic Radio Network, Advance South Sudan, Ministry of Information (National and State level), Media Authority on efforts to promote access to information, freedom of expression, and safety of journalists.

This project aims to ensure the sustainability of its interventions and seeks to scale up the activities into the third phase of the constitution making process which involves the debate and final adoption of the permanent constitution by the Constituent Assembly and subsequent civic education. The project is being implemented in close collaboration with the government, particularly the MOJCA and R-NCRC and will continue to work with additional statutory bodies like NCC. The NCRC are seeking additional matching funds from the national consolidated fund and international donors giving them a greater stake in the success and sustainability of the process. Adopting the permanent constitution will end activities in the process of drafting it, which will not need further support. The project will strengthen CSOs, the media, community structures and networks of women and youth groups. As such, the project will foster local ownership at the national, state and community level, increase the sustainability of the results long after the project ends and lay a foundation for open and democratic participation in governance and building a culture of constitutionalism in the future.

Also, to ensure sustainability, national organizations/CSOs, have been empowered to implement and advocate for an inclusive gendered constitution making process. For instance, through the project, the Union of Journalists of South Sudan (UJOSS) has gone ahead to strengthen its presence and network in all 10 states and 3 Administrative Areas to bolster media monitoring and continued advocacy for a conducive media environment and the safety of journalists during the constitution making process and implementation of the peace agreement across the country.

Since the NCRC assumed office in November 2023, it has started substantive work commencing with the development of tools of operation including the workplan, organogram and rule of engagement. The NCRC has also commenced the civic education envisaged to culminate into actual drafting of the constitution. However, the NCRC has not received additional resources, as the government has not disbursed funds for the operation of NCRC. Hence, the actual Constitution making process, as per the NCRC leadership, will commence on an 18-month action plan adopted by the NCRC and receiving some financial resources from the government to launch the process of civic education and public consultations, and appoint the Constitution Drafting Committee (CDC). The NCRC is to practically commence actual activities on civic education neither the formation of the drafting committee.
