The project has closely collaborated with the Autonomous Bougainville Government's (ABG) Department of Bougainville Independence Mission Implementation (DIMI), the ABG Media Bureau, and the ABG Department of Community Development to coordinate, plan, and implement the Sustaining Peace in Bougainville (SPB) project. Strong partnerships have been established with the Secretary for the Department of Independence Mission Implementation (DIMI) Ms. Stephanie Elijah, and the Secretary for Community Development Mr. Medley Koito.

The project successfully engaged 29 out of 34 Community Governments to mobilize women and youth for community dialogues, which were jointly facilitated by UNFPA and the Nazareth Centre for Rehabilitation (NCFR). This engagement demonstrates government involvement from the ABG's ministerial level down to grassroots governance. Additionally, the project strengthened the capacity of Bougainville Community Governments by promoting knowledge about gender-responsive governance and inclusive economic development, both of which are essential for fostering sustainable peacebuilding in Bougainville.

Moreover, the project actively collaborated with the ABG Department of Commerce, Trade, Industry, and Economic Development by contributing to the development of the Bougainville Economic Development Plan 2025-2035 (BEDP 2025-2035). This plan includes key components such as Private Sector and Investment Growth through Special Economic Zones (SEZs) and MSME incubation hubs. UN Women played a critical role in ensuring that the BEDP is inclusive of gender and disability considerations and aligned with local economic development (LED) priorities.

To commemorate International Women's Day, the project partnered with the ABG to raise awareness about women's economic empowerment and to generate momentum for community-based livelihood activities. Additionally, the project collaborated with the ABG on Human Rights Defenders initiatives to enhance strategic planning, expand the Human Rights Defender network, and strengthen inclusive governance frameworks within the Bougainville Government.

Finally, the project supported the mediation and consultation process during the Moderators' consultations between the Government of Papua New Guinea and Bougainville, with backing from the Department of Peacebuilding and Political Affairs. Since January, three consultation meetings have been held to identify key issues requiring resolution to progress toward a mutually acceptable political settlement. The project engaged with various levels of government, including the Chief Secretary, the Secretaries and the directors of both governments to ensure that the project is aligned with the ongoing Moderation process.

The PBF/Bougainville Programme Coordinator commenced her role in January and has since played a pivotal role in enhancing coordination and collaboration among the three participating UN agencies. Under her leadership, biweekly coordination meetings have been established, providing a consistent platform for sharing updates and planning the successful implementation of project activities. A significant milestone was the consolidation of each agency's Annual Work Plan into a unified AWP for the project. Regular coordination meetings among the four agencies have not only strengthened inter-agency collaboration but also reaffirmed their collective commitment to advancing the peace-development-humanitarian nexus.

Recruitment efforts are ongoing, with the process to onboard the Governance and Peace Specialist (IPSA10) currently in progress. This position is expected to further strengthen the programme's operational capacity and support the delivery of key initiatives.

In addition, the contracting of an international communications and Knowledge management consultant and the national Documentation and Knowledge management consultant has expedited significantly the implementation of outcome 2 and brought additional expertise on the ground for the key activities such the community dialogues conducted in May and June.

In terms of stakeholder engagement, bilateral meetings have been held with department heads and directors of the Autonomous Bougainville Government (ABG), as well as with civil society organizations such as the Bougainville Women's Federation (BWF). These engagements have been instrumental in sharing information, providing updates on project progress, and reinforcing collaboration and coordination with local partners.

The implementing partner – NCFR - was supported to build their capacity to collect and analyze data via Kobo Toolbox to measure community sentiments on the post-referendum peace process. As a result 29 community dialogues across 13 districts were conducted.

Draft work plans with ABG Media Bureau and Bougainville Women's Federation (BWF) await finalization due to delayed PBF second-tranche disbursement, though participants from both organizations remain engaged in trainings. A draft UN-to-UN agreement with IOM for the Displacement Tracking Matrix also awaits funds. Activities under a signed work plan with ABG Community Development were completed in 2024 and payments are still in process. The partnership with OHCHR on "Education for Peace" human rights defender training has resulted in the completion of three trainings across the three regions of Bougainville.

As a result of these coordinated efforts, outreach and engagement activities have successfully reached 29 out of 34 Community Governments, along with the Bougainville Women's Federation, women members of Parliament, and Human Rights Defenders. These efforts have been particularly focused on conflict-affected communities such as Konnou, Bana, and Tonu in South Bougainville. These achievements mark a significant step forward in building inclusive and community-driven peacebuilding processes across Bougainville.

Activities related to outcome 1 have seen limited progress with the ongoing moderation process between the government of Papua New Guinea (PNG) and the Autonomous Bougainville Region taking longer than expected, during this reporting period. The political agenda is closely linked to this process, and hastening negotiations would be counterproductive, so the Project has concentrated on supporting it in a complementary way. Additionally, outcome 3 has not progressed during this period due to a lack of funding due to cash-flow issues, as the second tranche has already been allocated to the agreement with the implementing partner. As a result, the project has focused on monitoring the work completed last year and providing technical support to the Autonomous Bougainville Government (ABG) using in-house resources.

Outcome 1

Activity 1.1.1-1.1.5:

While the Joint Supervisory Body meeting and Bougainville elections are pending, preparatory efforts have laid key groundwork. The project did not support formal dialogue forums but contributed to mediation efforts between the Governments of Papua New Guinea and Bougainville through technical support to RCO and DPPA. Activities related to power transfer remain sensitive and unimplemented, with concerns over perceived readiness for independence. Recruitment of technical experts was not pursued as it was not identified as a need.

Activity 1.2.1-1.2.4:

One session was held for women election candidates on the post-Referendum process. Bilateral meetings with key stakeholders helped align perspectives and promote inclusive dialogue. The project re-engaged with the Bougainville House of Representatives and is planning support for the inactive Bipartisan Committee on Bougainville Affairs. Continued capacity-building for women MPs has equipped them to engage in post-referendum discussions, including the Enga Road Map and Era Kone Covenant.

Outcome 2

Activity 2.1.2 UNFPA and ABG Media Bureau developed information kits and high-quality printed materials in November 2024 for Sir Jerry Mataparae's (the independent Moderator) visit. Despite ABG endorsement, broader distribution remains on hold pending PNG government approval, delaying dissemination to communities. Mediaskills workshops for implementing partners were completed during the June reporting period.

- Community Dialogues Training of Trainers were held on 27 June 2025 which included 7 participants (5 female, 2 male)
- Community Dialogues Training of Trainers Buka Urban Pilot were held on 28 June 2025 which included 25 participants (10 male, 11 female)
- Media Training with Implementing Partners was held from 3-4 June 2025 for 19 communication officers/focal points (14 female, 5 male)
- Media Training with Journalists was held from 5-6 June 2025 -for 6 journalists (5 female, 1 male) from NBC, Post-Courier, ABG Media and New Dawn FM.

Activity 2.1.3 UNFPA have trained BWF staff on collecting participatory monitoring data via Kobo Toolbox for the Bougainville Voices Dashboard, ensuring that women's inputs inform ABG planning and budgets and can be sustained beyond the life cycle of this project. Furthermore, UNFPA is engaging with BWF to conduct a mapping of SMEs in Bougainville and supporting them through social media marketing, including a trade show at the innovation hub.

Activity 2.1.4 In November 2024, ABG Community Development with NCFR facilitators conducted a Youth Capacity Building Workshop in Siwai (4-8 November 2024; 30 participants) and a Bougainville Youth Forum & Open Dialogue in Kieta (18-22 November 2024; 37 participants), covering themes from "Peacebuilding Education and Trauma Resilience" to mental health and community engagement. Final payments and documentation remains outstanding due to delays in submission of supporting documents but payments have finally begun.

Activity 2.1.5 Between 26–29 May 2025, UNFPA conducted a Community Dialogues Training of Trainers session in Buka, where seven facilitators from NCFR and BWF practiced participatory exercises and configured Kobo Toolbox for real-time data capture. Two teams are slated to roll out 29 community dialogues (June–July 2025), with documentation, briefs, and infographics to follow through December 2025, culminating in a "Bougainville Community Dialogues Manual" and a "Bougainville Voices Dashboard" for participatory monitoring to inform the ABG Government's budgeting, planning and decision making (June–December 2025).

Activity 2.1.6 UNFPA in collaboration with UNDP and UN Women are planning a closing showcase event at the Innovation Hub in October 2025, which will integrate a trade show to promote Bougainville made products.

Activity 2.1.7 UNFPA and OHCHR completed "Human Rights Defender" trainings in Buka (27-28 November 2024), Arawa (9-10 May 2025), and Buin (12-13 May 2025), reaching a total of 65 participants who now serve as community-level HRD focal points. Participation in the Women Peace and Security (WPS) Summit (7-8 May 2025) further reinforced connections between human-rights education and women's leadership development. Setting the stage

for additional HRD sessions as staffing and schedules allow.

Activity 2.1.8 UNFPA and IOM are finalizing a UN-to-UN agreement (June 2025) to implement the Displacement Tracking Matrix (DTM) in Bougainville, pending transfer of the second tranche.

Outcome 3

It saw limited progress due to funding constraints; however, the project remained active in engaging government counterparts. It provided technical support to the Bougainville Government for the International Women's Day celebrations (7–8 March 2025), which gathered over 500 participants, including women leaders, CSOs, human rights defenders, and officials. The event featured awareness sessions on sustainable peace, women's economic empowerment, and the Women, Peace and Security (WPS) agenda, and strengthened the role of Community Government Chairladies in peacebuilding.

The project also supported the Department of Commerce, Trade, Industry and Economic Development in drafting Bougainville's first Economic Development Plan (2025–2035), which emphasized local governance reform, women's economic empowerment, and conflict-sensitive, sustainable development.

Additionally, peacebuilding awareness was promoted during the WPS Summit (7–8 May), which produced recommendations to enhance inclusive governance and resilience in Bougainville.

GEWE and Youth Inclusion has been ensured across project outputs through three strategies, a) working with organizations that specifically target women and youth, b) ensuring that methodologies use a participatory approach rooted in feminist and intersectional principles, and c) specifically targeting women and youth, for example through the WPS Summit and through the community dialogues where criteria for participation include 50% women and 50% youth of mixed gender.

Additionally, the project has promoted Gender Equality by providing technical assistance to the Department of Commerce, Trade, Industry and Economic Development to develop a gender-responsive governance and economic development framework.

In the reporting period, the PBF "Sustaining Peace on Bougainville" Project made significant strides in supporting Human Rights Defenders (HRDs) across the region, enhancing their capacity, visibility, and protection in a complex post-referendum environment.

The project strengthened grassroots peace networks, with a focus on equipping HRDs -many of them women, youth, and church leaders—with tools to document and mediate human rights issues. In conflict-prone areas like Tonu, Bana, and Konnou, HRDs received training in conflict sensitivity, human rights frameworks, and traumainformed approaches, enabling them to address local grievances, land disputes, and gender-based violence in nonviolent, rights-respecting ways.

HRDs also benefited from the project's inclusive governance approach, which promoted community dialogue and participatory decision-making. Through provincial consultations and peace summits, defenders engaged in shaping the Women, Peace and Security roadmap, integrating human rights protection into Bougainville's evolving political and legal landscape.

Crucially, the project elevated the profile of HRDs through public advocacy and storytelling, empowering defenders to safely share experiences of violence, injustice, and reconciliation. This visibility fostered stronger community trust and protective networks. Several HRDs emerged as local peacebuilders and mediators, resolving disputes once handled through retribution or silence.

At a systemic level, UN

agencies worked with ABG institutions to recognize the role of HRDs in advancing inclusive peace. This contributed to a safer environment for their work and increased collaboration between civil society and local government.

In sum, the project's impact on HRDs between in the reporting period in 2025 was multifaceted: building their capacity, amplifying their voices, and increasing protections, allowing them to play a vital role in Bougainville's path toward sustainable, rights-based peace.

Women peace mediators Between Jan -June 2025, the project has successfully:

- Amplified women's voices in Bougainville's peace and governance arenas.
- Equipped women with mediation and leadership skills, enabling them to resolve conflicts in families and communities.
- Granted access to economic and digital tools, empowering entrepreneurial and climateresilient pursuits.
- · Sparked mindset change, steering individuals from trauma and hostility to reconciliation and peace.

Enhanced Peacebuilding & Leadership Capacity

- Training grassroots mediators: **Dozens of Bougainvillean** women received training in conflict resolution, advocacy, and human rights. For example, Elizabeth, after being trained by UN Women and Melanesian Institute, became a peace mediator in her villageresolving land disputes and earning community respect **Inclusive Governance &** Advocacy
- Conflict-analysis tools: 22 women in Tonu, Bana, and Konnou received training in conflict sensitivity, social mapping, and financial literacy -enabling them to actively participate in post-referendum decision-making and peace processes
- Shifts in attitudes and behaviours: Participants like Merceline shared that following training, they moved from cycles of violence and revenge toward forgiveness and reconciliation. Similarly, Benedicta in Buka began using soccer gatherings to address domestic violence—reporting increased harmony in families and safer community environments. **Empowerment, Economic &**

Bougainville Voices Dashboard: A participatory monitoring tool developed with BWF and UNFPA, enabling community feedback to inform ABG planning and budgeting beyond the project's lifecycle.

Community Dialogues Manual: A standardized guide to support ongoing local peacebuilding dialogues, ensuring continuity of community engagement practices.

2. Capacity Building and Local Ownership

Training of Trainers (ToT): Local facilitators were trained to lead community dialogues and human rights education, creating a pool of skilled individuals who can continue activities independently.

Support to Women Leaders and MPs: Targeted capacity-building has equipped women leaders to actively participate in governance and peace processes, reinforcing inclusive leadership.

3. Socio-Economic Empowerment

Support to Women-led SMEs: Through mapping, marketing support, and trade shows, the project has strengthened women's economic resilience, linking peacebuilding with livelihoods.

Bougainville Economic Development Plan (2025–2035): The plan integrates conflict-sensitive, gender-responsive, and environmentally sustainable strategies, with a focus on empowering Community Governments to drive local economic development.
