**The project has engaged several relevant government actors, including the Liberia Land Authority, the National Bureau of Concessions (NBC), the Environmental Protection Agency (EPA), and the Ministry of Agriculture, through the Technical Working Group. These meetings facilitated the review and adoption of the joint annual work plan, the M&E plan, and the joint field missions plan. During these meetings, the implementation status, including challenges, was discussed and solutions devised. The Chairman of the Liberia Land Authority (LLA) chaired these meetings that included UN Women, UNDP, WFP, AEDE, NBC, EPA, and MIA.**

**The Project completed preliminary and preparatory activities, laying a strong foundation for implementation. Key milestones included the contracting of implementing partners and local NGOs to support community engagement and technical assistance, as well as the recruitment and training of core staff within the Liberia Land Authority (LLA) and project teams. Institutional structures were operationalized, with business plans and administrative procedures established in alignment with the Land Rights Act of 2018. At the community level, preparatory work such as self-identification, boundary harmonization, and governance training has been completed in thirty-two customary land-owning communities, ensuring readiness for formal land documentation. Gender-responsive measures were integrated throughout, promoting women's participation in decision-making and dispute resolution. With these foundational steps achieved, the project proceeded to advance toward full-scale implementation, including the issuance of communal land deeds and continued capacity building for sustainable land governance.**

## Project progress summary

**In 2025, Liberia's land governance sector recorded notable progress under the Liberia Land Authority (LLA) with support from this Project. Key reforms included the introduction of a standardized National Deed Form, new operational guidelines for validating tribal certificates, and interim measures for public land transactions. These changes aim to curb fraudulent practices, improve transparency, and formalize customary land rights. Additionally, over 23 communities received statutory deeds securing nearly one million acres, while alternative dispute resolution mechanisms were promoted to address conflicts involving women, youth, and marginalized groups.**

**The project continues to support semi-formal and informal dispute resolution structures to enhance their capacity to use alternative dispute resolution procedures and to actively engage women, ensuring their participation. In addition, communities' perception towards women's rights to land ownership has positively shifted, allowing women to fully participate in land governance and ensuring they inherit and own land.**

This was done through a quizzing competition featuring key portions of the land rights law and other land rights regulations**

**An additional two community radios were engaged in Gbarpolu and Bomi counties and are now airing land rights messages in both English and the local vernaculars. This brings the number of community radios airing land rights messages in the western region of the country to five. Additionally, forty-six community women and youth were trained and are now disseminating messages on women's access and ownership of land, processes to legally acquire community land, the presence of ADR mechanisms to settle land disputes, and locations of local land governance structures. This has increased the awareness of women in the communities on their rights to land and how to make use of the ADR systems.**

**The project donated a Toyota Land Cruiser hardtop vehicle to the National Bureau of Concession (NBC) to strengthen its capacity to monitor and address potential triggers of land and concession conflicts. This vehicle will also enable field verification of complaints received from concession-affected communities through the call centers and facilitate timely engagement with stakeholders to resolve the issues.**

**Gender equality and women's empowerment, as well as youth inclusion, remain an integral part of the project's implementation. Through established land governance structures, women and youth in the project counties have strengthened their participation in land governance and ownership, ensuring that issues that affect them are given attention. For example, all established Community Land Development and Management Committees (CLMDCs) are gender balanced to the extent that leadership roles are equally distributed, with 50% held by women and 50% by men. This ensures that both genders share equal responsibility in decision-making regarding land matters. Meanwhile, youth engagement emerged as a cornerstone of the project's success. Young people aged 18 to 35 constitute approximately 53% of all individuals reached during implementation. Their active participation spanned multiple domains, including serving as community facilitators during town hall meetings and awareness sessions. This involvement not only empowered youth but also ensured intergenerational continuity in land governance and community development.**

**Furthermore, women, men, and youth are involved in alternative dispute resolution, livelihood interventions, and community mapping processes. The project is further empowering women's structures, such as the Peace Huts, as agents of change in their role in peacebuilding and conflict resolution. Such interventions targeting women-led community structures enhance the capacity of women to constructively engage in peacebuilding processes by also reducing financial constraints that have in the past impeded their participation.**

**In September 2025, 23 customary communities received legal titles to their land (land deeds) from the government of Liberia, supported by the project. This is a significant milestone that greatly contributes to the reduction in land disputes in the country. It addresses the long-standing issue of land ownership and boundary demarcation that were once potential triggers for violent conflicts. With the granting of these deeds, these customary communities now have the right to decide how to use their land so that it provides benefits for all.**

**Meanwhile, the project facilitated the establishment of 23 additional Community Land Development and Management Committees (CLDMCs) to manage the land on behalf of the communities. Each beneficiary community developed its own bylaws, tailored to local customs and legal frameworks, and officials were elected that reflect a 50/50 gender balance.**

**One of the most challenging aspects of the project was addressing land disputes in Grand Gedeh County, a region marked by the influx of Burkinabe migrants seeking agricultural opportunities. This migration triggered widespread land grabbing, resulting in violent conflicts, loss of life, and destruction of property. In response, the project prioritized dispute resolution in Grand Gedeh, successfully resolving sixteen critical land conflicts. These interventions restored stability and paved the way for peaceful coexistence. The resolution of these conflicts demonstrates the project's relevance in navigating complex socio-political landscapes and delivering tangible peace dividends. It also underscores the importance of inclusive dialogue, legal clarity, and community ownership in mitigating land-related tensions.**

**Alternative Dispute Resolution (ADR) mechanisms established under this project in Bomi, Gbarpolu, and Grand Cape Mount Counties have documented 87 land dispute cases (23 in Grand Cape Mount, 18 in Bomi, and 41 in Gbarpolu). Of these cases, 33 have been resolved through mediation, 42 are still being mediated, and 1 has been referred to local government authorities for intervention. In addition, an accumulative total of 183 (96F & 87M) members of the MSPs, CLDMC, and County Land Offices from thirteen (13) concession-affected communities in Nimba and Grand Gedeh Counties benefited from gender masculinity and ADR trainings. These training sessions focused on understanding ADR and its processes, including mediation and negotiation, and the referral pathway.**

**Meanwhile, 8 of the farmer groups that established VSLAs have begun to increase their incomes through the process. This has provided access to finance for the members of the groups to attain economic stability. The table below shows the income generated in Liberian dollars by the groups.**

**The once-strained relationship between affected community members in Sango-Zao and ArcelorMittal Liberia (AML) due to the loss of livelihood opportunities has improved since the commencement of the project in the area through the facilitation of regular meetings. During the reporting period, a consultative meeting was held in which the company encouraged the farmers' groups to establish cooperatives to facilitate direct purchase from the company and better link to market opportunities. The meeting was attended by the Ministry of Internal Affairs (MIA), the Environmental Protection Agency (EPA), the Ministry of Agriculture (MOA), GERAD-Liberia, community leadership, and ArcelorMittal Liberia.**
