Please indicate what level of government the project has been engaging with. <i>Please limit your response to 3000 characters</i> <p>The project worked closely with the Autonomous Bougainville Government (ABG)—including the Department of Independence Mission Implementation (DIMI), Media Bureau, and Department of Community Development—to coordinate and implement the Sustaining Peace in Bougainville (SPB) project. Strong partnerships with DIMI Secretary Ms. Stephanie Elijah and Community Development Secretary Mr. Medley Koito have flourished, with Koito attending the UN's 50th Anniversary in Port Moresby (Oct 2025).</p> <p>Under UNFPA and Nazareth Centre for Rehabilitation leadership, 26 participatory community dialogues were completed across all 13 districts, engaging 692 participants—344 (49.7%) women and 19 (2.7%) persons with disabilities. These dialogues focused on ABG's six "Independence readiness" benchmarks: Law and Order; Governance; Social Services; Human Resource Development; Economic Development; and Health and Standards of Living. Endorsed by Parliamentary Motion, benchmarks require constituencies to define locally appropriate criteria.</p> <p>Dialogues, supported by Community Government Chairs, enabled communities to assess progress, identify challenges, and set priorities. Sessions integrated gender equality, disability inclusion, and power dynamics, producing practical recommendations: stronger leadership, better education and justice access, and improved support for survivors of violence. Participants' understanding of benchmarks rose from 2.84 to 4.15 (Likert scale), showing significant awareness gains.</p> <p>Findings gained political traction. With DIMI endorsement, UNFPA presented results to the Bougainville House of Representatives (Oct 2025), generating strong interest. A high-level dinner convened Women Members of the House, Women Department Secretaries, and partners (23 participants—15 women, 8 men, including UNDP and APLJ-DFAT), reaffirming commitments to peace, gender equality, youth empowerment, and inclusive development.</p> <p>The project also collaborated with ABG's Department of Commerce, Trade, Industry, and Economic Development on the Bougainville Economic Development Plan 2025–2035, which includes SEZs and MSME incubation hubs. UN Women ensured gender and disability inclusion in alignment with local economic priorities.</p> <p>To mark International Women's Day, the project partnered with ABG to promote women's economic empowerment and supported Human Rights Defenders initiatives to strengthen governance frameworks. A Women's Leadership Training engaged participants from North, Central, and South Bougainville preparing for ABG elections, co-facilitated by DIMI and UN agencies.</p> <p>The project enabled ABG Technical Services officials' participation in Port Moresby meetings on transfer of powers and coordinated a Peacebuilding Fund mission to Buka, facilitating dialogue with ABG secretaries and partners. It also supported mediation during Moderators' consultations between PNG and Bougainville, contributing to the signing of the Melanesian Agreement. Engagement with both governments ensured alignment with the ongoing Moderation process.</p>

The PBF/Bougainville Programme Coordinator assumed her role in January and has since strengthened coordination among the three participating UN agencies. Bi-weekly meetings were established to share updates and plan activities, and a major milestone was the consolidation of individual agency work plans into a unified Annual Work Plan. These regular meetings have reinforced inter-agency collaboration and commitment to advancing the peace-development-humanitarian nexus.

Recruitment for the IPSA-10 position began in April but was delayed due to the late transfer of the final tranche of project funds. The process was finalized in November 2025, and the role will enhance operational capacity and support delivery of key initiatives.

Stakeholder engagement included bilateral meetings with ABG department heads, directors, and civil society organizations such as Bougainville Women's Federation (BWF) and Bougainville Youth Federation (BYF). These engagements have been critical for sharing progress and strengthening collaboration. NCFR was supported to build capacity in data collection and analysis using Kobo Toolbox, enabling facilitators to capture real-time data from 26 community dialogues now featured on the Bougainville Voices dashboard.

A draft work plan with BWF awaits finalization due to delayed tranche disbursement, though BWF remains active in trainings. Similarly, a draft UN-to-UN agreement with IOM for the Displacement Tracking Matrix will proceed now that the second tranche has been released. Activities under ABG Community Development's signed work plan were completed in 2024, with payments pending. OHCHR partnership on "Education for Peace" resulted in three Human Rights Defender trainings across Bougainville.

Through these coordinated efforts, outreach has reached all 26 constituencies across 13 districts, engaging BWF, women MPs, and Human Rights Defenders, with a focus on conflict-affected areas such as Konnou, Bana, and Tonu in South Bougainville. In collaboration with the Department of Commerce, Trade and Economic Development, UN Women distributed 57 forms in these hotspots—Konnou (20), Bana (20), Tonu (17)—to help women and youth groups register cooperatives that will generate livelihoods and strengthen local peace.

These achievements mark significant progress toward inclusive, community-driven peacebuilding and reinforce partnerships between UN agencies, ABG, and civil society to advance Bougainville's post-referendum roadmap.

Activities related to outcome 1 have seen limited progress with the ongoing moderation process between the government of Papua New Guinea (PNG) and the Autonomous Bougainville Region taking longer than expected, during this reporting period. The political agenda is closely linked to this process, and hastening negotiations would be counterproductive, so the Project has concentrated on supporting it in a complementary way. Outcome 2 is close to completion with just two activities remaining: Activity 2.1.6 and Activity 2.1.8. Targets for Activity 2.1.2 and Activity 2.1.3 are in progress and will be achieved by early 2026. The no-cost extension will enable full project delivery. Additionally, outcome 3 has not progressed during this period due to a lack of funding due to cash-flow issues, as the second tranche has already been allocated to the agreement with the implementing partner. As a result, the project has focused on monitoring the work completed last year and providing technical support to the Autonomous Bougainville Government (ABG) using in-house resources.

Outcome 1

Progress under Outcome 1 has been limited due to the ongoing moderation process between the Government of Papua New Guinea and the Autonomous Bougainville Government (ABG). While the formal Joint Supervisory Body (JSB) meeting and Bougainville elections are pending, preparatory efforts have laid important groundwork.

The project supported the RCO and DPPA in providing technical assistance for mediation and consultations addressing outstanding post-referendum issues. Transfer of powers remains a sensitive topic, with concerns that lack of visible progress could signal limited readiness for independence.

No progress was made on convening formal dialogue fora or recruiting short-term technical experts, as these were not identified as immediate needs. However, bilateral meetings were held with key stakeholders, including the Clerk of the Bougainville House of Representatives, BWF, and the Departments of Community Development and Community Government, helping align perspectives and ensure inclusive participation.

One session was conducted for women contesting elections on the post-referendum process, including the Enga Road Map and Era Kone Covenant. The project also maintained active communication with Members of Parliament and the Bipartisan Parliamentary Committee for Bougainville Affairs, which has been inactive since 2017. Plans are underway to provide technical and logistical support to reactivate this committee.

Targeted capacity-building initiatives continued for women MPs and leaders, equipping them to engage meaningfully in post-referendum processes and future political mechanisms.

Outcome 2

Activity 2.1.2: Media training strengthened communication capacity among partners and journalists, including three Bougainville Women's Federation (BWF) members who contested elections. Training enhanced skills in press release writing and virtual engagement, promoting balanced media discourse.

• 3–4 June 2025: Training for 19 communication officers (14F, 5M).

• 5–6 June 2025: Training for 6 journalists (5F, 1M) from NBC, Post-Courier, ABG Media, and New Dawn FM.

UNFPA also supported Nazareth Centre for Rehabilitation (NCFR) to hire a media officer to improve social media, videography, and liaison with journalists.

Activity 2.1.3: UNFPA trained BWF staff on participatory monitoring via Kobo Toolbox for the Bougainville Voices Dashboard, ensuring women's inputs inform ABG planning. A high-level dinner (23 participants: 15F, 8M) with Women MPs, Department Secretaries, and partners reaffirmed commitments to peace, gender equality, and youth engagement.

Activity 2.1.4: ABG Community Development completed youth workshops on peacebuilding and mental health (67 participants). Payments were delayed due to tranche disbursement but will be processed.

Activity 2.1.5: UNFPA held a Training of Trainers (26–29 May 2025) for seven facilitators (5F, 2M) from NCFR and BWF. Two teams rolled out 26 community dialogues across 13 districts, reaching 692 participants (344 women; 19 persons with disabilities). Dialogues explored six independence benchmarks, gender, and inclusion, raising understanding scores from 2.8–3.0 to 4.03–4.27. Communities emphasized family stability as key to readiness. Results were presented to the new ABG House in October 2025 and received enthusiastically. A manual and detailed report are being developed.

Activity 2.1.6: Plans for a closing showcase—likely a Football for Peace tournament—are underway, pending tranche disbursement.

Activity 2.1.7: Human Rights Defender trainings in Buka, Arawa, and Buin reached 65 participants, now serving as community focal points.

Activity 2.1.8: UNFPA and IOM will finalize an agreement to implement the Displacement Tracking Matrix following tranche release.

By combining participatory approaches with real-time data capture, the project created a replicable model that bridges community priorities and government decision-making, advancing inclusive peacebuilding across Bougainville.

Outcome 3

Progress under Outcome 3 was limited due to cash-flow constraints; however, the project actively engaged with government counterparts. Technical support was provided to the ABG Community Development Department for International Women's Day celebrations (7–8 March 2025) in Buka, which gathered over 500 participants, including

women leaders, civil society, human rights defenders, government officials, and development partners. Awareness sessions focused on sustainable peace, women's economic empowerment, and the Women, Peace and Security (WPS) agenda, while enhancing the role of 9 Community Government Chairladies as peacebuilding implementers. The event strengthened networking among women's groups, government agencies, business associations, and faith-based organizations.

The project also supported the Bougainville Economic Development Plan (BEDP) 2025–2035, emphasizing governance reform, local economic development, and women's economic empowerment through women-led businesses and youth entrepreneurship. The BEDP integrates conflict-sensitive approaches, environmental sustainability, and disaster resilience, with a focus on women and girls.

Additionally, awareness sessions during the WPS Summit (7–8 May) produced recommendations for inclusive governance and resilience. The project worked with ABG to operationalize priorities from the Local Economic Development Assessment Survey in hotspot areas. In collaboration with the Department of Commerce, Trade and Economic Development and UN Women, 57 forms were distributed in Konnou (20), Bana (20), and Tonu (17) to help women and youth groups register cooperatives for livelihoods and peacebuilding.

GEWE and Youth Inclusion has been ensured across project outputs through three strategies, a) working with organizations that specifically target women and youth, b) ensuring that methodologies use a participatory approach rooted in feminist and intersectional principles, and c) specifically targeting women and youth, for example through the WPS Summit and through the community dialogues where criteria for participation include 50% women and 50% youth of mixed gender.

Outcome 1: In terms of broader peacebuilding efforts, the project has contributed meaningfully to ongoing consultations between the National Government and the Autonomous Bougainville Government. These dialogues have supported decision-making processes related to the implementation of the Bougainville Peace Agreement (BPA) and post-referendum arrangements. As a result of these sustained engagements, public hearings led by the bipartisan committee are currently underway across the country.

Through Outcome 2: Structural change is already underway: ABG seeks to institutionalize the community-dialogue methodology used by UNFPA and NCFR into its annual planning and budgeting cycle. Institutionalising this approach within ABG systems will create sustainable financing pathways for NCFR and other local partners, reducing reliance on short-term project funds and supporting long-term peace dividends. It will also facilitate the prioritization of community level priorities in Government planning processes. High-level discussions between Department Secretaries (Community Government, Finance and DIMI) and UN partners are already in progress, with the first concrete step being the Secretaries' facilitation of the Bougainville Voices Regional Workshops (24-28 November 2025).

In these workshops, UNFPA and NCFR will present the detailed results of the community dialogues after which the Departmental Secretary's will guide Members of Parliament and Community Government Chairpersons to access, cost and allocate ABG budgets directly against priorities identified through the Bougainville Voices dashboard, creating a consistent and repeatable link between community evidence and government decision-making.

The goal of the regional workshops is to secure a tangible commitment from all 44 constituencies to allocate PGK 1 million each for 2026 (PGK 44 million / ~USD 10 million) to address priority actions arising from the dialogues. Embedding these processes within government practice will strengthen accountability, improve community-government feedback, and support sustained peace and development in Bougainville.

Partnerships with Secretary Stephanie Elijah (DIMI) and Secretary Medley Koito (Community Development) have been particularly strong, yielding joint efforts on independence dialogues at the policy level, media training at the societal level, and support for community dialogues at the local level. Individual relationships among UN focal points have further consolidated government backing for SPB.

The Bougainville Voices Dashboard, powered by Kobo Toolbox, enables ongoing participatory monitoring and data-driven decision-making by ABG and communities. Community Dialogues have produced a replicable manual to institutionalize inclusive approaches at local levels. Networks of Human Rights Defenders (65 trained focal points) and strengthened Bougainville Women's Federation capacities ensure continued advocacy for gender equality and peace. Socio-economic initiatives include support for women-led cooperatives and youth entrepreneurship through the Bougainville Economic Development Plan (2025-2035), embedding conflict-sensitive and resilience strategies. These platforms and partnerships create lasting structures for inclusive governance, local economic development, and community-driven peacebuilding.
