Consequently, the CMP project does not have a dedicated, project-specific Steering Committee. Day-to-day management and project-related decisions are considered under the broader UNDP Access to Justice project framework. The most recent board meeting was held on 29 October 2025, during which annual results were presented and formally adopted.
The project is further supported by an active Technical Working Group (TWG) composed of all implementing agencies —UNDP, UNESCO, and UN Women—alongside the PBF Secretariat within the Office of the UN Resident Coordinator. TWG provides a structured platform to monitor implementation progress, share lessons, and offer technical guidance to mitigate challenges or bottlenecks that could impede or delay project delivery. This mechanism ensures coordinated oversight, strengthens inter-agency collaboration, and reinforces the project's capacity to achieve its objectives efficiently and effectively.

The project has maintained a consistent and high-level engagement with various branches and levels of the South Sudanese government over the last 10 months, primarily at the national level. The project engaged with the National Constitutional Review Commission (NCRC), which is the key institution mandated to lead the constitution-making process. The project's support was instrumental in a major national milestone: the NCRC's official launch of the civic and public consultations for the Constitution-Making Process on 27 March 2025. This collaboration continued with the project supporting the actual commencement of the first phase of public consultations in October 2025 across four (4) states, including Eastern Equatoria, Western Bahr El Ghazal, Northern Bahr El Ghazal, and Lakes States. This engagement is foundational, as it marks the start of substantive public participation, raising awareness and gathering citizens' input to directly inform the drafting of the nation's Permanent Constitution.

In parallel, the project has actively partnered with key line ministries to ensure inclusive governance. A significant partnership with the Ministry of Gender, Child and Social Welfare culminated in the official and public submission of the South Sudan Women's Charter to the NCRC on 21 August 2025. This action, taken in line with the Constitution Making Process Act, 2022, is designed to ensure that women's priorities are systematically integrated into the new constitution, thereby strengthening gender equality in national policymaking. To further anchor gender inclusion within the legislative branch, the project worked with the Women Parliamentary Caucus (WPC) of the Transitional National Legislative Assembly, enhancing the members' capacity to contribute effectively to the deliberations for a gender-sensitive permanent constitution.

Furthermore, the project engaged the Ministry of Youth and Sports, in collaboration with the Ministry of Gender, to officially launch the South Sudan Youth Charter in July 2025. The project facilitated the printing and dissemination of 2,000 copies of this charter to civil society and youth groups, with 500 copies formally submitted to the NCRC. The NCRC has since adopted this charter as a critical reference document in its nationwide civic education and public consultation activities, ensuring that youth perspectives are integral to the process.

Additionally, through an engagement with the University of Juba School of Law, a public institution, the project supported the development and dissemination of a validated Position Paper on Constitution-Making and Elections. This academic contribution provides key stakeholders with a critical analysis of the interlinkages between these two processes, advocating for a coherent and sequenced approach to South Sudan's democratic transition.

The main objective to deliver a people-driven and gender responsive permanent constitution in South Sudan. The, despite significant strides, the actual drafting of the permanent constitution was significantly delayed owing to slow rate of the formation of the statutory mechanisms for constitution making process. So far, only the National Constitution Review Commission (NCRC)-the main mechanism for leading the constitution making process has been formed and commenced it work. The other supporting mechanisms, including the Constitution Drafting Committee (CDC), the Preparatory Sub-Committee (PSC) for the National Constitutional Conference and the National Constitutional Conference (NCC) are yet to be formed. Despite these delays, significant achievements that lay the foundation for the actual drafting of the constitution have been attained. They include the enactment of the CMP Act of 2023, the development of the NCRCs rule of engagement documents, partnership with Civil Society for the conduct of nationwide awareness and consultations as well as the completion of round-one of the civic educations in four locations. Subsequent civic education is planned for the month of December 2025. Some of the key issues emanating from civic education include separation of power of the government arms, decentralization, term-limits of elected officials as well as gender equality and women's empowerment.

In summary, the NCRC has adopted a comprehensive set of civic and public consultation materials and toolkits, including the Women's Engagement Strategy, to guide inclusive public participation in the Constitution-Making Process. This adoption paved the way for the official launch of civic education and public consultations in Juba in March 2025, followed by subnational consultations — including women-specific consultations — held in Eastern Equatoria, Western Bahr El Ghazal, Northern Bahr El Ghazal, and Lakes States in October 2025. Through six (6) grassroots dialogues, dissemination of civic education materials, and NCRC-led consultations, a total of 2,184 individuals (1,261 women and 916 men) have been empowered with information on the Constitution-Making Process and key constitutional topics. This engagement is anticipated to increase meaningful participation and community mobilization during the ongoing national consultations. The overall consultations and civic education is led by the NCRC and apply the civic educations tools previously developed and validated for quality.

The launch and commencement of civic and public consultations marked a significant milestone toward a people-driven and inclusive Permanent Constitution that addresses gender barriers and integrates gender equality and youth-centered principles. These consultation materials were developed with technical assistance from constitutional experts from South Africa and Kenya. The materials have further been used to train 217 constitutional actors (147 women and 70 men) from the NCRC and the Transitional National Legislative Assembly (TNLA) by the same experts from South Africa and Kenya. The training focused on gender-responsive public participation and constitutional gender mainstreaming, culminating in a hands-on session on public sensitization and consultation methodologies held from 23–26 September 2025.

In accordance with Section 12 (6) of the Constitution-Making Process Act (2022), the NCRC formally received the South Sudan Women's Charter, Youth Charter, and seven (7) position papers commissioned in collaboration with key stakeholders, including women, youth, and persons with disabilities. These papers aim to promote inclusive dialogue, facilitate mediated negotiations, and build broad consensus on critical constitutional issues While the actual text of the constitution has not been drafted, these position papers will form the basis for these themes and principles to be included in the final constitution.

The position papers cover key themes such as:

- Affirmative action for women
- Constitutional safeguards against gender-based and conflict-related sexual violence (CRSV).
- Protection of the Bill of Rights and international human rights conventions
- Land reforms
- Women's socio-economic rights
- Access to justice is a constitutional right
- Electoral provisions

These position papers were commissioned through partner organizations including the Centre for Inclusive Governance, Peace and Justice (CIGPJ), the International Federation of Women Lawyers (FIDA) South Sudan, the Human Rights Commission of South Sudan, and the University of Juba.

The project also strengthened media engagement by training and mentoring 60 journalists (41 women, 19 men) on gender-sensitive and accurate reporting of the constitution-making process, in partnership with the Female Journalists Network (FJN) in November 2024. Consequently, journalists have begun publishing gender-sensitive articles, while women leaders have gained confidence in articulating women's priorities through radio talk shows, press statements, and consultative meetings.

Further, in partnership with the Union of Journalists of South Sudan (UJOSS), 25 journalists (15 men, 5 women) from the Abyei Administrative Area were trained on ethical reporting, fact-checking, gender-responsive and conflict-sensitive journalism, safety and protection, and media law. Following the training, journalists in Abyei have increased their coverage of the Constitution-Making Process, and UJOSS has enhanced its presence and monitoring capacity in the region. A Journalists' Safety Guide was also developed and disseminated to promote both physical and digital safety during reporting. As results, journalists who are members of UJOSS are more sensitive and safer in

their reporting as per the UJOSS reports.

In partnership with Samaritan Media (CSO), the project conducted capacity-building workshops for eight (8) community radio stations and community groups across the country. Targeted stations included:

- Amadi FM (Mundri West, Western Equatoria)
- Voice of Hope (Magwi County, Eastern Equatoria)
- Pibor FM (Greater Pibor Administrative Area)
- Iyete FM (Morobo County, Central Equatoria)
- Yirol FM (Yirol West County, Lakes State)
- Jam Jang FM (Ruweng Administrative Area)
- Nile FM (Malakal, Upper Nile)
- Voice of Reconciliation (Bor, Jonglei

The training focused on promoting community listenership, the role of listener clubs, and inclusive radio programming. As a result, two listener clubs were established in Morobo and Pibor, strengthening community ownership of the Constitution-Making dialogue. Following these interventions, participating radio stations expanded their production and broadcasting of programmes, public service announcements, and talk shows on the Constitution-Making Process. During ongoing public consultations in Rumbek, Torit, Magwi, and Wau, radio programmes aired in local languages such as Arabic and Dinka significantly increased public awareness and engagement. It is estimated that through these efforts, approximately 920,000 people have been reached nationwide.

The project also launched a series of Constitutional Dialogues to foster inclusive participation in the drafting process. The first Youth Constitutional Forum, held on 21–22 May 2025, brought together over 90 youth participants (40 female) to discuss the Constitution-Making Process, civic education campaigns, and NCRC's role in facilitating consultations. A second dialogue, held in September 2025, convened over 120 youth from across South Sudan to deliberate on the recently launched Youth Charter (July 2025) and to disseminate additional copies nationwide.

The National Constitution Review Commission (NCRC) adopted the Women's Engagement Strategy and the Gender-Responsive Public Consultation Toolkit, both of which have significantly strengthened the participation of women, youth, and persons with disabilities in the ongoing nationwide civic education and public consultations on the Constitution-Making Process. This was evidenced inclusion of gender equality and women's empowerment as a key theme and take away from the consultations. This achievement represents a major step toward ensuring that the Permanent Constitution is people-driven, inclusive, and responsive to gender equality and youth priorities, while addressing long-standing barriers to meaningful participation of both women and youth.

The milestones were made possible through targeted capacity-building provided to NCRC members on gender-responsive public participation, practical application of the consultation toolkit, and effective use of the Women's Charter and Youth Charter. This support was facilitated by the Senior Gender Advisor deployed to the NCRC and the project's implementing partner, the Centre for Inclusive Governance, Peace and Justice (CIGPJ), whose technical assistance has been instrumental in embedding gender and inclusion principles throughout the constitution-making process.

Through CIGPJ, the project trained 150 Members of Parliament (106 women, 44 men) from the Transitional National Legislative Assembly (TNLA) on gender mainstreaming in the Constitution-Making Process. As a result, legislators enhanced their knowledge and understanding of inclusive participation, gender-sensitive constitutional debates, and rights protection as measured through the post engagement assessments. Notably, 71% of the participants were women parliamentarians, primarily from the Women Parliamentary Caucus and the Young Parliamentarians Caucus, reflecting the project's strong focus on promoting women's leadership in the constitutional discourse.

In addition, 180 women and men (135 women, 45 men) across six South Sudanese locations — Yei, Torit, Bor, Wau, Yambio, and Juba — were empowered to lead grassroots awareness on the Constitution-Making Process. This was achieved through the strengthening of six women-led coalitions through targeted trainings and dissemination of Arabic-translated civic education materials. As a result, these coalitions have sensitized 200 community members (152 women, 48 men) on key constitutional issues, including women's inheritance rights, family law, marriageable age, property ownership, affirmative action, resource management, and subnational governance.

The central objective of this project is to facilitate the drafting and adoption of a permanent constitution for South Sudan that is people-centered, inclusive, and gender-responsive. While this ultimate goal remains in progress, significant foundational milestones have been achieved. The critical legal framework was established with the passing of the Constitution-Making Process (CMP) Act 2023, and the National Constitutional Review Commission (NCRC), the principal body mandated to lead the process, has been successfully constituted. However, the formation of other essential mechanisms, such as the Constitutional Drafting Committee (CDC), has been delayed due to political and financing constraints for the NCRC.

The establishment of the NCRC itself is a monumental achievement in peacebuilding. Reconstituted to include 57 members and one ex-officio, its composition marks a pivotal step toward inclusivity, with 19 women (33.5%), including the Vice-Chairperson, and a youth representation of 33.5%. This diverse membership reflects a national commitment to a more representative governance process. The NCRC's formation, which required broad political consensus, has now laid the groundwork for the multi-phase civic education and public consultations essential for a people-driven constitution.

Through the project's technical advisory support, the NCRC, in collaboration with the Ministry of Cabinet Affairs, Ministry of Finance, and Ministry of Justice and Constitutional Affairs, organized a high-level event on 6 March 2025 under the theme "Together for a People-Driven Constitution." The event assessed the NCRC's institutional and operational readiness to deliver on its constitutional mandate and advocated increased Government ownership and financial support. During the dialogue, the NCRC highlighted two key challenges: (i) a funding gap of USD 42.2 million from the Government, and (ii) the non-swearing-in of some (nine) NCRC members. These challenges led to delayed selection of the Constitutional Drafting Committee and delayed the nationwide rollout of civic education and public consultations. NCRC is however commenced their work started having completed phase-one of the civic education and public consultation of content of the constitution The Minister of Cabinet Affairs and the Minister of Finance reaffirmed the Government's commitment to prioritize financial resource allocation to the NCRC, alongside other electoral institutions, in the 2024/2025 National Budget, and to engage the Presidency to expedite the oath-taking of the nine remaining members. Despite the absence of direct government funding, substantive and procedural progress has been achieved through the Peacebuilding Fund (PBF) investment and partner contributions, underscoring the continued momentum of the process.

This operational progress is underpinned by a transformative stride in gender equality: the adoption of the South Sudan Women's Charter for Constitution-Making. Developed through nationwide consultations, the Charter outlines twelve constitutional priorities for women, contextualized for South Sudan, including equal participation in decision-making, economic rights, protection from gender-based violence, and land rights. This document is not just a guide for the constitution; it is already influencing national policy, informing the drafting of key legislation like the Anti-GBV Bill and the Women's Empowerment Bill. Its impact is also evident at the grassroots level, where six women-led coalitions across different regions are spearheading civic education and advocacy, ensuring that gender equality remains a central theme in public consultations.

The project has also catalyzed a remarkable expansion in public engagement. Compared to a minimal baseline in 2023, the project anticipates that by December 2025, at least 50% of the targeted 5 million people will have been reached with civic awareness messages through NCRC-led consultations and partnerships with civil society. To amplify this outreach, strategic media engagement has been vital. Training for 25 journalists in the Abyei Administrative Area on ethical, gender-responsive, and conflict-sensitive reporting has resulted in increased media coverage of the constitution-making process, enhancing public understanding and reinforcing the media's role as a driver of civic engagement. Through these combined efforts—building institutional capacity, empowering women and youth, and broadening public participation—the project has generated significant momentum toward a permanent constitution that embodies the aspirations of all South Sudanese.

1	Government Officials	NCRC is in the process of developing a targeted strategy that will effectively engage women, youth, and persons with disabilities in civic education and constitution drafting, advancing gender equality and inclusivity in the constitution-making process. This progress follows the training held from November 26 to 28, 2024, on 'Gender Responsive Public Participation in Constitution Making, using the comparative experiences from Kenya and South Africa,' which significantly improved members' knowledge and skills in inclusive public participation targeting both women representative and commissioners of NCRC. As a result of this training, they have actively mobilized and participated in the phase-one of the NCRC-led consultations from which gender equality has been included as key theme for consideration in subsequent consultations/civic education sessions. It is anticipated that, with the women and youth engagements, the text of the permanent constitution will be alive to key issues identified in both the South Women and Youth Charters.	"I am genuinely excited and deeply appreciative of the training centered on gender-responsive public participation in constitution making, drawing on comparative experiences from Kenya and South Africa. This was the first time such focused training had been organized specifically to empower the commissioners with the crucial knowledge they need. What made it stand out was its unique emphasis on building the capacity of Commissioners to engage effectively with the people of South Sudan during civic education and public consultations—a vital part of our broader strategic goals. The opportunity to learn from Kenya and South Africa's experiences brought clear benefits to the NCRC, especially in shaping a gender-responsive approach to public participation in constitution-making. It also helped develop a strategy to ensure women's voices are meaningfully included. The Constitution-Making Process (CMP) continues to play an important role in advancing South Sudan's state-building agenda as envisaged in the R-ARCSS, even as it progresses under challenging political, security, and resource conditions. The reconstitution of the National Constitutional Review Commission (NCRC) in November 2023; comprising 57 members and one ex-officio member, including 19 women, remains a foundational step under the Constitution-Making Process Act (2022). Although implementation has been slower than envisioned, the NCRC provides a strengthened institutional platform for promoting transparency, inclusivity, and national ownership as depicted the just-concluded phase one of the national consultations and civic education .

Phase One of civic education and public consultations has now been completed, marking an important step forward. During this phase, the NCRC successfully engaged communities across four states, reaching diverse populations to gather views on governance arrangements, federalism, governance systems, separation of powers, equality, affirmative action, human rights protections, natural resource management, the role of traditional authorities, and transitional justice priorities. This engagement expanded participation among women, youth, persons with disabilities, civil society actors, and community leaders, helping to widen civic space and enhance public understanding of constitutional matters. Despite constraints, including limited access to remote areas, logistical challenges, and varying subnational security conditions, Phase One strengthened public trust and provided an initial platform for inclusive dialogue.

At this stage, the CMP remains a work in progress, transitioning into Phase Two, which will involve national dialogue on the draft constitutional text the remaining location with targeted consultations and broader consensus-building among political stakeholders. Significant technical, logistical, and financial preparations are still needed to ensure Phase Two is conducted in an inclusive, gender-responsive, and credible manner. Continued support to the NCRC and relevant institutions will be vital to sustain momentum and maintain the participatory mechanisms established during Phase One.

As South Sudan moves toward the next stage, the CMP is gradually laying the groundwork for a legitimate and widely accepted constitutional order that supports peace, democratic governance, and long-term stability. While substantial work remains before achieving a fully ratified Permanent Constitution, the progress to date demonstrates a growing national commitment to shaping a constitutional framework will reflects the aspirations and voices of all South Sudanese.

Improved or initiated policy frameworks: The overarching objective of the Constitution-Making Process (CMP) in South Sudan is to deliver a people-driven, inclusive, and gender-responsive Permanent Constitution. While this ultimate goal has not yet been achieved within the lifespan of the project, substantial groundwork has been laid to anchor the drafting phase on a solid legal and institutional foundation. Notably, the Constitution-Making Process Act (2022) was enacted, providing the legal basis for the establishment and functioning of the statutory bodies responsible for steering the process. This legislation paved the way for the gradual formation of the constitution-making mechanisms, beginning with the reconstitution and operationalization of the National Constitution Review Commission (NCRC). These developments represent critical progress toward enabling a credible, participatory, and rights-based constitution-drafting process, even as the country continues to prepare for the subsequent phases required to achieve the final constitutional outcome

Partnered with local/grassroots civil society organizations: In strengthening the women-led coalitions engaged in the Constitution-Making Process (CMP), the project delivered targeted training and capacity-building across the country, with good examples in Juba, Yei, Torit, Yambio, Bor, and Wau. Through this effort, the project successfully mobilized and partnered with 30 grassroots civil society organizations, including women-led organizations, community-based women's groups, Women's Associations, media institution and youth organizations. These actors played a vital role in raising public awareness, lobbying for meaningful women's participation, creating awareness and knowledge and advocating for the inclusion of women's priorities and aspirations in the development of the Permanent Constitution.

Beyond grassroots CSOs, the project also collaborated with academic and statutory bodies, which contributed analytical expertise (position papers), facilitated dialogue sessions, and supported evidence-based advocacy on gender equality and inclusive constitution-making. Their involvement strengthened the quality of civic engagement, enhanced the credibility of public dialogues, and ensured that women-led coalitions had access to research, technical guidance, and platforms that amplified their voices at both national and subnational levels.

Strengthened partnerships within UN Agencies: The project strengthened collaboration across the UN system including UNDP, UNESCO, UNMISS, UN Woman and PBF Secretariat in supporting the NCRC, community members and other stakeholders engaged in the Constitution-Making Process. This included training on gender-responsive public participation and awareness raising where multiple UN entities worked together in planning and integrating comparative constitutional experiences, combining technical knowledge and field-level insights. The collaboration extended beyond the training itself, supporting subsequent consultations and broader activities led by the NCRC and other stakeholders. It demonstrated a coordinated, system-wide approach, reinforced institutional capacity, and contributed to more inclusive and effective engagement throughout the constitution-making process

Strengthened partnerships within UN Agencies: The project has fostered closer collaboration and coordination among UN Agencies to support the Constitution-Making Process (CMP) in South Sudan. While the implementing agencies routinely work together, the project has deepened these partnerships by pooling expertise, coordinating technical support, and jointly planning interventions. For example, in supporting the NCRC and broader constitutional consultations. Further, this is a joint project that bring UNDP, UNESCO and UNWOMEN together with strategic support from UMISS and RCO.

Partnered with local civil society organizations: The project actively partnered with national, local, and grassroots CSOs, including women-led organizations and youth groups, to support a people-driven, inclusive, and gender-responsive Constitution-Making Process (CMP). These organizations were trained on civic engagement, constitutional literacy, and advocacy, enabling them to lead They played a key role in advocating for the inclusion of women's, youth, and marginalized groups' priorities in the constitution. Through coordinated efforts with academic institutions and other stakeholders, these CSOs strengthened outreach, harmonized activities, and amplified community voices, helping to make the CMP more inclusive, responsive, and representative.

Partnered with local academia: The project partnered with Juba University to develop a Position Paper on Elections and Constitution-Making in South Sudan: A Paradox of Sequencing and Pragmatism. This paper provided evidence-based analysis and recommendations on the relationship between electoral processes and constitutional reform, exploring challenges and opportunities in sequencing governance reforms while promoting inclusivity and gender responsiveness and with Sout Sudan Context in mind

Partnered with national entities: The UN partnered closely with key national institutions to strengthen the Constitution-Making Process (CMP) and promote gender-responsive participation. Working with the National Constitution Review Commission (NCRC), the Women's Parliamentary Caucus (WPC), and the Ministry of Gender, Child and Social Welfare (MGCSW), the UN supported targeted trainings for NCRC members on gender-responsive public participation, drawing on comparative experiences from Kenya and South Africa, and for members of the Transitional National Legislative Assembly (TNLA) on constitutional gender mainstreaming.

Through these partnerships, the UN enhanced the capacity of national institutions to lead inclusive and participatory processes, ensured that women's perspectives and priorities were integrated into the CMP, and reinforced collaboration between government institutions and the UN system in advancing a gender-responsive constitutional process.

The project has played a crucial catalytic role in unblocking and advancing the stalled Constitutional Making Process (CMP) in South Sudan. Its primary non-financial impact has been to sustain high-level political momentum and forge a collaborative platform for key national stakeholders. By providing consistent technical advisory support and facilitating dialogue, the project helped convene a critical high-level event in March 2025 under the theme "Together for a People-Driven Constitution." This event directly addressed institutional blockages, bringing together the NCRC, the Ministry of Cabinet Affairs, the Ministry of Finance, and the Ministry of Justice and Constitutional Affairs. It served as a catalytic platform to publicly address and advocate for solutions to two major bottlenecks: a significant government funding gap and the delayed swearing-in of nine NCRC members. This high-profile advocacy resulted in concrete governmental commitments to prioritize budget allocation and expedite the appointments, thereby helping to unblock the political and administrative logjams that were preventing the process from moving forward.

Furthermore, the project acted as a catalyst for inclusivity and consensus-building around the constitution's substance. The development and adoption of the South Sudan Women's Charter for Constitution-Making is a prime example. This document, created through nationwide consultations, has fundamentally shifted the landscape by providing a concrete, nationally owned framework for integrating gender equality into the new constitution. It has catalysed a new level of structured engagement, not only influencing the NCRC's consultation manuals but also creating a ripple effect into national policy, informing the drafting of other key legislation like the Anti-GBV Bill. By equipping women-led coalitions and building the capacity of the NCRC and legislators on gender-responsive principles, the project created the necessary conditions for a more inclusive and legitimate process that directly addresses the priorities of marginalized groups.

Finally, the project catalysed broad-based public engagement where minimal outreach existed before. Through strategic partnerships with media and civil society, it helped transform the CMP from a elite-driven, stalled political discussion into a nascent national conversation. Training journalists on gender-responsive reporting and supporting community radio stations has built a new infrastructure for civic education, amplifying public awareness and creating bottom-up pressure for progress. This multi-level catalytic effect—from unblocking high-level political barriers to establishing new, inclusive processes and empowering public voice—has been instrumental in maintaining the momentum of South Sudan's critical constitution-making journey.

The project has been deliberately designed to ensure the sustainability of peacebuilding and governance gains beyond its duration by embedding ownership within national institutions, civil society, and communities. It is envisioned that the project's interventions will continue to inform and strengthen the third phase of the constitution-making process—covering the debate and final adoption of the Permanent Constitution by the Constituent Assembly and subsequent civic education once the draft is adopted.

Implementation is anchored in strong collaboration with government institutions, particularly the Ministry of Justice and Constitutional Affairs (MoJCA), the Reconstituted National Constitutional Review Commission (R-NCRC), and other statutory bodies to be formed such as the National Constitutional Conference (NCC). This institutional partnership ensures that national actors remain the primary drivers of the process. The R-NCRC is actively mobilizing additional matching funds from the National Consolidated Fund and international partners, reinforcing both national commitment and financial sustainability. The eventual adoption of the Permanent Constitution will institutionalize these efforts, reducing the need for external technical support and embedding constitutionalism within the governance framework of South Sudan.

At the societal level, the project is strengthening civil society organizations (CSOs), the media, women's and youth networks, and community-based structures to sustain civic engagement, gender equality, and peacebuilding. By building their technical and organizational capacities, these actors will continue to advocate for inclusive governance and constitutional implementation beyond the project lifespan. The project's investment in empowering women-led coalitions, youth groups, and organizations of persons with disabilities has enhanced their ability to influence decision-making and sustain gender-responsive civic education at both state and community levels.

Media institutions have been a central pillar of sustainability. The Union of Journalists of South Sudan (UJOSS), supported through the project, has expanded its operational network to all 10 States and 3 Administrative Areas. This strengthened presence will enhance continuous public information dissemination, media monitoring, and advocacy for a safe and enabling media environment during the constitution-making process and subsequent implementation of peace and governance frameworks.

Furthermore, by integrating civic education and constitutional literacy into CSO programming and community dialogues, the project fosters a culture of constitutionalism, accountability, and inclusive participation. These local and institutional capacities create a durable foundation for democratic governance, social cohesion, and long-term peacebuilding in South Sudan.

Since its reconstitution in November 2023, the National Constitutional Review Commission (NCRC) has made important progress in establishing operational structures and tools, including its work plan, organogram, and rules of engagement. These developments have set the foundation for leading the civic education and public consultation phases of the Permanent Constitution-making process.

However, the Commission continues to face major funding and capacity constraints. Despite the Government's commitment, no funds have yet been disbursed from the national treasury, leaving the NCRC reliant on partner support, including the PBF-funded project, to sustain basic operations. This financial and political will deficit has delayed the appointment of the Constitutional Drafting Committee (CDC) and the full-scale rollout of civic education and consultations across the country. To manage these challenges, the NCRC has adopted 18-month action plan prioritizing key milestones while continuing to mobilize resources from the Government and international partners. Institutionally, the NCRC requires strengthened capacities in strategic planning, project and financial management, gender mainstreaming, and data and information management to effectively coordinate and report on the constitution-making process. Logistical challenges, including limited vehicles, ICT tools, and decentralized infrastructure, also impede outreach and stakeholder engagement at subnational levels.

Targeted technical and financial support to the NCRC Secretariat—particularly in institutional strengthening, coordination, and communication—is critical to maintaining momentum and ensuring transparency, inclusivity, and efficiency throughout the Constitution-Making Process. Sustained collaboration with the Ministry of Cabinet Affairs, the Ministry of Finance, and key development partners will remain essential for advancing civic education and public consultations, establishing the Constitution Drafting Committee (CDC), and supporting the successful drafting of a people-driven, inclusive, and gender-responsive Permanent Constitution for South Sudan In parallel, the project has incorporated funding advocacy into project boards to encourage consistent government allocations for constitution-making activities and broader rule of law initiatives. This approach ensures continued attention to financial sustainability, reinforces government accountability, and safeguards the resources needed to support the NCRC, enable participatory consultations, and advance the country's constitutional and governance reforms.
