During the reporting period, MEISA focused on strengthening religious networks, promoting women's faith leadership, and advancing peer learning among Ulema. Key activities included facilitating coordination workshops, outreach activities, and dialogue sessions to enhance consensus-building among Ulema networks on peace and violence reduction. Targeted outreach and engagement were undertaken to increase the inclusion of female madrasa teachers within network structures, alongside facilitated dialogues among network members to build consensus on women's participation and endorse of inclusive practices. The Partner also delivered tailored capacity-building support for female network members through leadership training and mentorship initiatives. In addition, annual regional Ulema conferences were organized to promote peer-to-peer learning and the exchange of best practices on Islamic principles of mediation, countering extremist narratives, and fostering peaceful religious discourse.

Key activities included capacity-building and institutional support to Ulema network umbrella structures at the FMS level, expansion of the network's presence to additional districts, and facilitation of coordination workshops and dialogue forums to enhance consensus on peace and violence reduction. The Ministry supported Ulema engagement in insider mediation and community dispute resolution, including collaboration with traditional leaders and formal justice institutions. Targeted outreach, forums, and leadership trainings were conducted to increase the inclusion, endorsement, and capacity of female madrasa teachers and women religious leaders within the network. In addition, regional peer-learning engagements and inclusive community dialogue forums were organized to promote Islamic principles of mediation, counter extremist narratives, and foster social cohesion and good governance.

During the reporting period, MERA SWS advanced inclusive Ulema networks, women's faith leadership, and peacebuilding grounded in Islamic principles. The Ministry strengthened Ulema umbrella structures at Federal Member State level through coordination and capacity-building, while outreach expanded networks to new districts, including recently recovered areas. Workshops and dialogue forums promoted consensus on peace and violence reduction, reinforcing Ulema's role as insider mediators. To empower women, targeted outreach integrated female madrasa teachers into network structures, supported by dialogues that endorsed inclusive practices. Leadership training and mentorship further built women's capacity. Regional Ulema conferences facilitated peer learning on mediation, countering extremist narratives, and fostering peaceful discourse. Community dialogue forums across target areas promoted Islamic perspectives on governance, social cohesion, and justice acceptable to all.

The preliminary activities of the project have been successfully completed. Partner contracting was finalized through six Letters of Agreement (LOAs) with the Office of National Security (ONS) and five Federal Member State (FMS) Ministries of Endowment and Religious Affairs, along with one LOA with the Federal Ministry of Endowment and Islamic Affairs. These LOAs outline the agreed budget allocations and partner activities for the year.

UNDP project staff have also been successfully recruited. Both the Project Manager and National PVE Analyst positions were filled, with the recruitment process completed by the end of May 2025 and onboarding finalized in June. Similarly, the Federal and FMS Ministries of Endowment and Religious Affairs completed the recruitment of project staff for their respective institutions.

A public perception survey was initiated to establish baseline indicators for project outcomes. This survey, conducted in selected locations by UNDP's contracted Third-Party Monitoring organization, will be repeated at regular intervals throughout the project duration to track changes in public perceptions.

The project implementation phase commenced in July and continued through December 2025. During this period, activities focused on delivering training sessions and workshops across all FMS and FGS institutions to strengthen mediation efforts for peace in Somalia.

Project activities covered Southwest State, Hirshabelle, Galmudug, Puntland, Jubaland, and Benadir Region. The project strengthened religious leadership (Ulema) as insider mediators via capacity building, social dialogues, consensus building, awareness raising, and institutional support to Ulema Networks under state-level umbrella structures. More than 1,000 participants engaged directly (religious scholars, women madrassa teachers, youth, traditional elders), contributing to improved conflict-resolution mechanisms, coherent religious messaging, early-warning functions, and stronger linkages between ulema, communities, and state institutions.

Network development and messaging.

Ulema Networks established state-level umbrella structures and expanded reach by incorporating women madrassa teachers and scholars from newly accessible areas. Unified messages on peaceful coexistence, dispute resolution, and violence prevention were disseminated through weekly sermons and radio programs. Networks supported authorities on land disputes, awareness against increasing youth migration to Europe, and transition-related fears in newly recovered areas.

State highlights

Southwest State (Baidoa, Hudur, Awdiinle, Barawe).

- 200 scholars (160M, 40F) attended the Baidoa Scholars Council Conference; commitments: weekly harmonized sermons, discouraging revenge killings, and sustained dialogue on mediation, governance, and resilience.
- Awdiinle: trained scholars applied mediation and conflict analysis in 2 land disputes; agreements held. Ulema launched a WhatsApp early-warning group. Women's leadership (Southwest State).
- Women madrassa teachers in Baidoa and Barawe led awareness via study groups and madrassa classes on unity, non-violent household tension management, and discouraging harmful practices.

Hirshabelle.

- 160 (110M, 50F) scholars trained on mediation, conflict-sensitive communication, and religious principles of social justice and violence prevention.
- Weekly consultation group formed as an informal early-warning mechanism; authorities received timely updates on tensions and misinformation. Sermons addressed fears related to taxation, new administrative procedures, and movement restrictions.

Galmudug (Dhusamareeb, Wisil, Bahdo).

- 120 (80M, 40F) imams and dugsi teachers trained on clan conflict drivers, justice, social responsibility, and aligned peace messaging.
- Ulema established a WhatsApp coordination group for sermon themes and risk alerts; prior to the project, no such mechanisms existed and sermons varied widely.

Puntland (Galkayo, Qardho, Bosaso, Garowe).

- 85 participants (scholars, women madrassa teachers, elders, youth groups, judges, officials) attended a workshop convened by the state-level umbrella institution; outcome: scholars incorporated into district reconciliation committees.
- Galkayo: scholars mediated disputes between business owners and transport operators over new fee structures.
- Women's inclusion: 31 women sensitized on the Quranic Schools Act (2021) and SOPs; 15 formally registered into the Ulema Network; women joined planning meetings and aligned sermon themes via girls' madrassas and women's learning groups; male scholars reported improved reach in family settings.

Jubaland (Kismayo, Afmadow, Dhoble, JanaayAbdalle).

- Activities mobilized ulema under the network umbrella, engaged women madrassa teachers, and ran awareness campaigns targeting youth, mothers, pastoral communities, and residents in newly recovered areas near Afmadow.
- Estimated 15,000 people reached through sermons, community events, and women's dugsi classes both online and in person.
- Dialogues addressed youth vulnerability, family tensions, and moral conduct, countering misinformation during border transitions in Dhoble.
- Women's participation in religious guidance increased from ~25% to ~40% across supported districts; women contributed to early warning and consistent peace messaging.
- Networks expanded structured outreach, improved communication with district authorities on early-warning signs (immigration-related youth movement, family disputes, misinformation), and conducted mobile awareness with pastoral communities around Afmadow and Dhoble on migration corridors and livestock access points. Cross-cutting initiatives Unified Friday sermons.
- Networks in Southwest State, Hirshabelle, Galmudug, Puntland, Jubaland, Benadir formed weekly thematic

guidance on conflict prevention (revenge killings, land disputes, youth issues, harmful practices, cooperation with authorities).

- Baidoa and Awdiinle: collective sermon outlines distributed to mosques via WhatsApp.
- Hirshabelle and Jubaland: Thursday evening WhatsApp discussions ensured alignment before Friday prayers.
- Barawe: short audio messages via local WhatsApp groups on social harmony, youth conduct, and seasonal displacement.
- Women madrassa teachers in Mogadishu, Puntland, Jubaland delivered guidance during women-only gatherings and madrassa lessons, aligned with weekly themes.
- The federal ministry increased collaboration with the Women Scholars Association and invited members as keynote speakers at the Ulema Conference.

Policy and regulatory outcomes:

- Puntland training on the Quranic Schools Act (2021) improved understanding of regulatory frameworks, licensing, and compliance; outcomes included strengthened legitimacy, improved classroom management, and more effective teaching on ethics and peaceful behavior.
- Galmudug: Ulema network endorsed the Quranic Schools Bill and Ulema Council Bill; both submitted to cabinet for approval (expected within the year).
- The federal ministry initiated drafting and consultation with Ulema on National Quranic Act and Zakat Act; both not yet finalized. Cross-regional learning.
- Exchange visit to Djibouti exposed scholars from all states to institutionalized religious governance: Waqf administration, structured religious broadcasting, and coordinated messaging systems.

The project has allocated at least 32,97% of the annual budget to support women's inclusion and empowerment within the network. Each Letter of Agreement with implementing partner includes two fully funded activities dedicated to increasing the proportion of female members in the religious leader networks and to providing targeted leadership trainings for them. During engagements with government partners, the project team consistently emphasized the importance of inclusion - particularly the active participation of women and youth - as a core pillar of the project initiatives.
