

Addendum No. 1
to the Memorandum of Understanding
between
Participating UN Organizations¹,
and
the UNDP Multi-Partner Trust Fund Office
regarding the Operational Aspects of the Equatorial Guinea Multi-Partner Trust
Fund

WHEREAS, the Participating United Nations Organizations (hereinafter referred to collectively as the “Participating UN Organizations”) and the United Nations Development Programme (UNDP) Multi-Partner Trust Fund Office acting as Administrative Agent (hereafter referred to as the “Administrative Agent”) of the **Equatorial Guinea Multi-Partner Trust Fund** (hereinafter referred to as the “Fund”) have signed a Memorandum of Understanding on 14 August 2021 to establish and develop the **Equatorial Guinea Multi-Partner Trust Fund** which sets out the operational aspects of the Fund, starting on August 2021 and ending on 31 December 2023, as may be amended from time to time, and have agreed to establish a coordination mechanism (hereinafter referred to as the “Steering Committee”) to facilitate the effective and efficient collaboration between the Participating UN Organizations and the Host Government (if applicable) for the implementation of the Fund;

WHEREAS, on 12 July 2024 the Fund Steering Committee decided to extend the Fund until **31 December 2025**.

WHEREAS, on 10 December 2025 the Fund Steering Committee has decided to further extend the Fund until **31 December 2026**.

NOW, THEREFORE, the Memorandum of Understanding between the Participants is modified as follows:


WHEREAS, the Participating United Nations Organizations that have signed a Memorandum of Understanding (hereinafter referred to collectively as the “Participating UN Organizations”) have developed the **Equatorial Guinea Multi-Partner Trust Fund** hereinafter referred to as the “Fund”) starting on **August 2021** and ending on **31 December 2026** (hereinafter “End Date”), as may be amended from time to time, as part of their respective development cooperation, as more fully described in the updated Terms of Reference, a copy of which is attached hereto as Annex A.

All other terms and conditions of the Agreement remain unchanged. This Addendum will come into effect on the date of signature by the Participants.

IN WITNESS WHEREOF, the undersigned, duly authorized representatives of the respective Participants, have signed this Memorandum of Understanding in English.
