

Addendum 1
To the Memorandum of Understanding
between
Participating UN Organizations¹,
and
the UNDP Multi-Partner Trust Fund Office
regarding the Operational Aspects of a
NBSAP Accelerator Action Account
Multi-Partner Trust Fund

WHEREAS, the Participating United Nations Organizations have signed a Memorandum of Understanding (hereinafter referred to collectively as the “Participating UN Organizations”) establishing a NBSAP Accelerator Action Account Multi-Partner Trust Fund (hereinafter referred to as the “Fund”) on 18th December 2024, as may be amended from time to time, as more fully described in the Terms of Reference of the Multi-Donor Trust Fund dated 19 November 2024, and amended 17 November 2025, a copy of which is attached hereto as ANNEX A.

WHEREAS, the Participating UN Organizations have agreed to ask the United Nations Development Programme (which is also a Participating UN Organization in connection with this Fund) through the Multi-Partner Trust Fund Office to serve as the administrative interface between the donors and the Participating UN Organizations and for these purposes the Multi-Partner Trust Fund Office has agreed to do so; and

NOW, THEREFORE, the Participating UN Organizations and the Multi-Partner Trust Fund Office (hereinafter referred to collectively as the “Participants”) hereby agree as follows:

Non-UN Organizations (NUNOs) that are assessed by the Fund Secretariat as being (i) low risk following a Harmonized Approach to Cash Transfers (HACT) assessment conducted by the Fund Secretariat, or through an Equivalence Procedure, and (ii) satisfactory following a Sexual Exploitation, Abuse and Harassment (SEAH) assessment, will be eligible to access and receive financing directly from the Fund by signing the NUNO Framework Agreement and the Financing Agreement attached hereto as ANNEX D will have access to the Fund, and will carry out programmatic activities and assume responsibilities identical to those of the Participating UN Organizations, as well as any additional obligations imposed by the Fund’s Board in its approval of a NUNO’s project proposal.

IN WITNESS WHEREOF, the undersigned, duly authorized representatives of the respective Participants, have signed this Addendum to the Memorandum of Understanding in English.
