

Addendum No. 1
to the Memorandum of Understanding
between
Participating UN Organizations¹,
and
the UNDP Multi-Partner Trust Fund Office
regarding the Operational Aspects of a
Western Balkans SALW Control Roadmap MPTF

WHEREAS, the Participating United Nations Organizations (hereinafter referred to collectively as the “Participating UN Organizations”) and the United Nations Development Programme (UNDP) Multi-Partner Trust Fund Office acting as Administrative Agent (hereafter referred to as the “Administrative Agent”) of the **Western Balkans SALW Control Roadmap MPTF** (hereinafter referred to as the Fund) have signed a Memorandum of Understanding on 21 March 2022 to establish and develop the **Western Balkans SALW Control Roadmap MPTF** which sets out the operational aspects of the Fund, starting on 15 March 2019 and ending as indicated in the Fund Terms of Reference, as may be amended from time to time, and have agreed to establish a coordination mechanism (hereinafter referred to as the “Steering Committee”) to facilitate the effective and efficient collaboration between the Participating UN Organizations for the implementation of the Fund.


WHEREAS, on **14 May 2025** the Steering Committee has approved a revised Terms of Reference.

NOW, THEREFORE, the Memorandum of Understanding between the Participants is modified with the updated Annex A – Terms of Reference.

All other terms and conditions of the Agreement remain unchanged. This Addendum will come into effect on the date of signature by the Participants.
