NARRATIVE

Situation Update (please describe critical changes, if any, in the situation that affect the project (1-2 paragraphs))

The policy governing payment was revised from the EVD Resilient Zero Allowance Policy that ended in December 2015 to the EVD Heightened Surveillance policy which covers the first half of the year, Feb 5th to June 30th 2016. As its name implies it is generally designed to enhance surveillance and swabbing activities at chiefdom levels nationwide, in addition to accommodating standby burial teams at district levels to ensure that any re-appearance could be detected and responded to promptly to avoid possible spread.

The EVD HSA Policy covers the resilient zero strategy of government during the 0+42+90 days phase. The revised EHSAP covers the period from February 5 until June 30 2016. The policy in accordance to the enhanced protocols recommended by Ministry of Health and WHO is restricted to non-formal activities such as swabbing, surveillance and case investigation activities etc all other activities have been engrafted into the mainstream operations of the MoHS.

The Digital Financial Service eco-system diagnostic assessment was successfully conducted. The preliminary findings were presented to all the relevant stockholders including government, financial institutions, private companies and digital institution through a validation workshop. The draft report of the Digital Financial Service Diagnostic will be submitted in the ensuing weeks.

- Compiled and submitted the March national EVD allowance pay list of 428 beneficiaries.
- Provided technical support, coordination and secured the required approval for the revision EVD Heightened Surveillance Allowance Policy (EHSAP)
- Providing technical support to the District Medical Officers in all districts on policy implementations and complaint resolution.
- Support MoHS in ensuring timely and effective communication is provided to the District Health Management Teams (DHMTs)
- Coordination and collaboration in harmonizing allowances paid by other paying partners in accordance to the EHSAP.
- Coordinate and trouble shoot bottle necks with respect to the transitions of risk allowance responsibilities from NERC to MoHS.
- Agreed on plan and strategy in transitioning and handing over the payments system to MoHS.

The significant delay the project is experiencing is in the area of finalization of pay lists submitted to the fiduciary agent, BDO and the changing of new bank signatories and authorization codes to reflect the present status quo.
