<b>Project Summary :</b>	<p>With road blockages and a high level of insecurity prevailing, Air access is a necessity with no commercial alternatives existing for the humanitarian community. Lack of funding would necessitate a reduction in the fleet of aircraft and reduce the primary access into Somalia and critically, the secondary access to field locations for over 100 UN, NGO and Donor agencies involved in humanitarian assistance in Somalia.</p> <p>UNHAS personnel, both in Nairobi and Somalia, carry out aircraft and passenger handling operations as well as emergency security and medical evacuations where required. UNHAS has been operating ad hoc flights to newly accessible areas in south and central Somalia to towns such as Wajid, Hudur, Beletweyne and Garbaharey on an ad hoc basis and will continue to do so as new locations are expected to open up following the next phase of the offensive that recently started. **BACKGROUND**

**1. Humanitarian context analysis**

Over the past 20 years Somalia has endured violence, political instability and environmental and economic shocks resulting in acute hunger and malnutrition. Most state services ceased in the 1990s affecting education, health and food production. Gender inequality in Somalia is the fourth highest globally, with high levels of gender based violence, child marriage, and maternal mortality. Somalia remains among the world's worst performing countries for maternal and child mortality. Since 2012, Somalia has slowly emerged from a "failed" to a "fragile" state with the establishment of the Federal Government of Somalia (FGS). In 2013, the FGS and the international community endorsed the 'New Deal for Somalia' aiming to rebuild the country, stabilize institutions and develop the federal state. The achievements to date are mixed as many political, social and economic challenges remain.

Somalia, with a population of 12.3 million (UNFPA, 2014) is among the poorest and most food insecure countries in the world. Over 60 per cent of the households in urban areas and 95 percent of rural households suffer from multidimensional poverty (UNDP, 2014). For many years, Somalia has faced insecurity, conflict and recurrent food and nutrition crises and as a result has been unable to consistently invest in basic services, agriculture and social safety nets. Somalia has experienced significant improvement in the food security and nutrition situation since the July 2011 famine as a result of favorable seasonal rainfall performance and continued humanitarian response. However, a combination of drought, soaring food prices, conflict, access constraints and slow funding led to a significant deterioration of the food security situation in 2014. According to the Food Security and Nutrition Analysis Unit for Somalia (FSNAU) Technical Release issued in April 2015, an estimated 953 000 people are in Crisis and emergency (Integrated Phase Classification - IPC Phase 3 and 4) across Somalia between February and June 2016. Additionally, about 3.7 million people across the country are classified as Stressed (IPC Phase 2) through June 2016. Military operations launched against armed insurgents in March 2014 triggered population displacement in various towns in south-central Somalia, disrupting market activities and undermining the food security situation through to the end of the year. Delivery of humanitarian assistance in the newly opened up areas remained extremely challenging as the roads leading to the towns remained largely controlled by armed groups.

**2. Needs assessment**

Nearly 380,000 people face acute water and pasture shortage in drought-affected parts of Bari, Nugaal, Sanaag and Sool in Puntland as well as in Awdal, Togdheer and Waqooyi Galbeed regions of Somaliland. In Puntland, erratic rainfall for two successive seasons including the Deyr 2015 rains have exacerbated the humanitarian situation. Dangorayo and Garowe and parts of Badhan, Dhahar, Eyl, Qardho, eastern Taleex/Xudun, and districts of Bari, Nugaal and Sanaag and Sool regions are among the most affected. An estimated 220,000 people are affected by drought in Puntland, according to the Humanitarian Affairs and Disaster Management Agency (HADMA) and humanitarian partners. The start of the 2016 Gu (April-June) season has brought good rains to parts of Somalia especially in the north. However, drought conditions continue in parts of Puntland and Somaliland where the rains have been late and erratic. About 385,000 poor households in the drought affected areas face acute food insecurity with an estimated 1.3 million at risk of slipping into acute food insecurity if they do not receive assistance.

In May 2016, the torrential rains has caused high level floods in Beletweyn and its surrounding areas, requiring immediate response in the area.

The availability of humanitarian air services is crucial to support the humanitarian aid and relief programs in the country and facilitate the delivery of humanitarian assistance to the affected population. The capacity already in place for this project includes the current UNHAS fleet of air assets comprising of seven aircraft (1 Dornier 228 and 1 Caravan C-208s based in Mogadishu, 2 Dash - DHC 8's and 1 Q400 high speed Turboprop based in Nairobi, and 1 Beechcraft 1900D based in Hargeisa). UNHAS personnel, both in Nairobi and Somalia, carry-out aircraft and passenger handling operations as well as Emergency Security and Medical Evacuations where required. UN staff levels allowed in Somalia at any given time (staff ceiling) is in direct relation to the security evacuation capacity of UNHAS

**3. Description Of Beneficiaries**

The project contributes to all cluster priorities by enabling the presence in Somalia for their project management and monitoring and indirectly supporting all beneficiary groups identified and targeted by HRP.

**4. Grant Request Justification**

UNHAS's 2016 budget totals US\$29 million of which 60 per cent is expected to be generated from cost recovery and the remaining 40 per cent from Donor contributions . UNHAS operations in 2014 were supported by DFID, Canada, Finland , Germany and the CHF and in 2015 by Canada. Traditional Donors continue to be approached locally and from HQ for their support to UNHAS operations.

CHF Funding of \$1,000,000 is requested in this initial allocation to continue operating the existing UNHAS fleet providing air access into and within Somalia for Humanitarian agencies implementing programs there without contraction during September . With road blockages and a high level of insecurity prevailing, Air access is a necessity with no commercial alternatives existing for the humanitarian community. Lack of funding would necessitate a reduction in the fleet of aircraft and reduce the primary access into Somalia and critically, the secondary access to field locations for over 100 UN, NGO and Donor agencies involved in humanitarian assistance in Somalia. Large surrounding areas are still not safe for road travel by neither humanitarians nor commercial companies. This situation leads to an increased demand for air services provided to the international community. The lack of a safe, secure and efficient commercial alternative endorsed by the United Nations to fly humanitarian personnel into and across Somalia, makes UNHAS one of few options to reach those locations safely and to provide high standard of aviation security on the ground to provide critical assistance and closely monitor lifesaving projects in Somalia.

In accordance with WFP Air Transport Directive of January 2004 and in compliance with the International Civil Aviation Organization (ICAO) recommendations, WFP will continue to be guided by UNHAS User Group Committee (UGC) composed of United Nations agencies, NGOs and donor representatives in Nairobi, where most country offices of the organizations are based. The role of the UGC is to define the requirements and priorities in terms of air transport needs, as well as to monitor the quality of services rendered and provide feedback and guidance to the WFP Chief Air Transport Officer (CATO). With support of UNDSS security risk assessments in areas of concern, UNHAS operations are continued allowing programmes and operations to continue while decreasing staff vulnerability.

Following an offensive by the African Union Mission in Somalia (AMISOM) and Government Forces which started in March 2014, more and more areas in southern and central Somalia become accessible to humanitarian actors and the international community in general. A new phase of this offensive has just started and is expected to open up access to additional towns in the south. However, the Federal Government's control and administration in these newly accessible areas only extends to main towns, creating 'urban islands' that are only accessible by air. Large surrounding areas are still not safe for road travel by neither humanitarians nor commercial companies. This situation leads to an increased demand for air services provided to the international community. The lack of a safe, secure and efficient commercial alternative endorsed by the United Nations to fly humanitarian personnel into and across Somalia, makes UNHAS one of few options to reach those locations safely and to provide high standard of aviation security on the ground to provide critical assistance and closely monitor lifesaving projects in Somalia.
