During the registrations and training we have targeted male farmers who also represent households. According to our statistics an average household is 5 people. The registration of farmers during the period of reporting is 437. This will be five times when members of the households are taken into account which includes men women and children. In rural communities FSA has always worked with households. There will be other beneficiaries such as tourism and public consumers who are not included or hard to estimate at this time.

On Emae the whole community on the island were involved. On Efate it included the vegetable farmers. On Tanna Island, Nasituan, Napil Rural Training Centre, and the Tanna coffee producers were included in these trainings. 1 training for Efate farmers on meeting market demands and 1 training for hotel staff on organic food preparation. Specific product standards are being developed for farmers. Total number of farmers registered for organic certification and underwent initial organic trainings as mentioned above is around 440 to date compared to the 1151 who attended the organic awareness training and this is expected to increase in the next reporting period.	On Tanna the largest target group is coffee farmers who mostly farm inland. Difficult terrain and inaccessible farms takes a lot of time for Field officers to get to these farmers. A Quad bike has been purchased to assist field officers with this activity.	During this reporting period our major task has been farm registration and standards training. When this is completed, our trainings will be more skills-focused on the targeted groups. These will include best farming practices, peer review training and certification training.

Cross-cutting issues

How has the JP addressed during the reporting period (please provide concrete actions):

1) The **sustainability** of the JP work. (200 words)

Organic practices have been proven to promote environmental sustainability.

Long term sustainability of the project work has been strengthened by FSA accepting PGS as a long term target for the organization to prioritize as part of the organic activities that they have been involved in since the 1990's. FSA will continue to operate as secretariat for the Vanuatu Organic Certification Committee who will be responsible for the Vanuatu PGS. The Vanuatu PGS structure has been established during this reporting period. Private sector and government support for this activity has been strong as well.

2) The promotion of women's empowerment and gender equality. (200 words)

Across the board, the project also target the involvement of women and this account for around 400 women both direct and indirect beneficiaries. They are also considered valuable actors in the value chain ensuring targets are achieved. This include nursery management, on field production, harvesting, post harvesting losses management, transportation, financial management and also marketing. Farm To Table project is working with a female entrepreneur turned businesswoman. She operates a small food processing factory within her residence. During this reporting period her company has been

registered in the PGS. Her procedures for processing manioc flour have been documented. She has gone through the standards training and understands the concept of organics. Prior to this project she has been trying to get HACCP certified for the past five years. The process have given her a learning experience on the standards of producing and processing organics products. She is also an active VOCC committee member. As a local food processor she wants to get organically certified for the tourist market. If the certified products can assist her to do this, it may boost her production.

3) The engagement in **public-private partnerships**. (200 words)

The Vanuatu Organic Certification Committee has been established during this reporting period. The committee consists of organic advocates, a government civil servant and private company owners involved in processing organic products.

The linkages with this project between FSA and private sector have been strong so far. In the future, FSA will work closely with them to understand their responsibilities for keeping the PGS in operation. So far the project has worked closely with Lapita Café, Tanna Coffee as private sector and Nasituan as a Community Based Organization.
