1.1 Overall project progress to date

The project is at the midway point of its implementation. So far, the official launching, the establishment of the project structures and team, and the creation of a partnership with federal and regional government institutions and Civil Society Organizations (CSOs) have been completed. Major progresses to strengthen the capacity of government and non-government actors and to mobilize women and youth, were made to ensure inclusive and effective process for policy development and implementation of peacebuilding initiatives in the country. Community level conflict management and peacebuilding mechanisms were also implemented to strengthen the social cohesion and security of host communities and returnees in the targeted Oromia Somali and SNNP regions.

The unique approach of the project is using a bottom-up approach to work with key stakeholders and design peace dialogues at the community level. The engagements of women leaders at the grass-root level called 'Haadha Siqqes', female students from universities, traditional and religious leaders, and youth associations are expected to inform regional and national level peace dialogues and norm-settings in the peacebuilding efforts of the country.

The project is also documenting the perspective and outlooks of returnees, host communities, youth, and women to stimulate a meaningful discussion around the national peacebuilding strategy. The formal set-up of Women Peace Forum in Oromia is also a beneficial approach that has been used to create sustainable women peacebuilders' platform. This will also help to aggregate the voices and demands of women to influence future consultations on the development of national peacebuilding strategy.

Further to the project's effort to foster peaceful co-existence at the community level, football matches were used to connect returnees and host community children of the Gedio and Guji Zones of Oromia and SNNP Regions. This approach has been applauded by the parents of the children as it was an effective way to relieve the tension between the communities (see real human impact story).

In a few sentences summarize **major project peacebuilding progress/results** (with evidence), which PBSO can use in public communications to highlight the project (1500 character limit): The following are the major project progress being made in 2019:

The capacity of government and non-government actors strengthened: progress was made to strengthen the capacity of government and non-government actors for inclusive and effective development process of the peacebuilding strategy. Six Hundred Thirteen participants (501 Male and 112 Female) from the media, federal and regional sector ministries, justice and police and women affairs bureaus were trained on gender sensitive journalisms and conflict reporting, conflict management and peacebuilding, conflict sensitive planning, rule of law, and durable solutions concepts. The knowledge and skillsets created by these trainings also means government institutions will effectively manage early warning facilities and the media will apply conflict sensitive journalism and development planning without putting the public at risk.

Establishment of Women Peace Forum: Women Peace Forum has been established in Oromia by bringing 63 participants (13 Male and 50 female) from 20 zones and 19 city administrations of the region. The forum is a significant step forward in creating a united women's front for a decisive role in preventing conflict and building peace in the region and beyond.

Community Dialogue platforms created: The project has managed to facilitate eight consecutive peace dialogues, between 786 host communities and returnees (535 male and 251 female) in Gedeo, West Guji and East Hararge zones of Oromia and SNN

Yirgachefe district in Gedo Zone has been inflicted by conflict since 2018 causing massive human displacement. Along the border areas of Gedeo and West Guji zones of SNNP Regional State, the conflict has been going requiring interventions to build confidence between these two communities. The ethnic group "Guji" was displaced and they fled to Guji Zone in Oromia region and now returned with very limited humanitarian and development support.

In response to this, the project supported community dialogues and friendly football matches at school. The team players were from both host and returnee children. During the match, parents and the community members came to support and cheer the children. The atmosphere was vibrant, fun and emotional at the same time; most of the community members and parents got emotional as they saw their children playing along with one another. A father whose son was playing the football match said 'he is happy to have learned how to focus on the things that bring the community together, rather than tear it apart: ...the things connecting us are the schools; even if you are in bad terms, nonetheless your children still go to the same school. The market also connects us together...and youth playing football together, this is quite a relief for us to continue our coexistence."

If the project progress assessment is **on-track**, please explain what the key **challenges** (if any) have been and which measures were taken to address them (1500 character limit).

Restructuring of federal and regional government institutions leading to detracting of authorities: The Ministry of Peace (MoP) and other regional executive branches of government are in a reform process. The turnover of key staff in the MoP has delayed the conflict analysis and strategic planning process required for strategy. To remedy this, the project has hired a national advisor that will be embedded in the MoP for the development of the peacebuilding strategy.

Regional briefing workshops were conducted to remedy the limited local level engagement of the project in Oromia, Somali and SNNP regional states. The Peace and Security Administration Bureaus are now coordinating local level activities with participating UN agencies.

Two CSOs -Peace and Development Center and Inter Religious Council of Ethiopiawere engaged to accelerate project delivery and to expand the reach of the project by involving other actors have critical roles to play in promoting peace. This effected mitigation measure required budget reallocations.

Security challenges: Continued conflicts in various parts of the country means that security situation is not conducive to engage regional stakeholders and accelerate implementation. A recent phenomenon was the sudden eruption of protests followed by roadclosures which made it difficult to engage with participants of women Peace Conference prepared with Ministry of Women, Children and Youth.

<u>Outcome 1:</u> The Government of Ethiopia develops/adopts a national peacebuilding strategy through an inclusive and evidence- based process

The project seeks to support the development of national-level peacebuilding strategy, which is the first step to ensuring national ownership of peacebuilding priorities in Ethiopia. The major progress made so far is the capacity building of government and non-government actors for an inclusive and effective process of the peacebuilding strategy. Accordingly, 541 (445 Male and 96 Female) federal and regional government actors are equipped with the required skills-set to structurally transform conflict and build peace by applying the Do No Harm principles in their actions. The capacity of 72 journalists (56 Male and 16 Female) have also been enhanced for conflict sensitive reporting on issues which impact the lives of persons in conflict situations.

The project facilitated a high-level consultation on the mandates of the newly established MoP as part of the institutional level efforts to ensure the development of a national peacebuilding strategy for Ethiopia.

Two conferences on the management of religious and ethnic diversity and conflict were also conducted with the participation of 725 participants (411 from SNNPR and 374 from Oromia regions). The regional level structures of Inter-Religious Council of Ethiopia were instrumental to mobilize relevant participants of the two regions. This

platform was also used to document issues around religious and ethnic-based conflicts for a national level policy dialogue planned by the project. These will be documented and feed into the national peacebuilding strategy.

A village assessment survey in Gedio and west Guji was also supported in collaboration with the National Disaster Risk Management Commission (NDRMC). Result of the assessment is expected to inform the ongoing durable solutions initiatives in the country.

The Oromia Women Peace Forum was established to ensure a sustainable women's front to voice the concerns and priorities of women in peacebuilding and conflict resolution in the region and beyond. The establishment of this forum was celebrated with the presence 63 participants (13 Male and 50 Female) from 20 zones and 19 city administrations of the region. The major action following the establishment of the forum was the peace conference conducted with 135 representatives (50 Male and 85 Female) of the region. The conference lead to a renewal of commitments to revive the negotiation role of the long-standing Oromo traditional women alliance for peace known as 'Haadha Siqqe'.

A national level women peace conference has also been conducted by bringing 360 participants (22 mothers of peace-serving as ambassadors of peace- 338 female students of 45 universities) and from women affairs offices of all regions. The role of university students in peacebuilding and conflict resolution was the main agenda discussed at the conference. This conference is a platform created by the project for women and youth to voice their concerns and demands towards the peacebuilding strategy.

Outcome 2: Increased Security and Social Cohesion in Conflict Prone Clusters

The project also seeks to ensure regional security and social cohesion in the targeted Oromia, Somali and SNNP regions. In this reporting period, progress was made to create regional and community-level mechanisms (dialogue, early warning) to peacefully resolve conflicts and address the challenges resulting from displacement.

The peace dialogues which were conducted between host communities and returnees of Gedio and Guji Zones led to community level social initiatives to expand the provision of services (schools, and health posts) to the host communities and returnees. These dialogues were conducted with the direct engagement of the local authorities. This engagement was an opportunity for both the local authorities and the community to have an open consultation that could lead to trust in the way of taking into account the needs of the community. The dialogues are also exemplary initiatives in creating peace and development nexus in the broader peacebuilding efforts of the targeted regions and beyond.

As part of the community initiatives, series of five children football matches were also conducted with a participation of 144 children (56 Male and 88 Female), as players

and supports. Around 10,300 people form Gedo and West Guji zones have watched these games which were powerful in reconnecting the children as well as relieving the parents from tensions that was surfacing between the two communities.

At regional level, a peace dialogue was conducted in SNNP region, with the attendance of 63 (56 male and 7 female) from government institutions, academia, community members and the media who were invited from selected zones and woredas of the region. The dialogue was successful in recognizing the need for genuine cooperation, tolerance, continuous dialogue and discussion to bring sustainable peace in the region and all parts of the country.

Following an assessment on Conflict and Early Warning (CEWARN) facilities in SNNP, Somali and Oromia regions, the project is also establishing 18 CEWARN facilities (6 for each region) for which procurement of IT equipment has been completed. The facilities will be strengthened for an effective coordination, early warning and conflict prevention activities of the three regions.

Pre-existing customary conflicts mechanisms were also mapped through the consecutive workshops conducted in Somali, Oromia and SNNP regions. the mapping exercise was conducted with participation of 63 (51 Male and 12 Female) community elders, regional and woreda officials. The workshops have now led to further discussions with government officials to strengthen the role of customary conflict resolving mechanisms. Also, 31 (19 Male and 12 Female) traditional leaders of Gedio and Guju Zones were empowered with valuable information to effectively coordinate with the statutory conflict management mechanisms.

Overall, progress in terms of achieving outcome has been constrained by the challenges mentioned above/below, although s
