EXECUTIVE SUMMARY

Information sessions on the project for partners and stakeholders to ensure their strong involvement took place in September and October 2019. Following these meetings and working sessions necessary for the creation of a common vision for the project, the official launch of the project was organized from 26 to 28 November 2019 in Bangui. A total of 21 people, including the prefect, mayor, district chief doctor and local NGO, participated in the three working sessions (on 26 and 28 November) on the roadmap for the 10 areas of impetus integrating the activities to combat HIV / AIDS planned in the project.

I. Purpose

The project aims to reduce the vulnerability to HIV / AIDS of displaced persons and host populations in five selected cities of the Central African Republic - Bangui, Bimbo, Bégoua, Bambari and Obo.

II. Results

i) Narrative reporting on results:

The project has contributed to the increased understanding of the vulnerability of displaced population against HIV and AIDS amongst the local and medical authorities. During the reporting period, the beneficiary of the actions were mostly the government officials in order to create a basis on the implementation of the project.

The project team worked closely with the Ministry of Health and Population, as well as the National AIDS Control Committee, and municipalities to encourage local authorities to participate in the development of roadmaps for universal health coverage which includes the fight against HIV in displaced and host populations. The fight against HIV / AIDS is one of ten areas and the project team seeks to create synergy with the Ministry of Health and Population.

Information sessions on the project for partners and stakeholders to ensure their strong involvement took place in September and October 2019. These sessions targeted the Association of Mayors of the Central African Republic and more particularly the Bangui town hall which coordinates this association. Work sessions were also organized with NGOs and representatives of people living with HIV to inform them of the project and make them aware of their involvement and role.

Following these meetings and working sessions necessary for the creation of a common vision for the project, the official launch of the project was organized from 26 to 28 November 2019 in Bangui. Seventy personalities including the mayors and prefects of the municipalities selected for the project (Bangui, Bimbo, Bégoua, Obo and Bambari) as well as representatives of the Ministry of Health, the territorial administration, and beneficiaries of the project, namely displaced people living with HIV were present. The Minister of Territorial Administration, the Minister responsible for the fight against AIDS, the Deputy Special Representative of the United Nations, Humanitarian Coordinator and Resident Coordinator, as well as the UNAIDS Country Director and the IOM Head of Mission were present at the launching ceremony. Before and after the launching ceremony on November 27, the local authorities participated in the working sessions organized jointly with the Ministry of Health and Population and worked on the plan roadmap for each of their municipalities.

A total of 21 people, including the prefect, mayor, district chief doctor and local NGO, participated in the three working sessions (on 26 and 28 November) on the roadmap for the 10 areas of impetus integrating the activities to combat HIV / AIDS planned in the project.

The project team also developed visibility materials such as flyers and t-shirts. Key messages for awareness have been identified.

The two local associations, pre-identified as implementing partners, demonstrated their weak capacity during the partnership on another project to carry out their activities in a coherent manner with regard to the financial framework. In this sense, the project team plans to call on a third implementing partner to direct the activities in close coordination with the two associations. The desired profile is a local NGO with extensive experience in community awareness, capacity building and HIV assistance to the population affected by the epidemic in CAR.

The implementation of the project was delayed by the process of making funds available. The project was signed by all MPTF stakeholders only at the end of July 2019. The funds were only available in September 2019. As a result, project implementation activities have not started than in October 2019. The request for a no-cost extension until September has been approved.

After launching the project and ensuring the availability of funds, we began recruiting implementing partners for the effective implementation of project activities.

UNAIDS has recruited the Catholic University Center which will take care of activities in the city of Bangui, Bimbo and Begoua and Agence Centrafricaine de Marketing Sociale (ACAMS) which will oversee activities in Obo and Bambari. These two NGOs will carry out their activities in collaboration with organizations of people living with HIV and national or international organizations dealing with displaced persons and municipalities.

The details and budgeting of each activity was discussed and the impact of each activity was assessed.

iii) Success Story

Challenge/underlying vulnerabilities being addressed:

While the number of displaced populations is significant in the country, their specific vulnerability toward HIV and AIDS is not recognized amongst the local authorities and medical actors. The project aimed to first increase their awareness on the subject, for them to include the population in their health-related activities and also actively participate in the design of the project activities.

Through the invitation to tender, procurement of NGOs with sufficient aptitude for the effective implementation of the activities was challenging.

Project Interventions:

From the initiation of the project, local and medical authorities were strongly encouraged to play an active role in the project. The project funded the working sessions where they were invited to develop series of plans on the fight against HIV and AIDS with specific focus on displaced population.

Result:

The working sessions offered opportunity for authorities from different target cities to come together and jointly discuss common challenges. The plan is in consultation at its local level and the project team and the local authorities agreed that the project funding will also support the local-level discussion to finalize the plan. The process of identifying implementing partners has been finalized and the implementation of the first activities will start in March.

For each activity, meeting notes and attendance sheet was prepared and completed for the monitoring. There has been continuous communication with the key stakeholders to ensure their strong involvement in the project and a supportive role.
