I. Overview

Angola and the Democratic Republic of Congo (DRC) have a long and porous border, some of which is in the diamonds exploration areas. Traditionally there has always been a considerable amount of contact and cross border activity. It has also been an area attracting migration from DRC given the attraction of the diamond areas, with considerable "illegal" and hand digging for diamonds and possible trafficking.

In recent years, the Angolan authorities have carried out various campaigns to expel irregular migrant workers in these areas back into DRC. Information on allegations of gross human rights abuse in the context of expulsions, including torture and sexual violence, in particular against women, have been collected in the DRC by the UN in collaboration with provincial structures. According to the United Nations Stabilisation Mission in the DRC (MONUSCO), more than

1932 Congolese migrant men, women and children were victims of sexual violence between January 2010 and May 2011 in the context of expulsions.

In a visit to Angola in March 2011, SRSG SVC Margot Wallstrom visited the border areas and discussed the allegations with the Angolan authorities and measures to address and prevent such abuses. This resulted in a joint communiqué by the Government of Angola and the United Nations System on 16 March 2011, committing to the following points:

- Reiterating through the respective chains of command existing Army and Police Command Orders prohibiting sexual abuse; and, re-enforcing the commitment for 'zero-tolerance' of such violations in Army and Police Codes of Conduct.
- Sending a clear signal that impunity will not be tolerated by undertaking investigations of alleged violations on the basis of credible information, and ensuring punishment of perpetrators.
- Facilitating, as appropriate, the assessment missions of the Unite Nations and International Organization for Migration to areas of concern, and granting United Nations protection actors regular access to detention/holding centers or similar locations.
- Facilitating the participation of the United Nations and the International Organization for Migration as an observer in the organized expulsions being carried out by Angolan authorities.

The Resident Coordinator and the UN system in Angola are eager to engage with the Government to promote follow-up to the commitments and to provide necessary assistance in this regard.

The placement of a Protection Advisor in the Resident Coordinator's Office has the objective to: (i) Promote an effective follow up of the commitments made in the Joint UN Government of Angola Communiqué of 16 March 2011; (ii) Strengthen the capacity of the UN system to advise the Government of Angola to prevent and address sexual violence and other human rights violations in the context of expulsions and migration control.

II. Proposal's compliance with UN Action's Strategic Framework

a. What pillar does the proposal fall under?

The proposal falls under Pillar A: Support to UN System-Wide Action at Country Level. UN Action's 2011-12 Strategic Framework states that "UN Action will intensify its strategic support to UN missions as priority countries by the SRSG-SVC". The project considers that the caseload of sexual violence amongst expelled Congolese migrants from Angola is very high and therefore any attempt to combat sexual violence in the DRC would be incomplete if this problem is ignored. The project is unique to UN Action in that it presents a regional, interstate challenge to combating sexual violence in conflict. In line with this, the proposed Protection Advisor will support the Resident Coordinator and the UNCT in promoting follow-up to the Government's commitments to address sexual violence in the context of expulsions of DRC citizens.

b. Explain how the proposal enhances UN system coordination and joint programming.

The advisor will work directly with the Resident Coordinator and relevant UN and other international entities to ensure sustained and coordinated action to promote Government's compliance with the commitments made during the SRSG SVC visit and its international obligations.

c. Explain how the UN, governmental organizations, NGOs, and other key stakeholders will be engaged throughout implementation of the proposal.

The advisor, for the nature of the functions of the post, will work with and through the UN entities on the ground. The Terms of Reference further foresee that the advisor will raise awareness and knowledge of international norms and standards, as they relate to migration control, expulsions, sexual violence and other human rights violations, within the United Nations, national authorities and civil society organizations, including through the organization of training and sensitization sessions for local authorities, security forces, and communities

d. Explain how the proposal would strengthen the capacity of national institutions to deal with war-related sexual violence.

According to the terms of reference, the functions of the post include specifically advising the authorities, as well as the UN system and civil society organizations, on international standards, norms and mechanisms applicable to migration control and expulsions and facilitate dialogue with the authorities and other stakeholders on their implementation, with special attention to concrete instances of organized expulsions, the situation in detention centres and other areas of possible concern along the border. The advisor will also liaise with national authorities on the status of investigations of allegations of human rights abuses and advise the RC and UNCT in Angola accordingly.

III. Success criteria and means of evaluating results

a. Explain how the Participating UN Organisation(s) submitting the proposal have the institutional capacity to successfully achieve the proposed objectives.

The Resident Coordinator in Angola oversees the strategic programme implementation by the UNCT and will e the first reporting officer of the protection Advisor OHCHR, although not present in Angola, has a regional office in South Africa which ensures cooperation with the Government, UN actors, civil society organizations and other stakeholders for the promotion and protection of human rughts in the country. The OSRSG SVC and OHCHR, through the SRSG/DSRSG/RC DRC will ensure coordination and information sharing between the UNCT DRC and the Protection Advisor for the purpose of performing the functions detailed in the Terms of Reference.

b. Describe the overall management structure of this project.

The Resident Coordinator- Angola will be responsible for supervising the Advisor, who will report directly to her. OHCHR and OSRSG SVC will provide substantive/technical support as required/requested. Quarterly reports will be submitted to the OSRSG SVC and OHCHR for information.

c. Explain how the proposal will be monitored and evaluated.

Through regular contacts with the Resident Coordinator and the reports of the Advisor, UN Action will be able to measure progress towards the project's objective. A check list of activities and output achievements agreed with the RC Angola will be used to measure progress.
