2. Reason revision is being requested:

The UN Joint project would like to request at least 15-day extension, until 31st of March 2021 in order to ensure quality completion of all of the required programmatic activities as stipulated in the current timeframe of the project duration as well as adequate sustainability transition. The Workplan progress tracker is herewith enclosed to support justification for granting the requested extension. While the overall progress of implementation and results achieved to date are positively assessed by the UN RCO and UN implementing agencies (UNICEF, UNESCO and ILO), it has been officially noted that 'catalyst' changes require time. National ownership of the policy making process (adopted ICT standards and ongoing work on Digital and Pedagogical Standards) in BiH education sector has prepared the government partners for scaling up and delivery of trainings to key target groups.

The UN Joint Project simultaneously, under the leadership of UN RCO in BiH, initiated resource-mobilization strategy to continue with the UN Joint approach in delivering results for education and preventing further learning losses. Budget revision reflects savings in travel.
