#### Gender

The 2012-16 House of the People only had 14% women representation. In a historic achievement during the 2016 electoral process, Somali women secured 25% representation in the 10th Federal Parliament. This marked 71% increase from the previous 14% representation. The achievement was the result of sustained efforts by women's rights advocates over a period of two years; starting with consultations towards the National Consultative Forum in 2015 and ending with the inauguration of the new Parliament in February 2017. This process was continuously supported by the Project.

In order to ensure that the increase of women in Parliament translated into results for all women in Somalia, the Project continued to support the empowerment of female MPs to address women's concerns. As outlined above, this also included contributing to an enabling environment - especially in terms of legislation and the national budget - that is conducive to addressing the marginalization of women. The project thus provided support to making parliaments inclusive in nature and in process and offered support for mainstreaming and the engagement of target groups—including women—and to better engage women MPs in specific activities. It also supported capacity development for review with a gender-sensitive perspective.

Respective activity results include, among others:

- the capacity of 1,082 (M: 832 W: 250) MPs to review legislation with a gender perspective and enact gender responsive laws was enhanced
- 445 women MPs and staff were provided with training based on the unique challenges they are facing, including gender sensitive budgeting, legislative analysis, research, and drafting of amendments, which significantly contributed to enhanced skills of Somali women MPs to effectively discharge their mandates
- 5 women Young Graduates were supported through the Project, who significantly contributed to the functioning of Somali Parliaments and ensured the delivery of core functions by being driving forces to the implementation of the day to day tasks of the parliaments
- The NFP Women's Parliamentary Forum (WFP) was supported to debate ways of participating in the review process of the Provisional Constitution of Somalia to ensure it focuses on women's rights, gender issues and quotas for women MPs
- the first Annual Somali Women Parliamentarian Conference was held in 2017, which brought together 129 Women MPs from both Houses of the NFP, the State Assemblies, and civil society members and resulted in the identification of key priorities for women within the context of the NDP
- 2017, MPs and Parliamentary staff from both Federal and State parliaments attended a "Transformative Leadership for Results" training with the aim of enhancing their leadership skills to transform Somali organizations and institutions, and to promote gender responsive legal and policy reforms. The training increased the ability of MPs and Senators to promote gender responsive reforms and looked at how to strategically address the underlying social causes of gender inequality and identify sustainable "breakthrough initiatives" that can lead to change in the area.
- In Jubbaland, a Gender Advisor was recruited in 2017, who provided advice to the HoR, enhanced the capacity of secretariat staff and provided a two-day gender training for six parliamentary interns.

### Support to Drought Response

With the support of the project, in 2016, Guurti House conducted an oversight mission to the ongoing expansion project of Hargeisa Water Supply funded by The European Union, Somaliland Development Fund, UN-HABITAT and the Government of Somaliland. The project aims to install new 23 km long water supply pipeline from Geed Deeble to Hargeisa in order to increase the capital's water supply system.

Two (2) Parliamentary committees of Somaliland House of Elders (Guurti) and House of Representatives 16 MPs and 2 staff from the secretariat visited Awdal and Togdheer Regions of Somaliland in 2017-Q3. The aim of the mission was to provide oversight on the drought emergency response and distribution of aid in the regions. The committees also assessed the current response and recovery situation in the regions and the ongoing efforts to halt the outbreak of diarrhea. The committee met with the communities greatly affected by the drought in urban and rural areas. They also visited the regional governor, regional directors, officials from the Drought Response Committee and the health officials of the region. The committees are expected to present their findings during the coming session of the House of Elders (Guurti) and House of Representatives. Among their findings are: Kiridh District, hosted 521 displaced families with limited water access; Wadaamo Goo District, was hosted 1400 displaced families, no health post; Ainabo District, hosted 2,030 displaced families, shortage in water and nutrition and Oog District 1,050 IDP Families with limited access to water.

As a result of the outreach support provided by the Project, the media coverage of the drought has improved significantly, and different sectors of the community started to provide water trucking and food donations to the drought effected community.

#### **Communications & Visibility**

In accordance with donor guidelines, the project developed a communications and visibility plan for information sharing and visibility of project activities. As a result, significant improvements have been made in terms of sharing information with beneficiaries, donors and other stakeholders.

**Articles** related to accomplished activities of the Constitution Review Support Project have been regularly published in monthly project newsletters, the UNDP CO website (<u>www.so.undp.org</u>), and social media platforms (Facebook – <u>www.facebook.com/undpsom</u> - and Twitter – <u>www.twitter.com/undpsomalia</u>). UNDP staff ensured regular interaction with national counterparts in addition to the deployment of national staff within the premises of Parliaments and regional assemblies to ensure timely and continuous communication.

## Looking Ahead

While substantial progress was made under difficult conditions, there is still clearly more efforts that is needed to enable the country's legislatures to function effectively and sustainably. Experience in conflict-affected countries consistently shows that state building and institution-building is a long-term process.

The Project will thus enter its second Phase in 2018 (Phase II of Parliamentary Support Project Document (2018 – 2021). This phase of support is based on the recommendations of the independent evaluations made by UNDP and EU, among them the need to promote the developmental role of the parliament so that it contributes to achievement of the National Development Plan in line with the Sustainable Development Goals.

The Project will focus on the four key pillars of democratic governance that play an important role in the development of Somalia's Inclusive Politics – National Federal Parliaments, State and Regional Parliaments and Civil Society, – through an integrated approach that is in line with a fourth component, of achieving progress towards SDG 16 in Somalia. Phase II of the Project will notably support linking the parliaments and civil society organizations – not only NGOs – but also universities, professional organizations and community-based organizations.

While some limitations encountered in Phase I were primarily due to funding constraints, other limitations are related to staff needs for ongoing capacity development. As the micro-capacity assessment has shown, the situation in the emerging regional assemblies is more critical – some have no staff at all, relying instead on a few volunteers. Over the coming four years they will need to build their basic capacities in order to be enabled to effectively become part of Somalia's federal framework.
