Subject: 2021 Annual Reporting for MPTFs and Joint Programmes

Dear Colleagues,

I am writing to you regarding the 2021 annual reporting cycle for the various Multi-Donor Trust Funds (MDTFs) and Joint Programmes (JPs) administered by the UN Multi-Partner Trust Fund Office (MPTF Office) as listed on the <u>MPTF Office GATEWAY</u>.

In accordance with the Memorandum of Understanding (MOU), each Participating Organization is required to provide annual or final narrative reporting, and financial reporting for the MPTF programmes/JPs for which their organization has received funding. These reports are used to prepare the Fund-level consolidated narrative and financial reports that will be submitted to relevant Steering Committees, contributing partners and other stakeholders.

Mandatory Reporting Timeline

In accordance with the signed MOUs, the reporting deadlines are:

- Submission of Participating Organizations' narrative reports by **31 March 2022**
- Submission of Participating Organizations' financial reports by **30 April 2022**
 - to be done at headquarters level
 - a separate letter with further financial guidance will be sent to your organization's comptroller
- Submission of MPTF Office fund-level consolidated narrative and financial reports by **31 May 2022**
