2. Reason revision is being requested:

The project implementation is ongoing in both the project provinces; however, we predict delays in implementation of the project interventions due to a couple of factors. In order to mitigate against this risk, the need for an alternate strategy was felt to divide the project targets for District Kurram (Khyber Pakhtunkhwa). This was due to delay in issuance of No Objection Certificate NoC (a mandatory formal permission required for implementation of every project by Government Departments and Intelligence Agencies) to our Responsible Party PVDP, hence we propose to allocate targets to other two project locations/districts in KP Province.

Secondly, the changing Covid-19 pandemic scenario in Pakistan with covid-19 (5th Phase – Omicron) positivity rate surging to 12.53% (at the time of writing; as per NCOC-the government entity leading the efforts against the virus) has once again forced the Government to impose partial lockdowns, squeezed hours of business/work, limit the mobility of citizens, complete ban on indoor gathering and strict compliance of Covid 19 SoPs. Given the historic decrease in numbers due to the change in climate, we foresee that the type of project activities, requiring direct interaction with local communities, government stakeholders and service providers, will be completed in the requested duration.

The Implementation Plan with revised timelines is attached for reference and approval. There are no budgetary changes.

Also, one of the major outputs of the MPTF project, is provision of emergency relief cash assistance to vulnerable and poor Home-Based Women Workers. We are almost into the final stage of procuring services of a financial firm for this activity, but as the funds involved in this activity are huge, this requires an approval from UN Women HQ which might take some time and given short project timelines, achievement of this output can be hindered in the existing timelines; however, the extended timeframe requested will ensure timely completion of the exercise.

Moreover, it is important to mention that MPTF Partner FAO undertook all necessary arrangements for acquisition of No Objection Certificate (NoC) from Government of Khyber Pakhtunkhwa. However, due to administrative delays, the issuance of NoC has significantly been delayed, ultimately causing delay in implementation of project activities.

Two (2) months extension requested for the project will be of high importance as the activities which could not be completed and are witnessing delays caused due to non-issuance of NoC for District Kurram. With Covid-19 now slowing down, the pace of various project activities, will accelerate, and they will be completed in the extended timeline.

Moreover, UN Women after consultation with relevant stakeholders (keeping MPTFO in the loop) have decided to divide project targets for District Kurram between Districts Peshawar and Swabi by broadening the geographical scope and increasing the number of beneficiaries in these two districts. This will help ensure that no further administrative delays would be faced, and project targets can be achieved as planned. NoCs for the two districts have already been issued by the Government.


