External and internal factors delayed project implementation. Internally, lengthy recruitment processes deferred team constitution. However, UNDP succeeded in hiring a qualified project manager (International UNV), who will join the team on June 11. The National UNV has been on board since January 2022 and the project assistant will start in August 2022.

Despite these challenges, the project team successfully developed a joint project workplan and M&E plan, which were validated by the Agencies' Representatives and the PBF secretariat. Moreover, the project team finalized the terms of reference for the baseline study, which will be launched in June.

Moreover, the project team has made progress in identifying the communities to be targeted in the context of this intervention. The agencies consulted with Government representatives, including the Ministry of Territorial Administration, and put together a preliminary list of 15 villages (tabankas) in the three sectors targeted by the project, which are particularly vulnerable to climate-related conflicts. This selection also built on the extensive partner consultations made at the stage of the project proposal. The field missions scheduled for June/July will allow the team to visit these communities and confirm the relevance of the targeting.
