

With the overall vision of the project to facilitate sustainable and holistic reintegration of returning migrants in the economic, social and psychosocial dimensions in a manner that contributes to peacebuilding, the project has brought significant achievements during the overall implementation period covering from December 18, 2018 to March 17, 2022. The project successfully recruited staff and worked in close partnership with key government and non-governmental partners and has contributed to reduced stigma and trauma faced by returnees, enhanced social inclusion and cohesion among returning migrants and host communities, and a more balanced and positive public perception of return migration, and the roles of returnees in community stabilization, through the following key achievements, among others:

- 1. Launched the National Coordination Mechanism on Migration (NCM) in November 2019 and operationalized eight (8) Thematic Working Groups (TWGs) by June 2021
- 2. Established community-based reintegration task force in December 2020 with ten (10) community projects completed.
- 3. Established a Project Technical Committee (PTC) in September 2020. The PTC met four (4) times to discuss implementation progress and organized three (3) field monitoring visits to the project sites.
- 4. 5,500 community members including returnees engaged in dialogue, shared learning, and intergenerational sessions, with an additional 510 involved in moonlight storytelling in the seven (7) regions.

Having established the NCM, in November 2019, and under the leadership of the Office of the Vice President (OVP) the Government of The Gambia (GoTG) has put in place a coordination structure to ensure a whole-of-government approach on migration governance. The NCM provided the platform for discussions on migration governance in the eight (8) Thematic Working Groups (TWGs): Border Management, Communication and Advocacy, Cross-cutting issues, Internal Migration, Labour Migration, Migration and Development, Migration Data, Policy and Legislation, Return and Reintegration.

Structural changes are evident as: 1) The Mental Health and Psychosocial Support (MHPSS) The MHPSS framework gave the Ministry of Health (MoH) an integrated approach to the community mental health system, whilst the curriculum addressed knowledge gaps in MHPSS, particularly in health institutions whose learning curricula had sparsely incorporated MHPSS despite the need, 2) GoTG has strengthened capacity to facilitate sustainable reintegration by establishing community-based reintegration structures, 3) community linkages strengthened through and social inclusion and reintegration of returnees based on dialogue sessions, moonlight storytelling, among others.

The research on reintegration and peacebuilding highlighted the roles of returnees in community peacebuilding initiatives. As part of the research findings, 68 per cent of community members interviewed believed that migrants need more financial support for a more sustainable reintegration. Interestingly, an overwhelming 72 per cent of returnees were very open to staying and contributing to national and community development efforts. Findings from the study have been used throughout the project's implementation phase, for more sustainable outcomes.

The Displacement Tracking Matrix (DTM) generated evidence-based data on the population mobility within and outside The Gambia, in four identified Flow Monitoring Points (FMPs): Brikama in West Coast Region (WCR), Basse Upper River Region (URR), Barra and Farafenni North Bank Region (NBR). To ensure a more community-driven approach and ownership of the process, Flow Monitoring (FM) activities were done with local partners and a total of eight (8) monthly Flow Monitoring Reports (FMR) and two (2) quarterly Flow Monitoring Surveys (FMS) have been published from June 2021 to January 2022. The FMR and FMP have generated data for discussions on migration at two NCM Thematic Working Groups (TWGs) on Internal Migration, and Data, Policy and Legislation and at regular consultations with government partners on migration-related issues

The project has strengthened and supported the GoTG through the Ministry of Information and Communication Infrastructure which acts as Chair of the Communication Platform which is anchored under the Communication and Advocacy TWG of the NCM. Since the validation of the communication strategy, the action plan on the communications platform was implemented with the first government TV and radio programs held. The media outreach (through TV and radio) hosted by the Ministry of Information and Communication (MOICI) contributed to awareness-raising on return and reintegration. MOICI also developed media sensitization engagements and held TV and Radio shows to discuss migration concepts and misconceptions.

In July 2021, the project supported the OVP on a nationwide tour to directly engage returnees, community leaders and local government authorities on the topic "Irregular migration and social cohesion". Support was also provided to the National Youth Council (NYC) by establishing and operationalizing the Youth Toll-Free line (1216) for returnees and young people in general, with 201 calls recorded (159 males and 42 females) including returnees. Additional support was provided to National Youth Council regional TekkiFii awareness activities, through music and entertainment, were organized in Bansang (CRR) and Kudang (CRR). In total, 32 radio talk shows took place and the Gambians' perception of return migration has been influenced positively. Department of Labour (DoL) also engaged and rolled out the job centre services and referrals to regional youth centres.

The research on return and reintegration and its implication on peacebuilding adopted a youth and gender-sensitive approach, with most interviewees being returnees between the ages of 18–35 years. Among family members, there were 24 respondents from parents/guardians (12 males and 12 females) and 24 respondents from siblings (12 males and 12 females) per cluster, ten (10) women's group leaders and ten (10) youth leaders (5 males and 5 females) per cluster, among others. DTM enumerators for data collection had eight (8) males, and seven (7) females, showing a 46 % female composition. The eight (8) FMR reports generated from June 2021 to January 2021 showed a total of 27708 (male=50%, 50%=female) travellers have been captured through daily observation.

Additionally, the referral program and key messages on migration, return and reintegration under this project did not only cater for returnees (mostly youth returnees) but also their families and community members which included women.

The NCM launch also included the Global Compact for Migration (GCM) prioritization exercise where the GoTG selected 15 priority objectives out of the GCM 23 objectives, to address in the short to mid-term. Under the overall guidance of the OVP as the lead for the NCM and technical lead of the Ministry of Foreign Affairs, International Cooperation and Gambians Abroad (MOFA), the first National Voluntary Review of The Gambia GCM implementation progress was finalized and published in April 2021 – and a second review meeting took place in February 2022 to review and update on progress of GCM implementation in The Gambia as part of the Government's preparation ahead of the International Migration Review Forum (IMRF) New York in May 2022

The project Enhanced access to MHPSS services for returnees and communities as the national MHPSS framework and a training curriculum on the MHPSS needs of migrants was developed. Office and printing supplies were provided to facilitate dissemination of the documents. Furthermore, the capacity of mental health practitioners has been strengthened with 725 (392 males, 333 females) health care workers from private and public hospitals trained to support covid response and MHPSS.

Through an IOM-driven initiative, and in coordination with the Department of Community Development (DCD), communities of high return and beneficiaries' needs were identified, in January 2021 for community-based reintegration. IOM took the lead to support partners and stakeholders in trainings to establish the CBR, however, concerns have emerged from the lack of sustainability of the approach used by other partners who only provided economic reintegration. In February 2022, Mbolo Association, an implementing partner for ITC's training of six (6) returnees on Tuk-tuk operation as part of the PBF project raised concerns about the way in which the returnees are being trained without support first in MHPSS and rehabilitation of their psychological state. To mitigate the concerns, IOM:1) delivered MHPSS training for ITC's CBR beneficiaries 2) organized a mini-information session for all partners on modalities of a holistic and sustainable reintegration on the importance of psychosocial support to ensure consistency, even so, some partners couldn't participate. In March 2022, the project handed over ten (10) community projects.

To strengthen CSOs, the project partnered with Starfish International in Kiang Kwinella in the Lower River Region (LRR) and trained 35 community members (32 women and 3 men) including families affected by irregular migration and human trafficking, on soap making, tie and dye, batik and basic literacy. The referral platform (www.dol.gm) and staff emails set up for DoL created platforms for awareness of available opportunities in The Gambia, on top of media campaigns on QTV and GRTS. These are all demonstrations of the government's enhanced capacity to manage reintegration.

Gender mainstreaming was considered in implementing activities under this outcome. The MHPSS and Infection Prevention Control (IPC) trainings had 54 % male and 46% representations among health, protection, and frontline workers across the regions in the Gambia. The community-based livelihood interventions ensured gender mainstreaming since the inception stage by involving women and returnees in the consultations for pre-identifying and validating projects with community members included women and returnees. The active involvement of Youth Against Irregular Migration (YAIM) further ensured the inclusion of the returnees in the consultation processes and the project implementation. Furthermore, the craft production training in Kiang had 91% female and 9%, male trainees, promoting inclusiveness according to their peculiar needs

The formation of three Migrant Peer Support Groups (MPSGs) in three regions of high return gave returnees the chance to drive community-led initiatives as trainings provided improved their understanding of stress and coping mechanisms and also helped them build resilience through home visits, tie and dye-making, cooking competitions, visits to schools and shared their experiences, and awareness-raising on stigma and discrimination which have contributed to their sustainable reintegration.

The refurbishment and additional construction at Tanka-Tanka increased the facility's bed capacity from 100 to 150, has changed the ecosystem of MHPSS in The Gambia. The initiative aimed at enhancing the well-being of mental health patients and creating safe and dignified spaces that are in line with the international safety, security, and sanitary standards. Additional recreational items were also donated to facilitate psychosocial support activities and recovery. Furthermore, 60 personnel (male 36, female 24) from the facility were trained in February 2022, on facility management, MHPSS, Infection Prevention Control (IPC), and conflict/crisis management.

The Youth Centres in Bundung and Pakalinding were refurbished, and the Bundung centre hosted some activities in 2020 and 2021, mainly returnees and community members. Also, ten (10) coaches participated in an intensive five-day ToT workshop in March 2021, that combined theoretical training about essential football-based life skills for employability and entrepreneurship using Life Skills Curriculum. Eight (8) of the coaches in the ToT workshop received additional resources to support the rollout of the employability and entrepreneurship program in KMC, WCR and NBR. The coaches have implemented a four-month Kick 4 Trade workshops using the Kick for Trade curriculum in their communities with 200 participants. Since the launch of the training, two refresher workshops have been held to support the eight coaches during the roll-out of their workshops.

The shared learning sessions in seven (7) regions have engaged over 5,500 community members including returnees, vulnerable young people, opinion leaders, family members, women leaders, chiefs, and religious leaders in intergenerational dialogues and enhanced understanding of reintegration and irregular migration and facilitated the engagements returnees in decision-making processes

A five-day bootcamp was held for 50 migrant returnees and the moonlight storytelling sessions with 510 participants created a safe space for migrants to share their stories, and be trained on irregular migration and reintegration, entrepreneurship skills, and peacebuilding and to benefit from psychosocial support, fostering social cohesion. The community surveillance and contact tracing initiative involved 80 young people including returnees sensitized community members including young people on COVID-19 and the signs shown in suspected cases.

Overall, 60% of beneficiaries were females and 40% males. For instance, the mobile health outreach benefitted more females than males. The migrant peer support groups had 33.3% female and 66.7% male, and the photography training sessions had both male and female beneficiaries. Furthermore, shared learning sessions, moonlight storytelling sessions, and the community contact tracing and surveillance initiative featured young people including women and migrant returnees empowering women and young people to participate in community initiatives.

- 1. The support provided to GoTG by refurbishing Tanka Tanka has positively impacted the ecosystem of mental health in The Gambia. "Sometimes, we are worried about the support and resources we need to ensure that basic needs are met," remark made by Dr. Mustapha Bittaye, Director of Health Services at the Ministry of Health. "This support is timely; it is a permanent increase in bed capacity that will serve the people in need", he added (link)
- 2. The female survivor group of the December 2019 shipwreck intervention later became a migrant peer support group and continued to support each other. In March 2022, the group engaged in a livelihood training through tie and dye workshop. "We became a family and that means we will continue to support ourselves as a group and share our experiences with others who could also benefit from it, even beyond the project " said one of the group members.
- 3. Six-month training on livelihood initiatives (soap making, tie and die, batik with basic literacy) implemented by Starfish International supported with participants with start-ups (seed capital) and enhanced their busy ideas. "This training has provided us with the opportunity to work together with our brothers (returnees) that we thought will never come our way. This brought us together" said Arra Ceesay- a trainee in the livelihood initiative. See links: link
- 4. In December 2019, ACTIVISTA The Gambia organized community-shared learning sessions in 16 communities across the country to enhance understanding on irregular migration and social inculsion. "We wish our young people had the opportunity to participate in such forum before they departed for the backway journey" said Abdul Aziz Kah of Medina Sering Mass (link)
- 5. The dialogue and intergenerational sessions carried out in five regions, have provided platforms for returnees to share their stories with their peers fostering social cohesion and peaceful co-existence(Link)
- 6. Sports are very useful in engaging youths and are among ways to reach community members irrespective of their academic and social status "anywhere you go, sports are the only vehicle to engage with teenagers. I can go everywhere and talk about migration while playing basketball. Kids become passionate about the sport and understand the risks of migration."
