Proposal Title: Ensuring accessibility of rehabilitation services for people with disabilities in response to COVID-19 challenges

Amount: \$ 100 000

I. Immediate Socio-Economic Response to COVID19

The COVID-19 pandemic became an unexpected test of the sustainability of national health and social welfare systems, social service, and also of the financial and economic conditions created at the national level.

The COVID-19 pandemic has impacted all areas of society and, first and foremost, public health. The consequences of the pandemic increased the risk of disability and its severity, especially among people with chronic diseases. This fact influenced strengthening of social isolation of people with disabilities (PWDs), which is characterized by the reduction of accessibility of lifesaving social services, as well as worsening living conditions stemming from reducing employment opportunities.

One of the negative consequences of COVID-19 outbreak is the decrease in accessibility of social services, especially for vulnerable groups, including people with disabilities. This fact is caused by the threat of spread of COVID-19 among beneficiaries of social services and providers, high workload of medical and social workers in the process of service provision, lack of necessary digital and protective conditions for providing services.

Disability social services are guaranteed by the state and include treatment and medical care; pension provision; rehabilitation measures (specific activities for medical, social, professional and vocational rehabilitation) and provision of rehabilitation facilities with specialized equipment (wheelchairs, sticks, pants, special shoes, etc.); benefits in the area of medicine, travel, payment of utility bills, educational services, etc., depending on the ability to work and the degree of disability; social services (accompanied accommodation, social support, living in closed institutions of psycho-neurological profile, personal assistant of the

disabled person, etc. services); assistance in employment. However, the guaranteed services are even more to provide in the context of the pandemic, as social support measures, having a universal character, are oriented to support PWDs irrespective of type of disability, gender, place of residence, etc.

The process of providing disability support is based on the applicant principle: a person with a disability or a person of trust should apply for an appropriate measure of support. There is an urgent need for adaptation of social support services to the needs of different categories of people with disabilities, implementation of identification principle of support, creation of a mechanism for determining the needs of people with disabilities with different types of disorders, taking into account gender, regional and age characteristics. With regard to barrier-free environment in Belarus, it is based on legislative regulations and requirements only for infrastructure/architectural environment (including public facilities) and therefore it is mainly focused on the needs of the people with the disorders of the musculoskeletal system (including wheelchair users) and the people with visual disorders. *These standards do not* take into account specific needs of disabled people with other forms of communication and orientation in space, with features of understanding information and possibilities of using social services: disabled people with mental disorders, psychiatric diseases, diseases of nervous system, genetic deviations and congenital anomalies, etc.

The accessibility of social services, including rehabilitation and habilitation services, is also reduced in the COVID-19 situation due to a decline in the income of people with disabilities and an increase in their unemployment. The situation of the pandemic reduced their competitiveness in the labor market and increase the risk of poverty and decline of living conditions for both citizens and their families. The negative consequences of unemployment particularly affect socially vulnerable populations, including people with disabilities, who have low competitiveness in the labor market and have little to no employment opportunities in the context of the pandemic. Due to the fact that certain groups of the population find it more difficult to find a job than others, the state provides them with additional guarantees and takes additional measures to promote their employment. At the same time, certain members of vulnerable groups have a higher risk of morbidity and take social distancing measures, which limit their mobility, access to employment services and dramatically decrease their employment opportunities in the context of the pandemic.

At present, the country is improving the vocational rehabilitation services for people with disabilities as part of implementation of the norms of the UN Convention on the Rights of Persons with Disabilities. In particular, it is expected to develop and implement recommendations for taking into account the types of disability both in preparation for employment, special digital solutions for training the disabled and their accessibility to services, as well as the creation of working conditions that take into account the characteristics of people with different types of disabilities.

Thus, the COVID-19 pandemic and the process of implementing international norms in the field of services for people with disabilities involves the assistance and expert support of national partners from rehabilitation institutions, organizations of persons with disabilities in improving the accessibility of social services in the field of rehabilitation of persons with disabilities, as well as activities for their validation.

Solutions proposed

The aim of the initiative is to strengthen socio-economic resilience of PWDs during COVID-19 crisis and beyond by enhancing accessibility of rehabilitation services with the focus on scaling-up vocational rehabilitation and promoting a barrier-free workplace environment.

The project will have two main objectives:

- 1. to identify the labor potential of people with disabilities (its volume, qualitative characteristics) and assess the conditions for the realization of their labor potential;
- 2. to develop and pilot effective mechanisms for ensuring the accessibility of professional and labor rehabilitation services for people with disabilities in the context of the pandemic.

To achieve the objectives, it is planned to assess the needs of people with disabilities, the range of skills, knowledge, abilities and opportunities they have to receive professional and labor rehabilitation services, using methods of sociological research. In addition, as part of this objective, the available resources for providing vocational and labor rehabilitation services at employment centers and potential employers will be studied and evaluated.

Based on the results of the evaluation, it is planned to carry out three pilot projects to test the mechanism for ensuring the accessibility of vocational and labor rehabilitation services for persons with disabilities in pandemic conditions, both based at employment centers and at an employing organization. The piloting procedure will be conducted using expertise and with the participation of representatives from various groups of people with disabilities, who will be engaged as experts.

III. What is the specific need/problem the intervention seeks to address?

The COVID-19 pandemic has increased and sharpened limitations to access social, economic and employment benefits for people with disabilities. This fact influenced strengthening of social isolation of people with disabilities, which is characterized by reduction of accessibility of lifesaving social services, as well as reduction of living standards due to reduction of opportunities for employment. While the international community prioritize support to alleviating consequences of the negative social and economic impact of COVID on PWDs the employment related issues appeared to be beyond the major development radars.

Among the most significant social and medical services for people with disabilities are rehabilitation services. A range of rehabilitation and habilitation services, including vocational and employment rehabilitation, are in place to facilitate the social integration of persons with disabilities. Rehabilitation services involve creating conditions both to restore and maintain the health of people with disabilities, as well as conditions for their education and employment. Special assignments for professional rehabilitation services are performed by medical and rehabilitation expert commissions. Employment centers are responsible for providing services in the area of professional and vocational rehabilitation. In the COVID-19 situation, the need for vocational and employment rehabilitation is increasing. In 2020, employment centers registered 3,282 people with disabilities with need in special vocational and professional rehabilitation services, of whom 2009 people with disabilities received employment assistance. In January-May 2021, employment centers registered 1,364 persons with disabilities who needed vocational and professional rehabilitation services, which is 40 percent higher than in the same period last year.

In this connection, to ensure the accessibility of vocational rehabilitation for people with disabilities, and to increase its effectiveness, the development and implementation of innovative digital and organizational solutions in the sphere of social services to promote the employment of people with disabilities and their working conditions is necessary at the present time during the COVID-19 recovery.

How does this collaborative programme solve the challenge? Please describe your theory of change.

The initiative is aimed at testing mechanisms for researching the needs of various vulnerable groups in social and medical services, as well as piloting their accessibility on the basis of medical and social institutions within the framework of Belarus COVID-19 Action Program (BeCAP): a Joint Action for Recovering Better through Strengthening Health, Social Services and Community Resilience in Belarus.

The initiative will ensure:

- To overcome the lack of country data in the field of accessibility of services (on the example of rehabilitation services) for one of the vulnerable groups of population people with disabilities through a broad sociological survey (at least 1500 respondents of different gender, different types of disabilities, living in rural and urban areas in all regions of the country (6 regions and the city of Minsk). The data collected will make it possible to assess the labor potential of people with disabilities, to determine the need for rehabilitation services, their content and spectrum;
- to formulate proposals on the organization of professional and labor rehabilitation for people with disabilities as well as recommendations on the organization of working conditions, taking into account gender, different types of disability, place of residence (rural and urban areas) in response to COVID-19:
- to test mechanisms for ensuring the accessibility of rehabilitation services for people with disabilities on the example of employment centers and employers' organizations.

The results will be used to promote tailored health and social support during the implementation of the Belarus COVID-19 Action Program (BeCAP): a Joint Action for Recovering Better through Strengthening Health, Social Services and Community Resilience in Belarus.

IV. Documentation

The collaborative efforts of UN agencies in Belarus to mitigate negative impact of COVID-19 outbreak on national economy, people's health and well-being are underpinned by the COVID-19 Socio-economic Response Plan for Belarus: From economic shocks to build back better (SERP), which seeks to address among others the challenges posed by the pandemic for sustainability of healthcare, social protection and community resilience as well as to ensure that the recovery from the COVID-19 crisis is both socially inclusive and sustainable. The project priorities fully correspond to SERP Pillar 2: Protecting People: Social Protection and Basic Services, that implies scaling-up interventions for social protection and inclusion of vulnerable groups mostly affected by the pandemic (e.g. people with disabilities, elderly, people with mental disorders and so on) to ensure their ability to fulfil their needs and exercise fundamental rights. SERP complies with UNCT Preparedness and Response Plan on COVID-19, which focuses on the procurement of personal protection equipment (PPE) resources and pharmaceutical products as well as National Comprehensive Plan on COVID-19 prevention, which aims to deter the spread of COVID-19 and avert the rise of new COVID-19 cases among the population.

UNCT efforts in promoting social and economic resilience of Belarus are reinforced by UNDP strategic and operational inputs withing the framework of UNDP Country programme document for Belarus (2021-2025), which sets the priorities for UNDP efforts in sustainable development of Belarus, including strengthening social cohesion and inclusive economic growth. The project activities comply with UNDP Country programme Priority area 4. Fuller participation of vulnerable groups in socio-economic life, which seeks to address among others discrimination and inequalities in the access to services and jobs for vulnerable groups, strengthen inclusiveness of labor-market and ensure productive employment and decent incomes.

The fundamental rights of PWDs in Belarus are secured by the <u>UN Convention on the Rights of Persons with Disabilities</u> ratified by the Republic of Belarus in 2016. The Convention sets the fundamental obligations of states to ensure decent living conditions of PWDs, availability of supporting and rehabilitation services, equal access to healthcare, social protection and social benefits as well as PWDs' freedom from discrimination in social life and employment.

Following Belarus ratification of CRPD in October 2016, the government and civil society jointly developed the <u>National Action Plan for the implementation of the provisions of CRPD in Belarus for 2017-2025</u>, which focuses on protecting the rights of PWDs and eradicating discrimination based on disability, creating conditions for integration of PWDs into all kind of social interactions, securing PWDs' dignity and creating organizational and institutional conditions for the implementation of the Convention. To monitor the implementation of the Plan, annual reports on the progress made are to be submitted by implementing agencies to the Ministry of Labour and Social Protection.

National strategic and policy frameworks for the implementation of the project activities are also provided by State Programme on Public Health and Demographic Security 2021-2025, which defines enhancing rehabilitation interventions and strengthening primary medical care and mental healthcare as paramount national priorities in the socio-medical field and underlines the importance of the issue of creating jobs for people with mental disorders and disabilities and providing a protective environment for these workers and State Programme on Social Protection 2021-2025, which is aimed at further improvement of social protection of the population, the formation of an accessible living environment, particularly through provision of social services to citizens in difficult situations and PWDs, social support, social rehabilitation services as well as ensuring the accessibility of social infrastructure facilities and formation of a positive attitude in society towards disabled people. Furthermore, State Programme on Labor Market and Employment Promotion 2021-2025 reiterates the national objective to create the conditions for the integration of PWDs into the workforce, which is in line with SDGs Target 8.5. By 2030, achieve full and productive employment and decent work for all women and men, including for young people and persons with disabilities, and equal pay for work of equal value.

V. Target population

The project activities are targeted directly at men and women with disabilities of working age, who face challenges in entering the workforce and obtaining employment assistance and social protection. At the end of December 2020, there were 573,700 PWDs registered with the bodies of Labor and Social Protection in Belarus, which accounts for 6% of the total population. The number of PWDs with the 1st group of disability, which implies severe social insufficiency of individual and significantly pronounced disruption of organism' functions, amounts to 86.7 thousand of all PWDs in Belarus, while 360.3 thousand of PWDs have the 2nd disability group, characterized by moderate social insufficiency and lasting health disorder. 33.2 thousand children under 18 are registered among the disabled persons in Belarus.

PWDs in focus include people with different types of disability (e.g., mental, psychiatric disorders, physical deficiencies, visual and hearing disabilities). Such a broad range of beneficiaries is essential for comprehensive assessment of PWDs' needs and substantive review of health and social sectors' capacities to carry out in-depth disability assessment, undertake effective medical, social and vocational rehabilitation of PWDs and provide efficient employment assistance and social support. PWDs' expertise will be used in piloting activities on accessibility of rehabilitation services.

Furthermore, medical and social workers will be involved in the project. Particularly, personnel of Medical and Rehabilitation Expert Commissions under the MoH and employment centers under the Ministry of Labor and Social Protection will participate in the assessment and piloting activities to provide firsthand knowledge and expertise on PWDs' needs and demands as well as to practice innovative solutions and data-driven recommendations to increase the quality of

disability assessment and enhance the effectiveness of rehabilitation referral mechanisms (medical component) and to ensure PWDs' access to employment services and social support (social component).

Potential **employers** are also to be involved in the project activities to participate in the assessment of workplace environment and preparedness for PWDs' employment as well as in piloting activities to create PWDs-sensitive working conditions. That implies the establishment of barrier-free modalities at the employer facilities reinforced by evidence-based recommendations to create favorable and enabling conditions for PWDs to successfully enter the workforce.

VI. Who will deliver this solution?

UNDP will serve as an implementing agency to the project with relevant expertise, human resources and partnership-building experience in socio-economic development and resilience at the country level. UNDP's role in Belarus COVID-19 Action Program (BeCAP): a Joint Action for Recovering Better through Strengthening Health, Social Services and Community Resilience in Belarus for 2021-2024 is also crucial as it reiterates the importance and applicability of the project results for further action.

The project will build on the UNDP accumulated capacity and lessons learned under the completed project "Preventing Non-communicable Diseases, Promoting Healthy Lifestyle and Support to Modernization of the Health System in Belarus" (BELMED) as well as the ongoing project "Support to Economic Development at the Local Level in Belarus". Partnerships established between UNDP and relevant stakeholders as part of the implementation of the aforementioned projects will facilitate meaningful collaboration with government bodies concerned (Ministry of Health and Ministry of Labor and Social Protection) and ensure operational frameworks of the project.

Ministry of Labor and Social Protection will serve as implementing partner for the project. The ministry will promote vocational rehabilitation activities and ensure participation and accountability of employment centers selected for the pilots. Ministry of Labor and Social Protection will also provide recommendations on PWDs-sensitive working conditions and barrier-free environment at the employer facility to better comply with national standards and approaches to organization of working process for PWDs.

Ministry of Health will be involved in strengthening and updating algorithms and procedures of disability assessment that is conducted by Medical and Rehabilitation Expert Commissions to better respond to the needs of PWDs, contribute to the improvement of rehabilitation referral mechanisms and provide expertise in vocational rehabilitation of PWDs.

Both Ministries will accept and approve the results of the project, performing monitoring and evaluation (M&E) function, which entails sustained engagement of both bodies in all stages of project's implementation as well as preliminary and final reporting in accordance with set procedures. In addition, Ministry of Health and Ministry of Labor and Social Protection will act as coordinating authorities responsible for operationalizing guidelines, recommendations and mechanisms developed based on piloting results.

To better respond to the needs of PWDs, civil society organizations (CSOs), which work with PWDs on their rehabilitation and social inclusion will be actively involved in the assessment and piloting activities through inclusive and open dialogue and establishing sustainable cooperation for the future action. These organizations may include Office for the Rights of People with Disabilities, CPA «World without Borders», Public association "Republican Association of Wheelchair Users, Public Association "Belarusian Society of the Deaf", Belarusian Association of Social Workers.
