NARRATIVE REPORT

I. Purpose

The Justice and Rule of Law Project provides the Iraqi government with technical support and training necessary for improvement of key components of the judicial system, toward advancing the rule of law in Iraq, specifically for improving the functioning of the courts and penitentiary system. In line with its commitment to assist the Republic of Iraq to encourage respect for the rule of law and increase the effectiveness of the judicial sector as a whole, UNDP-Iraq is implementing a pilot model court in Iraq, building the capacity of the Iraqi Judicial Training Institute, completing the Iraqi Legal Database, and will implement a number of key activities to support reform of the penitentiary system, including its management and treatment of women and juveniles. This project forms part of a consolidated framework in support of the rule of law and justice, together with the EC-funded project "Support to the Rule of Law and Justice".

Development of Justice and Rule of Law as supported through this project remains a major priority for the GoI in order to achieve the goals articulated in the NDS (2007-2010) and ICI, as well as the MDGs more broadly.

The Support to the Development of Justice and the Rule of Law Project contributes to priorities of both the NDS and the ICI. This Project contributes to the NDS priority of strengthening good governance and improving security (Pillar 4) and the ICI benchmarks (3.1.1) as follows:

Outcome 1: 'Strengthened administration of justice system' is aligned to:

- (i) Establish and implement effective rule of law institution and policy;
- (ii) Private sector development and investment promotion of the rule of law and judicial system in commercial and financial activities.

Outcome 2: 'Strengthened capacity of key government and non-government institutions to protect and promote human rights' is aligned to:

- (i) National Dialogue and reconciliation protection of Human rights systems to respect the rule of law and human rights;
- (ii) Establish a comprehensive human rights regime country wide.

The "Rule of Law" project also contributes toward MDG Goal 3: 'Promote gender equality and empower women'. The lack of application of rule of law is rendering women more vulnerable to social, tribal and religious rulings and practices. This leaves the Iraqi women to be the most vulnerable group in society, for example, vulnerability to variances in application of court rulings. The project's support to capacity development of the Judges and prisons' administrators, and empowering women within the penal system, through the penitentiary reform program, addressing their rights and concerns during incarceration and ensuring their participation in the complete penitentiary reform, should go some way to contribute towards this goal in Iraq.

II. Resources

Financial Resources:

The project budget has been reviewed and the revision approved on 17 October 2009. The revision aimed at moving funds (495,000 USD) between project components on the basis of number of discussions with Iraqi government and parliamentary officials, independent legal experts, members of the judiciary, and, after a request by the HJC, to substitute Output 3 of the Project with an alternative Output 3, which will serve to complete the project to create an Iraqi Legal Database (the "ILD").

III. Implementation and Monitoring Arrangements

UNDP assumes the overall responsibility, and accountability, for the management and implementation of the project. As executing agent, UNDP has been working in conjunction with its Government of Iraq (GoI) counterparts and implementing partners in the day-to-day management of the project, along with the assumption of responsibility and accountability for the production of outputs, achievement of objectives and for the use of UN resources. The management of the project aligns in accordance with the RBM tools adopted by UNDP for project management. The management and implementation structure for the project consists of (a) a Project Steering Committee¹ (b) a Project Management Unit, supported/overseen by (c) the Team Leader of the Governance Unit.

To contribute towards the priorities and the two broad project outcomes stated in point 1.b (above), the Project pursues four broad areas of intervention, defined as the project outputs: (i) Pilot model court in Baghdad, (ii) Reform of the teaching methods and curriculum in specialized areas of the Iraqi Judicial Training Institute (JTI), (iii) Completing the Iraqi Legal Database, and (iv) Capacity development of the penitentiary system, including treatment of women and juveniles.

This project forms part of a larger integrated framework for support to the Rule of Law and Justice, comprised of the "Support to the Rule of Law and Justice Project" funded by the European Commission and implemented jointly by UNDP and UNOPS with the

UNAMI Human Rights Office, and the present project. The EC-funded project spans the period of 2008-2010, and follows on a previous two-year project implemented by UNOPS related to the protection of detainees and victims of torture.

UNDP-Iraq has also been making use of its extensive network of regional and international experts that are specialized in this particular subject matter, in order to ensure that the implementation of this project is successful. In that respect, UNDP-Iraq calls upon wherever necessary and in consultation with the donors, the expertise of other United Nations agencies, including UNDP-SURF (Sub-Regional Resources Facility-for Arab States), UNDP-POGAR (Programme on Governance in the Arab Region) and UNODC (United Nations Office on Drugs and Crime), amongst others, as well as specialised non-governmental organizations already involved in prison monitoring. In addition, UNDP has been coordinating with the UNAMI-HRO national and international staff working specifically on prisons. The UNAMI-HRO staff has been involved in the data gathering, provision of background, and advise on human rights issues.

In terms of procurement procedures, a full procurement annual plan has been drafted during the first quarter of 2009, detailing the required assets to be purchased during the first year of the project. UNDP Regulations and Rules were applied.

As regards the project monitoring, it has been executed by UNDP under the overall supervision of the Project Steering Committee. In addition, relevant government ministries and other partners, UNAMI, UN Agencies, as well as NGOs, have been kept informed with regard to the implementation of the activities specified in Annual Work Plans (AWPs).

The project was approved in December 2008. As a result, no assessments, evaluations or studies have been undertaken during the reporting period.

IV. Results

Results Overview:

This project has progressed well since its start date. The period January- December 2009 was used to hire project staff, engage with the Iraqi counterparts for the identification of the pilot court and related policy guidance, identify pilot court and court administration experts, prepare a detailed work plan including a procurement plan, hire an expert on pilot courts, prepare terms of reference for competitive bidding so that the various components of this project could be implemented, and finalize contracts for the various service components.

The project's main impact will be a strengthened administration of the justice system including increased access, transparency and efficiency, and strengthened capacities of key government and non-government institutions to protect and promote human rights.

During January-December 2009, below activities were accomplished:

- Outcome 1: Strengthened administration of justice system' is aligned to:
- (i) Establish and implement effective rule of law institution and policy;
- (ii) Private sector development and investment promotion of the rule of law and judicial system in commercial and financial activities

Outcome 2: Strengthened capacity of key government and non-government institutions to protect and promote human rights' is aligned to:

- (i) National Dialogue and reconciliation, protection of human rights systems to respect the rule of law and human rights;
- (ii) Establish a comprehensive human rights regime country wide.

Output 1: Pilot model court established in Baghdad Physical progress: 35%

- o The IT equipment for Baghdad pilot court has been delivered and received by counterparts and capacity development on pilot courts and case management system undertaken. This is considered the starting point for the establishment of the automated case management in the selected pilot courts.
- o Baseline assessment on Baghdad pilot court is completed.
- The expert on Pilot courts is on board and started work in October 09. He has conducted a mission to Baghdad in December 2009.
- Contract for law library and legal research centre at Baghdad pilot court has been awarded.
- o Contract for media awareness campaign for the Baghdad pilot court has been awarded.
- o Providing help desk and hotline for Baghdad pilot court is subject to further formal consultation with key stakeholders.

Output 2: Reform of the curriculum in specialised areas of the Iraqi Judicial Training Institute Physical progress: 25%

- A contract for a comprehensive assessment and curricula reform of the JTI has been awarded
- o A contract for building the JTI staff capacity has been awarded
- o A contract to deliver gender/child specific legal training for the JTI has been awarded.

Output 3: Implementation of Phase III of the POGAR/UNDP Iraqi Legal Database (ILD)

Physical progress: 35%

- o Individual experts for Iraqi Legal Database phase III have been recruited and started their tasks.
- o Terms of Reference for Iraqi Legal Database phase III implementing partner along with selection process is accomplished.

Output 4: Reform of the penitentiary system, including its management and treatment of women juveniles Physical progress: 20%

- Contract for the reform of the Iraqi penitentiary system, including a needs assessment, training curriculum, and security assessment has been awarded.
- o A contract to deliver gender/child specific legal training for the penitentiary system administrators has been awarded.

The project was approved in December 2008. The implementation during the reporting period has not faced any major delays or constraints. However, the security situation in Iraq, especially in Baghdad, has been a major obstacle in implementing the project activities, especially after the two massive bombings of 19 August, 2009, at the Foreign Affairs and Finance Ministries and 25 October, 2009, at the Higher Judicial Council and Ministry of Justice in Baghdad, which are the main two Iraqi institutions the project works with. Field visits to the pilot court, Ministry of Justice, and JTI, and meeting with the Iraqi counterparts have been difficult and faced security impediments.

In addition, hesitation from the Iraqi counterparts towards one of the project's main outputs "Alternative Civil Law Dispute Settlement Mechanisms" has been significant. The Iraqi Chief Justice has requested the project manager to disburse the allocated funds to the development of the third phase of the Iraqi Legislative Database (ILD). Requests to change the project's scope, concerning the third output, has been submitted and approved by the Head of the ITF Steering Committee. This resulted in a considerable postponement to the start date of this particular component.

Recruitment of project personnel has been lengthy. As a result, starting the project's implementation has also been delayed for four to six months. This would be accommodated through a six month no cost extension for the project to finish the implementation of its activities.

The Project was developed in close consultation with the Chief Justice, the Ministry of Justice, the Judicial Training Institute, the Kurdish Ministry of Justice, and the Kurdish Ministry of Labour and Social Affairs, and is based on field visits to courts and women and juvenile reformatories. The Project has been cleared by the Governance Sector Outcome Team and has identified areas of collaboration with other UN Agencies, namely UNICEF and UNAMI-HRO in the area of penitentiary reform and protection of human rights in general. The project is fully supported by the previously mentioned institutions, which helps in facilitating the project's implementation.

Gender Equality

The project will improve access to justice for vulnerable groups, including women and juveniles. The Penitentiary Reform component will improve the conditions of women and juvenile inmates and will promote the respect of their human and civil rights within the penitentiary system.

Iraqi women are among the most vulnerable in society. The lack of application of rule of law is rendering women more vulnerable to social, tribal and religious rulings and practices such as increases in early marriages, crimes in the name of honour, and vulnerability to variances in application of court rulings. By developing the capacity of the judges, and prison administrators, the project seeks to contribute to an improvement in women's conditions. Gender equality will be pursued through:

- Selection of an equal number of men and women for all capacity-building activities;
- Through penitentiary reform activities, addressing the rights of women during incarceration and ensuring their participation in all components of reform.

Human rights

Present-day Iraq has a legacy of human rights abuses and ongoing conflict, but civil society groups and government commitment, through a dedicated Ministry of Human Rights and current intentions to create a Human Rights Commission, are trying to bring about change. The capacity revolves around a lack of knowledge and therefore the ability to apply human rights principles. The primary duty bearers in this project are Ministry of Justice and Ministry of Labour and Social Affairs. It is recognised that to enable these duty bearers to develop their capacity to meet their human rights obligations and to empower rights-holders - Iraqi citizens and prisoners - to claim and exercise their rights is a gradual and lengthy process. The project will pursue the following as the environment and capacities allow:

- Ensure that relevant policies and laws promote equality and are non-discriminatory, but contain positive measures, where considered critical.
- Conducting dedicated training in human rights and ensuring that human rights are clearly and adequately incorporated in the training curricula and materials in a manner that is easily understood.

- Develop capacity of rights-holders in certain rights, particularly associated with access to information, procedures, services and counsel.
- Improve access to justice for vulnerable groups, including women and juveniles. The Penitentiary Reform component will improve the conditions of women and juvenile inmates and will promote the respect of their human and civil rights within the penitentiary system.
