i. Provide an overview of the level of completion of the Programme to date

For the previously approved February-March 2023 cost extension, post-mobilisation Community Consultations were successfully completed in Ayod, Pibor, Duk, Twic East, Akobo West, and Uror. Bor South and Akobo East consultations shall be completed 2-31 March, and a workshop to consolidate the findings was scheduled for 30-31 March in Bor but has been pushed to mid-April. This will allow partners to optimize learning from other ongoing consultations and dialogues. The NCE will overlap with the anticipated inception of phase 02 in April 2023 and hence ensure smooth continuation of the project.

ii. Briefly explain why the no-cost extension is required

There was a delay in the approval of a cost-extension request for US\$306,141.70 for February and March 2023. Therefore, it was not possible to programme funds and expense invoices within the current end date of 31 March. As such, an NCE is required to cover the lead time required for programming funds and involving before the Terminal Disbursement Date (TDD) of the grant in the system.
